18 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

20 *SECTION 1. Arkansas Code § 5-73-319 is amended to read as follows:*

21 *5-73-319. Transfer of a license to Arkansas.*

22 *(a) ~~Any~~ Within thirty (30) days of becoming an Arkansas resident, a*
23 *person who becomes a resident of Arkansas who has a valid license to carry a*
24 *concealed handgun issued by ~~a reciprocal~~ another state may and who wishes to*
25 *obtain a license to carry a concealed handgun in Arkansas shall apply to*
26 *transfer his or her out-of-state handgun carry license to Arkansas by*
27 *submitting the following to the Department of Arkansas State Police:*

28 *(1) ~~The~~ A copy of the person's current reciprocal out-of-state*
29 *handgun carry license;*

30 *(2) Two (2) properly completed fingerprint cards;*

31 *(3) A nonrefundable license fee of thirty-five dollars (\$35.00);*

32 *and*

33 *(4) Any fee charged by a state or federal agency for a criminal*
34 *history check; ~~and.~~*

35 *~~(5) A digital photograph of the person or a release~~*
36 *~~authorization to obtain a digital photograph of the person from another~~*

2 (b) ~~After July 31, 2007, the~~ The newly transferred license to carry a
3 concealed handgun in Arkansas is valid for a period of five (5) years from
4 the date of issuance and binds the holder to all Arkansas laws and
5 regulations regarding the carrying of the concealed handgun.

6 (c) When a person receives his or her license to carry a concealed
7 handgun in Arkansas, he or she shall promptly surrender the out-of-state
8 handgun carry license to the Department of Arkansas State Police unless that
9 is impractical due to the out-of-state handgun carry license's integration
10 with another government-issued document.

11

12 SECTION 2. Arkansas Code § 5-73-321 is amended to read as follows:

13 5-73-321. Recognition of other states' licenses.

14 A person who is not an Arkansas resident and who is in possession of a
15 valid license to carry a concealed handgun issued to the person by another
16 state is entitled to the privileges and subject to the restrictions
17 prescribed by this subchapter.
