## Subtitle

14 AN ACT CONCERNING THE REVIEW AND APPROVAL  
15 OF ADMINISTRATIVE RULES AND THE  
16 IMPLEMENTATION OF ARTICLE 5, SECTION 42,  
17 OF THE ARKANSAS CONSTITUTION.

21 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:  
22

23 *SECTION 1. Arkansas Code § 6-15-2106(b), concerning rules implementing*  
24 *a school rating system, is amended to read as follows:*

25 *(b) The state board may, by rules adopted under the Arkansas*  
26 *Administrative Procedure Act, § 25-15-201 et seq., and reviewed and approved*  
27 *under § 10-3-309, redesignate the levels of performance categories and*  
28 *improvement categories under this subchapter to be consistent with:*

29 *(1) The Common Core State Standards;*

30 *(2) Assessments that correlate with those standards; and*

31 *(3) Rules adopted under the requirements of a law enacted by*  
32 *Congress for general education, including without limitation the Elementary*  
33 *and Secondary Education Act of 1965 as reauthorized by the No Child Left*  
34 *Behind Act of 2001, 20 U.S.C. § 6301 et seq., or any supplementary federal*  
35 *regulations, directives, or decisions of the United States Department of*  
36 *Education pertaining to that legislation.*

2           SECTION 2. Arkansas Code § 6-60-902(b)(2)(B)(ii), concerning the  
3 Arkansas Higher Education Information System and as amended by Act 218 of  
4 2015, is amended to read as follows:

5                           (ii) Disclose to the bureau and to the ~~Arkansas~~  
6 ~~Lottery Legislative Oversight Committee~~ Legislative Council the method of  
7 electronic blocking or redaction the Department of Higher Education will use  
8 under this subsection.

9  
10           SECTION 3. Arkansas Code § 6-60-903(b), concerning compliance by  
11 institutions of higher education and as amended by Act 218 of 2015, is  
12 amended to read as follows:

13           (b) Within two (2) weeks of an institution of higher education's  
14 failure to comply with the requirements for submission of data published by  
15 the department, the department shall report to the ~~Arkansas Lottery~~  
16 ~~Legislative Oversight Committee~~ Legislative Council:

17                           (1) The name of an institution of higher education that has not  
18 complied with the deadline;

19                           (2) The type of data the institution of higher education failed  
20 to submit;

21                           (3) The length of time of noncompliance; and

22                           (4) Any additional information requested by the ~~Arkansas Lottery~~  
23 ~~Legislative Oversight Committee~~ Legislative Council.

25           SECTION 4. Arkansas Code § 6-85-205(a), concerning the authority and  
26 duties of the Department of Higher Education and as amended by Act 218 of  
27 2015, is amended to read as follows:

28           (a)~~(1)~~ The Department of Higher Education shall develop and promulgate  
29 rules for the administration of the Arkansas Academic Challenge Scholarship  
30 Program consistent with the purposes and requirements of this subchapter.

31                           ~~(2) The Arkansas Lottery Legislative Oversight Committee~~  
32 ~~Subcommittee of the Legislative Council shall perform the function of the~~  
33 ~~Legislative Council required by law for the review of a proposed rule or~~  
34 ~~proposed change to a rule promulgated by the Department of Higher Education~~  
35 ~~under this subchapter.~~

6 ~~Lottery Legislative Oversight Committee~~ Legislative Council for review.

8           SECTION 6. Arkansas Code § 6-85-205(g), concerning the authority and  
9 duties of the Department of Higher Education and as amended by Act 218 of  
10 2015, is amended to read as follows:

11           (g)(1)(A) By July 15 of each year, the Director of the Department of  
12 Higher Education shall provide a report to the ~~Arkansas Lottery Legislative~~  
13 ~~Oversight Committee~~ Legislative Council on:

14                           (i) The implementation of this subchapter;

15                           (ii) The number of recipients that either:

16   (a) Dropped out during the academic year; or

17   (b) Lost the scholarship during the academic

18 year; and

19                           (iii) Any additional information requested by the  
20 ~~Arkansas Lottery Legislative Oversight Committee~~ Legislative Council.

21           (B) The ~~Arkansas Lottery Legislative Oversight Committee~~  
22 Legislative Council shall include the information reported under this  
23 subsection in its annual report to the General Assembly under § 6-85-220.

24           (2) By August 1 of each year, the Department of Higher Education  
25 shall provide to the ~~Arkansas Lottery Legislative Oversight Committee~~  
26 Legislative Council an unaudited financial report on the administration of  
27 the Arkansas Academic Challenge Scholarship Program for the fiscal year just  
28 ended.

36                           (2) Number or type of scholarships; and

1                   (3) *Eligibility requirements.*

3           *SECTION 8. Arkansas Code § 6-85-212(j), concerning scholarship award*  
4 *amounts and as amended by Act 218 of 2015, is amended to read as follows:*

5           *(j) When the General Assembly determines that sufficient net lottery*  
6 *proceeds exist to fund students enrolling in certificate, associate degree,*  
7 *and baccalaureate degree programs, the department shall submit*  
8 *recommendations to the ~~Arkansas Lottery Legislative Oversight Committee~~*  
9 *Legislative Council for the award of scholarships and grants to certain*  
10 *graduate and professional programs at approved institutions of higher*  
11 *education.*

12  
13           *SECTION 9. Arkansas Code § 6-85-216(c), concerning an institution*  
14 *report to the Department of Higher Education and as amended by Act 218 of*  
15 *2015, is amended to read as follows:*

16           *(c) The department shall use the information provided under this*  
17 *section to conduct the research and analysis needed to support the annual*  
18 *report of the Director of the Department of Higher Education to the ~~Arkansas~~*  
19 *~~Lottery Legislative Oversight Committee~~ Legislative Council under § 6-85-205.*

21           *SECTION 10. Arkansas Code § 6-85-219 and 6-85-220, as amended by Act*  
22 *218 of 2015, are amended to read as follows:*

23           *6-85-219. Reports to legislative committees.*

24           *(a)(1) Annually by August 1, the Department of Higher Education shall*  
25 *report to the ~~Arkansas Lottery Legislative Oversight Committee~~ Legislative*  
26 *Council in the manner and format that the ~~Arkansas Lottery Legislative~~*  
27 *~~Oversight Committee~~ Legislative Council requires on all state-supported*  
28 *student financial assistance awarded by the department and awarded by*  
29 *approved institutions of higher education.*

30           *(2) The information provided shall include without limitation:*

31                   *(A) Current year expenditures for scholarships and grants*

 6 nonlottery state educational resources; and

 8 ~~Legislative Oversight Committee~~ Legislative Council or the General Assembly  
 9 requests.

10 (b) Annually by December 1, the department shall report to the  
 11 ~~Arkansas Lottery Legislative Oversight Committee~~ Legislative Council its  
 12 recommendations for changes to the program, including without limitation:

13 (1) Adjustments to the eligibility requirements of the program;  
 14 and

15 (2) Increases or decreases in the amounts awarded for a  
 16 scholarship under the program based on the amount of net proceeds from the  
 17 state lottery available.

18 (c) Annually by December 31, the department shall report to the

26 (4) Family or individual income as reported on the student's  
 27 Free Application for Federal Student Aid.

31 (a) The ~~Arkansas Lottery Legislative Oversight Committee~~ Legislative  
 32 Council shall:

33 (1) Oversee the development and implementation of Arkansas Code  
 34 requirements with regard to the Arkansas Academic Challenge Scholarship  
 35 Program;

36 (2) Review whether and how the use of net state lottery proceeds

1 *helps to accomplish state objectives for higher education;*

2 *(3) Review the ongoing data collection, research, and evaluation*  
3 *of the program;*

4 *(4) Review the annual report of the Director of the Department*  
5 *of Higher Education under § 6-85-219;*

6 *(5) Review and recommend changes to the:*

7 *(A) Number of awards for each scholarship and grant;*

8 *(B) Award levels;*

9 *(C) Eligibility requirements; and*

10 *(D) Overall administration of the program; and*

11 *(6) Review and recommend policies for scholarships and grants*  
12 *funded with nonlottery state educational resources, including without*  
13 *limitation ways to ensure that net proceeds from the state lottery are used*  
14 *to supplement and not supplant nonlottery state educational resources.*

15 *(b) Annually by December 15, the ~~Arkansas Lottery Legislative~~*  
16 *~~Oversight Committee~~ Legislative Council shall report its findings and*  
17 *recommendations to the Office of the Arkansas Lottery, the President Pro*  
18 *Tempore of the Senate, the Speaker of the House of Representatives, the*  
19 *Governor, the House Committee on Education, and the Senate Committee on*  
20 *Education.*

21  
22 *SECTION 11. Arkansas Code § 9-13-106(g), concerning the attorney ad*  
23 *litem program, is amended to read as follows:*

24 *(g) In order to ensure that each judicial district will have an*  
25 *appropriate amount of funds to utilize for ad litem representation in custody*  
26 *cases, the funds appropriated shall be apportioned based upon a formula*  
27 *developed by the office, promulgated by rule, and approved by the Arkansas*  
28 *Judicial Council and the ~~Administrative Rules and Regulations Committee of~~*  
29 *~~the Arkansas~~ Legislative Council.*

30  
31 *SECTION 12. Arkansas Code § 10-3-309 is amended to read as follows:*

32 *10-3-309. Review and approval of state agency rules, ~~regulations,~~*  
33 *~~amendments, revisions, etc.~~*

34 *(a)(1)(A) In the passage of this section, the General Assembly is*  
35 *aware of the significant number of laws which have been enacted granting to*  
36 *boards, commissions, departments, and administrative agencies of state*

1 government the authority to promulgate and enforce rules ~~and regulations~~.

2 (B) The General Assembly is further aware that ample  
3 safeguards have not been established whereby the General Assembly may be  
4 informed of circumstances in which administrative rules ~~and regulations~~ do  
5 not conform to legislative intent.

6 (2) It is the purpose of this section to establish a method for  
7 continuing legislative review and approval of such rules ~~and regulations~~  
8 ~~whereby the General Assembly at each legislative session may take remedial~~  
9 ~~steps to correct abuses of rulemaking authority or clarify legislative intent~~  
10 ~~with respect to the rulemaking authority granted the administrative boards,~~  
11 ~~commissions, departments, or agencies.~~

12 ~~(b)(1)(A) Whenever a state agency finalizes the promulgation of a rule~~  
13 ~~or regulation or a revision, amendment, or change in the regulation, a copy~~  
14 ~~shall be filed with the Bureau of Legislative Research if the rule or~~  
15 ~~regulation contains any changes from the initial filing of the rule or~~  
16 ~~regulation.~~

17 ~~(B) A state agency shall notify the Legislative Council of~~  
18 ~~its intention to repeal any rule or regulation which is on file with the~~  
19 ~~bureau.~~

20 ~~(2) As used in this section, "state agency" means any office,~~  
21 ~~board, commission, department, council, bureau, or other agency of state~~  
22 ~~government having authority by statute enacted by the General Assembly to~~  
23 ~~promulgate or enforce the administrative rules and regulations.~~

24 ~~(c)(1) The research staff of the bureau shall study and review all~~  
25 ~~current rules, or proposed rules, and all adopted amendments and revisions of~~  
26 ~~rules by state agencies and shall report to the Legislative Council in regard~~  
27 ~~to them.~~

28 ~~(2) The Legislative Council shall act in an advisory capacity to~~  
29 ~~the General Assembly with respect to administrative rules and procedures and~~  
30 ~~shall report to the General Assembly at each regular session all~~  
31 ~~administrative rules and regulations which the Legislative Council believes~~  
32 ~~to be contrary to legislative intent or promulgated without legislative~~

34 ~~(d)(1)(A) The Legislative Council may selectively review possible,~~  
35 ~~proposed, or adopted rules and regulations and prescribe appropriate~~  
36 ~~Legislative Council procedures for that purpose.~~

1 ~~(B) The Legislative Council may receive and investigate~~  
2 ~~complaints from members of the public with respect to possible, proposed, or~~  
3 ~~adopted rules and regulations and hold public proceedings on those~~  
4 ~~complaints.~~

5 ~~(2)(A) The Legislative Council may request a representative of~~  
6 ~~an agency whose possible, proposed, or adopted rule or regulation is under~~  
7 ~~examination to attend a Legislative Council meeting and answer relevant~~  
8 ~~questions.~~

9 ~~(B) The Legislative Council may also communicate to the~~  
10 ~~agency its nonbinding comments on any possible, proposed, or adopted rule or~~  
11 ~~regulation and request the agency to respond to them in writing.~~

12 ~~(3)(A) The Legislative Council may recommend and refer the~~  
13 ~~recommendation to the appropriate committee or committees of the General~~  
14 ~~Assembly.~~

15 ~~(i) Enactment of a statute to improve the operation~~  
16 ~~of an agency; and~~

17 ~~(ii) That a particular rule or regulation be~~  
18 ~~superseded in whole or in part by statute.~~

19 ~~(B) Subdivision (d)(3)(A) of this section does not~~  
20 ~~preclude any committee of the General Assembly from reviewing a rule or~~  
21 ~~regulation on its own motion or recommending that it be superseded in whole~~  
22 ~~or in part by statute.~~

23 ~~(4)(A)(i) If the Legislative Council considers all or any~~  
24 ~~portion of a rule or regulation to be beyond the procedural or substantive~~  
25 ~~authority delegated to the adopting agency, the Legislative Council may file~~  
26 ~~notice of that with the agency issuing the rule or regulation in question.~~

27 ~~(ii) The notice shall contain a concise statement~~  
28 ~~detailing the precise reasons that the Legislative Council considers the rule~~  
29 ~~or regulation, or portion thereof, to be beyond the procedural or substantive~~  
30 ~~authority delegated to the agency.~~

31 ~~(B) The Legislative Council shall maintain a permanent~~  
32 ~~register open to public inspection of all notices.~~

33 ~~(C)(i) Within thirty (30) calendar days after the filing~~  
34 ~~of an objection by the Legislative Council to a rule or regulation, the~~  
35 ~~issuing agency shall respond in writing to the Legislative Council.~~

36 ~~(ii) After receipt of the response, the Legislative~~

1 ~~Council may withdraw or modify its findings.~~

2 ~~(D) The failure of the Legislative Council to file a~~  
3 ~~notice regarding a rule or regulation is not an implied legislative~~  
4 ~~authorization of its procedural or substantive validity.~~

5 ~~(5) The Legislative Council may make nonbinding recommendations~~  
6 ~~to an agency that it adopt a rule or regulation.~~

7 ~~(e)(1)(A) Before any rule or regulation of any state agency may be~~  
8 ~~revised, promulgated, amended, or changed, a copy of the rule or amendment to~~  
9 ~~existing rules and a financial impact statement shall be filed with the~~  
10 ~~bureau at least thirty (30) days before the expiration of the period for~~  
11 ~~public comment on the rule pursuant to the Arkansas Administrative Procedure~~  
12 ~~Act, § 25-15-201 et seq., or other acts pertaining to the rule-making~~  
13 ~~authority of that agency.~~

14 ~~(B) The scope of the financial impact statement shall be~~  
15 ~~as provided under the Arkansas Administrative Procedure Act, § 25-15-201 et~~  
16 ~~seq., and shall include without limitation the estimated cost of complying~~  
17 ~~with the rule or regulation and the estimated cost for the agency to~~  
18 ~~implement the rule or regulation.~~

19 ~~(2) The bureau shall review the proposed revised or amended rule~~  
20 ~~or regulation and, if it is believed that the rule or regulation is contrary~~  
21 ~~to legislative intent, shall file a statement thereof with the Legislative~~  
22 ~~Council.~~

23 ~~(3) Filings under the Arkansas Administrative Procedure Act, §~~  
24 ~~25-15-201 et seq., and any comment on the proposed rule or regulation~~  
25 ~~prepared by the bureau shall be submitted to the Legislative Council at the~~  
26 ~~next regular meeting following its filing with the Legislative Council.~~

27 ~~(f)(1) In addition, before any rule or regulation of any state agency~~  
28 ~~may be revised, promulgated, amended, or changed, a copy of the rule or~~  
29 ~~amendment to existing rules shall be filed with the interim committees of the~~  
30 ~~General Assembly having responsibility for review of that agency under Acts~~  
31 ~~1977, No. 100.~~

32 ~~(2) The filing shall be made at least thirty (30) days before~~  
33 ~~the expiration of the period for public comment on the rule, pursuant to the~~  
34 ~~Arkansas Administrative Procedure Act, § 25-15-201 et seq., or other acts~~  
35 ~~pertaining to the rulemaking authority of the agency.~~

36 (b) As used in this section:

1           (1)(A) "Rule" means a state agency statement of general  
2 applicability and future effect that implements, interprets, or prescribes  
3 law or policy or describes the organization, procedure, or practice of a  
4 state agency and includes without limitation the amendment or repeal of a  
5 prior rule.

6           (B) "Rule" does not mean:

7           (i) A statement that concerns the internal  
8 management of a state agency and that does not affect the private rights or  
9 procedures available to the public;

10           (ii) A declaratory order or ruling issued under §  
11 25-15-206 or other provision of law applicable to the state agency issuing  
12 the declaratory order or ruling; or

13           (iii) Intraagency memoranda; and

14           (2)(A) "State agency" means an office, board, commission,  
15 department, council, bureau, or other agency of state government having  
16 authority by statute enacted by the General Assembly to promulgate or enforce  
17 rules.

18           (B) "State agency" does not include:

19           (i) The Arkansas State Game and Fish Commission, if  
20 the rule is not promulgated under authority of a statute enacted by the  
21 General Assembly;

22           (ii) The State Highway Commission and the Arkansas  
23 State Highway and Transportation Department, if the rule is not promulgated  
24 under authority of a statute enacted by the General Assembly; and

25           (iii) An institution of higher education.

26           (c)(1) A state agency shall file a proposed rule with the Legislative  
27 Council at least thirty (30) days before the expiration of the period for  
28 public comment on the rule under the Arkansas Administrative Procedure Act, §  
29 25-15-201 et seq., or other laws or policies pertaining to the rulemaking  
30 authority of that state agency.

31           (2) The Legislative Council shall assign proposed rules to the  
32 Administrative Rules and Regulations Subcommittee of the Legislative Council.

33           (3)(A)(i) The proposed rule shall be reviewed by the  
34 Administrative Rules and Regulations Subcommittee of the Legislative Council.

35           (ii) When reviewing a rule under subdivision  
36 (c)(3)(A)(i) of this section, the Administrative Rules and Regulations

1 Subcommittee of the Legislative Council shall allow members of the public a  
2 reasonable opportunity to comment on the proposed rule.

3 (B)(i) Upon conclusion of the review of the proposed rule  
4 by the Administrative Rules and Regulations Subcommittee of the Legislative  
5 Council, the proposed rule shall be considered approved unless a majority of  
6 a quorum present request that the Administrative Rules and Regulations  
7 Subcommittee of the Legislative Council vote on the issue of approving the  
8 proposed rule.

9 (ii) If the Administrative Rules and Regulations  
10 Subcommittee of the Legislative Council votes on the issue of approving the  
11 proposed rule, the proposed rule shall be approved unless a majority of a  
12 quorum present vote for the proposed rule to not be approved.

13 (4)(A) A proposed rule approved by the Administrative Rules and  
14 Regulations Subcommittee of the Legislative Council shall be considered  
15 approved by the Legislative Council unless a majority of a quorum present  
16 request that the Legislative Council vote on the issue of approving the  
17 proposed rule.

18 (B) If the Legislative Council votes on the issue of  
19 approving the proposed rule, the proposed rule shall be approved unless a  
20 majority of a quorum present vote for the proposed rule to not be approved.

21 (d)(1) A state agency shall file a proposed emergency rule with the  
22 Executive Subcommittee of the Legislative Council.

23 (2) A proposed emergency rule shall be considered approved by  
24 the Executive Subcommittee of the Legislative Council if:

25 (A)(i) The proposed emergency rule is reviewed and  
26 approved at a meeting of the Executive Subcommittee of the Legislative  
27 Council.

28 (ii) After the review of a proposed emergency rule  
29 at a meeting of the Executive Subcommittee of the Legislative Council, the  
30 proposed emergency rule shall be considered approved unless a majority of a  
31 quorum present request that the Executive Subcommittee of the Legislative  
32 Council vote on the issue of approving the proposed emergency rule.

33 (iii) If the Executive Subcommittee of the  
34 Legislative Council votes on the issue of approving the proposed emergency  
35 rule, the proposed emergency rule shall be approved unless a majority of a  
36 quorum present vote for the proposed emergency rule to not be approved; or

1 (B)(i) A majority or more of the members of the Executive  
2 Subcommittee of the Legislative Council approve the proposed emergency rule  
3 in writing.

4 (ii) An approval in writing of a proposed emergency  
5 rule under subdivision (d)(2)(B)(i) of this section shall not constitute a  
6 meeting under the Freedom of Information Act of 1967, § 25-19-101 et seq.

7 (3) A proposed emergency rule approved by the Executive  
8 Subcommittee of the Legislative Council shall be reported to the  
9 Administrative Rules and Regulations Subcommittee of the Legislative Council.

10 ~~(g)(1)(e)(1)~~ The Joint Budget Committee shall establish the  
11 Administrative Rule and Regulation Review Subcommittee.

12 (2)(A) The Administrative Rule and Regulation Review  
13 Subcommittee shall consist of twenty-two (22) members of the General  
14 Assembly.

15 (B)(i) Nine (9) members of the Administrative Rule and  
16 Regulation Review Subcommittee shall be appointed by the Senate Cochair of  
17 the Joint Budget Committee.

18 (ii) The Senate Cochair of the Joint Budget  
19 Committee shall designate one (1) of his or her appointees as Senate Cochair  
20 of the Administrative Rule and Regulation Review Subcommittee.

21 (C)(i) Nine (9) members of the Administrative Rule and  
22 Regulation Review Subcommittee shall be appointed by the House Cochair of the  
23 Joint Budget Committee.

24 (ii) The House Cochair of the Joint Budget Committee  
25 shall designate one (1) of his or her appointees as House Cochair of the  
26 Administrative Rule and Regulation Review Subcommittee.

27 (3) The cochairs and co-vice chairs of the Legislative Council  
28 shall be ex officio members of the Administrative Rule and Regulation Review  
29 Subcommittee.

30 (4)(A) The Administrative Rule and Regulation Review

31 *(ii) Appropriate measures shall include without*  
32 *limitation posting the following information on the agency's website:*

33 *(a) The final rule;*

34 *(b) Copies of all written comments submitted*  
35 *to the agency regarding the rule;*

36 *(c) A summary of all written and oral comments*

1 submitted to the agency regarding the rule and the agency's response to those  
2 comments;

3 (d) A summary of the financial impact of the  
4 rule; and

5 (e) The proposed effective date of the final

7 (2)(A)(i) However, an emergency rule may become effective  
8 immediately upon filing or at a stated time less than ~~thirty (30)~~ ten (10)  
9 days after filing if the agency finds that this effective date is necessary

11 (ii) The agency's finding, a brief statement of the

19 ~~(h)~~(i)(1) In a proceeding that questions the existence of imminent  
20 peril to the public health, safety, or welfare, a written finding by an  
21 agency that adopting an emergency rule was necessary to avoid the loss of  
22 federal funding or certification establishes a prima facie case of the  
23 existence of imminent peril to the public health, safety, or welfare.

24 (2) The burden of proof shifts to the challenger to rebut the  
25 existence of the condition by a preponderance of the evidence.
