9 AN ACT TO CREATE A COMPREHENSIVE STATEWIDE WORKFORCE
10 DEVELOPMENT SYSTEM; TO RENAME THE STATE BOARD OF
11 CAREER EDUCATION; TO COORDINATE VARIOUS WORKFORCE
12 DEVELOPMENT PROGRAMS; TO CREATE A BOARD TO OVERSEE
13 CAREER EDUCATION AND WORKFORCE DEVELOPMENT IN
14 ARKANSAS; TO CREATE AN OFFICE OF SKILLS DEVELOPMENT;
15 TO DECLARE AN EMERGENCY; AND FOR OTHER PURPOSES.

26 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:
27


28 SECTION 1. DO NOT CODIFY. Findings.

29 The General Assembly finds that:

30 (1) Occupational, technical, and industrial training provides
31 unique opportunities to improve the lives of Arkansans while advancing the
32 state's economic development;

33 (2) Businesses seeking to begin operations in Arkansas look to
34 the level of education and skills in the workforce as a key factor in making
35 investment decisions;

36 (3) Currently, Arkansas workforce education proceeds in a



1 variety of agencies, without coordination, often with significant
2 inefficiencies arising from overlapping and repeated programming and from
3 important programs being overlooked as presumably covered by another program;
4 and

5 (4) Bringing coordination of all state and federal career
6 education and workforce development programs will:

7 (A) Reduce duplication of programming;

8 (B) Ensure that every Arkansan who seeks occupational,
9 technical, and industrial training will find an appropriate education program
10 in this state;

11 (C) Bring consistency and efficiency to the state's career
12 education and workforce development efforts; and

13 (D) Alert industry to the commitment of the State of
14 Arkansas to economic development through career education and workforce
15 education.

16
17 SECTION 2. Arkansas Code § 11-10-706(f)(1)(A), concerning the proceeds
18 of the stabilization tax under the Department of Workforce Services Law, is
19 amended to read as follows:

20 (f)(1)(A) ~~Provided, however~~ However, the proceeds of the stabilization
21 tax in the amount of two and one-half hundredths of one percent (.025%) of
22 taxable wages collected during the period July 1, 2007, through June 30, ~~2015~~
23 2019, shall be deposited and credited to the Department of Workforce Services
24 Training Trust Fund, there to be used for worker training.

25
26 SECTION 3. Arkansas Code § 11-10-706(f)(2)(A), concerning the proceeds
27 of the stabilization tax under the Department of Workforce Services Law, is
28 amended to read as follows:

29 (2)(A) However, the proceeds of the stabilization tax in the
30 amount of two and one-half hundredths of one percent (.025%) of taxable wages
31 collected during the period July 1, 2007, through June 30, ~~2015~~ 2019, shall
32 be deposited and credited to the Department of Workforce Services
33 Unemployment Insurance Administration Fund, there to be used for operating
34 expenses of the unemployment insurance program necessary for the proper
35 administration of § 11-10-101 et seq., as determined by the Director of the
36 Department of Workforce Services.

2 SECTION 4. Arkansas Code Title 19, Chapter 6, Subchapter 8, is amended
3 to add an additional section to read as follows:

4 19-6-829. Skills Development Fund.

5 (a) There is created on the books of the Treasurer of State, the
6 Auditor of State, and the Chief Fiscal Officer of the State a special revenue
7 fund to be known as the "Skills Development Fund".

8 (b) The Skills Development Fund shall consist of:

9 (1) Moneys obtained from private grants or other sources that
10 are designated to be credited to the Skills Development Fund; and

11 (2) Any other revenues as may be authorized by law.

12 (c) The Skills Development Fund shall be used by the Department of
13 Career Education – Office of Skills Development as provided in § 25-30-109.

14
15 SECTION 5. Arkansas Code Title 25, Chapter 30, Subchapter 1, is

 17 industry and business associations:

 21 (D) One (1) member to represent the healthcare industry;
 22 (E) One (1) member to represent the information technology
 23 industry;
 24 (F) One (1) member to represent the manufacturing
 25 industry;
 26 (G) One (1) member to represent the financial services
 27 industry;
 28 (H) One (1) member to represent the hospitality industry;
 29 (I) One (1) member to represent the transportation-

35 disseminate information on current and projected employment opportunities in
36 this state and other appropriate information relating to labor market

1 dynamics as determined by the office.

2 (B) The office shall make the information contained in the
3 labor market information system available on the department's website.

4 (c) On or before October 1 of each year, the office shall submit a
5 report to the Governor and the cochairs of the Legislative Council providing
6 an account of the activities and expenditures of the office during the
7 preceding calendar year.

8 (d) The office shall consult with the Arkansas Economic Development
9 Commission in reviewing applications for workforce training grants under this
10 section.

12 SECTION 6. Arkansas Code § 25-30-202 is amended to read as follows:
13 25-30-202. Scope of authority.

14 (a) All authorities and responsibilities defined in § 20-79-201 et
15 seq. shall be administered by the Arkansas Rehabilitation Services under the
16 direction of the ~~State Board of Workforce Education and Career Opportunities~~
17 Career Education and Workforce Development Board, except those transferred to
18 the Division of State Services for the Blind of the Department of Human
19 Services by § 25-10-201 et seq.

20 (b) Any and all statutory authority, powers, duties, functions,
21 records, authorized positions, property, unexpended balances of
22 appropriations, allocations, or other funds transferred from the Division of
23 Rehabilitation Services to the Department of Human Services by Acts 1985, No.
24 348, are hereby transferred to the Arkansas Rehabilitation Services of the

27 *SECTION 7. DO NOT CODIFY. (a) The Governor shall call the first*
28 meeting of the Career Education and Workforce Development Board within ninety
29 (90) days after the appointment of the industry members.

30 (b) The Governor shall appoint a voting member as chair of the board
31 to serve a one-year term.

32
33 SECTION 8. EMERGENCY CLAUSE. It is found and determined by the
34 General Assembly of the State of Arkansas that Arkansas workforce education
35 operates within a variety of agencies without coordination, often with
36 significant inefficiencies arising from overlapping and repeated programming;

1 that this act will bring workforce education programs together under a single
2 umbrella agency; and that this act is immediately necessary because the
3 effectiveness of this act is essential to the operation of the programs for
4 which appropriations will be provided, and that in the event of an extension
5 of the legislative session, the delay in the effective date of this act could
6 work irreparable harm upon the proper administration and provision of
7 essential governmental programs. Therefore, an emergency is declared to
8 exist, and this act being immediately necessary for the preservation of the
9 public peace, health, and safety shall become effective on:

10 (1) The date of its approval by the Governor;

11 (2) If the bill is neither approved nor vetoed by the Governor,
12 the expiration of the period of time during which the Governor may veto the
13 bill; or

14 (3) If the bill is vetoed by the Governor and the veto is
15 overridden, the date the last house overrides the veto.
