8 AN ACT TO ESTABLISH THE NINETIETH SESSION PROJECTS
9 ACCOUNT WITHIN THE GENERAL IMPROVEMENT FUND; TO
10 DEFINE THE MONIES TO BE AVAILABLE IN SUCH ACCOUNT;
11 AND TO DEFINE THE PURPOSES FOR WHICH MONIES MAY BE
12 MADE AVAILABLE FROM THE GENERAL IMPROVEMENT FUND SO
13 THAT ADDITIONAL FUNDS CAN BE MADE AVAILABLE FOR THE
14 STATE BUDGET; AND FOR OTHER PURPOSES.

17 **Subtitle**

18 THE DISTRIBUTION OF THE NINETIETH SESSION
19 PROJECTS ACCOUNT OF THE GENERAL
20 IMPROVEMENT FUND TO PROVIDE ADDITIONAL
21 FUNDS FOR THE STATE BUDGET.
22

23
24 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:
25

26 SECTION 1. This Act may be cited as the "General Improvement
27 Distribution Act of 2015".
28

29 SECTION 2. There is hereby created and established on the books of the
30 Chief Fiscal Officer of the State, the State Treasurer and the State Auditor,
31 the "90th Session Projects Account" within the "General Improvement Fund",
32 into which shall be transferred and credited the respective monies as
33 hereinafter provided in this Act, to be used for providing financing, in the
34 manner set forth herein, for the various projects and purposes enumerated in
35 this Act to be financed from said account.

36 Immediately upon the effective date of this Act, or as soon thereafter



1 as is practical, the State Treasurer shall transfer and credit to the "90th
2 Session Projects Account" of the "General Improvement Fund", upon
3 certification of the amounts thereof by the Chief Fiscal Officer of the
4 State, the following:

5 (a) all unobligated and unallocated monies remaining in the "General
6 Improvement Fund" on June 30, 2015 which are not required to finance projects
7 to be financed therefrom pursuant to appropriations enacted by the 89th
8 General Assembly, or which have not been reappropriated or reallocated for
9 financing from the "General Improvement Fund" by the 90th General Assembly;

10 (b)(1) any unobligated or unallocated funds remaining on July 2, 2015,
11 including all General Revenue Funds recovered from remaining fund balances in
12 the "General Revenue Allotment Reserve Fund" from monies accruing thereto
13 during the 2013-2015 fiscal biennium which are not required to finance
14 enactments of the 90th General Assembly that do not expire on June 30, 2015,

15 (2) All General Revenue Funds recovered from remaining fund balances in
16 the "General Revenue Allotment Reserve Fund" from monies accruing thereto
17 during the 2015-2016 fiscal year which are not required to finance enactments
18 of the 90th General Assembly that do not expire on June 30, 2016.

19 (c) interest earned on State Treasury fund balances as provided in
20 this subsection. For the period commencing on July 1, 2015, and ending June
21 30, 2017, the State Treasurer shall, after complying with provisions of

22 (1) Arkansas Code 27-70-204 for distributing interest income
23 earned from investment of average daily balances of the "State Highway and
24 Transportation Department Fund",

25 (2) Arkansas Code 15-41-110 for distributing interest earned from
26 investment of average daily balances of the "Game Protection Fund", and

27 (3) Arkansas Code 20-78-504 for the next one hundred thousand
28 dollars (\$100,000) of interest income received each fiscal year by the State
29 Treasurer for the "Arkansas Child Care Facilities Loan Guarantee Trust Fund",
30 credit to the "Budget Stabilization Trust Fund" or its successor fund, fifty
31 percent (50%) of the interest income received and credited to the "Securities
32 Reserve Fund", and credit to the "90th Session Projects Account" fifty
33 percent (50%) of the interest income received and credited to the "Securities
34 Reserve Fund" as certified by the Chief Fiscal Officer of the State, to
35 provide financing to the "90th Session Projects Account", until there has
36 been credited an amount, which when added to the other funds available for

1 such purposes will finance each of the projects or purposes hereinafter
2 enumerated; and

3 (d) Those special revenues credited to the General Improvement Fund
4 from estate taxes as set out in Arkansas Code 19-6-301(171).

5 (e) Any available balance remaining in the 89th Session Projects
6 Account of the General Improvement Fund from funds set aside for subsections
7 (a)(2) and (a)(3) of Section 3 of Act 1518 and Act 1519 of 2013 and any funds
8 made available for a Rainy Day Set-Aside as authorized in subsection (a)(ii)
9 of Section 10 of SB689 and HB1548 of 2015 to Amend the Revenue Stabilization
10 Law are to be made available and distributed as authorized in Section 3
11 subsection (a)(11) herein; and

12 (f) Any funds provided by the Arkansas Attorney General from the
13 Attorney General Consumer Education and Enforcement Account, received by the
14 State of Arkansas through Settlement agreements or as designated by court
15 order.

16
17 SECTION 3. Of those moneys accruing to the 90th Session Projects
18 Account of the General Improvement Fund as set out in Section 2 of this Act,
19 the State Treasurer shall first set-aside two hundred three million, three
20 hundred ninety-eight thousand, ten dollars (\$203,398,010), and any previous
21 set-aside remaining balance as made available by subsection (e) of Section 2
22 of this Act for the set-asides enumerated in subsection (a) of Section 3 of
23 this Act. Such funds set-aside as enumerated in Section 3 subsections (a)(1)
24 through (a)(10) shall be fully funded by June 30, 2017. The Shared Mandatory
25 Obligations Set-Asides enumerated in Section 3 subsections (a)(1) through
26 (a)(10) shall be distributed from time to time in amounts as determined by
27 the Chief Fiscal Officer of the State. If it is determined by the Chief
28 Fiscal Officer of the State that funding made available for Section 3
29 subsection (a)(4) and (a)(7) through (a)(10) is not required at the full
30 amount authorized by this Act, then any portion of those funds may be
31 transferred to the Rainy Day Set-Aside established by Section 3 subsection
32 (a)(11) of this Act. The Chief Fiscal Officer of the State shall notify the
33 Arkansas Legislative Council or the Joint Budget Committee of the release of
34 funds for projects enumerated in Section 3 subsections (a), (b)(3) and (d)
35 and any funds transferred to Section 3 subsection (a)(11) at the same time
36 that the Department of Finance and Administration is notified.

1 SHARED MANDATORY OBLIGATIONS SET-ASIDE:

2 (a) To establish the "Shared Mandatory Obligations Set-Aside" within
3 the 90th Session Projects Account of the General Improvement Fund to be
4 distributed as enumerated in subsections (a)(1) through (a)(10).

5 (1) HB1338 Department of Correction, for lease payments associated with
6 debt service on a 948-bed institution at Malvern, a 400-bed addition at the
7 Grimes Unit at Newport, and 862-bed Special Needs Unit and addition to the
8 Ouachita River Unit at Malvern, \$13,000,000;

10 (2) HB1328 Department of Human Services - Division of Medical Services,
11 for grant payments of the Arkansas Medicaid Program, \$90,000,000;

13 (3) SB284 Department of Education - Division of Public School Academic
14 Facilities and Transportation for transfer to the Educational Facilities
15 Partnership Fund Account for use in programs of the Division of Public School
16 Academic Facilities and Transportation, \$40,000,000;

13 RAINY DAY SET-ASIDE:

14 (11) To establish a "Rainy Day Set-Aside" within the 90th Session
15 Projects Account of the General Improvement Fund for transfers, from time to
16 time, to any fund or fund account authorized by the General Assembly, or for
17 transfers, from time to time, for projects in the Executive Discretionary
18 Division authorized in subsection (d) of Section 3 of this Act, upon approval
19 by the Arkansas Legislative Council or Joint Budget Committee.

20
21 (b)(1)Then the Treasurer of State shall distribute twenty million
22 dollars (\$20,000,000) to the Legislative Division as set out in subsection
23 (c) of this Act, and twenty million dollars (\$20,000,000) to the Executive
24 Discretionary Division as set out in subsection (d) of this Act. Funds made
25 available to the Executive Discretionary Division may be used for any project
26 or portion thereof enumerated within the Executive Discretionary Division but
27 not to exceed the amount set out in subsection (d) for the project. The Chief
28 Fiscal Officer of the State shall notify the Arkansas Legislative Council or
29 Joint Budget Committee of the Governor's released funds for projects at the
30 same time that the Department of Finance and Administration is notified. The
31 Legislative Division funds shall be used to provide funds to each project
32 enumerated in subsection (c) of this section in proportion that each
33 project's allocation bears to the total of the allocations of all projects
34 enumerated in subsection (c).

35 (2) Additional funds that may be received by the General Improvement
36 Fund after the projects in subsection (d) have been fully funded shall first

1 be transferred in an amount not to exceed fifty million dollars (\$50,000,000)
2 to the Rainy Day Set-Aside authorized in Section 3 subsection (a)(11) herein.

3 (3) Then any additional funds that may be received by the General
4 Improvement Fund shall be transferred to the "Economic Development Set-Aside"
5 established herein for the 90th Session Projects Account of the General
6 Improvement Fund in an amount not to exceed thirty million dollars
7 (\$30,000,000) for transfers from time to time for the appropriations
8 authorized in Section 1 subsections (A) through (E) of SB276 of 2015. The
9 Chief Fiscal Officer of the State shall notify the Arkansas Legislative
10 Council or Joint Budget Committee of the Governor's released funds for
11 projects at the same time that the Department of Finance and Administration
12 is notified.

13 (4) Then any additional funds shall remain in the General Improvement
14 Fund for such purpose as may be enacted by law, but shall not be a part of
15 the 90th Session Projects Account.

20 SECTION 4. NOT TO BE INCORPORATED INTO THE ARKANSAS CODE NOR PUBLISHED

21 SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. EXECUTIVE DIVISION FUNDING

22 TRANSFER. Immediately upon the effective date of this act, the Chief Fiscal

23 Officer of the State shall transfer on his or her books and those of the

24 State Treasurer and the Auditor of the State any remaining unobligated funds

25 from the Executive Discretionary Division of the 89th Session Projects

26 Account of the General Improvement Fund in subsection (d) of Section 3 of Act

27 1518 and Act 1519 of 2013 to provide funding for the 90th Session Projects

28 Account of the General Improvement Fund for the Executive Discretionary

29 Division, but not to exceed the amount as set out in subsection (d) of

30 Section 3 herein.

31

32 SECTION 5. NOT TO BE INCORPORATED INTO THE ARKANSAS CODE NOR PUBLISHED

33 SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. SENATE AND HOUSE BILL

34 REFERENCES. All Senate and House bills referenced in this Act are effective

35 as enacted by the 90th General Assembly in the 2015 Regular Session.

36

1 SECTION 6. DISBURSEMENT OF FUNDS. (a) Expenditure of the funds
2 authorized by the Ninetieth General Assembly in either the regular, fiscal or
3 extraordinary session from the 90th Session Projects Account shall be made
4 only upon documentation to the Chief Fiscal Officer of the State, in such
5 form as deemed necessary, that all criteria or pre-conditions established in
6 the appropriation act have been met or in the case of state agencies, and
7 that a Method of Finance has been filed with the Office of Accounting in the
8 Department of Finance and Administration, if required.

9 (b) Any matching funds as may be provided in law shall be certified to
10 the Chief Fiscal Officer of the State prior to the commencement of the
11 project.

12 (c) Any recipient of the funds appropriated herein:

13 (1) may be required to file a compliance audit and

14 (2) is also subject to an audit by the Division of Legislative
15 Audit in order to determine that the use of the funds was in compliance with
16 the intent and appropriated purposes of the General Assembly.

17
18 SECTION 7. (a) Any enactment of the 90th General Assembly in either
19 regular, fiscal or extraordinary session appropriating, transferring or
20 allocating funds to be payable from the "General Improvement Fund", for which
21 a specific allocation of funds is specifically authorized in this Act, shall
22 be deemed to be payable from the "90th Session Projects Account" within the
23 "General Improvement Fund" unless a specific intent is otherwise provided by
24 law.

25 (b) Any enactment of the 90th General Assembly, meeting in either
26 Regular, Fiscal or Extraordinary Session, appropriating, allocating or
27 transferring funds payable from the General Improvement Fund which is not
28 enumerated in this Act shall not be financed from monies accruing to the 90th
29 Session Projects Account, unless otherwise provided by law and funds are
30 specifically transferred from the 89th Session Projects Account to the 90th
31 Session Projects Account to fund the appropriation for the project.

32 (c) Monies reappropriated by the 90th General Assembly for projects
33 for which appropriations were made by the 89th General Assembly, which are
34 not enumerated in this Act and which are made payable from the "General
35 Improvement Fund", shall be payable from the "89th Session Projects Account"
36 of the "General Improvement Fund" and allowances shall be made therefore in

1 arriving at the uncommitted and unobligated balance of monies in the "General
2 Improvement Fund" before making transfers therefrom to the "90th Session
3 Projects Account", as authorized by this Act.

4
5 SECTION 8. Distribution of funds for constructing and equipping the
6 radiation therapy institutes specified herein, shall be contingent upon the
7 provision of matching funds, including those monies previously raised but not
8 previously used to match state funds, on a dollar by dollar basis on behalf
9 of each such radiation therapy institute.

10
11 SECTION 9. DEPARTMENT OF FINANCE AND ADMINISTRATION DISBURSING
12 OFFICER. The Chief Fiscal Officer of the State may distribute funds to the
13 projects in the Legislative Division enumerated under Department of Finance
14 and Administration - Disbursing Officer on a basis other than monthly after
15 prior review of the proposed calendar for disbursements by the Legislative
16 Council.

17
18 SECTION 10. This Act shall not be incorporated into the Arkansas Code
19 nor published separately as Special, Local and Temporary law. However,
20 individual sections in this Act may amend Arkansas Code if specifically
21 stated to do so.

22
23 SECTION 11. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE
24 ARKANSAS CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW.
25 DUPLICATE ACTS If HB1547 and SB691 of 2015 of the 2015 Regular Session of the
26 90th General Assembly are both enacted and adopted by the 90th General
27 Assembly in identical form, then the last Act passed or latest expression
28 shall supersede the other.

29
30 SECTION 12. EMERGENCY CLAUSE. It is found and determined by the
31 General Assembly that it has considered and enacted appropriations for
32 construction projects and other programs to be financed from the accumulated
33 balances and reserve funds available in the State Treasury; that the total of
34 the enacted appropriations exceed the estimated available funding available
35 for such projects and that the immediate passage of this Act is necessary to
36 establish a method of providing for the orderly financing and a system of

1 priority for the financing of such projects. Therefore, an emergency is
2 declared to exist and this act being immediately necessary for the
3 preservation of the public peace, health and safety shall become effective on
4 July 1, 2015.
