- 1 Strike subdivision (48) of section 1 in its entirety and insert the
- 2 following in lieu thereof:
- 3 "(48) "Social equity applicant" means a person that has applied for a
- 4 license for a cannabis establishment, where such applicant is at least
- 5 sixty-five per cent owned and controlled by an individual or
- 6 individuals, or such applicant is an individual, who:
- 7 (A) Had an average household income of less than three hundred per
- 8 cent of the state median household income over the three tax years
- 9 immediately preceding such individual's application; and
- 10 (B) (i) Was a resident of a disproportionately impacted area for not
- 11 less than five of the ten years immediately preceding the date of such
- 12 application;

(ii) Was a resident of a disproportionately impacted area for not less
than nine years prior to attaining the age of eighteen;

- 15 (iii) Was, as an adult or as a juvenile, arrested for or convicted of, the 16 sale, possession, use, manufacture or cultivation of cannabis; or
- 17 (iv) Has a parent, spouse or child who was, as an adult or as a 18 juvenile, arrested for or convicted of the sale, possession, use, 19 manufacture or cultivation of cannabis;"
- 20 Strike subsection (d) of section 26 in its entirety and insert the 21 following in lieu thereof:
- "(d) For purposes of this section, "social equity partner" means a person that is at least sixty-five per cent owned and controlled by an individual or individuals, or such applicant is an individual, who:
- 25 (1) Had an average household income of less than three hundred per 26 cent of the state median household income over the three tax years 27 immediately preceding such individual's application; and
- 28 (2) (A) Was a resident of a disproportionately impacted area for not 29 less than five of the ten years immediately preceding the date of such 30 application;
- 31 (B) Was a resident of a disproportionately impacted area for not less 32 than nine years prior to attaining the age of eighteen;
- 33 (C) Was, as an adult or as a juvenile, arrested for or convicted of, the 34 sale, possession, use, manufacture or cultivation of cannabis; or
- 35 (D) Has a parent, spouse or child who was, as an adult or as a 36 juvenile, arrested for or convicted of the sale, possession, use, 37 manufacture or cultivation of cannabis."
