AN ACT

1 RELATING TO CONCEALED WEAPONS; AMENDING SECTION 18-3302, IDAHO CODE, TO
2 PROVIDE LEGISLATIVE INTENT, TO DEFINE TERMS AND TO REVISE PROVISIONS
3 RELATING TO POLICIES AND PROCEDURES IN THE ISSUANCE OF A LICENSE TO
4 CARRY CONCEALED WEAPONS; AMENDING SECTION 18-3302I, IDAHO CODE, TO
5 REMOVE A DEFINITION; AMENDING SECTION 18-3302K, IDAHO CODE, TO REVISE
6 PROVISIONS RELATING TO POLICIES AND PROCEDURES IN THE ISSUANCE OF AN
7 ENHANCED LICENSE TO CARRY CONCEALED WEAPONS; AMENDING SECTION 18-3316,
8 IDAHO CODE, TO REMOVE A DEFINITION; AMENDING SECTION 31-870, IDAHO
9 CODE, TO PROVIDE THAT A BOARD OF COUNTY COMMISSIONERS SHALL NOT IMPOSE
10 OR COLLECT A FEE FOR LICENSES TO CARRY CONCEALED WEAPONS; AND AMENDING
11 SECTION 9-340B, IDAHO CODE, TO PROVIDE A CORRECT CODE REFERENCE.

13 Be It Enacted by the Legislature of the State of Idaho:

14 SECTION 1. That Section 18-3302, Idaho Code, be, and the same is hereby
15 amended to read as follows:

16 18-3302. ~~ISSUANCE OF LICENSES TO CARRY CONCEALED WEAPONS.~~ (1) The leg-
17 islature hereby finds that the people of Idaho have reserved for themselves
18 the right to keep and bear arms while granting the legislature the authority
19 to regulate the carrying of weapons concealed. The provisions of this chap-
20 ter regulating the carrying of weapons shall be strictly construed so as to
21 give maximum scope to the rights retained by the people.

22 (2) As used in this chapter:

23 (a) "Concealed weapon" means any deadly weapon carried on or about the
24 person in a manner not discernible by ordinary observation;

25 (b) "Deadly weapon" means:

26 (i) Any dirk, dirk knife, bowie knife, dagger or firearm;

27 (ii) Any other weapon, device, instrument, material or substance
28 that is designed and manufactured to be readily capable of causing
29 death or serious bodily injury; or

30 (iii) Any other weapon, device, instrument, material or substance
31 that is intended by the person to be readily capable of causing
32 death or serious bodily injury.

33 (c) The term "deadly weapon" does not include:

34 (i) Any knife, cleaver or other instrument that is intended by the
35 person to be used in the processing, preparation or eating of food;

36 (ii) Any knife with a blade four (4) inches or less; or

37 (iii) Any taser, stun-gun, pepper spray or mace;

38 (d) "Firearm" means any weapon that will, is designed to or may readily
39 be converted to expel a projectile by the action of an explosive;

40 (e) "Loaded" means:

41 (i) In the case of a firearm capable of using fixed ammunition,
42 that live ammunition is present in:

- 1 1. The chamber or chambers of the firearm;
- 2 2. Any internal magazine of the firearm; or
- 3 3. A detachable magazine inserted in the firearm;

4 (ii) In the case of a firearm that is not capable of using fixed
5 ammunition that the firearm contains:

- 6 1. A propellant charge; and
- 7 2. A priming cap or primer cap.

8 (3) No person shall carry concealed weapons on or about his person with-
9 out a license to carry concealed weapons, except:

- 10 (a) In the person's place of abode or fixed place of business;
- 11 (b) On property in which the person has any ownership or leasehold in-
12 terest;
- 13 (c) On private property where the person has permission to carry con-
14 cealed weapons from any person with an ownership or leasehold interest;
15 or
- 16 (d) Outside the limits of or confines of any city.

17 (4) Subsection (3) of this section shall not apply to restrict or pro-
18 hibit the carrying or possession of:

- 19 (a) Any deadly weapon located in plain view;
- 20 (b) Any lawfully possessed shotgun or rifle;
- 21 (c) A firearm that is not loaded and is concealed in a motor vehicle;
- 22 (d) A firearm that is not loaded and is secured in a case; and
- 23 (e) A firearm that is disassembled or permanently altered such that it
24 is not readily operable.

25 (5) The requirement to secure a license to carry concealed weapons un-
26 der this section shall not apply to the following persons:

- 27 (a) Officers of the United States authorized to carry weapons under
28 federal law while in the performance of official duties;
- 29 (b) Members of the armed forces of the United States or of the national
30 guard when in performance of official duties;
- 31 (c) Criminal investigators of the attorney general's office, crimi-
32 nal investigators of a prosecuting attorney's office, prosecutors and
33 their deputies;
- 34 (d) Any peace officer as defined in section 19-5101(d), Idaho Code, in
35 good standing;
- 36 (e) Any person who has physical possession of his valid license or per-
37 mit authorizing him to carry concealed weapons from another state; and
- 38 (f) Any person who has physical possession of a valid license or permit
39 from a local law enforcement agency or court of the United States autho-
40 riizing him to carry concealed weapons.

41 (6) The sheriff of a county, on behalf of the state of Idaho, shall,
42 within ninety (90) days after the filing of an license application by any
43 person who is not disqualified as provided herein from possessing or re-
44 ceiving a firearm under state or federal law, issue a license to the person
45 to carry a ~~weapon~~ concealed weapons on his person within this state. ~~For li-~~
46 enses issued before July 1, 2006, a license shall be valid for four (4) years
47 from the date of issue. For licenses issued on or after July 1, 2006, a Such
48 license shall be valid for five (5) years from the date of issue issuance.
49 The citizen's constitutional right to bear arms shall not be denied to him,
50 unless one (1) of the following applies. He:

- 1 ~~(a) Is ineligible to own, possess or receive a firearm under the provi-~~
 2 ~~sions of state or federal law;~~
 3 ~~(b) Is formally charged with a crime punishable by imprisonment for a~~
 4 ~~term exceeding one (1) year;~~
 5 ~~(c) Has been adjudicated guilty in any court of a crime punishable by~~

 7 ~~(d) Is a fugitive from justice;~~
 8 ~~(e) Is an unlawful user of, or addicted to, marijuana or any depres-~~
 9 ~~sant, stimulant or narcotic drug, or any other controlled substance as~~
 10 ~~defined in 21 U.S.C. 802;~~
 11 ~~(f) Is currently suffering or has been adjudicated as follows, based on~~
 12 ~~substantial evidence:~~
 13 ~~(i) Lacking mental capacity as defined in section 18-210, Idaho~~
 14 ~~Code;~~
 15 ~~(ii) Mentally ill as defined in section 66-317, Idaho Code;~~
 16 ~~(iii) Gravely disabled as defined in section 66-317, Idaho Code;~~
 17 ~~or~~
 18 ~~(iv) An incapacitated person as defined in section 15-5-101(a),~~
 19 ~~Idaho Code.~~
 20 ~~(g) Is or has been discharged from the armed forces under dishonorable~~
 21 ~~conditions;~~
 22 ~~(h) Is or has been adjudicated guilty of or received a withheld judgment~~
 23 ~~or suspended sentence for one (1) or more crimes of violence constitut-~~
 24 ~~ing a misdemeanor, unless three (3) years have elapsed since disposi-~~
 25 ~~tion or pardon has occurred prior to the date on which the application is~~
 26 ~~submitted;~~
 27 ~~(i) Has had entry of a withheld judgment for a criminal offense which~~
 28 ~~would disqualify him from obtaining a concealed weapon license;~~
 29 ~~(j) Is an alien illegally in the United States;~~
 30 ~~(k) Is a person who having been a citizen of the United States has re-~~
 31 ~~nounced his or her citizenship;~~
 32 ~~(l) Is under twenty-one (21) years of age;~~
 33 ~~(m) Is free on bond or personal recognizance pending trial, appeal or~~
 34 ~~sentencing for a crime which would disqualify him from obtaining a con-~~
 35 ~~cealed weapon license; or~~
 36 ~~(n) Is subject to a protection order issued under chapter 63, title~~
 37 ~~39, Idaho Code, that restrains the person from harassing, stalking or~~
 38 ~~threatening an intimate partner of the person or child of the intimate~~
 39 ~~partner or person, or engaging in other conduct that would place an~~
 40 ~~intimate partner in reasonable fear of bodily injury to the partner or~~
 41 ~~child.~~

42 (7) The sheriff shall make license applications readily available at
 43 the office of the sheriff or at other public offices in his or her jurisdic-
 44 tion. The license application shall be in a form to be prescribed by the di-
 45 rector of the Idaho state police, and shall meet the following requirements:

- 46 (a) The license application shall ask require the applicant's name,
 47 address, description and, signature of the licensee, date of birth,
 48 place of birth, social security number, military status, citizenship
 49 and the driver's license number or state identification card number of
 50 the licensee if used for identification in applying for the license.

1 Provided however, that if the applicant is not a United States citizen
 2 and is legally in the United States, the application shall also require
 3 any alien or admission number issued to the applicant by United States
 4 immigration and customs enforcement or any successor agency;

5 (b) The license application may ask the applicant to disclose his so-
 6 cial security number but shall indicate that ~~provision~~ disclosure of
 7 the applicant's social security number is optional-; and

8 (c) The license application shall contain a warning that substantially
 9 reads as follows:

10 CAUTION: Federal law and state law on the possession of weapons and
 11 firearms differ. If you are prohibited by federal law from possess-
 12 ing a weapon or a firearm, you may be prosecuted in federal court. A
 13 state permit is not a defense to a federal prosecution.

14 (8) The sheriff may require the applicant to demonstrate familiarity
 15 with a firearm and shall accept any one (1) of the following as evidence of
 16 the applicant's familiarity with a firearm:

17 (a) Completion of any hunter education or hunter safety course approved
 18 by the department of fish and game or a similar agency of another state;

19 (b) Completion of any national rifle association firearms safety or
 20 training course or any national rifle association hunter education
 21 course;

22 (c) Completion of any firearms safety or training course or class
 23 available to the general public offered by a law enforcement agency,
 24 community college, college, university or private or public institu-
 25 tion or organization or firearms training school, utilizing instruc-
 26 tors certified by the national rifle association or the Idaho state
 27 police;

28 (d) Completion of any law enforcement firearms safety or training
 29 course or class offered for security guards, investigators, special
 30 deputies, or offered for any division or subdivision of a law enforce-
 31 ment agency or security enforcement agency;

32 (e) Evidence of equivalent experience with a firearm through partici-
 33 ipation in organized shooting competition or military service;

34 (f) Is currently licensed to carry concealed weapons pursuant to this
 35 section, unless the license has been revoked for cause;

36 (g) Completion of any firearms training or safety course or class con-
 37 ducted by a state certified or national rifle association certified
 38 firearms instructor; or

39 (h) Other training that the sheriff deems appropriate.

40 (9) The sheriff shall require a~~Any person who is applying for original~~
 41 issuance of a license to carry concealed weapons shall be required to sub-
 42 mit his fingerprints in addition to the other information required in this
 43 subsection with the completed license application. Within five (5) days af-
 44 ter the filing of an application, the sheriff shall forward the applicant's
 45 completed license application and fingerprints to the Idaho state police ~~for~~
 46 a records check of state and national files. The Idaho state police shall
 47 conduct a national fingerprint-based records check, an inquiry through the
 48 national instant criminal background check system and a check of any appli-

1 cable state database, including a check for any mental health records for
 2 conditions or commitments that would disqualify a person from possessing a
 3 firearm under state or federal law, and return the results to the sheriff
 4 within ~~seventy-five~~ sixty (7560) days. If the applicant is not a United
 5 States citizen, an immigration alien query shall also be conducted through
 6 United States immigration and customs enforcement or any successor agency.
 7 The sheriff shall not issue a license before receiving the results of the
 8 records check and must deny a license if the applicant is disqualified under
 9 any of the criteria listed in paragraphs (a) through (n) subsection (10) of
 10 this subsection. In the event the sheriff has collected a fee to cover the
 11 cost of processing fingerprints for the records check, the sheriff shall
 12 provide the applicant with a copy of the results of the records check upon
 13 request of the applicant. The sheriff may deny a license to carry concealed
 14 weapons to an alien if background information is not attainable or verifi-
 15 able.

16 (10) A license to carry concealed weapons shall not be issued to any per-
 17 son who:

18 (a) Is under twenty-one (21) years of age, except as otherwise provided
 19 in this section;

20 (b) Is formally charged with a crime punishable by imprisonment for a
 21 term exceeding one (1) year;

22 (c) Has been adjudicated guilty in any court of a crime punishable by
 23 imprisonment for a term exceeding one (1) year;

24 (d) Is a fugitive from justice;

25 (e) Is an unlawful user of marijuana or any depressant, stimulant or
 26 narcotic drug, or any controlled substance as defined in 21 U.S.C. sec-
 27 tion 802;

28 (f) Is currently suffering from or has been adjudicated as having suf-
 29 fered from any of the following conditions, based on substantial evi-
 30 dence:

31 (i) Lacking mental capacity as defined in section 18-210, Idaho
 32 Code;

33 (ii) Mentally ill as defined in section 66-317, Idaho Code;

34 (iii) Gravely disabled as defined in section 66-317, Idaho Code;

35 or

36 (iv) An incapacitated person as defined in section 15-5-101,
 37 Idaho Code.

38 (g) Is or has been discharged from the armed forces under dishonorable
 39 conditions;

40 (h) Is or has been adjudicated guilty of or received a withheld judgment
 41 or suspended sentence for a crime of violence constituting a misde-
 42 meanor or a crime that would disqualify him from obtaining a concealed
 43 weapons license, unless three (3) years have elapsed since entry of
 44 judgment or successful completion of probation prior to the date on
 45 which the application is submitted;

46 (i) Is an alien illegally in the United States;

47 (j) Is free on bond or personal recognizance pending trial, appeal or
 48 sentencing for a crime which would disqualify him from obtaining a con-
 49 cealed weapons license;

1 (k) Is subject to a protection order issued under chapter 63, title
 2 39, Idaho Code, that restrains the person from harassing, stalking or
 3 threatening an intimate partner of the person or child of the intimate
 4 partner or person, or engaging in other conduct that would place an in-
 5 timate partner in reasonable fear of bodily injury to partner or child;
 6 or

7 (l) Is for any other reason ineligible to own, possess or receive
 8 a firearm under the provisions of Idaho or federal law. In making a
 9 determination in relation to an applicant's eligibility under this sub-
 10 section, the sheriff shall not consider:

11 (i) A conviction, guilty plea or adjudication that has been nul-
 12 lified by expungement, pardon, setting aside or other comparable
 13 procedure by the jurisdiction where the conviction, guilty plea
 14 or adjudication occurred or in respect of which conviction, guilty
 15 plea or adjudication the applicant's civil right to bear arms ei-
 16 ther specifically or in combination with other civil rights has
 17 been restored under operation of law or legal process; or

18 (ii) An adjudication of mental defect, incapacity of illness or an
 19 involuntary commitment to a mental institution if the applicant's
 20 civil right to bear arms has been restored under operation of law
 21 or legal process.

22 (11) The A license will to carry concealed weapons shall be in a form
 23 substantially similar to that of the Idaho driver's license. It will and
 24 shall meet the following specifications:

25 (a) The license shall bear provide the signature, licensee's name, ad-
 26 dress, date of birth, picture of the licensee, expiration date and the
 27 driver's license number or state identification card number of the li-
 28 icensee if used for identification in applying for the license;

29 (b) The license shall bear the licensee's signature and picture; and

30 (c) The license shall provide the date of issuance and the date on which
 31 the license expires.

32 (12) Upon issuing a license under the provisions of this section, the
 33 sheriff will shall notify the Idaho state police within three (3) business
 34 days on a form or in a manner prescribed by the Idaho state police. Informa-
 35 tion relating to an applicant or licensee received or maintained pursuant to
 36 this section by the sheriff or Idaho state police is confidential and exempt
 37 from disclosure under section 9-33840B, Idaho Code.

38 (213) The fee for original issuance of a license shall be twenty dol-
 39 lars (\$20.00) paid to the sheriff for the purpose of enforcing the provisions
 40 of this chapter, which the sheriff shall retain for the purpose of perform-
 41 ing the duties required in this section. The sheriff may collect the actual
 42 cost of any additional fees necessary to cover the cost of processing finger-
 43 prints lawfully required by any state or federal agency or department, and
 44 the actual cost of materials for the license lawfully required by any state
 45 agency or department, which costs shall be paid to the state. The sheriff
 46 shall provide the applicant with a copy of the results of the fingerprints
 47 based records check upon request of the applicant.

48 (314) The fee for renewal of the license shall be fifteen dollars
 49 (\$15.00), which the sheriff shall retain for the purpose of performing the
 50 duties required in this section. The sheriff may collect the actual cost

1 of any additional fees necessary to cover the processing costs lawfully re-
 2 quired by any state or federal agency or department, and the actual cost of
 3 materials for the license lawfully required by any state agency or depart-
 4 ment, which costs shall be paid to the state. ~~If a licensee applying for~~
 5 renewal has not previously been required to submit fingerprints, the sheriff
 6 shall require the licensee to do so and may collect any additional fees nec-
 7 essary to cover the cost of processing fingerprints lawfully required by any
 8 state or federal agency or department.

9 (415) Every license that is not, as provided by law, suspended, re-
 10 voked or disqualified in this state shall be renewable at any time during the
 11 ninety (90) day period before its expiration or within ninety (90) days after
 12 the expiration date. The sheriff shall mail rRenewal notices shall be mailed
 13 out ninety (90) days prior to the expiration date of the license. The sheriff
 14 shall require the licensee applying for renewal to complete an applica-
 15 tion. The sheriff shall submit the application to the Idaho state police
 16 for a records check of state and national databases. The Idaho state police
 17 shall conduct the records check and return the results to the sheriff within
 18 thirty (30) days. The sheriff shall not issue a renewal before receiving
 19 the results of the records check and must deny a license if the applicant is
 20 disqualified under any of the criteria listed provided in subsection (1),
 21 paragraphs (a) through (n) of this section. A renewal license shall be valid
 22 for a period of five (5) years. A license so renewed shall take effect on the
 23 expiration date of the prior license. A licensee renewing ninety-one (91)
 24 days to one hundred eighty (180) days after the expiration date of the li-
 25 cence shall pay a late renewal penalty of ten dollars (\$10.00) in addition to
 26 the renewal fee unless waived by the sheriff, except that any licensee serv-
 27 ing on active duty in the armed forces of the United States during the renewal
 28 period shall not be required to pay a late renewal penalty upon renewing
 29 ninety-one (91) days to one hundred eighty (180) days after the expiration
 30 date of the license. After one hundred eighty-one (181) days, the licensee
 31 shall be required to submit an initial application for a license and to pay
 32 the fees prescribed in subsection (213) of this section. The renewal fee
 33 and any penalty shall be paid to the sheriff for the purpose of enforcing the
 34 provisions of this chapter. Upon renewing a license under the provisions of
 35 this section, the sheriff shall notify the Idaho state police within five (5)
 36 days on a form or in a manner prescribed by the Idaho state police.

37 ~~(5) Notwithstanding the requirements of this section, the sheriff of~~
 38 ~~the county of the applicant's residence may issue a temporary emergency li-~~
 39 ~~cence for good cause pending review under subsection (1) of this section.~~

40 (16) A No city, county or other political subdivision of this state
 41 shall ~~not~~ modify or add to the requirements of this section, nor may shall
 42 a city, county or political subdivision ask the applicant to voluntarily
 43 submit any information not required in this section. A civil action may be
 44 brought to enjoin a wrongful refusal to issue a license or a wrongful modifi-
 45 cation of the requirements of this section. The civil action may be brought
 46 in the county in which the application was made or in Ada county at the dis-
 47 cretion of the petitioner. Any person who prevails against a public agency
 48 in any action in the courts for a violation of ~~subsections (1) through (5) of~~
 49 this section, shall be awarded costs, including reasonable attorney's fees
 50 incurred in connection with the legal action.

1 ~~(7) Except in the person's place of abode or fixed place of business, or~~
2 ~~on property in which the person has any ownership or leasehold interest, a~~
3 ~~person shall not carry a concealed weapon without a license to carry a con-~~
4 ~~cealed weapon. For the purposes of this section, a concealed weapon means~~
5 ~~any dirk, dirk knife, bowie knife, dagger, pistol, revolver or any other~~
6 ~~deadly or dangerous weapon. The provisions of this section shall not apply~~
7 ~~to any lawfully possessed shotgun or rifle, any knife, cleaver or other in-~~
8 ~~strument primarily used in the processing, preparation or eating of food,~~
9 ~~any knife with a blade four (4) inches or less or any lawfully possessed~~
10 ~~taser, stun gun or pepper spray.~~

11 ~~(8)17) A county sheriff, deputy sheriff or county employee who issues a~~
12 ~~license to carry a concealed weapon under this section shall not incur any~~
13 ~~civil or criminal liability as the result of the performance of his duties~~
14 ~~under in compliance with this section.~~

15 ~~(9) While in any motor vehicle, inside the limits or confines of any~~
16 ~~city, a person shall not carry a concealed weapon on or about his person~~
17 ~~without a license to carry a concealed weapon. This shall not apply to any~~
18 ~~firearm located in plain view whether it is loaded or unloaded. A firearm may~~
19 ~~be concealed legally in a motor vehicle so long as the weapon is disassembled~~
20 ~~or unloaded.~~

21 ~~(10) In implementing the provisions of this section on behalf of the~~
22 ~~state of Idaho, the sheriff shall make applications readily available at the~~
23 ~~office of the sheriff or at other public offices in his jurisdiction.~~

24 ~~(11)8) The sheriff of a county may issue a license to carry a concealed~~
25 ~~weapon to those individuals between the ages of eighteen (18) and twenty-one~~
26 ~~(21) years who in the judgment of the sheriff warrant the issuance of the li-~~
27 ~~cence to carry a concealed weapon. Such issuance shall be subject to limita-~~
28 ~~tions which the issuing authority deems appropriate. Licenses issued to in-~~
29 ~~dividuals between the ages of eighteen (18) and twenty-one (21) years shall~~
30 ~~be easily distinguishable from regular licenses issued pursuant to subsec-~~
31 ~~tion (6) of this section.~~

32 ~~(12) The requirement to secure a license to carry a concealed weapon un-~~
33 ~~der this section shall not apply to the following persons:~~

34 ~~(a) Officials of a county, city, state of Idaho, the United States,~~
35 ~~peace officers, guards of any jail, court appointed attendants or any~~
36 ~~officer of any express company on duty;~~

37 ~~(b) Employees of the adjutant general and military division of the~~
38 ~~state where military membership is a condition of employment when on~~
39 ~~duty;~~

40 ~~(c) Criminal investigators of the attorney general's office, crimi-~~
41 ~~nal investigators of a prosecuting attorney's office, prosecutors and~~
42 ~~their deputies;~~

43 ~~(d) Any person outside the limits of or confines of any city while en-~~
44 ~~gaged in lawful hunting, fishing, trapping or other lawful outdoor ac-~~
45 ~~tivity;~~

46 ~~(e) Any publicly elected Idaho official;~~

47 ~~(f) Retired peace officers or detention deputies with at least ten (10)~~
48 ~~years of service with the state or a political subdivision as a peace of-~~
49 ~~ficer or detention deputy and who have been certified by the peace offi-~~

1 ~~(g) Any person who has a valid permit from a state or local law enforce-~~
 2 ~~ment agency or court authorizing him to carry a concealed weapon. A per-~~
 3 ~~mit issued in another state will only be considered valid if the permit~~
 4 ~~is in the licensee's physical possession.~~

5 ~~(13) When issuing a license pursuant to this section, the sheriff may~~
 6 ~~require the applicant to demonstrate familiarity with a firearm and shall~~

5 (10) The worker's compensation records of the Idaho industrial commis-
6 sion provided that the industrial commission shall make such records avail-
7 able:

8 (a) To the parties in any worker's compensation claim and to the indus-
9 trial special indemnity fund of the state of Idaho; or

10 (b) To employers and prospective employers subject to the provisions of
11 the Americans with disabilities act, 42 U.S.C. 12112, or other statu-
12 tory limitations, who certify that the information is being requested
13 with respect to a worker to whom the employer has extended an offer of
14 employment and will be used in accordance with the provisions of the
15 Americans with disabilities act, 42 U.S.C. 12112, or other statutory
16 limitations; or

17 (c) To employers and prospective employers not subject to the provi-
18 sions of the Americans with disabilities act, 42 U.S.C. 12112, or other
19 statutory limitations, provided the employer presents a written autho-
20 rization from the person to whom the records pertain; or

21 (d) To others who demonstrate that the public interest in allowing in-
22 spection and copying of such records outweighs the public or private in-
23 terest in maintaining the confidentiality of such records, as deter-
24 mined by a civil court of competent jurisdiction; or

25 (e) Although a claimant's records maintained by the industrial commis-
26 sion, including medical and rehabilitation records, are otherwise ex-
27 empt from public disclosure, the quoting or discussing of medical or re-
28 habilitation records contained in the industrial commission's records
29 during a hearing for compensation or in a written decision issued by the
30 industrial commission shall be permitted; provided further, the true
31 identification of the parties shall not be exempt from public disclo-
32 sure in any written decision issued and released to the public by the in-
33 dustrial commission.

34 (11) Records of investigations compiled by the commission on aging in-
35 volving vulnerable adults, as defined in section 18-1505, Idaho Code, al-
36 leged to be abused, neglected or exploited.

37 (12) Criminal history records and fingerprints, as defined by section
38 67-3001, Idaho Code, and compiled by the Idaho state police. Such records
39 shall be released only in accordance with chapter 30, title 67, Idaho Code.

40 (13) Records furnished or obtained pursuant to section 41-1019, Idaho
41 Code, regarding termination of an appointment, employment, contract or
42 other insurance business relationship between an insurer and a producer.

43 (14) Records of a prisoner or former prisoner in the custody of any state
44 or local correctional facility, when the request is made by another prisoner
45 in the custody of any state or local correctional facility.

46 (15) Except as provided in section 72-1007, Idaho Code, records of the
47 Idaho industrial commission relating to compensation for crime victims un-
48 der chapter 10, title 72, Idaho Code.

49 (16) Records or information identifying a complainant maintained by the
50 department of health and welfare pursuant to section 39-3556, Idaho Code,

1 relating to certified family homes, unless the complainant consents in writ-
2 ing to the disclosure or the disclosure of the complainant's identity is re-
3 quired in any administrative or judicial proceeding.
