## DIGEST OF INTRODUCED BILL

Citations Affected: IC 35-47-9-1.

**Synopsis:** Retired law enforcement officers and firearms. Exempts certain law enforcement and retired law enforcement officers described in the federal Law Enforcement Officers Safety Act (LEOSA) from the prohibition against carrying a firearm on school property. Makes conforming amendments.

Effective: July 1, 2020.
