



SENATE MOTION

MADAM PRESIDENT:

I move that Senate Bill 14 be amended to read as follows:

1 Page 1, between the enacting clause and line 1, begin a new
2 paragraph and insert:
3 "SECTION 1. IC 2-3-10-2, AS ADDED BY P.L.181-2017,
4 SECTION 1, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE
5 JULY 1, 2024]: Sec. 2. A member of the general assembly who

7 ~~(2) is otherwise permitted to possess a handgun;~~
8 **is not prohibited under state or federal law from possessing a**

- 2 Page 1, between lines 4 and 5, begin a new paragraph and insert:
- 3 **"Sec. 1. As used in this chapter, "state office employee" means**
- 4 **a full-time employee of one (1) of the following elected offices:**
- 5 **(1) Attorney general.**
- 6 **(2) Secretary of state.**
- 7 **(3) State comptroller.**
- 8 **(4) Treasurer of state.**
- 9 **The term does not include a state officer."**
- 10 Page 1, line 5, delete "Sec. 1." and insert "**Sec. 2.**"
- 11 Page 1, line 5, delete "officer or employee"" and insert "**officer**".
- 12 Page 1, line 6, delete "or is employed full time by".
- 13 Page 1, line 12, delete "Sec. 2." and insert "**Sec. 3.**"
- 14 Page 1, line 12, delete "or employee who:" and insert "**who is not**
- 15 **prohibited under state or federal law from possessing a handgun**".
- 16 Page 1, delete lines 13 through 14.
- 17 Page 1, run in lines 12 through 15.
- 18 Page 1, after line 16, begin a new paragraph and insert:
- 19 **"Sec. 4. Subject to the written policy of the state officer, a state**
- 20 **office employee who is not prohibited under state or federal law**
- 21 **from possessing a handgun may carry a handgun within the state**
- 22 **capitol building and on the property of the state capitol complex."**
- 23 Renumber all SECTIONS consecutively.
