

# PROPOSED AMENDMENT

## HB 1001 # 95

### DIGEST

State budget. Appropriates money for capital expenditures, the operation of the state, K-12 and higher education, the delivery of Medicaid and other services, and various other distributions and purposes. Extends the review, analysis, and evaluation of tax incentives by the legislative services agency through 2030. Requires the legislative services agency to perform a fiscal impact analysis for each executive order issued by governor the under the emergency management and disaster law. Requires state officials to report to the budget committee expenses and funding used for trips taken in their official capacity. Appropriates \$2,000,000 from the Pokagon Band Tribal-state compact fund to the Midwest continental divide commission fund. Changes the name of the state agency contingency fund to the personal services/fringe benefits contingency fund and makes certain amending changes to the provisions for the fund. Requires the budget director to withhold not less than 5% of any appropriation to a state agency to be used for salaries or other wages for state agency employees or general operating expenses of the state agency, with certain exclusions. Establishes the Indiana local government investment pool board for the purpose of establishing policies governing the investment of funds contributed to the local government investment pool. Amends provisions regarding the investment authority of the treasurer of state. Removes political affiliation requirements that apply to members appointed by the governor to the board for depositories. Repeals a provision allowing the Indiana department of administration to enter into a lease with the Indiana historical society for use of a building. Requires the department of natural resources (not the Indiana department of veterans' affairs under current law) to provide staff support to the Indiana semiquincentennial commission and repeals provisions requiring certain meetings and events of the commission to be held at the World War Memorial in Indianapolis. Removes the statewide innovation development district fund as a funding source for an agreement between the Indiana economic development corporation (IEDC) and a taxpayer to receive payment in lieu of claiming an economic development for a growing economy tax credit. Establishes a home repair matching grant pilot program. Requires the secretary of commerce to develop a collaborative framework with regional economic development organizations and other regional stakeholders to identify and implement targeted, actionable economic growth strategies on a regional basis. Establishes a rural fund capital investment tax credit. Establishes the Hoosier workforce investment tax credit. Establishes a beginning farmer tax credit. Amends the cap on the aggregate amount of tax credits the IEDC may certify each year. Increases the amount of the public utility fee from 0.15% to 0.175% of the public utility's annual gross intrastate operating revenue and transfers the public utility fee revenue and certain payments to the state general fund (not the public utility fund under current law). Amends certain membership provisions regarding the Gary airport authority board. Requires that the salary matrix for state police, capitol police officers, and department of natural resources law enforcement officers be adjusted each time an adjustment is made to a pay plan for state employees in the executive branch. Adds therapeutic ibogaine research to the research that is currently funded under the therapeutic psilocybin research fund. Provides that funding to a local board of health from the local public health fund may only be used for Indiana residents who are legal citizens of the United States. Specifies provider payment requirements that apply to any managed care organization that participates in the risk based managed care program. Repeals the provisions requiring the office of the secretary of family and social services to transfer \$38,000,000 each year to the Health and Hospital Corporation of Marion County. Makes certain eligibility changes for the On My Way Pre-k program and the CCDF program. Provides that a community mental health

center that provides compensation to any individual employee in an amount that is \$400,000 or more per year is not eligible to receive funding from local property taxes or state programs or grants, but excluding the Medicaid program. Requires the department of natural resources to provide free admission to state parks to a Gold Star family member. Requires the bureau of motor vehicles to update the Gold Star family member license plate form. Establishes the health care engineering fund for the purpose of funding plan reviews for certain health facilities. Imposes a fee for each plan review that is deposited in the fund. Amends provisions that apply to local board of health spending of certain funds for core public health services. Requires the secretary of education to provide a report and recommendation to the general assembly concerning aligning state funding for dual credit and the advanced placement program with the new high school diploma and expanding access to dual credit course work to all Indiana students. Repeals the kids first trust license plate and kids first trust program chapters on June 30, 2027. Prohibits a school employer from bargaining collectively with the exclusive school employee representative regarding contract costs for curricular materials. Establishes a teacher appreciation grant program to provide grants to school corporations and charter schools to attract, reward, and retain teachers who significantly impact student outcomes. Repeals the chapter establishing the curricular materials fund and certain provisions related to procedures for reimbursement of costs of providing curricular materials. Prohibits a school corporation or career and technical education center or school from charging a career scholarship student enrolled in the career scholarship account program or an approved intermediary acting on behalf of a career scholarship student a tuition or fee amount to enroll in or attend a career and technical education program, course, or class that is more than the proportionate amount that the school corporation or career and technical education center or school would receive under the career and technical education grant if the student had enrolled in and completed the applicable career and technical education program, course, or class. Repeals provisions that allow the treasurer of state to deduct or transfer amounts from the career scholarship account (CSA) program for administration expenses. Makes similar technical and conflict resolving changes to provisions that apply to the education scholarship account (ESA) program. Changes the administration of the ESA program and the CSA program from the treasurer of state to the department of education, and in certain instances, the responsibilities related to the CSA program from the commission for higher education to the department. Repeals the nonreverting provisions for the higher education award fund and the freedom of choice grant fund. Requires the commission for higher education to annually prepare and submit to the legislative council and to the budget committee a report that examines the utilization of physical facilities for instruction at each state educational institution. Repeals the caseload limitations for the department of child services. Authorizes the department of child services to enter into a written agreement with the department of state revenue to transfer the administration of the child support bureau to the department of state revenue. Amends provisions concerning the designation of an innovation development district (district) to add certain qualification requirements. Provides for the determination of the: (1) base assessed value; (2) gross retail base period amount; and (3) income tax base period amount; in a district. Requires the executive of a city, county, or town, or, if applicable, executives, and the IEDC to enter into an agreement establishing the terms and conditions governing any district (instead of only certain districts). Repeals the statewide innovation development district fund. Establishes the economic development reserve account. Provides that unexpended and unencumbered amounts appropriated from the federal economic stimulus fund in P.L.165-2021 do not revert to the state general fund. Requires the state comptroller to transfer: (1) \$15,000,000 from the addiction services fund; and (2) \$25,000,000 from the department of insurance fund; to the tobacco master settlement agreement fund on July 1, 2025. Requires the budget agency to transfer to the state general fund the balance in the freedom of choice grant fund (IC 21-12-4-5) and the higher education award fund (IC 21-12-3-19) that is not needed for the payment of scholarship awards in the state fiscal year ending June 30, 2025. Requires the office of management and budget to submit a report to the budget committee with options for reforming a certain funding model in the Indiana office of technology in order to reduce and streamline technology costs in the executive branch, improve technology services, and reduce purchase costs for state agencies.

1    **SECTION 1. [EFFECTIVE JULY 1, 2025]**

3    **(a) The following definitions apply throughout this act:**

4    **(1) "Augmentation allowed" means the governor and the budget agency are**  
5    **authorized to add to an appropriation in this act from revenues accruing to the**  
6    **fund from which the appropriation was made.**

7    **(2) "Biennium" means the period beginning July 1, 2025, and ending June 30, 2027.**  
8    **Appropriations appearing in the biennial column for construction or other permanent**  
9    **improvements do not revert under IC 4-13-2-19 and may be allotted.**

10    **(3) "Equipment" includes machinery, implements, tools, furniture,**  
11    **furnishings, vehicles, and other articles that have a calculable period of service**  
12    **that exceeds twelve (12) calendar months.**

13    **(4) "Fee replacement" includes payments to universities to be used to pay indebtedness**  
14    **resulting from financing the cost of planning, purchasing, rehabilitation, construction,**  
15    **repair, leasing, lease-purchasing, or otherwise acquiring land, buildings, facilities,**  
16    **and equipment to be used for academic and instructional purposes.**

17    **(5) "Personal services" includes payments for salaries and wages to officers and**  
18    **employees of the state (either regular or temporary), payments for compensation**  
19    **awards, and the employer's share of Social Security, health insurance, life insurance,**  
20    **dental insurance, vision insurance, deferred compensation - state match, leave**  
21    **conversion, disability, and retirement fund contributions.**

1 (6) "State agency" means:

2 (A) each office, officer, board, commission, department, division, bureau, committee,  
3 fund, agency, authority, council, or other instrumentality of the state;

4 (B) each hospital, penal institution, and other institutional enterprise of the state;

5 (C) the judicial department of the state; and

6 (D) the legislative department of the state.

7 However, this term does not include cities, towns, townships, school cities, school  
8 townships, school districts, other municipal corporations or political subdivisions  
9 of the state, or universities and colleges supported in whole or in part by state  
10 funds.

11 (7) "Total operating expense" includes payments for "personal services", "services  
12 other than personal", "services by contract", "supplies, materials, and parts",  
13 "grants, subsidies, refunds, and awards", "in-state travel", "out-of-state travel",  
14 and "equipment".

15 (b) The state board of finance may authorize advances to boards or persons having  
16 control of the funds of any institution or department of the state of a sum of money  
17 out of any appropriation available at such time for the purpose of establishing  
18 working capital to provide for payment of expenses in the case of emergency when  
19 immediate payment is necessary or expedient. Advance payments shall be made by  
20 warrant by the state comptroller, and properly itemized and receipted bills or invoices  
21 shall be filed by the board or persons receiving the advance payments.

22 (c) All money appropriated by this act shall be considered either a direct appropriation  
23 or an appropriation from a rotary or revolving fund.

24 (1) Direct appropriations are subject to withdrawal from the state treasury and for  
25 expenditure for such purposes, at such time, and in such manner as may be prescribed  
26 by law. Direct appropriations are not subject to return and rewithdrawal from the  
27 state treasury, except for the correction of an error which may have occurred in any  
28 transaction or for reimbursement of expenditures which have occurred in the same  
29 fiscal year.

30 (2) A rotary or revolving fund is any designated part of a fund that is set apart as  
31 working capital in a manner prescribed by law and devoted to a specific purpose  
32 or purposes. The fund consists of earnings and income only from certain sources  
33 or combination of sources. The money in the fund shall be used for the purpose designated  
34 by law as working capital. The fund at any time consists of the original appropriation  
35 to the fund, if any, all receipts accrued to the fund, and all money withdrawn from the  
36 fund and invested or to be invested. The fund shall be kept intact by separate entries  
37 in the state comptroller's office, and no part of the fund shall be used for any purpose  
38 other than the lawful purpose of the fund or revert to any other fund at any time.  
39 However, any unencumbered excess above any prescribed amount may be transferred  
40 to the state general fund at the close of each fiscal year unless otherwise specified  
41 in the Indiana Code.

43 SECTION 2. [EFFECTIVE JULY 1, 2025]

44  
45 For the conduct of state government, its offices, funds, boards, commissions, departments,  
46 societies, associations, services, agencies, and undertakings, and for other appropriations  
47 not otherwise provided by statute, the following sums in SECTIONS 3 through 10 are  
48 appropriated for the periods of time designated from the general fund of the state of  
49 Indiana or other specifically designated funds.

**Included in the above appropriations for house and senate expenses are funds for a legislative business per diem allowance, meals, and other usual and customary expenses associated with legislative affairs. Each member of the house is entitled, when authorized by the speaker of the house, to the legislative business per diem allowance for every day the member is engaged in official business. The speaker shall authorize the legislative business per diem allowance to be consistent with law and house rules.**

**Each member of the senate is entitled, when authorized by the president pro tempore of the senate, to the legislative business per diem allowance for every day the member is engaged in official business. The president pro tempore of the senate shall authorize the legislative business per diem allowance to be consistent with law and senate rules.**

**The legislative business per diem allowance that each member of the general assembly is entitled to receive equals the maximum daily amount allowable to employees of the executive branch of the federal government for subsistence expenses while away from home in travel status in the Indianapolis area. The legislative business per diem changes each time there is a change in that maximum daily amount.**

**In addition to the legislative business per diem allowance, each member of the general assembly shall receive the mileage allowance in an amount equal to the standard mileage rates for personally owned transportation equipment established by the federal Internal Revenue Service for each mile necessarily traveled from the member's usual place of residence to the state capitol. However, if the member traveled by a means other than by motor vehicle, and the member's usual place of residence is more than one hundred (100) miles from the state capitol, the member is entitled to reimbursement in an amount equal to the lowest air travel cost incurred in traveling from the usual place of residence to the state capitol. During the period the general assembly is convened in regular or special session, the mileage allowance shall be limited to one (1) round**

1 trip each week per member.  
2

3 Any member of the general assembly who is appointed by the governor, speaker of  
4 the house, president or president pro tempore of the senate, house or senate minority  
5 floor leader, or Indiana legislative council to serve on any research, study, or survey  
6 committee or commission, or who attends any meetings authorized or convened  
7 under the auspices of the Indiana legislative council, including pre-session conferences  
8 and federal-state relations conferences, is entitled, when authorized by the legislative  
9 council, to receive the legislative business per diem allowance for each day the  
10 member is in actual attendance and is also entitled to a mileage allowance, at the  
11 rate specified above, for each mile necessarily traveled from the member's usual  
12 place of residence to the state capitol, or other in-state site of the committee,  
13 commission, or conference. The per diem allowance and the mileage allowance permitted  
14 under this paragraph shall be paid from the legislative council appropriation for  
15 legislator and lay member travel unless the member is attending an out-of-state  
16 meeting, as authorized by the speaker of the house of representatives or the president  
17 pro tempore of the senate, in which case the member is entitled to receive:

18 (1) the legislative business per diem allowance for each day the member is engaged in  
19 approved out-of-state travel; and

20 (2) reimbursement for traveling expenses actually incurred in connection with the  
21 member's duties, as provided in the state travel policies and procedures established  
22 by the legislative council.  
23

24 Notwithstanding the provisions of this or any other statute, the legislative council  
25 may adopt, by resolution, travel policies and procedures that apply only to members  
26 of the general assembly or to the staffs of the house of representatives, senate, and  
27 legislative services agency, or both members and staffs. The legislative council may  
28 apply these travel policies and procedures to lay members serving on research, study,  
29 or survey committees or commissions that are under the jurisdiction of the legislative  
30 council. Notwithstanding any other law, rule, or policy, the state travel policies and  
31 procedures established by the Indiana department of administration and approved by the  
32 budget agency do not apply to members of the general assembly, to the staffs of the house  
33 of representatives, senate, or legislative services agency, or to lay members serving  
34 on research, study, or survey committees or commissions under the jurisdiction of  
35 the legislative council (if the legislative council applies its travel policies and procedures  
36 to lay members under the authority of this SECTION), except that, until the legislative  
37 council adopts travel policies and procedures, the state travel policies and procedures  
38 established by the Indiana department of administration and approved by the budget  
39 agency apply to members of the general assembly, to the staffs of the house of representatives,  
40 senate, and legislative services agency, and to lay members serving on research, study,  
41 or survey committees or commissions under the jurisdiction of the legislative council.  
42 The executive director of the legislative services agency is responsible for the  
43 administration of travel policies and procedures adopted by the legislative council.  
44 The state comptroller shall approve and process claims for reimbursement of travel  
45 related expenses under this paragraph based upon the written affirmation of the  
46 speaker of the house of representatives, the president pro tempore of the senate, or  
47 the executive director of the legislative services agency that those claims comply with  
48 the travel policies and procedures adopted by the legislative council. If the funds  
49 appropriated for the house and senate expenses and legislative salaries are insufficient

1 to pay all the necessary expenses incurred, including the cost of printing the journals  
 2 of the house and senate, there is appropriated such further sums as may be necessary  
 3 to pay such expenses.

 10 Each member of the general assembly is entitled to a subsistence allowance of forty  
 11 percent (40%) of the maximum daily amount allowable to employees of the executive  
 12 branch of the federal government for subsistence expenses while away from home in  
 13 travel status in the Indianapolis area for:  
 14 (1) each day that the general assembly is not convened in regular or special session; and  
 15 (2) each day after the first session day held in November and before the first session  
 16 day held in January.

17  
 18 However, the subsistence allowance under subdivision (2) may not be paid with respect  
 19 to any day after the first session day held in November and before the first session day  
 20 held in January with respect to which all members of the general assembly are entitled  
 21 to a legislative business per diem, and the subsistence allowance under subdivision (1)  
 22 may not be paid to a member after the final recess day in April with respect to any  
 23 day in which the chamber in which the individual is a member meets as a body or in  
 24 any period in which the chamber is in recess for less than six (6) consecutive days.

 26 The subsistence allowance is payable from the appropriations for legislators' subsistence.

 28 The officers of the senate are entitled to the following amounts annually in addition

 30 pro tempore, \$3,000; majority floor leader, \$5,500; assistant majority floor leader(s),  
 31 \$3,500; majority floor leader emeritus, \$2,500; majority caucus chair, \$5,500;  
 32 assistant majority caucus chair(s), \$1,500; appropriations committee chair, \$5,500;  
 33 tax and fiscal policy committee chair, \$5,500; appropriations committee ranking  
 34 majority member, \$2,000; tax and fiscal policy committee ranking majority member,  
 35 \$2,000; majority whip, \$4,000; assistant majority whip, \$2,000; minority floor leader,  
 36 \$6,000; minority leader emeritus, \$1,500; minority caucus chair, \$5,000; assistant

5 Officers of the house of representatives are entitled to the following amounts annually  
6 in addition to the subsistence allowance: speaker of the house, \$7,000; speaker  
7 pro tempore, \$5,000; deputy speaker pro tempore, \$2,000; majority floor leader,  
8 \$5,500; majority caucus chair, \$5,500; majority whip, \$4,000; assistant majority  
9 floor leader(s), \$3,500; assistant majority caucus chair(s), \$2,000; assistant majority  
10 whip(s), \$2,000; ways and means committee chair, \$5,500; ways and means committee  
11 vice chair, \$4,000; ways and means k-12 subcommittee chair, \$1,500; ways and means  
12 higher education subcommittee chair, \$1,500; ways and means budget subcommittee  
13 chair, \$3,000; ways and means health and human services subcommittee chair, \$1,500;  
14 ways and means local government subcommittee chair, \$1,500; minority leader, \$6,000;  
15 minority floor leader, \$4,500; minority caucus chair, \$4,500; minority whip, \$3,000;  
16 assistant minority leader(s), \$1,500; assistant minority floor leader(s), \$1,500; assistant

34 If the senate or house of representatives eliminates a committee or officer referenced  
35 in this SECTION and replaces the committee or officer with a new committee or position,  
36 the above appropriations for subsistence shall be used to pay for the new committee  
37 or officer. However, this does not permit any additional amounts to be paid under  
38 this SECTION for a replacement committee or officer than would have been spent for  
39 the eliminated committee or officer. If the senate or house of representatives creates  
40 a new, additional committee or officer, or assigns additional duties to an existing  
41 officer, the above appropriations for subsistence shall be used to pay for the new  
42 committee or officer, or to adjust the annual payments made to the existing officer,  
43 in amounts determined by the legislative council.  
44

45 If the funds appropriated for legislators' subsistence are insufficient to pay all  
46 the subsistence incurred, there are hereby appropriated such further sums as may  
47 be necessary to pay such subsistence.

5 **Included in the above appropriations are funds for usual and customary expenses**  
6 **associated with legislative services.**

7  
8 **If the funds above appropriated for the legislative council and the legislative**  
9 **services agency and for legislator and lay member travel are insufficient to pay**  
10 **all the necessary expenses incurred, there are hereby appropriated such further**  
11 **sums as may be necessary to pay those expenses.**

12  
13 **Any person other than a member of the general assembly who is appointed by the governor,**  
14 **speaker of the house, president or president pro tempore of the senate, house or senate**  
15 **minority floor leader, or legislative council to serve on any research, study, or survey**  
16 **committee or commission is entitled, when authorized by the legislative council, to a**  
17 **per diem instead of subsistence of \$75 per day during the biennium. In addition to the**  
18 **per diem, such a person is entitled to mileage reimbursement, at the rate specified for**  
19 **members of the general assembly, for each mile necessarily traveled from the person's**  
20 **usual place of residence to the state capitol or other in-state site of the committee,**  
21 **commission, or conference. However, reimbursement for any out-of-state travel expenses**  
22 **claimed by lay members serving on research, study, or survey committees or commissions**  
23 **under the jurisdiction of the legislative council shall be based on SECTION 14 of this act,**

**SECTION 11. [EFFECTIVE JULY 1, 2025]**

Federal funds are available for career and technical education under the Carl D. Perkins Career and Technical Education Act of 2006 (20 U.S.C. 2301 et seq. for Career and Technical Education). Funds shall be received by the commission of higher education and may be allocated by the budget agency after consultation with the commission for higher education and any other state agencies, commissions, or organizations required by state law.

**SECTION 12. [EFFECTIVE JULY 1, 2025]**

In accordance with IC 20-20-38, the budget agency, upon the request of the commission for higher education, may proportionately augment or reduce an allocation of federal funds made under SECTION 11 of this act.

**SECTION 13. [EFFECTIVE JULY 1, 2025]**

Utility bills for the month of June, travel claims covering the period June 16 to June 30, payroll for the period of the last half of June, any interdepartmental bills for supplies or services for the month of June, and any other miscellaneous expenses incurred during the period June 16 to June 30 shall be charged to the appropriation for the succeeding year. No interdepartmental bill shall be recorded as a refund of expenditure to any current year allotment account for supplies or services rendered or delivered at any time during the preceding June period.

1 SECTION 14. [EFFECTIVE JULY 1, 2025]

2  
3 The budget agency, under IC 4-10-11, IC 4-12-1-13, and IC 4-13-1, in cooperation  
4 with the Indiana department of administration, may fix the amount of reimbursement  
5 for traveling expenses (other than transportation) for travel within the limits of  
6 Indiana. This amount may not exceed actual lodging and miscellaneous expenses  
7 incurred. A person in travel status, as defined by the state travel policies and  
8 procedures established by the Indiana department of administration and the budget  
9 agency, is entitled to a meal allowance not to exceed during any twenty-four (24)  
10 hour period the standard meal allowances established by the federal Internal Revenue  
11 Service.

12  
13 All appropriations provided by this act or any other statute, for traveling and hotel  
14 expenses for any department, officer, agent, employee, person, trustee, or commissioner,  
15 are to be used only for travel within the state of Indiana, unless those expenses are  
16 incurred in traveling outside the state of Indiana on trips that previously have received  
17 approval as required by the state travel policies and procedures established by the Indiana  
18 department of administration and the budget agency. With the required approval,  
19 a reimbursement for out-of-state travel expenses may be granted in an amount not  
20 to exceed actual lodging and miscellaneous expenses incurred. A person in travel  
21 status is entitled to a meal allowance not to exceed during any twenty-four (24) hour  
22 period the standard meal allowances established by the federal Internal Revenue  
23 Service for properly approved travel within the continental United States and a  
24 minimum of \$50 during any twenty-four (24) hour period for properly approved travel  
25 outside the continental United States. However, while traveling in Japan, the minimum  
26 meal allowance shall not be less than \$90 for any twenty-four (24) hour period. While  
27 traveling in Korea and Taiwan, the minimum meal allowance shall not be less than  
28 \$85 for any twenty-four (24) hour period. While traveling in Singapore, China, Great  
29 Britain, Germany, the Netherlands, and France, the minimum meal allowance shall  
30 not be less than \$65 for any twenty-four (24) hour period.

31  
32 In the case of the state supported institutions of postsecondary education, approval  
33 for out-of-state travel may be given by the chief executive officer of the institution,  
34 or the chief executive officer's authorized designee, for the chief executive officer's  
35 respective personnel.

36  
37 Before reimbursing overnight travel expenses, the state comptroller shall require  
38 documentation as prescribed in the state travel policies and procedures established  
39 by the Indiana department of administration and the budget agency. No appropriation  
40 from any fund may be construed as authorizing the payment of any sum in excess of  
41 the standard mileage rates for personally owned transportation equipment established

8      **No payment for personal services shall be made by the state comptroller unless the**  
9      **payment has been approved by the budget agency or the designee of the budget agency.**

11      **SECTION 17. [EFFECTIVE JULY 1, 2025]**

13      **No warrant for operating expenses, capital outlay, or fixed charges shall be issued**  
14      **to any department or an institution unless the receipts of the department or institution**  
15      **have been deposited into the state treasury for the month. However, if a department**  
16      **or an institution has more than \$10,000 in daily receipts, the receipts shall be deposited**  
17      **into the state treasury daily.**

19      **SECTION 18. [EFFECTIVE JULY 1, 2025]**

21      **In case of loss by fire or any other cause involving any state institution or department,**  
22      **the proceeds derived from the settlement of any claim for the loss shall be deposited**  
23      **in the state treasury, and the amount deposited is hereby reappropriated to the**  
24      **institution or department for the purpose of replacing the loss. If it is determined**  
25      **that the loss shall not be replaced, any funds received from the settlement of a claim**  
26      **shall be deposited into the state general fund.**

27  
28      **SECTION 19. [EFFECTIVE JULY 1, 2025]**

29  
30      **If an agency has computer equipment in excess of the needs of that agency, then**  
31      **the excess computer equipment may be sold under the provisions of surplus property**  
32      **sales, and the proceeds of the sale or sales shall be deposited in the state treasury.**  
33      **The amount so deposited is hereby reappropriated to that agency for other operating**  
34      **expenses of the current year, if approved by the director of the budget agency.**

35  
36      **SECTION 20. [EFFECTIVE JULY 1, 2025]**

37  
38      **This act does not authorize any rehabilitation and repairs to any state buildings,**  
39      **nor does it allow that any obligations be incurred for lands and structures, without**  
40      **the prior approval of the budget director or the director's designee. This SECTION**  
41      **does not apply to contracts for the state universities supported in whole or in part**  
42      **by state funds.**

43  
44      **SECTION 21. [EFFECTIVE JULY 1, 2025]**

45  
46      **If an agency has an annual appropriation fixed by law, and if the agency also receives**  
47      **an appropriation in this act for the same function or program, the appropriation in**  
48      **this act supersedes any other appropriations and is the total appropriation for the**  
49      **agency for that program or function.**

1  
2 **SECTION 22. [EFFECTIVE JULY 1, 2025]**  
3

4 **The balance of any appropriation or funds heretofore placed or remaining to the**  
5 **credit of any division of the state of Indiana, and any appropriation or funds provided**  
6 **in this act placed to the credit of any division of the state of Indiana, the powers,**  
7 **duties, and functions whereof are assigned and transferred to any department for**  
8 **salaries, maintenance, operation, construction, or other expenses in the exercise**  
9 **of such powers, duties, and functions, shall be transferred to the credit of the**  
10 **department to which such assignment and transfer is made, and the same shall be**  
11 **available for the objects and purposes for which appropriated originally.**

12  
13 **SECTION 23. [EFFECTIVE JULY 1, 2025]**  
14

15 **The director of the division of procurement of the Indiana department of administration,**  
16 **or any other person or agency authorized to make purchases of equipment, shall not**  
17 **honor any requisition for the purchase of an automobile that is to be paid for from any**  
18 **appropriation made by this act or any other act, unless the following facts are shown**  
19 **to the satisfaction of the commissioner of the Indiana department of administration or**  
20 **the commissioner's designee:**

21 **(1) In the case of an elected state officer, it shall be shown that the duties of the**  
22 **office require driving about the state of Indiana in the performance of official duty.**

23 **(2) In the case of department or commission heads, it shall be shown that the statutory**  
24 **duties imposed in the discharge of the office require traveling a greater distance**  
25 **than one thousand (1,000) miles each month or that they are subject to official duty**  
26 **call at all times.**

27 **(3) In the case of employees, it shall be shown that the major portion of the duties**  
28 **assigned to the employee require travel on state business in excess of one thousand**  
29 **(1,000) miles each month, or that the vehicle is identified by the agency as an integral**  
30 **part of the job assignment.**

31  
32 **In computing the number of miles required to be driven by a department head or an**  
33 **employee, the distance between the individual's home and office or designated official**  
34 **station is not to be considered as a part of the total. Department heads shall annually**  
35 **submit justification for the continued assignment of each vehicle in their department,**  
36 **which shall be reviewed by the commissioner of the Indiana department of administration,**  
37 **or the commissioner's designee. There shall be an insignia permanently affixed on each**  
38 **side of all state owned cars, designating the cars as being state owned. However, this**  
39 **requirement does not apply to state owned cars driven by elected state officials or to**  
40 **cases where the commissioner of the Indiana department of administration or the**  
41 **commissioner's designee determines that affixing insignia on state owned cars would**  
42 **hinder or handicap the persons driving the cars in the performance of their official**  
43 **duties.**

44  
45 **SECTION 24. [EFFECTIVE JULY 1, 2025]**  
46

47 **When budget agency approval or review is required under this act, the budget agency**  
48 **may refer to the budget committee any budgetary or fiscal matter for an advisory**  
49 **recommendation. The budget committee may hold hearings and take any actions authorized**

1 by IC 4-12-1-11, and may make an advisory recommendation to the budget agency.  
2

3 SECTION 25. [EFFECTIVE JULY 1, 2025]  
4

5 Except as provided for under IC 4-12-18, the governor of the state of Indiana is  
6 solely authorized to accept on behalf of the state any and all federal funds available  
7 to the state of Indiana. Federal funds received under this SECTION are appropriated  
8 for purposes specified by the federal government, subject to allotment by the budget  
9 agency. The provisions of this SECTION and all other SECTIONS concerning the  
10 acceptance, disbursement, review, and approval of any grant, loan, or gift made by  
11 the federal government or any other source to the state or its agencies and political  
12 subdivisions shall apply, notwithstanding any other law.  
13

14 SECTION 26. [EFFECTIVE JULY 1, 2025]  
15

16 Except as provided for under IC 4-12-18, federal funds received as revenue by a state  
17 agency or department are not available to the agency or department for expenditure  
18 until allotment has been made by the budget agency under IC 4-12-1-12(d).  
19

20 SECTION 27. [EFFECTIVE JULY 1, 2025]  
21

22 A contract or an agreement for personal services or other services may not be  
23 entered into by any agency or department of state government without the approval  
24 of the budget agency or the designee of the budget director.  
25

26 SECTION 28. [EFFECTIVE JULY 1, 2025]  
27

28 Except in those cases where a specific appropriation has been made to cover the  
29 payments for any of the following, the state comptroller shall transfer, from the  
30 personal services appropriations for each of the various agencies and departments,  
31 necessary payments for Social Security, public employees' retirement, health  
32 insurance, life insurance, and any other similar payments directed by the budget  
33 agency.  
34

35 SECTION 29. [EFFECTIVE JULY 1, 2025]  
36

37 Subject to SECTION 24 of this act as it relates to the budget committee, the budget  
38 agency with the approval of the governor may withhold allotments of any or all appropriations  
39 contained in this act for the biennium, if it is considered necessary to do so in order  
40 to prevent a deficit financial situation.  
41

42 SECTION 30. [EFFECTIVE JULY 1, 2025]  
43

44 CONSTRUCTION  
45

46 For the 2025-2027 biennium, the following amounts, from the funds listed as follows,  
47 are appropriated to provide for the construction, reconstruction, rehabilitation, repair,  
48 purchase, rental, and sale of state properties, capital lease rentals, and the purchase and  
49 sale of land, including equipment for these properties and other projects as specified.

16 (b) The officers of the board consist of a chairman, a secretary-investment manager, a vice chairman,

21 (7,000) according to the 2020 federal decennial census.

22 (13) "Rural fund" means an entity certified by the corporation under sections 3 through 5 of  
23 this chapter.

24 (14) "Rural investor" means an entity that makes a capital investment in a rural fund.

25 (15) "Senior-secured debt" means any loan that is secured by a first mortgage on real estate  
26 with a loan-to-value ratio of less than eighty percent (80%).

27 (16) "State tax liability" means a person's total tax liability that is incurred under:

28 (A) IC 27-1-18-2 (the insurance premiums tax); and

29 (B) IC 27-1-20-12 (the insurance premiums retaliatory tax);

30 as computed after the application of the credits that under IC 6-3.1-1-2 are to be applied  
31 before the credit provided by this chapter. An insurance company claiming a credit against  
32 the taxes listed in this subdivision is not required to pay any additional retaliatory tax in  
33 Indiana as a result of claiming the credit.

34 (17) "Taxpayer" means an entity that has state tax liability.

35 Sec. 3. (a) A rural fund that seeks to have an equity investment certified as a capital investment  
36 eligible for a credit allowed under this chapter must apply to the corporation. The corporation shall  
37 begin accepting applications within ninety (90) days after July 1, 2025.

38 (b) The application must include each of the following:

39 (1) The amount of capital investment requested.

40 (2) A copy of the applicant's or an affiliate of the applicant's license as a rural business  
41 investment company under 7 U.S.C. 2009cc or as a small business investment company under  
42 15 U.S.C. 681 and a certificate executed by an executive officer of the applicant attesting that  
43 the license remains in effect and has not been revoked.

44 (3) Evidence that, as of the date the application is submitted, the applicant or affiliates of the  
45 applicant have invested at least one hundred million dollars (\$100,000,000) in nonpublic  
46 companies located in counties within the United States with a population of less than  
47 seventy-five thousand (75,000) according to the 2020 federal decennial census. The evidence  
48 may be in the form of a list containing the names of the companies, the location of the

1 companies, and the amounts invested by the applicant or affiliates of the applicant. However,  
2 an officer of the applicant must certify the list.

3 (4) A business plan that includes a revenue impact assessment projecting state and local tax  
4 revenue to be generated by the applicant's proposed qualified investments, prepared by a  
5 nationally recognized, third party, independent economic forecasting firm using a dynamic  
6 economic forecasting model that analyzes the applicant's business plan over the ten (10) years  
7 following the date the application is submitted to the corporation. The plan must include an  
8 estimate of the number of jobs created and jobs retained in Indiana as a result of the  
9 applicant's qualified investments.

10 (5) A nonrefundable application fee of five thousand dollars (\$5,000) payable to the  
11 corporation.

12 Sec. 4. (a) Within thirty (30) days after the receipt of a completed application, the corporation  
13 shall grant or deny the application in full or in part. The corporation shall deny the application if  
14 any of the following apply:

15 (1) The applicant does not satisfy all the criteria set forth in section 3 of this chapter.

16 (2) The revenue impact assessment submitted with the application does not demonstrate that  
17 the applicant's business plan will result in a positive fiscal impact on Indiana over a ten (10)  
18 year period that exceeds the cumulative amount of credits that would be issued to the applicant  
19 if the application were approved.

20 (3) The corporation has already approved the maximum amount of capital investment  
21 authority allowed under section 6 of this chapter.

22 (b) If the corporation denies any part of the application, it shall inform the applicant of the  
23 grounds for the denial. If the applicant provides any additional information required by the  
24 corporation or otherwise completes its application within fifteen (15) days of the notice of denial,  
25 the application shall be considered complete as of the original date of submission. If the applicant  
26 fails to provide the information or fails to complete its application within the fifteen (15) day period,  
27 the application shall remain denied and must be resubmitted with a new submission date and a new  
28 application fee.

29 Sec. 5. (a) Upon approval of an application, the corporation shall provide a certification of the  
30 proposed equity investment as a capital investment eligible for credits under this chapter, subject  
31 to the limitations set forth in section 6 of this chapter. The corporation shall provide written notice  
32 of the certification to the applicant, which must include the amount of the applicant's capital  
33 investment authority and a schedule of credits by year and amount related to the capital investment  
34 authority.

35 (b) The corporation shall certify proposed capital investments in the order that the applications  
36 are received by the corporation. Applications received on the same day shall be deemed to have  
37 been received simultaneously. For applications that are complete and received on the same day, the  
38 corporation shall certify applications in proportionate percentages based upon the ratio of the  
39 amount of capital investment authority requested in all applications.

40 Sec. 6. (a) Subject to IC 5-28-6-9, the corporation may not certify capital investment authority  
41 under this chapter in an amount that exceeds fifteen million dollars (\$15,000,000) in credits to be  
42 claimed against state tax liability in any calendar year, excluding any credit amounts carried  
43 forward under section 7 of this chapter.

44 (b) Within ninety (90) days of the applicant receiving notice of certification, the rural fund shall  
45 issue the capital investment to and receive cash in the amount of the certified amount from a rural  
46 investor. At least ten percent (10%) of the rural investor's capital investment shall be composed of  
47 capital raised by the rural investor directly or indirectly from sources including directors,  
48 members, employees, officers, and affiliates of the rural investor, other than the amount invested

1 by the allocatee claiming the credits in exchange for the allocation of credits. The rural fund shall  
2 provide the corporation with evidence of the receipt of the cash investment within ninety-five (95)  
3 days of the applicant receiving notice of certification.

4 (c) If the rural fund does not receive the cash investment and issue the capital investment within  
5 the time period following receipt of the certification set forth in section 5(a) of this chapter, the  
6 certification shall lapse and the rural fund shall not issue the capital investment without reapplying  
7 to the corporation for certification. Lapsed certifications shall revert to the corporation and shall  
8 be reissued on a pro rata basis to applicants whose capital investment allocations were reduced in  
9 accordance with the application process set forth in section 5 of this chapter.

10 Sec. 7. (a) Upon making a capital investment in a rural fund, a rural investor is entitled to a  
11 vested credit against the taxpayer's state tax liability that may be used on each credit allowance  
12 date of the capital investment in an amount equal to:

13 (1) the applicable percentage for the credit allowance date; multiplied by

14 (2) the purchase price paid to the rural fund for the capital investment.

15 (b) The amount of the credit claimed by a taxpayer shall not exceed the amount of the taxpayer's  
16 state tax liability for the tax year for which the credit is claimed. Any amount of credit that a  
17 taxpayer is prohibited from claiming in a tax year as a result of this section may be carried forward  
18 for use in any of the five (5) subsequent tax years.

19 (c) The credit shall not be carried back and is not refundable.

20 Sec. 8. No credit claimed under this chapter shall be refundable or saleable on the open market.  
21 Credits may be transferred to affiliates of a taxpayer. Credits earned by or allocated to a  
22 partnership, limited liability company, or S corporation may be allocated to the partners, members,  
23 or shareholders of such an entity for their use in accordance with the provisions of any agreement  
24 among such partners, members, or shareholders, and a rural fund shall notify the department of  
25 taxpayers that are eligible to utilize credits and transfers upon such allocation, change, or transfer.  
26 Such allocations shall not be considered a sale for the purpose of this section.

27 Sec. 9. To apply a credit under this chapter against the taxpayer's state tax liability, a taxpayer  
28 must claim the credit on the taxpayer's annual state tax return or returns in the manner prescribed  
29 by the department. The taxpayer must attach the certification provided by the corporation in  
30 accordance with section 5(a) of this chapter and any additional information that the department  
31 determines is necessary for the department to determine whether the taxpayer is eligible for the  
32 credit.

33 Sec. 10. (a) A credit is subject to recapture if any of the following circumstances apply:

34 (1) The rural fund does not invest:

35 (A) at least sixty percent (60%) of its capital investment authority in qualified investments  
36 in Indiana within two (2) years of the credit allowance date; and

37 (B) one hundred percent (100%) of its capital investment authority in qualified investments  
38 in Indiana within three (3) years of the credit allowance date.

39 (2) The rural fund fails to maintain qualified investments equal to one hundred percent  
40 (100%) of its capital investment authority from the third anniversary until the sixth  
41 anniversary of the credit allowance date. For purposes of this subdivision, a qualified  
42 investment is considered maintained even if the qualified investment was sold or repaid as long  
43 as the rural fund reinvests an amount equal to the capital returned or recovered or repaid by  
44 the rural fund from the original investment, exclusive of any profits realized, in other qualified  
45 investments in Indiana within twelve (12) months of receipt of the capital. Amounts received  
46 periodically by a rural fund shall be treated as maintained in qualified investments if the  
47 amounts are reinvested in one (1) or more qualified investments by the end of the following

1 calendar year. A rural fund is not required to reinvest capital returned from qualified  
2 investments after the fifth anniversary of the credit allowance date, and the qualified  
3 investments shall be considered maintained by the rural fund through the sixth anniversary  
4 of the credit allowance date.

5 (3) Before the earlier of:

6 (A) exiting the program in accordance with this chapter; or

7 (B) thirty (30) days after the sixth anniversary of the credit allowance date;

8 the rural fund makes a distribution or payment that results in the rural fund having less than  
9 one hundred percent (100%) of its capital investment authority invested in qualified  
10 investments in Indiana or held in cash or other marketable securities.

11 (4) The rural fund violates section 11 of this chapter, in which case the corporation may  
12 recapture an amount equal to the amount of the rural fund's capital investment authority  
13 found to be in violation of those provisions.

14 (b) Recaptured credits and related capital investment authority shall revert to the corporation  
15 and shall be reissued on a pro rata basis to applicants whose capital investment allocations were  
16 reduced in accordance with sections 3 through 5 of this chapter.

17 (c) No recapture shall occur until the rural fund has been given notice of noncompliance and  
18 afforded six (6) months from the date of the notice to cure the noncompliance.

19 (d) A rural fund, before making a qualified investment, may request from the corporation a  
20 written opinion as to whether the business in which it proposes to invest is an eligible business. The  
21 corporation, not later than fifteen (15) business days after the date of receipt of the request, shall  
22 notify the rural fund of its determination. If the corporation fails to notify the rural fund of its  
23 determination by the twentieth business day, the business in which the rural fund proposes to invest  
24 shall be deemed an eligible business.

25 Sec. 11. No eligible business that receives a qualified investment under this chapter or any  
26 affiliates of the eligible business shall directly or indirectly:

27 (1) own or have the right to acquire an ownership interest in a rural fund or in a member or  
28 affiliate of a rural fund including, but not limited to, a holder of a capital investment issued  
29 by a rural fund; or

30 (2) lend to or invest in a rural fund or any member or affiliate of a rural fund including, but  
31 not limited to, a holder of capital investment issued by a rural fund, where the proceeds of the  
32 loan or investment are directly or indirectly used to fund or refinance the purchase of capital  
33 investments under this chapter.

34 Sec. 12. (a) A rural fund shall submit a report to the corporation by June 30 of each calendar  
35 year during the credit allowance period.

36 (b) The report following the second anniversary of the initial credit allowance date shall provide  
37 documentation as to the investment of at least sixty percent (60%) of the purchase price of such  
38 capital investment in qualified investments.

39 (c) The report following the third anniversary of the initial credit allowance date shall provide  
40 documentation as to the investment of one hundred percent (100%) of the purchase price of such  
41 capital investment in qualified investments. Unless previously reported under this section, the  
42 report must also include the following information:

43 (1) The name and location of each eligible business receiving a qualified investment.

44 (2) Bank statements of the rural fund evidencing each qualified investment.

45 (3) A copy of the written opinion of the corporation, as provided in section 10(d) of this  
46 chapter, or evidence that the business was an eligible business at the time of the qualified  
47 investment, as applicable.

48 (4) The number of jobs created and jobs retained as a result of each qualified investment.

1 (5) The average salary of the jobs described in subdivision (4).

2 (6) Any other information required by the corporation.

3 (d) For all subsequent years, a rural fund shall submit an annual report to the corporation by  
4 June 30 of each calendar year during the credit allowance period, which must include the following  
5 information:

6 (1) The number of jobs created and jobs retained as a result of qualified investments.

7 (2) The average annual salary of jobs described in subdivision (1).

8 (3) Any other information required by the corporation.

9 Sec. 13. On or after the sixth anniversary of the credit allowance date, a rural fund may apply  
10 to the corporation to exit the program and no longer be subject to the requirements established  
11 under this chapter. The corporation shall respond to the exit application within fifteen (15) days  
12 of receipt. In evaluating the exit application, the fact that no credits have been recaptured and that  
13 the rural fund has not received a notice of recapture that has not been cured as allowed under  
14 section 10(c) of this chapter shall be sufficient evidence to prove that the rural fund is eligible for  
15 exit. The corporation shall not unreasonably deny an exit application submitted under this section.  
16 If an exit application is denied, the notice shall include the reasons for the determination.

17 SECTION 76. IC 6-3.1-34-11, AS AMENDED BY P.L.159-2021, SECTION 19, IS AMENDED TO  
18 READ AS FOLLOWS [EFFECTIVE JULY 1, 2025]: Sec. 11. (a) Subject to IC 5-28-6-9, a taxpayer may  
19 claim a credit against the taxpayer's state tax liability for a taxable year only if the corporation awards a  
20 credit to the taxpayer and enters into an agreement with the taxpayer as set forth under this chapter. The  
21 corporation may establish an application period for applying for awards. If an application period is  
22 established, the corporation shall establish policies and procedures necessary to administer the application  
23 period. The corporation may deny an application for a credit under this chapter in its sole discretion. A

32 (c) If a pass through entity may claim a credit under this section but does not have state tax liability  
33 against which the tax credit may be applied, a shareholder, partner, beneficiary, or member of the pass  
34 through entity may claim a credit equal to:

35 (1) the credit determined for the pass through entity for the taxable year; multiplied by

36 (2) the percentage of the pass through entity's distributive income that the shareholder, partner,  
37 beneficiary, or member may claim.

38 The credit provided under this subsection is in addition to a credit that a shareholder, partner, beneficiary,  
39 or member of a pass through entity may claim. However, a pass through entity and a shareholder, partner,  
40 beneficiary, or member of a pass through entity may not claim more than one (1) credit for the qualified  
41 investment.

42 (d) Notwithstanding subsections (a), (b), and (c), a pass through entity (other than an entity described  
43 in IC 6-3-1-35(1)) and its partners, beneficiaries, or members may allocate the credit among its partners,  
44 beneficiaries, or members of the pass through entity as provided by written agreement without regard to  
45 their sharing of other tax or economic attributes. Such agreements shall be filed with the corporation not  
46 later than fifteen (15) days after execution. The pass through entity shall also provide a copy of such  
47 agreements, a list of partners, beneficiaries, or members of the pass through entity, and their respective

1 shares of the credit resulting from such agreements in the manner prescribed by the department of state

9 **Sec. 1. As used in this chapter, "corporation" means the Indiana economic development**  
10 **corporation established by IC 5-28-3-1.**

11 **Sec. 2. As used in this chapter, "credit" refers to a credit allowed under this chapter.**

12 **Sec. 3. As used in this chapter, "eligible business" means an individual, corporation, partnership,**  
13 **estate, trust, or other entity that employs at least five (5) employees based in Indiana.**

14 **Sec. 4. As used in this chapter, "eligible employee" means an employee of an eligible business**  
15 **who:**

16 (1) worked as a full-time employee for an eligible business in Indiana for the calendar year  
17 immediately preceding the calendar year in which the employee's training begins;

18 (2) received an average annual wage from the eligible business after completion of the training  
19 that exceeds both:

20 (A) the average annual wage the employee received before beginning the training:

21 (i) by at least twenty-five percent (25%); and

22 (ii) for at least two (2) calendar quarters; and

23 (B) the average annual wage of an individual in the economic growth region in which the  
24 employee resides; and

25 (3) is not a shareholder, partner, member, or beneficiary of the eligible business, or the spouse  
26 or dependent of a shareholder, partner, member, or beneficiary of the eligible business.

27 **Sec. 5. As used in this chapter, "eligible training costs" means amounts paid by an eligible**  
28 **business for training costs incurred after December 31, 2025, on behalf of an employee that are**  
29 **reasonably intended to result in the employee acquiring or improving skills related to the**  
30 **employee's current or future work for the eligible business.**

31 **Sec. 6. As used in this chapter, "pass through entity" has the meaning set forth in IC 6-3-1-35.**

32 **Sec. 7. As used in this chapter, "state tax liability" means a taxpayer's total tax liability that is**  
33 **incurred under:**

34 (1) IC 6-3-1 through IC 6-3-7 (the adjusted gross income tax);

35 (2) IC 27-1-18-2 (the insurance premiums tax) or IC 6-8-15 (the nonprofit agricultural  
36 organization health coverage tax); and

37 (3) IC 6-5.5 (the financial institutions tax);

38 **as computed after the application of the credits that under IC 6-3.1-1-2 are to be applied before the**  
39 **credit provided by this chapter.**

40 **Sec. 8. As used in this chapter, "taxpayer" means an eligible business with any state tax liability.**

41 **Sec. 9. As used in this chapter, "training" means a course of instruction intended to increase the**  
42 **marketable skills of an eligible employee.**

43 **Sec. 10. As used in this chapter, "wages" has the meaning set forth in IC 22-4-4-2.**

44 **Sec. 11. An eligible business may apply to the corporation for a tax credit under this chapter. The**  
45 **corporation shall prescribe the form and contents of the application. The corporation may request**  
46 **any information required to determine the amount of credit allowable under this chapter.**

47 **Sec. 12. (a) Subject to subsection (b) and section 17 of this chapter, a taxpayer is entitled to a**

1 credit under this chapter in the amount equal to the lesser of:

- 2 (1) the eligible training costs paid for an eligible employee and certified by the corporation;
- 3 or
- 4 (2) five thousand dollars (\$5,000).

5 (b) A taxpayer may not be awarded aggregate credits totaling more than fifty thousand dollars  
6 (\$50,000) for eligible training costs paid on behalf of all eligible employees of the taxpayer.

7 (c) The corporation may decline to award all or part of a credit to a taxpayer if the corporation  
8 determines that the taxpayer's credit claim is intended to permit one (1) or more taxpayers to claim

11 Sec. 13. (a) Subject to sections 12 and 17 of this chapter, a taxpayer must be awarded a credit

- 14 (2) the eligible employee's average annual wage is at least an amount described in section 4(2)  
15 of this chapter.

16 (b) The first taxable year for which a taxpayer may claim the credit is the first taxable year for  
17 which an eligible employee meets the requirements in subsection (a) as certified by the corporation.

18 Sec. 14. (a) If a pass through entity does not have state income tax liability against which the  
19 credit provided by this chapter may be applied, a shareholder, partner, beneficiary, or member of  
20 the pass through entity is entitled to a credit equal to:

- 21 (1) the credit determined for the pass through entity for the taxable year; multiplied by
- 22 (2) the percentage of the pass through entity's distributive income to which the shareholder,  
23 partner, beneficiary, or member is entitled.

24 (b) The credit provided under subsection (a) is in addition to a credit to which a shareholder,  
25 partner, or member of a pass through entity is otherwise entitled under this chapter.

26 (c) Notwithstanding subsections (a) and (b), for a credit awarded to a pass through entity that  
27 is an estate or trust, the estate or trust may elect to retain all or part of the credit to apply against  
28 its own state tax liability and attribute the remaining portion of the credit to its beneficiaries as  
29 provided under subsection (a). Such election shall be made in the first year in which the estate or  
30 trust is permitted the credit and shall be irrevocable, except that the estate or trust may distribute  
31 any remaining portion of the credit in the manner provided in subsection (a) upon termination of  
32 the estate or trust.

33 Sec. 15. (a) If the amount of the credit determined under section 12 of this chapter for a taxpayer  
34 in a taxable year exceeds the taxpayer's state tax liability for that taxable year, the taxpayer may  
35 carry the excess credit over for a period not to exceed the taxpayer's following nine (9) taxable  
36 years.

37 (b) The amount of the credit carryover from a taxable year shall be reduced to the extent that  
38 the carryover is used by the taxpayer to obtain a credit under this chapter for any subsequent

40 (c) A taxpayer is not entitled to a carryback or a refund of any unused credit amount.

41 (d) A taxpayer may not assign any portion of the credit under this chapter.

42 Sec. 16. A taxpayer shall report the credit under this chapter in the manner prescribed by the

44 Sec. 17. (a) A tax credit awarded under this chapter is subject to the limitations set forth in  
45 IC 5-28-6-9.

46 (b) The aggregate amount of tax credits allowed under this chapter may not exceed four million  
47 dollars (\$4,000,000) in a state fiscal year.

48 Sec. 18. The department may adopt rules under IC 4-22-2 to carry out the provisions of this

2 SECTION 79. IC 6-3.1-47 IS ADDED TO THE INDIANA CODE AS A NEW CHAPTER TO READ  
3 AS FOLLOWS [EFFECTIVE JANUARY 1, 2026]:

4 **Chapter 47. Beginning Farmer Tax Credit**

5 **Sec. 1. This chapter applies to taxable years beginning after December 31, 2025, and ending**  
6 **before January 1, 2028.**

7 **Sec. 2. As used in this chapter, "agricultural asset" means agricultural land, livestock, facilities,**  
8 **buildings, and machinery used for agricultural production in Indiana.**

9 **Sec. 3. As used in this chapter, "agricultural land" means land that is composed of tracts, lots,**  
10 **or parcels totaling not less than ten (10) acres devoted to agricultural production or totaling less**  
11 **than ten (10) acres devoted to agricultural production if the land produces an average yearly gross**  
12 **income of at least two thousand five hundred dollars (\$2,500) from agricultural production.**

13 **Sec. 4. As used in this chapter, "agricultural production" means commercial aquaculture,**  
14 **algaculture (meaning the farming of algae), apiculture, animal husbandry, or poultry husbandry;**  
15 **the production for a commercial purpose of timber, field crops, tobacco, fruits, vegetables, nursery**  
16 **stock, ornamental shrubs, ornamental trees, flowers, or sod; the growth of timber for a**  
17 **noncommercial purpose if the land on which the timber is grown is contiguous to or part of a parcel**  
18 **of land under common ownership that is otherwise devoted exclusively to agricultural use; or any**  
19 **combination of such husbandry, production, or growth; and includes the processing, drying,**  
20 **storage, and marketing of agricultural products when those activities are conducted in conjunction**  
21 **with such husbandry, production, or growth.**

22 **Sec. 5. As used in this chapter, "beginning farmer" means an individual who has been certified**  
23 **as a beginning farmer by the department of agriculture.**

24 **Sec. 6. As used in this chapter, "department of agriculture" means the Indiana state department**  
25 **of agriculture established by IC 15-11-2-1.**

26 **Sec. 7. As used in this chapter, "owner of agricultural assets" means a person that is the owner**  
27 **in fee of agricultural land or that has legal title to any other agricultural asset. The term does not**  
28 **include an equipment dealer or comparable entity engaged in the business of selling agricultural**  
29 **assets for profit.**

30 **Sec. 8. As used in this chapter, "share rent agreement" means a rental agreement in which the**  
31 **principal consideration given to the owner of agricultural assets is a predetermined portion of the**  
32 **production of the agricultural products produced from the rented agricultural assets and which**  
33 **provides for sharing production costs or risk of loss.**

34 **Sec. 9. The director of the department of agriculture shall certify individuals as beginning**  
35 **farmers. An individual may apply to the director, and the director shall provide the certification,**  
36 **if the director determines that the individual meets all of the requirements of this section. The**

3 (6) Provides the majority of the daily physical labor and management of the farm.

4 (7) Has adequate farming experience or knowledge in the type of farming for which they are  
5 seeking assistance.

6 (8) Submits projected earnings statements and demonstrates a profit potential.

7 (9) Demonstrates farming will be a significant source of income for the individual.

8 (10) Participates in a financial management program approved by the department of  
9 agriculture.

10 **Sec. 10. (a)** The owner of agricultural assets who sells agricultural assets to a beginning farmer  
11 during the calendar year or who rents agricultural assets to a beginning farmer during the calendar  
12 year may apply to the director of the department of agriculture for a tax credit under this chapter.

26 of HEA 1001-2023 for "Northern IN Regional Economic Dev" shall remain available through June  
27 30, 2027, to be spent on supporting potential regional economic development projects. The Northern  
28 Indiana Regional Development Authority may create a regional revolving loan fund administered  
29 by the regional development authority for eligible capital projects. The funds can be used for  
30 expenses including fixed asset loans, land costs, building costs, project gap funding, and grants for  
31 nonprofit entities. If the revolving loan fund issues a grant to a nonprofit entity, the grant shall not  
32 exceed one million dollars (\$1,000,000) and shall require a dollar for dollar match. Up to two  
33 million dollars (\$2,000,000) may be set aside for the purpose of accruing interest. Only the interest  
34 may be used for administrative expenses incurred in administering the fund. The regional  
35 development authority must submit an annual report to the budget committee detailing the balance  
36 of the revolving loan fund and the progress of the projects that have received funding by July 1,  
37 2026, and by July 1 of each year thereafter.

38 SECTION 218. [EFFECTIVE UPON PASSAGE] The amounts appropriated under SECTION 30  
39 of HEA 1001-2023 for "Northeast IN Regional Economic Dev" shall remain available through June  
40 30, 2027. Up to two million dollars (\$2,000,000) may be set aside for the purpose of accruing  
41 interest. The authority must submit an annual report to the budget committee detailing the projects  
42 that have received funding by July 1, 2026, and by July 1 of each year thereafter.

43 SECTION 219. An emergency is declared for this act.
