AN ACT

To repeal section 208.952, RSMo, and to enact in lieu thereof one new section relating to the joint committee on MO HealthNet.

Be it enacted by the General Assembly of the State of Missouri, as follows:

Section A. Section 208.952, RSMo, is repealed and one new section 2 enacted in lieu thereof, to be known as section 208.952, to read as follows:

208.952. 1. There is hereby established [the] a permanent "Joint

- 2 Committee on MO HealthNet". The committee shall have as its purpose the
- 3 study, monitoring, and review of the efficacy of the program as well as
- 4 the resources needed to continue and improve the MO HealthNet program over
- 5 time. The committee shall receive and obtain information from the
- 6 departments of social services, mental health, health and senior
- 7 services, and elementary and secondary education, as applicable,
- $8\,\,$ regarding the projected budget of the entire MO HealthNet program
- 9 including projected MO HealthNet enrollment growth, categorized by
- 10 population and geographic area. The committee shall consist of ten
- 11 members:
- 12 (1) The chair and the ranking minority member of the house committee
- 13 on the budget;
- 14 (2) The chair and the ranking minority member of the senate committee
- 15 on appropriations [committee];
- 16 (3) The chair and the ranking minority member of the house committee
- 17 on appropriations [for health, mental health, and social services] designated to
- 18 consider MO HealthNet legislation and matters;

- 19 (4) The chair and the ranking minority member of the **standing** senate 20 committee [on health and mental health] designated to consider MO 21HealthNet legislation and matters;
- 22 (5) A representative chosen by the speaker of the house of representatives; 23 and
- 24(6) A senator chosen by the president pro tem of the senate.
- No more than three members from each house shall be of the same political party. 25
- 26 2. A chair of the committee shall be selected by the members of the 27 committee.
- 3. The committee shall meet [as necessary] at least twice a year. The committee shall provide notice to the public thirty days prior to any meeting of the committee. A portion of the meeting shall be set aside 31 for the purpose of receiving public testimony. In the event of three 32consecutive absences on the part of any member, such member may be 33 removed from the committee. The committee shall seek from statewide organizations representing health care professionals any recommendations they have to improve the quality of health care and its cost.
- 37 4. [Nothing in this section shall be construed as authorizing the 38 committee to hire employees or enter into any employment contracts] The committee is authorized to hire an employee or enter into employment 39 contracts, including an executive director to conduct an audit, special 40 review or investigation of the MO HealthNet program in order to assist 42the committee with its duties. The employee or executive director shall be authorized to conduct an audit, special review, or investigation into 43 any contract between the MO HealthNet program and a vendor for the provision of services to the program. Such executive director shall 45have free access to all divisions or offices within the departments of 46 social services, health and senior services, or mental health associated 4748 with the MO HealthNet program for the inspection of such books, 49 accounts, contracts, data, and papers as concern any of the executive 50 director's duties. The compensation of such personnel and the 51expenses of the committee shall be paid from the joint contingent fund 52or jointly from the senate and house contingent funds until an appropriation is made therefor. 53
 - 5. [The committee shall receive and study the five-year rolling MO

6.] The committee shall annually conduct a rolling five-year MO HealthNet forecast and make recommendations in a report to the general assembly by January first each year, beginning in [2008] 2017, on anticipated growth in the MO HealthNet program, needed improvements, anticipated needed appropriations, and suggested strategies on ways to structure the state budget in order to satisfy the future needs of the program.
