26 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MONTANA:

Section 1. Section 15-30-2110, MCA, is amended to read:

28
29 **"15-30-2110. Adjusted gross income.** (1) Subject to subsection (13), adjusted gross income is the
30 taxpayer's federal adjusted gross income as defined in section 62 of the Internal Revenue Code, 26 U.S.C. 62,



1 and in addition includes the following:

2 (a) (i) interest received on obligations of another state or territory or county, municipality, district, or other
3 political subdivision of another state, except to the extent that the interest is exempt from taxation by Montana
4 under federal law;

5 (ii) exempt-interest dividends as defined in section 852(b)(5) of the Internal Revenue Code, 26 U.S.C.
6 852(b)(5), that are attributable to the interest referred to in subsection (1)(a)(i);

7 (b) refunds received of federal income tax, to the extent that the deduction of the tax resulted in a
8 reduction of Montana income tax liability;

9 (c) that portion of a shareholder's income under subchapter S. of Chapter 1 of the Internal Revenue
10 Code that has been reduced by any federal taxes paid by the subchapter S. corporation on the income;

11 (d) depreciation or amortization taken on a title plant as defined in 33-25-105;

12 (e) the recovery during the tax year of an amount deducted in any prior tax year to the extent that the
13 amount recovered reduced the taxpayer's Montana income tax in the year deducted;

14 (f) if the state taxable distribution of an estate or trust is greater than the federal taxable distribution of
15 the same estate or trust, the difference between the state taxable distribution and the federal taxable distribution
16 of the same estate or trust for the same tax period; and

17 (g) except for exempt-interest dividends described in subsection (2)(a)(ii), for tax years commencing after
18 December 31, 2002, the amount of any dividend to the extent that the dividend is not included in federal adjusted
19 gross income.

20 (2) Notwithstanding the provisions of the Internal Revenue Code, adjusted gross income does not
21 include the following, which are exempt from taxation under this chapter:

22 (a) (i) all interest income from obligations of the United States government, the state of Montana, or a
23 county, municipality, district, or other political subdivision of the state and any other interest income that is exempt
24 from taxation by Montana under federal law;

25 (ii) exempt-interest dividends as defined in section 852(b)(5) of the Internal Revenue Code, 26 U.S.C.
26 852(b)(5), that are attributable to the interest referred to in subsection (2)(a)(i);

27 (b) interest income earned by a taxpayer who is 65 years of age or older in a tax year up to and including
28 \$800 for a taxpayer filing a separate return and \$1,600 for each joint return;

29 (c) (i) except as provided in subsection (2)(c)(ii), the first \$3,600 of all pension and annuity income
30 received as defined in 15-30-2101;

- 1 (ii) for pension and annuity income described under subsection (2)(c)(i), as follows:
- 2 (A) each taxpayer filing singly, head of household, or married filing separately shall reduce the total
3 amount of the exclusion provided in subsection (2)(c)(i) by \$2 for every \$1 of federal adjusted gross income in
4 excess of \$30,000 as shown on the taxpayer's return;
- 5 (B) in the case of married taxpayers filing jointly, if both taxpayers are receiving pension or annuity
6 income or if only one taxpayer is receiving pension or annuity income, the exclusion claimed as provided in
7 subsection (2)(c)(i) must be reduced by \$2 for every \$1 of federal adjusted gross income in excess of \$30,000
8 as shown on their joint return;
- 9 (d) all Montana income tax refunds or tax refund credits;
- 10 (e) gain required to be recognized by a liquidating corporation under 15-31-113(1)(a)(ii);
- 11 (f) all tips or gratuities that are covered by section 3402(k) or service charges that are covered by section
12 3401 of the Internal Revenue Code of 1954, 26 U.S.C. 3402(k) or 3401, as amended and applicable on January
13 1, 1983, received by a person for services rendered to patrons of premises licensed to provide food, beverage,
14 or lodging;
- 15 (g) all benefits received under the workers' compensation laws;
- 16 (h) all health insurance premiums paid by an employer for an employee if attributed as income to the
17 employee under federal law, ~~including premiums paid by the employer for an employee pursuant to 33-22-166;~~
- 18 (i) all money received because of a settlement agreement or judgment in a lawsuit brought against a
19 manufacturer or distributor of "agent orange" for damages resulting from exposure to "agent orange";
- 20 (j) principal and income in a medical care savings account established in accordance with 15-61-201
21 or withdrawn from an account for eligible medical expenses, as defined in 15-61-102, of the taxpayer or a
22 dependent of the taxpayer or for the long-term care of the taxpayer or a dependent of the taxpayer;
- 23 (k) principal and income in a first-time home buyer savings account established in accordance with
24 15-63-201 or withdrawn from an account for eligible costs, as provided in 15-63-202(7), for the first-time purchase
25 of a single-family residence;
- 26 (l) contributions or earnings withdrawn from a family education savings account or from a qualified tuition
27 program established and maintained by another state as provided by section 529(b)(1)(A)(ii) of the Internal
28 Revenue Code, 26 U.S.C. 529(b)(1)(A)(ii), for qualified higher education expenses, as defined in 15-62-103, of
29 a designated beneficiary;
- 30 (m) the recovery during the tax year of any amount deducted in any prior tax year to the extent that the

1 recovered amount did not reduce the taxpayer's Montana income tax in the year deducted;

2 (n) if the federal taxable distribution of an estate or trust is greater than the state taxable distribution of
3 the same estate or trust, the difference between the federal taxable distribution and the state taxable distribution
4 of the same estate or trust for the same tax period;

5 (o) deposits, not exceeding the amount set forth in 15-30-3003, deposited in a Montana farm and ranch
6 risk management account, as provided in 15-30-3001 through 15-30-3005, in any tax year for which a deduction
7 is not provided for federal income tax purposes;

8 (p) income of a dependent child that is included in the taxpayer's federal adjusted gross income pursuant
9 to the Internal Revenue Code. The child is required to file a Montana personal income tax return if the child and
10 taxpayer meet the filing requirements in 15-30-2602.

11 (q) principal and income deposited in a health care expense trust account, as defined in 2-18-1303, or
12 withdrawn from the account for payment of qualified health care expenses as defined in 2-18-1303;

13 (r) that part of the refundable credit provided in 33-22-2006 that reduces Montana tax below zero; and

14 (s) the amount of the gain recognized from the sale or exchange of a mobile home park as provided in
15 15-31-163.

16 (3) A shareholder of a DISC that is exempt from the corporate income tax under 15-31-102(1)(l) shall
17 include in the shareholder's adjusted gross income the earnings and profits of the DISC in the same manner as
18 provided by section 995 of the Internal Revenue Code, 26 U.S.C. 995, for all periods for which the DISC election
19 is effective.

20 (4) A taxpayer who, in determining federal adjusted gross income, has reduced the taxpayer's business
21 deductions by an amount for wages and salaries for which a federal tax credit was elected under sections 38 and
22 51(a) of the Internal Revenue Code, 26 U.S.C. 38 and 51(a), is allowed to deduct the amount of the wages and
23 salaries paid regardless of the credit taken. The deduction must be made in the year that the wages and salaries
24 were used to compute the credit. In the case of a partnership or small business corporation, the deduction must
25 be made to determine the amount of income or loss of the partnership or small business corporation.

26 (5) Married taxpayers filing a joint federal return who are required to include part of their social security
27 benefits or part of their tier 1 railroad retirement benefits in federal adjusted gross income may split the federal
28 base used in calculation of federal taxable social security benefits or federal taxable tier 1 railroad retirement
29 benefits when they file separate Montana income tax returns. The federal base must be split equally on the
30 Montana return.

1 (6) Married taxpayers filing a joint federal return who are allowed a capital loss deduction under section
2 1211 of the Internal Revenue Code, 26 U.S.C. 1211, and who file separate Montana income tax returns may
3 claim the same amount of the capital loss deduction that is allowed on the federal return. If the allowable capital
4 loss is clearly attributable to one spouse, the loss must be shown on that spouse's return; otherwise, the loss
5 must be split equally on each return.

6 (7) In the case of passive and rental income losses, married taxpayers filing a joint federal return and
7 who file separate Montana income tax returns are not required to recompute allowable passive losses according
8 to the federal passive activity rules for married taxpayers filing separately under section 469 of the Internal
9 Revenue Code, 26 U.S.C. 469. If the allowable passive loss is clearly attributable to one spouse, the loss must
10 be shown on that spouse's return; otherwise, the loss must be split equally on each return.

11 (8) Married taxpayers filing a joint federal return in which one or both of the taxpayers are allowed a
12 deduction for an individual retirement contribution under section 219 of the Internal Revenue Code, 26 U.S.C.
13 219, and who file separate Montana income tax returns may claim the same amount of the deduction that is
14 allowed on the federal return. The deduction must be attributed to the spouse who made the contribution.

15 (9) (a) Married taxpayers filing a joint federal return who are allowed a deduction for interest paid for a
16 qualified education loan under section 221 of the Internal Revenue Code, 26 U.S.C. 221, and who file separate
17 Montana income tax returns may claim the same amount of the deduction that is allowed on the federal return.
18 The deduction may be split equally on each return or in proportion to each taxpayer's share of federal adjusted
19 gross income.

20 (b) Married taxpayers filing a joint federal return who are allowed a deduction for qualified tuition and
21 related expenses under section 222 of the Internal Revenue Code, 26 U.S.C. 222, and who file separate Montana
22 income tax returns may claim the same amount of the deduction that is allowed on the federal return. The
23 deduction may be split equally on each return or in proportion to each taxpayer's share of federal adjusted gross
24 income.

25 (10) A taxpayer receiving retirement disability benefits who has not attained 65 years of age by the end
26 of the tax year and who has retired as permanently and totally disabled may exclude from adjusted gross income
27 up to \$100 a week received as wages or payments in lieu of wages for a period during which the employee is
28 absent from work due to the disability. If the adjusted gross income before this exclusion exceeds \$15,000, the
29 excess reduces the exclusion by an equal amount. This limitation affects the amount of exclusion, but not the
30 taxpayer's eligibility for the exclusion. If eligible, married individuals shall apply the exclusion separately, but the

1 limitation for income exceeding \$15,000 is determined with respect to the spouses on their combined adjusted
2 gross income. For the purpose of this subsection, "permanently and totally disabled" means unable to engage
3 in any substantial gainful activity by reason of any medically determined physical or mental impairment lasting
4 or expected to last at least 12 months.

5 (11) (a) An individual who contributes to one or more accounts established under the Montana family
6 education savings program or to a qualified tuition program established and maintained by another state as
7 provided by section 529(b)(1)(A)(ii) of the Internal Revenue Code, 26 U.S.C. 529(b)(1)(A)(ii), may reduce adjusted
8 gross income by the lesser of \$3,000 or the amount of the contribution. In the case of married taxpayers, each
9 spouse is entitled to a reduction, not in excess of \$3,000, for the spouses' contributions to the accounts. Spouses
10 may jointly elect to treat half of the total contributions made by the spouses as being made by each spouse. The
11 reduction in adjusted gross income under this subsection applies only with respect to contributions to an account
12 of which the account owner is the taxpayer, the taxpayer's spouse, or the taxpayer's child or stepchild if the
13 taxpayer's child or stepchild is a Montana resident. The provisions of subsection (1)(e) do not apply with respect
14 to withdrawals of contributions that reduced adjusted gross income.

15 (b) Contributions made pursuant to this subsection (11) are subject to the recapture tax provided in
16 15-62-208.

17 (12) (a) A taxpayer may exclude the amount of the loan payment received pursuant to subsection
18 (12)(a)(iv), not to exceed \$5,000, from the taxpayer's adjusted gross income if the taxpayer:

19 (i) is a health care professional licensed in Montana as provided in Title 37;

20 (ii) is serving a significant portion of a designated geographic area, special population, or facility
21 population in a federally designated health professional shortage area, a medically underserved area or
22 population, or a federal nursing shortage county as determined by the secretary of health and human services
23 or by the governor;

24 (iii) has had a student loan incurred as a result of health-related education; and

25 (iv) has received a loan payment during the tax year made on the taxpayer's behalf by a loan repayment
26 program described in subsection (12)(b) as an incentive to practice in Montana.

27 (b) For the purposes of subsection (12)(a), a loan repayment program includes a federal, state, or
28 qualified private program. A qualified private loan repayment program includes a licensed health care facility, as
29 defined in 50-5-101, that makes student loan payments on behalf of the person who is employed by the facility
30 as a licensed health care professional.

1 (13) Notwithstanding the provisions of subsection (1), adjusted gross income does not include 40% of
 2 capital gains on the sale or exchange of capital assets before December 31, 1986, as capital gains are
 3 determined under subchapter P. of Chapter 1 of the Internal Revenue Code as it read on December 31, 1986.

4 (14) By November 1 of each year, the department shall multiply the amount of pension and annuity
 5 income contained in subsection (2)(c)(i) and the federal adjusted gross income amounts in subsection (2)(c)(ii)
 6 by the inflation factor for that tax year, but using the year 2009 consumer price index, and rounding the results
 7 to the nearest \$10. The resulting amounts are effective for that tax year and must be used as the basis for the
 8 exemption determined under subsection (2)(c). (Subsection (2)(f) terminates on occurrence of contingency--sec.
 9 3, Ch. 634, L. 1983; subsection (2)(o) terminates on occurrence of contingency--sec. 9, Ch. 262, L. 2001.)"

11 **Section 2.** Section 17-6-606, MCA, is amended to read:

12 **"17-6-606. Tobacco settlement accounts -- purpose -- uses.** (1) The purpose of this section is to
 13 dedicate a portion of the tobacco settlement proceeds to fund statewide programs for tobacco disease prevention
 14 designed to:

15 (a) discourage children from starting use of tobacco;

16 (b) assist adults in quitting use of tobacco; and

17 (c) provide funds for the children's health insurance program; ~~and~~

18 ~~— (d) provide funds for the comprehensive health association programs.~~

19 (2) An amount equal to 32% of the total yearly tobacco settlement proceeds received after June 30,
 20 2003, must be deposited in a state special revenue account. Subject to subsection (5), the funds referred to in
 21 this subsection may be used only for funding statewide programs for tobacco disease prevention designed to
 22 prevent children from starting tobacco use and to help adults who want to quit tobacco use. The department of
 23 public health and human services shall manage the tobacco disease prevention programs and shall adopt rules
 24 to implement the programs. In adopting rules, the department shall consider the standards contained in Best
 25 Practices for Comprehensive Tobacco Control Programs--August 1999 or its successor document, published by
 26 the U.S. department of health and human services, centers for disease control and prevention.

27 (3) An amount equal to 17% of the total yearly tobacco settlement proceeds received after June 30,
 28 2003, must be deposited in a state special revenue account. Subject to subsection (5), the funds referred to in
 29 this subsection may be used only for:

30 (a) matching funds to secure the maximum amount of federal funds for the Children's Health Insurance

1 Program Act provided for in Title 53, chapter 4, part 10; and

2 ~~—— (b) programs of the comprehensive health association provided for in Title 33, chapter 22, part 15, with~~
3 ~~funding use subject to 33-22-1513.~~

4 (4) Funds deposited in a state special revenue account, as provided in subsection (2) or (3), that are not
5 appropriated within 2 years after the date of deposit must be transferred to the trust fund.

6 (5) The legislature shall appropriate money from the state special revenue accounts provided for in this
7 section for programs for tobacco disease prevention, for the programs referred to in the subsection establishing
8 the account, and for funding the tobacco prevention advisory board.

9 (6) Programs funded under this section that are private in nature may be funded through contracted
10 services."

12 **Section 3.** Section 27-1-732, MCA, is amended to read:

13 **"27-1-732. Immunity of nonprofit corporation officers, directors, and volunteers.** (1) An officer,
14 director, or volunteer of a nonprofit corporation is not individually liable for any action or omission made in the
15 course and scope of the officer's, director's, or volunteer's official capacity on behalf of the nonprofit corporation.
16 This section does not apply to liability for willful or wanton misconduct. The immunity granted by this section does
17 not apply to the liability of a nonprofit corporation.

18 (2) For purposes of this section, "nonprofit corporation" means:

19 (a) an organization exempt from taxation under section 501(c) of the Internal Revenue Code, 26 U.S.C.
20 501(c), as amended; or

21 (b) a corporation or organization that is eligible for or has been granted tax-exempt status by the
22 department of revenue under the provisions of 15-31-102; ~~or~~

23 ~~—— (c) the comprehensive health association created by 33-22-1503."~~

25 **Section 4.** Section 30-10-205, MCA, is amended to read:

26 **"30-10-205. Registration by qualification.** (1) Any security may be registered by qualification. A
27 registration statement under this section must contain the following information and be accompanied by the
28 following documents, in addition to payment of the registration fee prescribed in 30-10-209:

29 (a) with respect to the issuer and any significant subsidiary: its name, address, form of organization, the
30 state or foreign jurisdiction and date of its organization, the general character and location of its business, and

1 a description of its physical properties and equipment;

2 (b) with respect to every director and officer of the issuer or person occupying a similar status or
3 performing similar functions: the person's name, address, and principal occupation for the past 5 years, the
4 amount of securities of the issuer held by the person as of a specified date within 90 days of the filing of the
5 registration statement, the remuneration paid to all listed persons in the aggregate during the past 12 months and
6 estimated to be paid during the next 12 months, directly or indirectly, by the issuer, together with all predecessors,
7 parents, and subsidiaries;

8 (c) with respect to any person not named in subsection (1)(b) owning of record, or beneficially if known,
9 10% or more of the outstanding shares of any class of equity security of the issuer: the information specified in
10 subsection (1)(b) other than the person's occupation;

11 (d) with respect to every promoter not named in subsection (1)(b), if the issuer was organized within the
12 past 3 years: the information specified in subsection (1)(b), any amount paid to the promoter by the issuer within
13 that period or intended to be paid to the promoter, and the consideration for any payment;

14 (e) the capitalization and long-term debt, on both a current and a pro forma basis, of the issuer and any
15 significant subsidiary, including a description of each security outstanding or being registered or otherwise
16 offered, and a statement of the amount and kind of consideration, whether in the form of cash, physical assets,
17 services, patents, goodwill, or anything else, for which the issuer or any subsidiary has issued any of its securities
18 within the past 2 years or is obligated to issue any of its securities;

19 (f) the kind and amount of securities to be offered; the amount to be offered in this state; the proposed
20 offering price and any variation from the offering price at which any portion of the offering is to be made to any
21 persons except as underwriting and selling discounts and commissions; the estimated aggregate underwriting
22 and selling discounts, commissions, and other promotional fees, including separately cash, securities, or anything
23 else of value to accrue to the underwriters in connection with the offering; the estimated amounts of other selling
24 expenses, and legal, engineering, and accounting expenses to be incurred by the issuer in connection with the
25 offering; the name and address of every underwriter and every recipient of a promotional fee; a copy of any
26 underwriting or selling group agreement pursuant to which the distribution is to be made, or the proposed form
27 of any agreement whose terms have not yet been determined; and a description of the plan of distribution of any
28 securities that are to be offered otherwise than through an underwriter;

29 (g) the estimated cash proceeds to be received by the issuer from the offering, the purposes for which
30 the proceeds are to be used by the issuer, the amount to be used for each purpose, the amounts of any funds

1 to be raised from other sources to achieve the purposes stated and the sources of the additional funds, and, if
 2 any part of the proceeds is to be used to acquire any property, including goodwill, otherwise than in the ordinary
 3 course of business, the names and addresses of the vendors and the purchase price;

4 (h) a description of any stock options or other security options outstanding or to be created in connection
 5 with the offering, together with the amount of any options held or to be held by every person required to be named
 6 in subsection (1)(b), (1)(c), (1)(d), (1)(e), or (1)(g) and by any person who holds or will hold 10% or more in the
 7 aggregate of any options;

8 (i) the states in which a registration statement or similar document in connection with the offering has
 9 been or is expected to be filed;

10 (j) any adverse order, judgment, or decree previously entered in connection with the offering by any court
 11 or the securities and exchange commission;

12 (k) a description of any pending litigation or proceeding to which the issuer is a party and that materially
 13 affects its business or assets, including any litigation or proceeding known to be contemplated by governmental
 14 authorities;

15 ~~(k)(l)~~ a copy of any prospectus or circular intended as of the effective date to be used in connection with
 16 the offering;

17 ~~(l)(m)~~ if the issuer issues a document showing ownership of the security being registered, a specimen
 18 or copy of the security being registered, document;

19 (n) a copy of the issuer's articles of incorporation and bylaws as currently in effect, ~~and;~~

20 (o) a copy of any indenture or other instrument covering the security to be registered;

21 ~~(m)(p)~~ a signed or conformed copy of an opinion of counsel, if available, as to the legality of the security
 22 being registered;

23 ~~(n)(q)~~ a balance sheet of the issuer as of a date within 4 months prior to the filing of the registration
 24 statement, a profit and loss statement and analysis of surplus for each of the 3 fiscal years preceding the date
 25 of the balance sheet and for any period between the close of the last fiscal year and the date of the balance sheet
 26 or for the period of the issuer's and any predecessor's existence if less than 3 years, and, if any part of the
 27 proceeds of the offering is to be applied to the purchase of any business, the same financial statements that
 28 would be required if that business were the registrant;

29 ~~(o)(r)~~ a consent to service of process meeting the requirements of 30-10-208; and

30 ~~(p)(s)~~ other information that the commissioner may require.

1 (2) In the case of a nonissuer distribution, information may not be required under this section unless it
2 is known to the person filing the registration statement or to the persons on whose behalf the distribution is to be
3 made or can be furnished by them without unreasonable effort or expense.

4 (3) A registration statement by qualification under this section becomes effective when the commissioner
5 so orders. The commissioner may require as a condition of registration under this section that a prospectus
6 containing any designated part of the information specified in this section be sent or given to each person to

 29 which the settlements, releases, and judgments may be properly contested;

1 of labor and industry for workers' compensation claims;

2 (e) shall handle claims through its employees or through one or more insurers or other persons
3 designated as servicing facilities. Designation of a servicing facility is subject to the approval of the commissioner,
4 but the designation may be declined by a member insurer.

5 (f) shall reimburse each servicing facility for obligations of the association paid by the facility and for
6 expenses incurred by the facility while handling claims on behalf of the association and shall pay the other
7 expenses of the association authorized by this part.

8 (2) (a) Except as provided in subsection (2)(b), a covered claim may not include a claim filed with the
9 association or a liquidator for protection under the insured's policy for losses incurred but not reported and may
10 not include a claim filed with the association after the earlier of:

11 (i) 36 months after the date of the order of liquidation; or

12 (ii) the final date set by the court for the filing of claims against the liquidator or receiver of an insolvent
13 insurer.

14 (b) (i) If the claimant learns that the claimant's condition resulted from an occupational disease
15 compensable under Title 39, chapter 71, within 36 months of the order of liquidation or the final date set by the
16 court for the filing of claims against the liquidator, the claimant shall file a claim, which must be paid under the
17 terms of subsection (1)(a). If the claimant does not learn of a compensable condition under Title 39, chapter 71,
18 until after the time specified in either subsection (2)(a)(i) or (2)(a)(ii) has expired, the claimant shall file a claim

20 condition resulted from an occupational disease.

2 ~~(d)~~(c) children who are eligible to participate in the state children's health insurance program authorized
3 under Title 53, chapter 4, part 10; and

4 ~~(e)~~(d) other specific groups of persons who are participants in programs or services funded solely or
5 primarily through state general funds or who the department determines are in need of specific types of health
6 care and related services, such as prescription drugs, reproductive health care, and mental health services, and
7 are without adequate financial means to procure health insurance coverage of those needs.

8 (9) Children participating in a section 1115 waiver eligibility group or children who would be eligible to
9 participate in the state children's health insurance program are subject to the eligibility criteria applicable under
10 53-4-1004, except as provided in subsection (10) of this section, for participation in the state children's health
11 insurance program and must receive benefits as provided through the state children's health insurance program
12 under 53-4-1005.

13 (10) (a) Except as provided in this subsection (10), the eligibility for the section 1115 waiver eligibility
14 groups may not exceed 150% of the federal poverty level.

15 (b) The department may establish eligibility at greater than 150% but no more than 200% of the federal
16 poverty level for any of the following groups established for purposes of a section 1115 waiver:

17 (i) participants in the state children's health insurance program;

18 (ii) participants in a group that may be covered under the state children's health insurance program;

19 (iii) participants in a family planning program;

20 (iv) participants in a group composed of persons previously served through a program funded with state
21 general fund money and other nonmedicaid money; or

22 (v) participants in a group composed of persons with a significant need for particular services that are
23 not readily available to that population through insurance products or because of personal financial limitations.

24 (c) In establishing the eligibility criteria based upon federal poverty levels, the department shall select
25 levels to ensure that the resulting expenditures will remain within the available funding and will conform with the
26 terms and conditions of approval by the U.S. department of health and human services.

27 (d) The department may adopt additional programmatic and financial eligibility criteria for a section 1115
28 waiver eligibility group in order to appropriately define the subject population, to limit use for fiscal and
29 programmatic purposes, to prevent improper use, and to conform the administration of the program with the terms
30 and conditions of the section 1115 waiver.

1 (e) Eligibility criteria applicable to a section 1115 waiver eligibility group need not conform to the criteria
2 applicable to another section 1115 waiver eligibility group or to a medicaid eligibility group that is not
3 encompassed within the demonstration project.

4 (11) (a) For each section 1115 waiver eligibility group, the department shall establish the program benefit
5 or benefits to be available to the participants in the group.

6 (b) Program benefits may be in the form of:

7 (i) assistance in the payment of health insurance premiums for health care coverage through an
8 employer or other existing group coverage available to the program enrollee;

9 (ii) assistance in the payment of health insurance premiums for health care coverage that meets a set
10 of defined standards and limitations adopted by the department in consultation with the commissioner of
11 insurance and obtained from participating private insurers or through self-insured pools;

12 (iii) premium purchase for insurance coverage on behalf of children who are 18 years of age or younger
13 for the defined set of health care and related services adopted by the department for the state children's health
14 insurance program authorized in Title 53, chapter 4, part 10; or

15 (iv) coverage of a defined set of health care and related services administered directly by the department
16 on a fee-for-service basis.

17 (c) The department may limit the types of program benefits available to enrollees in a program. For
18 programs in which the department provides for more than one type of program benefit, the department may
19 require that enrollees, either as a whole or on an individual basis based on certain circumstances, use certain
20 types of program benefits in lieu of using other types of program benefits.

21 (d) The department shall, as necessary to maintain expenditures for a program within the available
22 funding for that program, set monetary limitations on the total benefit amounts available on a periodic basis for
23 an enrollee through that program, whether that benefit is in the form of premium assistance, premium purchase,
24 or a set of covered services.

25 (12) The benefits for a section 1115 waiver eligibility group may be in the form of a defined set of covered
26 services consisting of one or more of the mandatory and optional medicaid state plan services specified in
27 53-6-101 or other health-care related services. The department may select the types of services that constitute
28 a defined set of covered services for a section 1115 waiver eligibility group. The department may provide
29 coverage of a service not specified in 53-6-101 if the department determines the service to be appropriate for the
30 particular section 1115 waiver eligibility group. The department may define the nature, components, scope,

1 amount, and duration of each covered service to be made available to a section 1115 waiver eligibility group. The
2 nature, components, scope, amount, and duration of a covered service made available to a section 1115 waiver
3 eligibility group need not conform to those aspects of that service as defined by the department for delivery as
4 a covered service to another section 1115 waiver eligibility group or to a medicaid eligibility group that is not
5 encompassed within a section 1115 waiver.

6 (13) The department may adopt financial participation requirements for enrollees in a section 1115
7 eligibility group to foster appropriate use among enrollees and to maintain the fiscal accountability of the program.
8 The department may adopt financial participation requirements, including but not limited to copayments, payment
9 of monthly or yearly enrollment fees, or deductibles. The requirements may vary among the section 1115 waiver
10 eligibility groups. In adopting financial participation requirements for enrollees selecting coverage as provided in
11 subsection (11)(b)(iv), the department may not adopt cost-sharing amounts that exceed the nominal deductible,
12 coinsurance, copayment, or similar charges adopted by the department to apply to categorically or medically
13 needy persons for a service pursuant to the state medicaid plan.

14 (14) The department shall adopt rules as necessary for the implementation of a section 1115 waiver.
15 Rules may include but are not limited to:

- 16 (a) designation of programs and activities for implementation of a section 1115 waiver;
- 17 (b) features and benefit coverage of the programs;
- 18 (c) the nature, components, scope, amount, and duration of each program service;
- 19 (d) appropriate insurance products and coverage as benefits;
- 20 (e) required enrollee eligibility information;
- 21 (f) enrollee eligibility categories, criteria, requirements, and related measures;
- 22 (g) limits upon enrollment;
- 23 (h) requirements and limitations for service costs and expenditures;
- 24 (i) measures to ensure the appropriateness and quality of services to be delivered;
- 25 (j) provider requirements and reimbursement;
- 26 (k) financial participation requirements for enrollees;
- 27 (l) use measures; and
- 28 (m) other appropriate provisions necessary for administration of a demonstration project and for
29 implementation of the conditions placed upon approval of a section 1115 waiver by the U.S. department of health
30 and human services.

1 (15) The department shall administer the programs and activities that are subject to a section 1115 waiver
2 in accordance with the terms and conditions of approval by the U.S. department of health and human services.
3 The department may modify aspects of established programs and activities administered by the department as
4 may be necessary to implement a section 1115 waiver as provided in this section.

5 (16) The department may seek an initial duration and durational extensions for a section 1115 waiver as
6 the department determines appropriate for demonstration and fiscal considerations.

7 (17) The department shall provide a report to the legislature, as provided in 5-11-210, on the conditions
8 of approval and the status of implementation for each section 1115 waiver approved by the U.S. department of
9 health and human services. For any proposed section 1115 waiver not approved by the U.S. department of health
10 and human services, the department shall provide to the next legislative session a report on the basis for
11 disapproval and an analysis of the fiscal costs and programmatic impacts of serving the persons within the
12 proposed section 1115 waiver eligibility groups through eligibility under one of the optional medicaid eligibility
13 categories established in federal law and authorized by 53-6-131.

14 (18) The department shall present a section 1115 waiver proposal to the appropriate medicaid advisory
15 council, which must include consumer advocates, prior to the submission of the proposal to the federal
16 government.

17 (19) The department shall present a section 1115 waiver proposal to the house appropriations committee
18 or, during the interim, the children, families, health, and human services interim committee for review and
19 comment at a public hearing prior to the submission of the proposal to the federal government for formal approval
20 and shall also present the section 1115 waiver after final approval from the federal government.

21 (20) (a) The department shall provide for a public comment period on the proposed section 1115 waiver
22 at least 60 days before the submission of the section 1115 waiver application to the federal government for formal
23 approval.

24 (b) The department shall give notice of the proposal by announcing the pending submittal, stating its
25 general purpose, and informing the public that information on the proposal is available on the department's
26 website.

27 (c) The department shall provide for public comment through electronic means or mail and shall provide
28 for a public forum in at least one location at which members of the public can submit views on the proposal. The
29 department shall consider comments received and make any appropriate changes to the waiver request before
30 submitting it to the federal government.

1 (d) The department shall post on its website the waiver concept paper, formal correspondence regarding
2 a waiver proposal, and the final approved waiver, including documents received from the center for medicare and
3 medicaid services."

5 **Section 34.** Section 53-4-1007, MCA, is amended to read:

6 **"53-4-1007. (Temporary) Department may contract for services.** (1) The department of public health
7 and human services may administer the program directly or contract with insurance companies or other entities
8 to provide services for a set monthly or yearly fee based on the number of participants in the program and the
9 types of services provided or based on a fee for service as established by the department.

10 (2) The department of public health and human services may contract for a health care service based
11 on a fee for service when the department does not contract for a health care service through an insurance plan,
12 a health maintenance organization, or a managed care plan. A contract entered into or renewed on or after July
13 1, 2009, may not limit enrollee access to providers who are willing to provide services at the rates provided for
14 under the program. In operating the program and providing health services, the department may:

15 (a) pay providers on a fee-for-service basis in a self-funded program and contract with an insurance
16 company, third-party administrator, or other entity to provide administrative services, including but not limited to
17 processing and payment of claims with program funds;

18 (b) purchase health coverage for eligible children from an insurance company or other entity through
19 premiums, capitated payments, or other appropriate methods;

20 (c) purchase health coverage as provided in subsection (2)(b) for some types of health services and
21 contract directly with providers for other types of health services on a fee-for-service basis; or

22 (d) pay providers on a fee-for-service basis and directly provide administrative services in a self-funded
23 program.

24 (3) If the department of public health and human services contracts with an insurance company or other
25 entity to administer the program as provided in subsection (2)(b) or (2)(c), not more than 12% of the contract
26 payment may be used for administrative expenses, including:

27 ~~(a) direct and indirect expenses as specified in 33-22-1514;~~

28 ~~(b)(a)~~ risk charges; and

29 ~~(c)(b)~~ any applicable assessments, fees, and taxes.

30 (4) If the department operates the program by providing administrative services under subsection (2)(a),

1 (2)(c), or (2)(d), the department's administrative expense may not exceed the lesser of 10% of total program
2 expenses or the applicable federal limitation, excluding costs for federally required audits.

3 (5) (a) An insurance company or other entity that contracts with the department for a fully insured
4 contract as provided in subsection (2)(b) shall calculate the surplus account balance at the end of each contract
5 year and may retain an amount equal to 50% of the risk charge allowed under the contract. The remainder of the
6 surplus balance must be deposited in the state special revenue account provided for in 53-4-1012.

7 (b) For the purposes of this subsection (5):

8 (i) "risk charge" means the percentage of the administrative expense allowed in the contract for assuming
9 the risk; and

10 (ii) "surplus account balance" means funds that remain after all claims and all administrative expenses
11 have been paid for a claim period. (Terminates on occurrence of contingency--sec. 15, Ch. 571, L. 1999; sec.
12 7, Ch. 565, L. 2005; sec. 5, Ch. 129, L. 2007.)"
