24 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MONTANA:

26 **Section 1.** Section 2-2-121, MCA, is amended to read:

27 **"2-2-121. Rules of conduct for public officers and public employees.** (1) Proof of commission of any

28 act enumerated in subsection (2) is proof that the actor has breached a public duty.

29 (2) A public officer or a public employee may not:

30 (a) subject to subsection (7), use public time, facilities, equipment, supplies, personnel, or funds for the



1 officer's or employee's private business purposes;

2 (b) engage in a substantial financial transaction for the officer's or employee's private business purposes
3 with a person whom the officer or employee inspects or supervises in the course of official duties;

4 (c) assist any person for a fee or other compensation in obtaining a contract, claim, license, or other
5 economic benefit from the officer's or employee's agency;

6 (d) assist any person for a contingent fee in obtaining a contract, claim, license, or other economic
7 benefit from any agency;

8 (e) perform an official act directly and substantially affecting to its economic benefit a business or other
9 undertaking in which the officer or employee either has a substantial financial interest or is engaged as counsel,
10 consultant, representative, or agent; or

11 (f) solicit or accept employment, or engage in negotiations or meetings to consider employment, with a
12 person whom the officer or employee regulates in the course of official duties without first giving written
13 notification to the officer's or employee's supervisor and department director.

14 (3) (a) Except as provided in subsection (3)(b), a public officer or public employee may not use public
15 time, facilities, equipment, supplies, personnel, or funds to solicit support for or opposition to any political
16 committee, the nomination or election of any person to public office, or the passage of a ballot issue unless the
17 use is:

18 (i) authorized by law; or

19 (ii) properly incidental to another activity required or authorized by law, such as the function of an elected
20 public officer, the officer's staff, or the legislative staff in the normal course of duties.

21 (b) As used in this subsection (3), "properly incidental to another activity required or authorized by law"
22 does not include any activities related to solicitation of support for or opposition to the nomination or election of
23 a person to public office or political committees organized to support or oppose a candidate or candidates for
24 public office. With respect to ballot issues, properly incidental activities are restricted to:

25 (i) the activities of a public officer, the public officer's staff, or legislative staff related to determining the
26 impact of passage or failure of a ballot issue on state or local government operations;

27 (ii) in the case of a school district, as defined in Title 20, chapter 6, compliance with the requirements of
28 law governing public meetings of the local board of trustees, including the resulting dissemination of information
29 by a board of trustees or a school superintendent or a designated employee in a district with no superintendent
30 in support of or opposition to a bond issue or levy submitted to the electors. Public funds may not be expended

1 for any form of commercial advertising in support of or opposition to a bond issue or levy submitted to the
2 electors.

3 (c) This subsection (3) is not intended to restrict the right of a public officer or public employee to express
4 personal political views.

5 (d) (i) If the public officer or public employee is a Montana highway patrol chief or highway patrol officer
6 appointed under Title 44, chapter 1, the term "equipment" as used in this subsection (3) includes the chief's or
7 officer's official highway patrol uniform.

8 (ii) A Montana highway patrol chief's or highway patrol officer's title may not be referred to in the
9 solicitation of support for or opposition to any political committee, the nomination or election of any person to
10 public office, or the passage of a ballot issue.

11 (4) (a) A candidate, as defined in 13-1-101(6)(a)(8)(a), may not use or permit the use of state funds for
12 any advertisement or public service announcement in a newspaper, on radio, or on television that contains the
13 candidate's name, picture, or voice except in the case of a state or national emergency and then only if the
14 announcement is reasonably necessary to the candidate's official functions.

15 (b) A state officer may not use or permit the use of public time, facilities, equipment, supplies, personnel,
16 or funds to produce, print, or broadcast any advertisement or public service announcement in a newspaper, on
17 radio, or on television that contains the state officer's name, picture, or voice except in the case of a state or
18 national emergency if the announcement is reasonably necessary to the state officer's official functions or in the
19 case of an announcement directly related to a program or activity under the jurisdiction of the office or position
20 to which the state officer was elected or appointed.

21 (5) A public officer or public employee may not participate in a proceeding when an organization, other
22 than an organization or association of local government officials, of which the public officer or public employee
23 is an officer or director is:

24 (a) involved in a proceeding before the employing agency that is within the scope of the public officer's
25 or public employee's job duties; or

26 (b) attempting to influence a local, state, or federal proceeding in which the public officer or public
27 employee represents the state or local government.

28 (6) A public officer or public employee may not engage in any activity, including lobbying, as defined in
29 5-7-102, on behalf of an organization, other than an organization or association of local government officials, of
30 which the public officer or public employee is a member while performing the public officer's or public employee's

1 job duties. The provisions of this subsection do not prohibit a public officer or public employee from performing
2 charitable fundraising activities if approved by the public officer's or public employee's supervisor or authorized
3 by law.

4 (7) A listing by a public officer or a public employee in the electronic directory provided for in 30-17-101
5 of any product created outside of work in a public agency is not in violation of subsection (2)(a) of this section.
6 The public officer or public employee may not make arrangements for the listing in the electronic directory during
7 work hours.

8 (8) A department head or a member of a quasi-judicial or rulemaking board may perform an official act
9 notwithstanding the provisions of subsection (2)(e) if participation is necessary to the administration of a statute
10 and if the person complies with the disclosure procedures under 2-2-131.

11 (9) Subsection (2)(d) does not apply to a member of a board, commission, council, or committee unless
12 the member is also a full-time public employee.

13 (10) Subsections (2)(b) and (2)(e) do not prevent a member of the governing body of a local government
14 from performing an official act when the member's participation is necessary to obtain a quorum or to otherwise
15 enable the body to act. The member shall disclose the interest creating the appearance of impropriety prior to
16 performing the official act."

18 **Section 2.** Section 13-1-101, MCA, is amended to read:

19 **"13-1-101. Definitions.** As used in this title, unless the context clearly indicates otherwise, the following
20 definitions apply:

21 (1) "Active elector" means an elector whose name has not been placed on the inactive list due to failure
22 to respond to confirmation notices pursuant to 13-2-220 or 13-19-313.

23 (2) "Active list" means a list of active electors maintained pursuant to 13-2-220.

24 (3) "Anything of value" means any goods that have a certain utility to the recipient that is real and that
25 is ordinarily not given away free but is purchased.

26 (4) "Application for voter registration" means a voter registration form prescribed by the secretary of state
27 that is completed and signed by an elector, submitted to the election administrator, and contains voter registration
28 information subject to verification as provided by law.

29 (5) "Ballot" means a paper ballot counted manually or a paper ballot counted by a machine, such as an
30 optical scan system or other technology that automatically tabulates votes cast by processing the paper ballots.

1 (6) (a) "Ballot issue" or "issue" means a proposal submitted to the people at an election for their approval
 2 or rejection, including but not limited to an initiative, referendum, proposed constitutional amendment, recall
 3 question, school levy question, bond issue question, or ballot question.

4 (b) For the purposes of chapters 35 and 37, an issue becomes a "ballot issue" upon certification by the
 5 proper official that the legal procedure necessary for its qualification and placement on the ballot has been
 6 completed, except that a statewide issue becomes a "ballot issue" upon preparation and transmission by the
 7 secretary of state of the form of the petition or referral to the person who submitted the proposed issue.

8 (7) "Ballot issue committee" means a political committee specifically organized to support or oppose a
 9 ballot issue.

10 ~~(6)(8)~~ "Candidate" means:

11 (a) an individual who has filed a declaration or petition for nomination, acceptance of nomination, or
 12 appointment as a candidate for public office as required by law;

13 (b) for the purposes of chapter 35, 36, or 37, an individual who has solicited or received and retained
 14 contributions, made expenditures, or given consent to an individual, organization, political party, or committee
 15 to solicit or receive and retain contributions or make expenditures on the individual's behalf to secure nomination
 16 or election to any office at any time, whether or not the office for which the individual will seek nomination or
 17 election is known when the:

18 (i) solicitation is made;

19 (ii) contribution is received and retained; or

20 (iii) expenditure is made; or

21 (c) an officeholder who is the subject of a recall election.

22 ~~(7)(9)~~ (a) "Contribution" means:

23 (i) the receipt by a candidate or a political committee of an advance, gift, loan, conveyance, deposit,
 24 payment, or distribution of money or anything of value to influence an election support or oppose a candidate or
 25 a ballot issue;

26 (ii) an expenditure, including an in-kind expenditure, that is made in coordination with a candidate or ballot
 27 issue committee and is reportable by the candidate or ballot issue committee as a contribution;

28 ~~(ii)(iii) a transfer of funds between political committees~~ the receipt by a political committee of funds
 29 transferred from another political committee;

30 ~~(iii)(iv) the payment by a person other than a candidate or political committee~~ OTHER THAN A CANDIDATE

1 OR POLITICAL COMMITTEE of compensation for the personal services of another person that are rendered to a
 2 candidate or political committee.

3 (b) "Contribution" does not mean:

4 ~~——(i) services provided without compensation by individuals volunteering a portion or all of their time on~~
 5 ~~behalf of a candidate or political committee or meals and lodging provided by individuals in their private~~
 6 ~~residences for a candidate or other individual;~~

7 ~~——(ii) the cost of any bona fide news story, commentary, or editorial distributed through the facilities of any~~
 8 ~~broadcasting station, newspaper, magazine, or other periodical publication of general circulation;~~

9 ~~——(iii) the cost of any communication by any membership organization or corporation to its members or~~
 10 ~~stockholders or employees; or~~

11 ~~——(iv) filing fees paid by the candidate.~~

12 (10) "Coordinated", including any variations of the term, means made in cooperation with, in consultation
 13 with, at the request of, or with the express prior consent of a candidate or political committee or an agent of a
 14 candidate or political committee.

15 (11) "De minimis act" means an action, contribution, or expenditure that is so small that it does not trigger
 16 registration, reporting, disclaimer, or disclosure obligations under Title 13, chapter 35 or 37, or warrant
 17 enforcement as a campaign practices violation under Title 13, chapter 37.

18 ~~(8)(12)~~ "Election" means a general, regular, special, or primary election held pursuant to the
 19 requirements of state law, regardless of the time or purpose.

20 ~~(9)(13)~~ "Election administrator" means the county clerk and recorder or the individual designated by a
 21 county governing body to be responsible for all election administration duties, except that with regard to school
 22 elections not administered by the county, the term means the school district clerk.

23 (14) (a) "Election communication" means the following forms of communication to support or oppose a
 24 candidate or ballot issue:

25 (i) a paid advertisement broadcast over radio, television, cable, or satellite;

26 (ii) paid placement of content on the internet or other electronic communication network;

27 (iii) a paid advertisement published in a newspaper or periodical or on a billboard;

28 (iv) a mailing; or

29 (v) printed materials.

30 (b) The term does not mean:

1 (i) an activity or communication for the purpose of encouraging individuals to register to vote or to vote,
 2 if that activity or communication does not mention or depict a clearly identified candidate or ballot issue;

3 (ii) a communication that does not support or oppose a candidate or ballot issue;

4 (iii) a bona fide news story, commentary, blog, or editorial distributed through the facilities of any
 5 broadcasting station, newspaper, magazine, internet website, or other periodical publication of general circulation;

6 (iv) a communication by any membership organization or corporation to its members, stockholders, or
 7 employees; or

8 (v) a communication that the commissioner determines by rule is not an election communication.

9 (15) (a) "Electioneering communication" means a PAID communication THAT IS PUBLICLY DISTRIBUTED BY
 10 RADIO, TELEVISION, CABLE, SATELLITE, INTERNET WEBSITE, NEWSPAPER, PERIODICAL, BILLBOARD, MAIL, OR ANY OTHER
 11 DISTRIBUTION OF PRINTED MATERIALS, THAT IS made within 60 days of the initiation of voting in an election, that does
 12 not support or oppose a candidate or ballot issue, that can be received by more than 100 recipients in the district
 13 voting on the candidate or ballot issue, and that:

14 (i) refers to one or more clearly identified candidates in that election;

15 (ii) depicts the name, image, likeness, or voice of one or more clearly identified candidates in that
 16 election; or

17 (iii) refers to a political party, ballot issue, or other question submitted to the voters in that election.

18 (b) The term does not mean:

19 (i) a bona fide news story, commentary, blog, or editorial distributed through the facilities of any
 20 broadcasting station, newspaper, magazine, internet website, or other periodical publication of general circulation
 21 UNLESS THE FACILITIES ARE OWNED OR CONTROLLED BY A CANDIDATE OR POLITICAL COMMITTEE;

22 (ii) a communication by any membership organization or corporation to its members, stockholders, or
 23 employees; or

24 (III) A COMMERCIAL COMMUNICATION THAT DEPICTS A CANDIDATE'S NAME, IMAGE, LIKENESS, OR VOICE ONLY IN
 25 THE CANDIDATE'S CAPACITY AS OWNER, OPERATOR, OR EMPLOYEE OF A BUSINESS THAT EXISTED PRIOR TO THE
 26 CANDIDACY;

27 (IV) A COMMUNICATION THAT CONSTITUTES A CANDIDATE DEBATE OR FORUM OR THAT SOLELY PROMOTES A
 28 CANDIDATE DEBATE OR FORUM AND IS MADE BY OR ON BEHALF OF THE PERSON SPONSORING THE DEBATE OR FORUM; OR

29 ~~(iii)~~ (v) a communication that the commissioner determines by rule is not an electioneering communication.

30 ~~(10)~~ (16) "Elector" means an individual qualified to vote under state law.

1 ~~(14)~~(17) (a) "Expenditure" means a purchase, payment, distribution, loan, advance, promise, pledge, or
2 gift of money or anything of value;

3 (i) made for the purpose of influencing the results of an election by a candidate or political committee
4 to support or oppose a candidate or a ballot issue; or

5 (ii) used or intended for use in making independent expenditures or in producing electioneering
6 communications.

7 (b) "Expenditure" does not mean:

8 (i) services, food, or lodging provided in a manner that they are not contributions under subsection ~~(7)~~
9 (9);

10 (ii) payments by a candidate for a filing fee or for personal travel expenses, food, clothing, lodging, or
11 personal necessities for the candidate and the candidate's family;

12 (iii) the cost of any bona fide news story, commentary, blog, or editorial distributed through the facilities
13 of any broadcasting station, newspaper, magazine, or other periodical publication of general circulation; or

14 (iv) the cost of any communication by any membership organization or corporation to its members or
15 stockholders or employees.

16 ~~(12)~~(18) "Federal election" means a general or primary election in which an elector may vote for
17 individuals for the office of president of the United States or for the United States congress.

18 ~~(13)~~(19) "General election" or "regular election" means an election held for the election of public officers
19 throughout the state at times specified by law, including elections for officers of political subdivisions when the
20 time of the election is set on the same date for all similar political subdivisions in the state. For ballot issues
21 required by Article III, section 6, or Article XIV, section 8, of the Montana constitution to be submitted by the
22 legislature to the electors at a general election, "general election" means an election held at the time provided
23 in 13-1-104(1). For ballot issues required by Article XIV, section 9, of the Montana constitution to be submitted
24 as a constitutional initiative at a regular election, regular election means an election held at the time provided in
25 13-1-104(1).

26 ~~(14)~~(20) "Inactive elector" means an individual who failed to respond to confirmation notices and whose
27 name was placed on the inactive list pursuant to 13-2-220 or 13-19-313.

28 ~~(15)~~(21) "Inactive list" means a list of inactive electors maintained pursuant to 13-2-220 or 13-19-313.

29 (22) (a) "Incidental committee" means a political committee that is not specifically organized or operating
30 for the primary purpose of supporting or opposing candidates or ballot issues but that may incidentally become

1 a political committee by receiving a contribution or making an expenditure.

2 (b) For the purpose of this subsection (22), the primary purpose is determined by the commissioner by
 3 rule and includes criteria such as the allocation of budget, staff, or members' activity or the statement of purpose
 4 or goal of the person or individuals that form the committee.

5 (23) "Independent committee" means a political committee organized for the primary purpose of receiving
 6 contributions and making expenditures that is not controlled either directly or indirectly by a candidate and that
 7 does not coordinate with a candidate in conjunction with the making of expenditures except pursuant to the limits
 8 set forth in 13-37-216(1).

9 (24) "Independent expenditure" means an expenditure for an election communication to support or
 10 oppose a candidate or ballot issue made at any time that is not coordinated with a candidate or ballot issue
 11 committee.

12 ~~(16)~~(25) "Individual" means a human being.

13 ~~(17)~~(a) "Issue" or "ballot issue" means a proposal submitted to the people at an election for their approval
 14 or rejection, including but not limited to initiatives, referenda, proposed constitutional amendments, recall
 15 questions, school levy questions, bond issue questions, or a ballot question.

16 ~~————~~(b) For the purposes of chapters 35 and 37, an issue becomes a "ballot issue" upon certification by the
 17 proper official that the legal procedure necessary for its qualification and placement upon the ballot has been
 18 completed, except that a statewide issue becomes a "ballot issue" upon preparation and transmission by the
 19 secretary of state of the form of the petition or referral to the person who submitted the proposed issue.

20 ~~(18)~~(26) "Legally registered elector" means an individual whose application for voter registration was
 21 accepted, processed, and verified as provided by law.

22 ~~(19)~~(27) "Mail ballot election" means any election that is conducted under Title 13, chapter 19, by mailing
 23 ballots to all active electors.

24 ~~(20)~~(28) "Person" means an individual, corporation, association, firm, partnership, cooperative,
 25 committee, including a political committee, club, union, or other organization or group of individuals or a candidate
 26 as defined in subsection ~~(6)~~ (8).

27 ~~(24)~~(29) "Place of deposit" means a location designated by the election administrator pursuant to
 28 13-19-307 for a mail ballot election conducted under Title 13, chapter 19.

29 ~~(22)~~(30) (a) "Political committee" means a combination of two or more individuals or a person other than
 30 an individual who ~~makes~~ receives a contribution or makes an expenditure:

1 ~~(a)~~(i) to support or oppose a candidate or a committee organized to support or oppose a candidate or
 2 a petition for nomination; or

3 ~~(b)~~(ii) to support or oppose a ballot issue or a committee organized to support or oppose a ballot issue;
 4 or

5 ~~(c) as an earmarked contribution~~

6 (iii) to prepare or disseminate an election communication, an electioneering communication, or an
 7 independent expenditure.

8 (b) Political committees include ballot issue committees, incidental committees, independent committees,
 9 and political party committees.

10 (c) A candidate and the candidate's treasurer do not constitute a political committee.

11 (d) A political committee is not formed when a combination of two or more individuals or a person other
 12 than an individual makes an election communication, an electioneering communication, or an independent
 13 expenditure of \$100 \$250 or less.

14 (31) "Political party committee" means a political committee formed by a political party organization and
 15 includes all county and city central committees.

16 (32) "Political party organization" means a political organization that:

17 (a) was represented on the official ballot in either of the two most recent statewide general elections; or

18 (b) has met the petition requirements, as provided in Title 13, chapter 10, part 5.

19 ~~(23)~~(33) "Political subdivision" means a county, consolidated municipal-county government, municipality,
 20 special district, or any other unit of government, except school districts, having authority to hold an election for
 21 officers or on a ballot issue.

22 ~~(24)~~(34) "Polling place election" means an election primarily conducted at polling places rather than by
 23 mail under the provisions of Title 13, chapter 19.

24 ~~(25)~~(35) "Primary" or "primary election" means an election held throughout the state to nominate
 25 candidates for public office at times specified by law, including nominations of candidates for offices of political
 26 subdivisions when the time for nominations is set on the same date for all similar subdivisions in the state.

27 ~~(26)~~(36) "Provisional ballot" means a ballot cast by an elector whose identity or eligibility to vote has not
 28 been verified as provided by law.

29 ~~(27)~~(37) "Provisionally registered elector" means an individual whose application for voter registration
 30 was accepted but whose identity or eligibility has not yet been verified as provided by law.

1 ~~(28)~~(38) "Public office" means a state, county, municipal, school, or other district office that is filled by
2 the people at an election.

3 ~~(29)~~(39) "Random-sample audit" means an audit involving a manual count of ballots from designated
4 races and ballot issues in precincts selected through a random process as provided in 13-17-503.

5 ~~(30)~~(40) "Registrar" means the county election administrator and any regularly appointed deputy or
6 assistant election administrator.

7 ~~(31)~~(41) "School election" has the meaning provided in 20-20-101.

8 ~~(32)~~(42) "School election filing officer" means the filing officer with whom the declarations for nomination
9 for school district office were filed or with whom the school ballot issue was filed.

10 ~~(33)~~(43) "School recount board" means the board authorized pursuant to 20-20-420 to perform recount
11 duties in school elections.

12 ~~(34)~~(44) "Signature envelope" means an envelope that contains a secrecy envelope and ballot and that
13 is designed to:

14 (a) allow election officials, upon examination of the outside of the envelope, to determine that the ballot
15 is being submitted by someone who is in fact a qualified elector and who has not already voted; and

16 (b) allow it to be used in the United States mail.

17 ~~(35)~~(45) "Special election" means an election other than a statutorily scheduled primary or general
18 election held at any time for any purpose provided by law. It may be held in conjunction with a statutorily
19 scheduled election.

20 ~~(36)~~(46) "Statewide voter registration list" means the voter registration list established and maintained
21 pursuant to 13-2-107 and 13-2-108.

22 (47) "Support or oppose", including any variations of the term, means:

23 (a) using express words, including but not limited to "vote", "oppose", "support", "elect", "defeat", or
24 "reject", that call for the nomination, election, or defeat of one or more clearly identified candidates, the election
25 or defeat of one or more political parties, or the passage or defeat of one or more ballot issues submitted to voters
26 in an election; or

27 (b) otherwise referring to or depicting one or more clearly identified candidates, political parties, or ballot
28 issues in a manner that is susceptible of no reasonable interpretation other than as a call for the nomination,
29 election, or defeat of the candidate in an election, the election or defeat of the political party, or the passage or
30 defeat of the ballot issue or other question submitted to the voters in an election.

1 ~~(37)~~(48) "Transfer form" means a form prescribed by the secretary of state that may be filled out by an
2 elector to transfer the elector's registration when the elector's residence address has changed within the county.

15 the following information concerning expenditures made:

16 (i) the full name, mailing address, occupation, and principal place of business, if any, of each person to
17 whom expenditures have been made by the committee or candidate during the reporting period, including the
18 amount, date, and purpose of each expenditure and the total amount of expenditures made to each person;

19 (ii) the full name, mailing address, occupation, and principal place of business, if any, of each person
20 to whom an expenditure for personal services, salaries, and reimbursed expenses have been made, including
21 the amount, date, and purpose of that expenditure and the total amount of expenditures made to each person;

22 (iii) the total sum of expenditures made by a political committee or candidate during the reporting period;

23 (iv) the name and address of each political committee or candidate to which the reporting committee or
24 candidate made any transfer of funds, together with the amount and dates of all transfers;

25 (v) the name of any person to whom a loan was made during the reporting period, including the full
26 name, mailing address, occupation, and principal place of business, if any, of that person and the full names,
27 mailing addresses, occupations, and principal places of business, if any, of the endorsers, if any, and the date
28 and amount of each loan;

29 (vi) the amount and nature of debts and obligations owed by a political committee or candidate in the
30 form prescribed by the commissioner; and

1 (vii) other information that may be required by the commissioner to fully disclose the disposition of funds
2 used to support or oppose candidates or issues.

3 (b) Reports of expenditures made to a consultant, advertising agency, polling firm, or other person that
4 performs services for or on behalf of a candidate or political committee must be itemized and described in
5 sufficient detail to disclose the specific services performed by the entity to which payment or reimbursement was
6 made.

7 (c) A candidate is required to report the information specified in this subsection (2) only if the transactions
8 involved were undertaken for the purpose of supporting or opposing a candidate."

9

10 **NEW SECTION. Section 14. Disclosure requirements for incidental committees.** (1) The reports
11 required under 13-37-225 through 13-37-227 from incidental committees must disclose the following information
12 concerning contributions to the committee that are designated by the contributor for a specified candidate, ballot
13 issue, or petition for nomination or that are made by the contributor in response to an appeal by the incidental
14 committee for contributions to support incidental committee election activity, including in-kind expenditures,
15 independent expenditures, election communications, or electioneering communications:

16 (a) the full name, mailing address, occupation, and employer, if any, of each person who has made
17 aggregate contributions during the reporting period for a specified candidate, ballot issue, or petition for
18 nomination of \$35 or more;

19 (b) for each person identified under subsection (1)(a), the aggregate amount of contributions made by
20 that person for all reporting periods;

21 (c) each loan received from any person during the reporting period for a specified candidate, ballot issue,
22 or petition for nomination, together with the full names, mailing addresses, occupations, and employers, if any,
23 of the lender and endorsers, if any, and the date and amount of each loan;

24 (d) the amount and nature of debts and obligations owed to an incidental committee for a specified
25 candidate, ballot issue, or petition for nomination in the form prescribed by the commissioner;

26 (e) an account of proceeds that total less than \$35 per person from mass collections made at fundraising
27 events sponsored by the incidental committee for a specified candidate, ballot issue, or petition for nomination;
28 and

29 (f) the total sum of all contributions received by or designated for the incidental committee for a specified
30 candidate, ballot issue, or petition for nomination during the reporting period.

1 (2) The reports required under 13-37-225 through 13-37-227 from incidental committees must disclose
2 the following information concerning expenditures made:

3 (a) the full name, mailing address, occupation, and principal place of business, if any, of each person
4 to whom expenditures have been made during the reporting period, including the amount, date, and purpose of
5 each expenditure and the total amount of expenditures made to each person;

6 (b) the full name, mailing address, occupation, and principal place of business, if any, of each person
7 to whom an expenditure for personal services, salaries, and reimbursed expenses have been made during the
8 reporting period, including the amount, date, and purpose of that expenditure and the total amount of
9 expenditures made to each person;

10 (c) the total sum of expenditures made during the reporting period;

11 (d) the name and address of each political committee or candidate to which the reporting committee
12 made any transfer of funds together with the amount and dates of all transfers;

13 (e) the name of any person to whom a loan was made during the reporting period, including the full
14 name, mailing address, occupation, and principal place of business, if any, of that person, and the full names,
15 mailing addresses, occupations, and principal places of business, if any, of the endorsers, if any, and the date
16 and amount of each loan;

17 (f) the amount and nature of debts and obligations owed by a political committee in the form prescribed
18 by the commissioner; and

19 (g) other information that may be required by the commissioner to fully disclose the disposition of funds
20 used to make expenditures.

21 (3) Reports of expenditures made to a consultant, advertising agency, polling firm, or other person that
22 performs services for or on behalf of an incidental committee must be itemized and described in sufficient detail
23 to disclose the specific services performed by the entity to which payment or reimbursement was made.

24 (4) AN INCIDENTAL COMMITTEE THAT DOES NOT RECEIVE CONTRIBUTIONS FOR A SPECIFIED CANDIDATE, BALLOT
25 ISSUE, OR PETITION FOR NOMINATION AND THAT DOES NOT SOLICIT CONTRIBUTIONS FOR INCIDENTAL COMMITTEE ELECTION
26 ACTIVITY, INCLUDING IN-KIND EXPENDITURES, INDEPENDENT EXPENDITURES, ELECTION COMMUNICATIONS, OR
27 ELECTIONEERING COMMUNICATIONS, IS REQUIRED TO REPORT ONLY ITS EXPENDITURES.

28

29 **Section 15.** Section 13-37-231, MCA, is amended to read:

30 "**13-37-231. Reports to be certified as true, complete, and correct.** (1) A report required by this

1 chapter to be filed by a candidate or political committee must be verified as true, complete, and correct by the
 2 oath or affirmation of the individual filing the report. The individual filing the report must be the candidate or an
 3 officer of a political committee who is on file as an officer of the committee with the commissioner.

4 (2) A copy of a report or statement filed by a candidate or political committee must be preserved by the
 5 individual filing it for a period coinciding with the term of office for which the person was a candidate or for a
 6 period of 4 years, whichever is longer."

7
 8 **NEW SECTION. Section 16. Reports to be filed regardless of tax status.** A person that makes an
 9 election communication, an electioneering communication, or an independent expenditure shall file reports
 10 required by this chapter regardless of the person's tax status under state or federal law.

 12 **Section 17.** Section 13-37-402, MCA, is amended to read:

13 **"13-37-402. Constituent accounts -- reports.** (1) A constituent services account may be established
 14 to pay for constituent services by a successful candidate required to report ~~contributions~~ under 13-37-229 ~~and~~
 15 ~~expenditures under 13-37-230~~. A constituent services account may be established by filing an appropriate form
 16 with the commissioner.

17 (2) (a) A successful candidate may deposit only surplus campaign funds in a constituent services
 18 account.

19 (b) The money in the account may be used only for constituent services. The money in the account may
 20 not be used for personal benefit. Expenditures from a constituent services account may not be made when the
 21 holder of the constituent services account also has an open campaign account.

22 (3) A person described in subsection (1) may not establish any account related to the public official's
 23 office other than a constituent services account. This subsection does not prohibit a person from establishing a
 24 campaign account.

25 (4) The holder of a constituent services account shall file a quarterly report with the commissioner, by
 26 a date established by the commissioner by rule. The report must disclose the source of all money deposited in
 27 the account and enumerate expenditures from the account. The report must include the same information as
 28 required for a candidate ~~reporting contributions~~ required to report under 13-37-229 ~~and expenditures under~~
 29 ~~13-37-230~~. The report must be certified as provided in 13-37-231.

30 (5) The holder of a constituent services account shall close the account within 120 days after the account

1 holder leaves public office."

7 NEW SECTION. Section 19. Codification instruction. [Sections 14 and 16] are intended to be codified
8 as an integral part of Title 13, chapter 37, part 2, and the provisions of Title 13, chapter 37, part 2, apply to
9 [sections 14 and 16].

11 NEW SECTION. Section 20. Saving clause. [This act] does not affect rights and duties that matured,
12 penalties that were incurred, or proceedings that were begun before [the effective date of this act].

14 NEW SECTION. Section 21. Severability. If a part of [this act] is invalid, all valid parts that are
15 severable from the invalid part remain in effect. If a part of [this act] is invalid in one or more of its applications,
16 the part remains in effect in all valid applications that are severable from the invalid applications.
