A BILL FOR AN ACT ENTITLED: "AN ACT GENERALLY REVISING CAMPAIGN PRACTICES LAWS; REVISING THE DEFINITION OF "EXPENDITURE"; INCREASING FILING FEES FOR LEGISLATIVE CANDIDATES; REVISING PROCEDURES USED BY THE COMMISSIONER TO ISSUE ORDERS OF NONCOMPLIANCE; REVISING LAWS RELATED TO INVESTIGATION OF CAMPAIGN PRACTICES AND ELECTION-RELATED COMPLAINTS; CREATING AN APPEAL PROCEDURE FOR A CANDIDATE, POLITICAL COMMITTEE, OR RESPONDENT TO APPEAL CERTAIN COMPLAINTS OR PRELIMINARY ORDERS OF NONCOMPLIANCE THAT ARE FILED OR ISSUED DURING CERTAIN TIME PERIODS; REVISING LIMITATIONS ON CAMPAIGN CONTRIBUTIONS; PROVIDING THAT THE COMMISSIONER MAY NOT INITIATE A CRIMINAL ACTION AGAINST A CANDIDATE FOR CERTAIN VIOLATIONS; REVISING THE AGGREGATE CONTRIBUTION AMOUNT THAT TRIGGERS DISCLOSURE OF CERTAIN CONTRIBUTOR INFORMATION; AND AMENDING SECTIONS 13-1-101, 13-10-202, 13-37-113, 13-37-115, 13-37-121, 13-37-124, 13-37-128, 13-37-206, 13-37-216, 13-37-218, 13-37-229, AND 13-37-232, MCA."

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MONTANA:

Section 1. Section 13-1-101, MCA, is amended to read:

"13-1-101. Definitions. As used in this title, unless the context clearly indicates otherwise, the following definitions apply:

(1) "Active elector" means an elector whose name has not been placed on the inactive list due to failure to respond to confirmation notices pursuant to 13-2-220 or 13-19-313.

(2) "Active list" means a list of active electors maintained pursuant to 13-2-220.

(3) "Anything of value" means any goods that have a certain utility to the recipient that is real and that is ordinarily not given away free but is purchased.

(4) "Application for voter registration" means a voter registration form prescribed by the secretary of state that is completed and signed by an elector, is submitted to the election administrator, and contains voter registration information subject to verification as provided by law.

(5) "Ballot" means a paper ballot counted manually or a paper ballot counted by a machine, such as an

1 optical scan system or other technology that automatically tabulates votes cast by processing the paper ballots.

2 (6) (a) "Ballot issue" or "issue" means a proposal submitted to the people at an election for their approval
3 or rejection, including but not limited to an initiative, referendum, proposed constitutional amendment, recall
4 question, school levy question, bond issue question, or ballot question.

5 (b) For the purposes of chapters 35 and 37, an issue becomes a "ballot issue" upon certification by the
6 proper official that the legal procedure necessary for its qualification and placement on the ballot has been
7 completed, except that a statewide issue becomes a "ballot issue" upon preparation and transmission by the
8 secretary of state of the form of the petition or referral to the person who submitted the proposed issue.

9 (7) "Ballot issue committee" means a political committee specifically organized to support or oppose a
10 ballot issue.

11 (8) "Candidate" means:

12 (a) an individual who has filed a declaration or petition for nomination, acceptance of nomination, or
13 appointment as a candidate for public office as required by law;

14 (b) for the purposes of chapter 35, 36, or 37, an individual who has solicited or received and retained
15 contributions, made expenditures, or given consent to an individual, organization, political party, or committee
16 to solicit or receive and retain contributions or make expenditures on the individual's behalf to secure nomination
17 or election to any office at any time, whether or not the office for which the individual will seek nomination or
18 election is known when the:

19 (i) solicitation is made;

20 (ii) contribution is received and retained; or

21 (iii) expenditure is made; or

22 (c) an officeholder who is the subject of a recall election.

23 (9) (a) "Contribution" means:

24 (i) the receipt by a candidate or a political committee of an advance, gift, loan, conveyance, deposit,
25 payment, or distribution of money or anything of value to support or oppose a candidate or a ballot issue;

26 (ii) an expenditure, including an in-kind expenditure, that is made in coordination with a candidate or ballot
27 issue committee and is reportable by the candidate or ballot issue committee as a contribution;

28 (iii) the receipt by a political committee of funds transferred from another political committee; or

29 (iv) the payment by a person other than a candidate or political committee of compensation for the
30 personal services of another person that are rendered to a candidate or political committee.

1 (b) ~~"Contribution"~~ The term does not mean services provided without compensation by individuals
2 volunteering a portion or all of their time on behalf of a candidate or political committee or meals and lodging
3 provided by individuals in their private residences for a candidate or other individual.

4 (10) "Coordinated", including any variations of the term, means made in cooperation with, in consultation
5 with, at the request of, or with the express prior consent of a candidate or political committee or an agent of a
6 candidate or political committee.

7 (11) "De minimis act" means an action, contribution, or expenditure that is so small that it does not trigger
8 registration, reporting, disclaimer, or disclosure obligations under Title 13, chapter 35 or 37, or warrant
9 enforcement as a campaign practices violation under Title 13, chapter 37.

10 (12) "Election" means a general, special, or primary election held pursuant to the requirements of state
11 law, regardless of the time or purpose.

12 (13) "Election administrator" means the county clerk and recorder or the individual designated by a county
13 governing body to be responsible for all election administration duties, except that with regard to school elections
14 not administered by the county, the term means the school district clerk.

15 (14) (a) "Election communication" means the following forms of communication to support or oppose a
16 candidate or ballot issue:

- 17 (i) a paid advertisement broadcast over radio, television, cable, or satellite;
18 (ii) paid placement of content on the internet or other electronic communication network;
19 (iii) a paid advertisement published in a newspaper or periodical or on a billboard;
20 (iv) a mailing; or
21 (v) printed materials.

22 (b) The term does not mean:

23 (i) an activity or communication for the purpose of encouraging individuals to register to vote or to vote,
24 if that activity or communication does not mention or depict a clearly identified candidate or ballot issue;

25 (ii) a communication that does not support or oppose a candidate or ballot issue;

26 (iii) a bona fide news story, commentary, blog, or editorial distributed through the facilities of any
27 broadcasting station, newspaper, magazine, internet website, or other periodical publication of general circulation;

28 (iv) a communication by any membership organization or corporation to its members, stockholders, or
29 employees; or

30 (v) a communication that the commissioner determines by rule is not an election communication.

1 (15) "Election cycle" means the primary election and the general election held to fill an office.

2 ~~(15)~~(16) (a) "Electioneering communication" means a paid communication that is publicly distributed by
3 radio, television, cable, satellite, internet website, newspaper, periodical, billboard, mail, or any other distribution
4 of printed materials, that is made within 60 days of the initiation of voting in an election, that does not support or
5 oppose a candidate or ballot issue, that can be received by more than 100 recipients in the district voting on the
6 candidate or ballot issue, and that:

7 (i) refers to one or more clearly identified candidates in that election;

8 (ii) depicts the name, image, likeness, or voice of one or more clearly identified candidates in that
9 election; or

10 (iii) refers to a political party, ballot issue, or other question submitted to the voters in that election.

11 (b) The term does not mean:

12 (i) a bona fide news story, commentary, blog, or editorial distributed through the facilities of any
13 broadcasting station, newspaper, magazine, internet website, or other periodical publication of general circulation
14 unless the facilities are owned or controlled by a candidate or political committee;

15 (ii) a communication by any membership organization or corporation to its members, stockholders, or
16 employees;

17 (iii) a commercial communication that depicts a candidate's name, image, likeness, or voice only in the
18 candidate's capacity as owner, operator, or employee of a business that existed prior to the candidacy;

19 (iv) a communication that constitutes a candidate debate or forum or that solely promotes a candidate
20 debate or forum and is made by or on behalf of the person sponsoring the debate or forum; or

21 (v) a communication that the commissioner determines by rule is not an electioneering communication.

22 ~~(16)~~(17) "Elector" means an individual qualified to vote under state law.

23 ~~(17)~~(18) (a) "Expenditure" means a purchase, payment, distribution, loan, advance, promise, pledge, or
24 gift of money or anything of value:

25 (i) made by a candidate or political committee to support or oppose a candidate or a ballot issue; or

26 (ii) used or intended for use in making independent expenditures or in producing electioneering
27 communications.

28 (b) ~~"Expenditure"~~ The term does not mean:

29 (i) services, food, or lodging provided in a manner that they are not contributions under subsection (9);

30 (ii) payments by a candidate for a filing fee or for personal travel expenses, food, clothing, lodging, or

- 1 personal necessities for the candidate and the candidate's family;
- 2 (iii) the cost of any bona fide news story, commentary, blog, or editorial distributed through the facilities
- 3 of any broadcasting station, newspaper, magazine, or other periodical publication of general circulation; ~~or~~
- 4 (iv) the cost of any communication by any membership organization or corporation to its members or
- 5 stockholders or employees; or
- 6 (v) the use by a candidate of yard signs, brochures, cards, bumper stickers, or other campaign materials
- 7 from a previous campaign IF THE MATERIALS ARE PROPERLY ATTRIBUTED AS REQUIRED IN 13-35-225.
- 8 ~~(18)~~(19) "Federal election" means an election in even-numbered years in which an elector may vote for
- 9 individuals for the office of president of the United States or for the United States congress.
- 10 ~~(19)~~(20) "General election" means an election that is held for offices that first appear on a primary election
- 11 ballot, unless the primary is canceled as authorized by law, and that is held on a date specified in 13-1-104.
- 12 ~~(20)~~(21) "Inactive elector" means an individual who failed to respond to confirmation notices and whose
- 13 name was placed on the inactive list pursuant to 13-2-220 or 13-19-313.
- 14 ~~(21)~~(22) "Inactive list" means a list of inactive electors maintained pursuant to 13-2-220 or 13-19-313.
- 15 ~~(22)~~(23) (a) "Incidental committee" means a political committee that is not specifically organized or
- 16 operating for the primary purpose of supporting or opposing candidates or ballot issues but that may incidentally
- 17 become a political committee by receiving a contribution or making an expenditure.
- 18 (b) For the purpose of this subsection ~~(22)~~ (23), the primary purpose is determined by the commissioner
- 19 by rule and includes criteria such as the allocation of budget, staff, or members' activity or the statement of
- 20 purpose or goal of the person or individuals that form the committee.
- 21 ~~(23)~~(24) "Independent committee" means a political committee organized for the primary purpose of
- 22 receiving contributions and making expenditures that is not controlled either directly or indirectly by a candidate
- 23 and that does not coordinate with a candidate in conjunction with the making of expenditures except pursuant
- 24 to the limits set forth in 13-37-216(1).
- 25 ~~(24)~~(25) "Independent expenditure" means an expenditure for an election communication to support or
- 26 oppose a candidate or ballot issue made at any time that is not coordinated with a candidate or ballot issue
- 27 committee.
- 28 ~~(25)~~(26) "Individual" means a human being.
- 29 ~~(26)~~(27) "Legally registered elector" means an individual whose application for voter registration was
- 30 accepted, processed, and verified as provided by law.

1 ~~(27)~~(28) "Mail ballot election" means any election that is conducted under Title 13, chapter 19, by mailing
2 ballots to all active electors.

3 ~~(28)~~(29) "Person" means an individual, corporation, association, firm, partnership, cooperative,
4 committee, including a political committee, club, union, or other organization or group of individuals or a candidate
5 as defined in subsection (8).

6 ~~(29)~~(30) "Place of deposit" means a location designated by the election administrator pursuant to
7 13-19-307 for a mail ballot election conducted under Title 13, chapter 19.

8 ~~(30)~~(31) (a) "Political committee" means a combination of two or more individuals or a person other than
9 an individual who receives a contribution or makes an expenditure:

10 (i) to support or oppose a candidate or a committee organized to support or oppose a candidate or a
11 petition for nomination;

12 (ii) to support or oppose a ballot issue or a committee organized to support or oppose a ballot issue; or

13 (iii) to prepare or disseminate an election communication, an electioneering communication, or an
14 independent expenditure.

15 (b) Political committees include ballot issue committees, incidental committees, independent committees,
16 and political party committees.

17 (c) A candidate and the candidate's treasurer do not constitute a political committee.

18 (d) A political committee is not formed when a combination of two or more individuals or a person other
19 than an individual makes an election communication, an electioneering communication, or an independent
20 expenditure of \$250 or less.

21 ~~(31)~~(32) "Political party committee" means a political committee formed by a political party organization
22 and includes all county and city central committees.

23 ~~(32)~~(33) "Political party organization" means a political organization that:

24 (a) was represented on the official ballot in either of the two most recent statewide general elections; or

25 (b) has met the petition requirements provided in Title 13, chapter 10, part 5.

26 ~~(33)~~(34) "Political subdivision" means a county, consolidated municipal-county government, municipality,
27 special purpose district, or any other unit of government, except school districts, having authority to hold an
28 election.

29 ~~(34)~~(35) "Polling place election" means an election primarily conducted at polling places rather than by
30 mail under the provisions of Title 13, chapter 19.

1 ~~(35)~~(36) "Primary" or "primary election" means an election held on a date specified in 13-1-107 to
2 nominate candidates for offices filled at a general election.

3 ~~(36)~~(37) "Provisional ballot" means a ballot cast by an elector whose identity or eligibility to vote has not
4 been verified as provided by law.

5 ~~(37)~~(38) "Provisionally registered elector" means an individual whose application for voter registration
6 was accepted but whose identity or eligibility has not yet been verified as provided by law.

7 ~~(38)~~(39) "Public office" means a state, county, municipal, school, or other district office that is filled by
8 the people at an election.

9 ~~(39)~~(40) "Random-sample audit" means an audit involving a manual count of ballots from designated
10 races and ballot issues in precincts selected through a random process as provided in 13-17-503.

11 ~~(40)~~(41) "Registrar" means the county election administrator and any regularly appointed deputy or
12 assistant election administrator.

13 ~~(41)~~(42) "Regular school election" means the school trustee election provided for in 20-20-105(1).

14 ~~(42)~~(43) "School election" has the meaning provided in 20-1-101.

15 ~~(43)~~(44) "School election filing officer" means the filing officer with whom the declarations for nomination
16 for school district office were filed or with whom the school ballot issue was filed.

17 ~~(44)~~(45) "School recount board" means the board authorized pursuant to 20-20-420 to perform recount
18 duties in school elections.

19 ~~(45)~~(46) "Signature envelope" means an envelope that contains a secrecy envelope and ballot and that
20 is designed to:

21 (a) allow election officials, upon examination of the outside of the envelope, to determine that the ballot
22 is being submitted by someone who is in fact a qualified elector and who has not already voted; and

23 (b) allow it to be used in the United States mail.

24 ~~(46)~~(47) "Special election" means an election held on a day other than the day specified for a primary
25 election, general election, or regular school election.

26 ~~(47)~~(48) "Special purpose district" means an area with special boundaries created as authorized by law
27 for a specialized and limited purpose.

28 ~~(48)~~(49) "Statewide voter registration list" means the voter registration list established and maintained
29 pursuant to 13-2-107 and 13-2-108.

30 ~~(49)~~(50) "Support or oppose", including any variations of the term, means:

1 (a) using express words, including but not limited to "vote", "oppose", "support", "elect", "defeat", or
 2 "reject", that call for the nomination, election, or defeat of one or more clearly identified candidates, the election
 3 or defeat of one or more political parties, or the passage or defeat of one or more ballot issues submitted to voters
 4 in an election; or

5 (b) otherwise referring to or depicting one or more clearly identified candidates, political parties, or ballot
 6 issues in a manner that is susceptible of no reasonable interpretation other than as a call for the nomination,
 7 election, or defeat of the candidate in an election, the election or defeat of the political party, or the passage or
 8 defeat of the ballot issue or other question submitted to the voters in an election.

9 ~~(50)~~(51) "Transfer form" means a form prescribed by the secretary of state that may be filled out by an
 10 elector to transfer the elector's registration when the elector's residence address has changed within the county.

11 ~~(54)~~(52) "Valid vote" means a vote that has been counted as valid or determined to be valid as provided
 12 in 13-15-206.

13 ~~(52)~~(53) "Voted ballot" means a ballot that is:

- 14 (a) deposited in the ballot box at a polling place;
 15 (b) received at the election administrator's office; or
 16 (c) returned to a place of deposit.

17 ~~(53)~~(54) "Voting system" or "system" means any machine, device, technology, or equipment used to
 18 automatically record, tabulate, or process the vote of an elector cast on a paper ballot."

20 **Section 2.** Section 13-10-202, MCA, is amended to read:

21 **"13-10-202. Filing fees.** Filing fees are as follows:

22 (1) for offices having an annual salary of \$2,500 or less ~~and candidates for the legislature~~, \$15;

23 (2) for candidates for the legislature, \$20;

24 ~~(2)~~(3) for county offices having an annual salary of more than \$2,500, 0.5% of the total annual salary;

25 ~~(3)~~(4) for other offices having an annual salary of more than \$2,500, 1% of the total annual salary;

26 ~~(4)~~(5) for offices in which compensation is paid in fees, \$10;

27 ~~(5)~~(6) for officers of political parties, presidential electors, and officers who receive no salary or fees, no
 28 filing fee is required."

29

30 **Section 3.** Section 13-37-113, MCA, is amended to read:

1 **"13-37-113. Hiring of attorneys -- prosecutions.** The commissioner may hire or retain attorneys who
 2 are properly licensed to practice before the supreme court of the state of Montana to prosecute violations of
 3 chapter 35 of this title or this chapter. Any attorney retained or hired shall exercise the powers of a special
 4 attorney general, and the attorney may prosecute, subject to the control and supervision of the commissioner and
 5 the provisions of 13-35-240, 13-37-124, and 13-37-125, any criminal or civil action arising out of a violation of any
 6 provision of chapter 35 of this title or this chapter. All prosecutions must be brought in the state district court for
 7 the county in which a violation has occurred or in the district court for Lewis and Clark County. The authority to
 8 prosecute as prescribed by this section includes the authority to:

9 (1) except as provided in 13-37-128(3), institute proceedings for the arrest of persons charged with or
 10 reasonably suspected of criminal violations of chapter 35 of this title or this chapter;

11 (2) attend and give advice to a grand jury when cases involving criminal violations of chapter 35 of this
 12 title or this chapter are presented;

13 (3) except as provided in 13-37-128(3), draw and file indictments, informations, and criminal complaints;

14 (4) prosecute all actions for the recovery of ~~debts, fines, DEBTS, FINES, penalties, or forfeitures, OR~~
 15 FORFEITURES accruing to the state or county from persons convicted of violating chapter 35 of this title or this
 16 chapter; and

17 (5) do any other act necessary to successfully prosecute a violation of any provision of chapter 35 of this
 18 title or this chapter."

20 **Section 4.** Section 13-37-115, MCA, is amended to read:

21 **"13-37-115. Orders of noncompliance.** The commissioner may issue orders of noncompliance as
 22 prescribed by 13-37-121 and [section 7]."

23

24 **Section 5.** Section 13-37-121, MCA, is amended to read:

25 **"13-37-121. Inspection of statements and reports -- issuance of preliminary and final orders of**
 26 **noncompliance.** (1) Each statement and report filed with the commissioner during an election or within 60 days
 27 after the election must be inspected within 20 days after the statement or report is filed. Intermediate Saturdays,
 28 Sundays, and holidays must be excluded in the computation of time under this section. If a person has not
 29 satisfied the provisions of this chapter, the commissioner shall immediately notify the person of the
 30 noncompliance. Notification by the commissioner may be accomplished by written or electronic communication

1 or by telephone. If the person fails to comply after the notification, the commissioner shall issue ~~an~~ a preliminary
 2 order of noncompliance as provided in this section.

3 (2) ~~An~~ A preliminary order of noncompliance may be issued when:

4 (a) upon examination of the official ballot, it appears that the person has failed to file a statement or
 5 report as required by this chapter or that a statement or report filed by a person does not conform to law; or

6 (b) it is determined that a statement or report filed with the commissioner does not conform to the
 7 requirements of this chapter or that a person has failed to file a statement or report required by law.

8 (3) ~~If an~~ the act occurred 45 days before an election and the commissioner issued the preliminary order
 9 of noncompliance ~~is issued during a campaign period or within 60 days after an~~ before the election, a candidate
 10 or political committee shall submit the necessary information within 5 days after receiving the preliminary order
 11 of noncompliance. Upon a failure to submit the required information within the time specified, the commissioner
 12 shall issue a final order of noncompliance and the appropriate county attorney or the commissioner may initiate
 13 a civil or criminal action pursuant to the procedures outlined in 13-37-124 and 13-37-125.

14 (4) (a) ~~If an~~ a preliminary order of noncompliance is issued during any period other than that described
 15 in subsection (3), within 10 days after receiving the order a candidate or political committee shall submit the
 16 necessary information ~~within 10 days after receiving the order of noncompliance~~ or notify the commissioner by
 17 written or electronic communication that the candidate or political committee intends to appeal the preliminary
 18 order of noncompliance as provided in [section 7].

19 (b) Upon a failure ~~of a candidate or a political committee to either~~ to submit the required information or
 20 notify the commissioner of an appeal within the time specified ~~in subsection (4)(a), the commissioner shall issue~~
 21 a final order of noncompliance and the appropriate county attorney or the commissioner shall initiate a civil or
 22 criminal action pursuant to the procedures outlined in 13-37-124 and 13-37-125.

23 (5) (a) ~~After a complaint is filed with the commissioner pursuant to 13-37-111, If the preliminary order~~
 24 of noncompliance is issued during the time period described in subsection (3), the procedure ~~procedures~~
 25 described in this section regarding the provision of notice and issuance of orders of noncompliance ~~is~~ are not a
 26 prerequisite to initiation of any other administrative or judicial action authorized under chapter 35 of this title or
 27 this chapter.

28 (b) If the preliminary order of noncompliance is issued during any period other than that described in
 29 subsection (3), the procedures described in this section and [section 7] regarding the provision of notice and
 30 issuance of orders of noncompliance are a prerequisite to initiation of any other administrative or judicial action

1 authorized under chapter 35 of this title or this chapter."

3 **NEW SECTION. Section 6. Preliminary decision regarding complaint.** (1) Before the commissioner
4 issues a formal decision regarding a complaint filed with the commissioner pursuant to 13-37-111, the
5 commissioner shall issue a preliminary decision and provide a copy of the preliminary decision to the complainant
6 and respondent. Within 10 days after receiving the preliminary decision, the respondent may notify the
7 commissioner by written or electronic communication that the respondent intends to comply with the decision or
8 intends to appeal the commissioner's decision as provided in [section 7].

9 (2) Upon failure of the respondent to notify the commissioner of an appeal within the time specified in
10 subsection (1), the commissioner shall issue a final decision, which must be provided to the complainant and the
11 respondent, and the commissioner may pursue any other administrative or judicial action authorized under
12 chapter 35 of this title or this chapter.

13 (3) (a) If a complaint is filed with the commissioner pursuant to 13-37-111 during the 45 days before an
14 election, the provisions of this section regarding the provision of notice and issuance of a preliminary decision
15 are not a prerequisite to initiation of any other administrative or judicial action authorized under chapter 35 of this
16 title or this chapter.

17 (b) If a complaint is filed with the commissioner pursuant to 13-37-111 during any period other than that
18 described in subsection (3)(a), the provisions of this section regarding the provision of notice and issuance of a
19 preliminary decision are a prerequisite to initiation of any other administrative or judicial action authorized under
20 chapter 35 of this title or this chapter.

21 (4) The provisions of this section do not apply if the commissioner dismisses the complaint.

22 (5) Intermediate Saturdays, Sundays, and holidays must be excluded in the computation of time under
23 this section.

24

25 **NEW SECTION. Section 7. Appeal of preliminary order of noncompliance or complaint decision**
26 **-- issuance of final order of noncompliance or complaint decision.** (1) If a candidate, political committee, or
27 respondent timely notifies the commissioner of an appeal of a preliminary order of noncompliance as provided
28 in 13-37-121 or a preliminary decision as provided in [section 6], the commissioner may not issue a final order
29 of noncompliance, issue a final decision, or pursue other administrative or judicial action until the requirements
30 of this section have been met.

1 (2) Within 3 days after receiving the appeal notification from a candidate, political committee, or
 2 respondent, the commissioner shall notify the candidate, political committee, or respondent by written or
 3 electronic communication or telephone to begin the appeal process.

4 (3) (a) Within 10 days after the appeal notification required by subsection (2), a mediator must have been
 5 selected by the parties and the parties must have scheduled a mediation proceeding, unless another timeline is

 7 the alleged violation and preliminary order of noncompliance or decision, including any initiating complaint, the
 8 investigative file, the decision, and all exhibits relevant to the alleged violation. The candidate, political committee,
 9 or respondent may provide the mediator with additional information regarding the alleged violation.

10 (b) An appeal proceeding may not proceed past 30 calendar days after the mediator is appointed, unless
 11 another timeline is agreed to in writing by both parties. Each party is responsible for that party's mediation costs
 12 and shall jointly share the costs of the mediator. An appeal proceeding may be held in person, online, or by
 13 telephone. Appeal proceedings must be conducted pursuant to 26-1-813 as a private, confidential, and informal
 14 dispute resolution.

15 (c) Within 5 days after the appeal proceedings have concluded, the mediator shall complete and file a
 16 mediator's report with the commissioner. The report must be made available to the candidate, political committee,
 17 or respondent.

18 (4) If the parties are unable to agree to a resolution of the complaint after the appeal procedure is

1 (4) An incidental committee that does not receive contributions for a specified candidate, ballot issue,
2 or petition for nomination and that does not solicit contributions for incidental committee election activity, including
3 in-kind expenditures, independent expenditures, election communications, or electioneering communications,
4 is required to report only its expenditures."
