

ASSEMBLY BILL NO. 440—COMMITTEE ON
LEGISLATIVE OPERATIONS AND ELECTIONS

MARCH 25, 2013

Referred to Committee on Legislative Operations and Elections

SUMMARY—Revises provisions relating to voter registration.
(BDR 24-987)

FISCAL NOTE: Effect on Local Government: May have Fiscal Impact.
Effect on the State: Yes.

EXPLANATION – Matter in *bolded italics* is new; matter between brackets ~~omitted material~~ is material to be omitted.

AN ACT relating to elections; extending the period during which an elector can register to vote in person or by computer; requiring county and city clerks to distribute sample ballots by electronic mail under certain circumstances; and providing other matters properly relating thereto.

Legislative Counsel’s Digest:

1 Under existing law, registration for any primary, primary city, general or
2 general city election closes on the third Tuesday before the election. Unless
3 otherwise specified, registration for a recall or special election closes on the third
4 Saturday before the election. After the fifth Sunday before a primary, primary city,
5 general or general city election, a person may register to vote only by appearing in
6 person at the office of the county or city clerk, as applicable, or other designated
7 site for registering to vote. (NRS 293.560, 293C.527) **Sections 5 and 12** of this bill
8 extend the period in which a person may register to vote for primary, primary city,
9 general and general city elections until the last day of early voting for those
10 elections, which is the Friday before the election. **Sections 5 and 12** also allow a
11 person to register to vote by computer after the fifth Sunday before the election.
12 Additionally, **sections 5 and 12** extend the period in which a person may register to
13 vote for all elections except otherwise specified recall and special elections until the
14 fourth day before the election. **Sections 3, 4, 7 and 11** of this bill make conforming
15 changes.

16 Under existing law, each county and city clerk is required to mail a sample
17 ballot to each registered voter in the applicable county or city. (NRS 293.565,
18 293C.530) **Sections 6.5 and 12.1** of this bill require each county and city clerk to
19 distribute sample ballots by electronic mail to each registered voter who elects to
20 receive sample ballots in that manner. **Sections 2.5, 7.5 and 12.2-12.6** of this bill
21 make conforming changes.

22 The changes in this bill take effect on January 1, 2014.

1 **Section 1.** (Deleted by amendment.)

2 **Sec. 2.** (Deleted by amendment.)

3 **Sec. 2.5.** NRS 293.097 is hereby amended to read as follows:

4 293.097 “Sample ballot” means a document distributed by a
5 county or city clerk upon which is ~~printed~~ *included* a list of the
6 offices, candidates and ballot questions that will appear on a ballot.
7 The term includes any such document which is printed by a
8 computer ~~+~~ *and which is distributed by mail or electronic mail.*

9 **Sec. 3.** NRS 293.356 is hereby amended to read as follows:

10 293.356 If a request is made *in person* to vote early by a
11 registered voter ~~in person,~~ *, including, without limitation, a*
12 *registered voter who registered to vote after the beginning of the*
13 *period for early voting by personal appearance,* the election board
14 shall issue a ballot for early voting to the voter. Such a ballot must
15 be voted on the premises of a polling place for early voting
16 established pursuant to NRS 293.3564 or 293.3572.

17 **Sec. 4.** NRS 293.557 is hereby amended to read as follows:

18 293.557 1. The county clerk may cause to be published once
19 in each of the newspapers circulated in different parts of the county
20 or cause to be published once in a newspaper circulated in the
21 county:

22 (a) An alphabetical listing of all registered voters, including the
23 precinct of each voter:

24 (1) Within the circulation area of each newspaper if the
25 listing is published in each newspaper circulated in different parts of
26 the county; or

27 (2) Within the entire county if the listing is published in only
28 one newspaper in the county; or

29 (b) A statement notifying the public that the county clerk will
30 provide an alphabetical listing of the names of all registered voters
31 in the entire county and the precinct of each voter free of charge to
32 any person upon request.

33 2. If the county clerk publishes the list of registered voters, the
34 county clerk must do so:

35 (a) Not less than 2 weeks before the ~~close of registration for~~
36 ~~any~~ primary election.

37 (b) After each primary election and not less than 2 weeks before
38 the ~~close of registration for the~~ ensuing general election.

39 3. The county may not pay more than 10 cents per name for
40 six-point or seven-point type or 15 cents per name for eight-point
41 type or larger to each newspaper publishing the list.



1 4. The list of registered voters, if published, must not be
2 printed in type smaller than six-point.

11 ~~Tuesday preceding the day of the elections.}~~

12 2. For a primary or special election, the office of the county
13 clerk must be open until 7 p.m. ~~{during}~~ *on the next to last {2 days}*
14 *day* on which registration is open ~~{}~~ *and 5 p.m. on the last day on*
15 *which registration is open.* In a county whose population is less
16 than 100,000, the office of the county clerk may close at 5 p.m.
17 ~~{during}~~ *on the next to last {2 days} day* before registration closes if
18 approved by the board of county commissioners.

19 3. For a general election:

20 (a) In a county whose population is less than 100,000, the office
21 of the county clerk must be open until 7 p.m. ~~{during}~~ *on the next to*
22 *last {2 days} day* on which registration is open ~~{}~~ *and 5 p.m. on the*
23 *last day on which registration is open.* The office of the county
24 clerk may close at 5 p.m. *on the next to last day on which*
25 *registration is open* if approved by the board of county
26 commissioners.

27 (b) In a county whose population is 100,000 or more, the office
28 of the county clerk must be open during the last 4 days on which
29 registration is open, according to the following schedule:

30 (1) On ~~{weekdays}~~ *a day other than the last day on which*
31 *registration is open*, until 9 p.m.; ~~{and}~~

32 (2) A minimum of 8 hours on Saturdays, Sundays and legal
33 holidays ~~{}~~; *and*

38 (a) The county clerk of each county shall cause a notice signed

29 (a) If applicable, the statement required by NRS 293.267;

30 (b) The fiscal note or description of anticipated financial effect,
31 as provided pursuant to NRS 218D.810, 293.250, 293.481, 293.482,
32 295.015 or 295.095 for each proposed constitutional amendment,
33 statewide measure, measure to be voted upon only by a special
34 district or political subdivision and advisory question;

35 (c) An explanation, as provided pursuant to NRS 218D.810,
36 293.250, 293.481, 293.482 or 295.121, of each proposed
37 constitutional amendment, statewide measure, measure to be voted
38 upon only by a special district or political subdivision and advisory
39 question;

40 (d) Arguments for and against each proposed constitutional
41 amendment, statewide measure, measure to be voted upon only by a
42 special district or political subdivision and advisory question, and
43 rebuttals to each argument, as provided pursuant to NRS 218D.810,
44 293.250, 293.252, 293.481, 293.482 or 295.121; and

45 (e) The full text of each proposed constitutional amendment.



1 2. If, pursuant to the provisions of NRS 293.2565, the word
2 “Incumbent” must appear on the ballot next to the name of the
3 candidate who is the incumbent, the word “Incumbent” must appear
4 on the sample ballot next to the name of the candidate who is the
5 incumbent.

6 3. Sample ballots that are mailed to registered voters may be
7 printed without the full text of each proposed constitutional
8 amendment if:

9 (a) The cost of printing the sample ballots would be significantly
10 reduced if the full text of each proposed constitutional amendment
11 were not included;

12 (b) The county clerk ensures that a sample ballot that includes
13 the full text of each proposed constitutional amendment is provided
14 at no charge to each registered voter who requests such a sample
15 ballot; and

16 (c) The sample ballots provided to each polling place include the
17 full text of each proposed constitutional amendment.

18 4. *A registered voter may elect to receive a sample ballot by
19 electronic mail. If a registered voter elects to receive a sample
20 ballot by electronic mail, the county clerk shall distribute the
21 sample ballot to the registered voter by electronic mail pursuant to
22 the procedures and requirements set forth by regulations adopted
23 by the Secretary of State. If a registered voter does not elect to
24 receive a sample ballot by electronic mail, the county clerk shall

13 requests a sample ballot in large type by exercising the option
14 provided pursuant to NRS 293.508, or in any other manner, must be
15 ~~printed~~ *prepared* in at least 14-point type, or larger when
16 practicable.

17 ~~8-7~~ 9. If a person requests a sample ballot in large type, the
18 county clerk shall ensure that all future sample ballots ~~mailed~~
19 *distributed* to that person from the county are in large type.

20 ~~9-7~~ 10. The county clerk shall include in each sample ballot a
21 statement indicating that the county clerk will, upon request of a
22 voter who is elderly or disabled, make reasonable accommodations
23 to allow the voter to vote at his or her polling place and provide

8 follows:

9 293C.530 1. *A registered voter may elect to receive a*
10 *sample ballot by electronic mail. If a registered voter elects to*
11 *receive a sample ballot by electronic mail, the city clerk shall*
12 *distribute the sample ballot to the registered voter by electronic*
13 *mail pursuant to the procedures and requirements set forth by*

37 **Sec. 12.2.** NRS 244A.785 is hereby amended to read as
38 follows:

39 244A.785 1. The board of county commissioners of a county
40 whose population is 700,000 or more may, by ordinance, create one
41 or more districts within the unincorporated area of the county for the
42 support of public parks. Such a district may include territory within
43 the boundary of an incorporated city if so provided by interlocal
44 agreement between the county and the city.



1 2. The ordinance creating a district must specify its boundaries.
2 The area included within the district may be contiguous or
3 noncontiguous. The boundaries set by the ordinance are not affected
4 by later annexations to or incorporation of a city.

5 3. The alteration of the boundaries of such a district may be
6 initiated by:

7 (a) A petition proposed unanimously by the owners of the
8 property which is located in the proposed area which was not
9 previously included in the district; or

10 (b) A resolution adopted by the board of county commissioners
11 on its own motion.

12 ➔ If the board of county commissioners proposes on its own motion
13 to alter the boundaries of a district for the support of public parks, it
14 shall, at the next primary or general election, submit to the
15 registered voters who reside in the proposed area which was not
16 previously included in the district, the question of whether the
17 boundaries of the district shall be altered. If a majority of the voters
18 approve the question, the board shall, by ordinance, alter the
19 boundaries of the district as approved by the voters.

20 4. The sample ballot required to be ~~mailed~~ *distributed*
21 pursuant to NRS 293.565 must include for the question described in
22 subsection 3, a disclosure of any future increase or decrease in costs
23 which may be reasonably anticipated in relation to the purposes of
24 the district for the support of public parks and its probable effect on
25 the district's tax rate.

26 **Sec. 12.3.** NRS 266.0325 is hereby amended to read as
27 follows:

28 266.0325 1. At least 10 days before an election held pursuant
29 to NRS 266.029, the county clerk or registrar of voters shall cause to
30 be ~~mailed~~ *distributed* to each qualified elector *by mail or*
31 *electronic mail, as applicable*, a sample ballot for the elector's
32 precinct with a notice informing the elector of the location of the
33 polling place for that precinct.

34 2. The sample ballot must:

35 (a) Be in the form required by NRS 266.032.

36 (b) Include the information required by NRS 266.032.

37 (c) Except as otherwise provided in subsection 3, be ~~printed~~
38 *prepared* in at least 12-point type.

39 (d) Describe the area proposed to be incorporated by assessor's
40 parcel maps, existing boundaries of subdivision or parcel maps,
41 identifying visible ground features, extensions of the visible ground
42 features, or by any boundary that coincides with the official
43 boundary of the State, a county, a city, a township, a section or any
44 combination thereof.



1 (e) Contain a copy of the map or plat that was submitted with
2 the petition pursuant to NRS 266.019 and depicts the existing
3 dedicated streets, sewer interceptors and outfalls and their proposed
4 extensions.

5 (f) Include on the front page, in a separate box created by bold
6 lines, a notice ~~printed~~ *prepared* in at least 20-point bold type that
7 states:

9 NOTICE: TO RECEIVE A SAMPLE BALLOT IN
10 LARGE TYPE, CALL (Insert appropriate telephone number)

12 3. A portion of a sample ballot that contains a facsimile of the
13 display area of a voting device may include material in less than 12-
14 point type to the extent necessary to make the facsimile fit on ~~the~~
15 ~~pages of~~ the sample ballot.

16 4. The sample ballot ~~mailed~~ *distributed* to a person who
17 requests a sample ballot in large type by exercising the option
18 provided pursuant to NRS 293.508, or in any other manner, must be
19 ~~printed~~ *prepared* in at least 14-point type, or larger when
20 practicable.

21 5. If a person requests a sample ballot in large type, the county
22 clerk shall ensure that all future sample ballots ~~mailed~~ *distributed*
23 to that person from the county are in large type.

24 **Sec. 12.4.** NRS 349.015 is hereby amended to read as follows:

25 349.015 1. Except as otherwise provided in subsection 3, the
26 sample ballot required to be ~~mailed~~ *distributed* pursuant to NRS
27 293.565 or 293C.530, and the notice of election must contain:

28 (a) The time and places of holding the election.

29 (b) The hours during the day in which the polls will be open,
30 which must be the same as provided for general elections.

31 (c) The purposes for which the bonds are to be issued.

32 (d) A disclosure of any:

33 (1) Future increase or decrease in costs which can reasonably
34 be anticipated in relation to the purposes for which the obligations
35 are to be issued and its probable effect on the tax rate; and

36 (2) Requirement relating to the bond question which is
37 imposed pursuant to a court order or state or federal statute and the
38 probable consequences which will result if the bond question is not
39 approved by the voters.

40 (e) An estimate of the annual cost to operate, maintain and
41 repair any buildings, structures or other facilities or improvements
42 to be constructed or acquired with the proceeds of the bonds.

43 (f) The maximum amount of the bonds.

44 (g) The maximum rate of interest.

45 (h) The maximum number of years which the bonds are to run.



1 2. Any election called pursuant to NRS 349.010 to 349.070,
2 inclusive, may be consolidated with a primary or general election.

3 3. If the election is consolidated with a general election, the
4 notice of election need not set forth the places of holding the
5 election, but may instead state that the places of holding the election
6 will be the same as those provided for the general election.

7 **Sec. 12.5.** NRS 350.024 is hereby amended to read as follows:

8 350.024 1. The ballot question for a proposal submitted to
9 the electors of a municipality pursuant to subsection 1 of NRS
10 350.020 must contain the principal amount of the general
11 obligations to be issued or incurred, the purpose of the issuance or
12 incurrence of the general obligations and an estimate established by
13 the governing body of:

14 (a) The duration of the levy of property tax that will be used to
15 pay the general obligations; and

16 (b) The average annual increase, if any, in the amount of
17 property taxes that an owner of a new home with a fair market value
18 of \$100,000 will pay for debt service on the general obligations to
19 be issued or incurred.

20 2. Except as otherwise provided in subsection 4, the sample
21 ballot required to be ~~mailed~~ *distributed* pursuant to NRS 293.565
22 or 293C.530 and the notice of election must contain:

23 (a) The time and places of holding the election.

24 (b) The hours during the day in which the polls will be open,
25 which must be the same as provided for general elections.

26 (c) The ballot question.

27 (d) The maximum amount of the obligations, including the
28 anticipated interest, separately stating the total principal, the total
29 anticipated interest and the anticipated interest rate.

30 (e) An estimate of the range of property tax rates stated in
31 dollars and cents per \$100 of assessed value necessary to provide for
32 debt service upon the obligations for the dates when they are to be
33 redeemed. The municipality shall, for each such date, furnish an
34 estimate of the assessed value of the property against which the
35 obligations are to be issued or incurred, and the governing body
36 shall estimate the tax rate based upon the assessed value of the
37 property as given in the assessor's estimates.

38 3. If an operating or maintenance rate is proposed in
39 conjunction with the question to issue obligations, the questions
40 may be combined, but the sample ballot and notice of election must
41 each state the tax rate required for the obligations separately from
42 the rate proposed for operation and maintenance.

43 4. Any election called pursuant to NRS 350.020 to 350.070,
44 inclusive, may be consolidated with a primary or general municipal
45 election or a primary or general state election. The notice of election



1 need not set forth the places of holding the election, but may instead
2 state that the places of holding the election will be the same as those
3 provided for the election with which it is consolidated.

4 5. If the election is a special election, the clerk shall cause
5 notice of the close of registration to be published in a newspaper
6 printed in and having a general circulation in the municipality once
7 in each calendar week for 2 successive calendar weeks next
8 preceding the close of registration for the election.

9 **Sec. 12.6.** NRS 350.027 is hereby amended to read as follows:

10 350.027 1. In addition to any requirements imposed pursuant
11 to NRS 350.024, any sample ballot required to be ~~mailed~~
12 *distributed* pursuant to NRS 293.565 or 293C.530 and any notice of
13 election, for an election that includes a proposal for the issuance by
14 any municipality of any bonds or other securities, including an
15 election that is not called pursuant to NRS 350.020 to 350.070,
16 inclusive, must contain an estimate of the annual cost to operate,
17 maintain and repair any buildings, structures or other facilities or
18 improvements to be constructed or acquired with the proceeds of the
19 bonds or other securities.

20 2. For the purposes of this section, "municipality" has the
21 meaning ascribed to it in NRS 350.538.
