

SENATE BILL NO. 484—COMMITTEE ON JUDICIARY

SUMMARY—Revises provisions concerning personal financial administration. (BDR 3-1087)

AN ACT relating to personal financial administration; revising provisions relating to the distribution and administration of the estate of a deceased person; revising provisions governing certain nonprobate transfers; revising provisions relating to the creation and administration of trusts; providing for the creation and administration of public benefit trusts; revising the powers that may be exercised by a trustee; revising provisions relating to directed trusts; revising provisions relating to the jurisdiction of a court in cases concerning the administration of the estate of a deceased person and the administration of trusts; and providing other matters properly relating thereto.

**Legislative Counsel’s Digest:**

- 1 **Sections 1 and 2** of this bill provide methods for recording the termination of a
- 2 life estate in a manner similar to existing law for terminating a joint tenancy.
- 3 **Section 3** of this bill establishes the effective date for the existing law
- 4 concerning the effect of divorce on certain instruments.
- 5 Existing law provides that, with one exception, a domestic partner has the
- 6 identical rights and responsibilities as those granted to or imposed upon a spouse.
- 7 (NRS 122A.200) **Sections 5, 7 and 10** of this bill clarify that any reference to a
- 8 spouse in title 12 of NRS is equally a reference to a domestic partner. **Sections**
- 9 **35.3-35.7** of this bill provide that same clarification with respect to title 13 of NRS.
- 10 Existing law defines the term “interested person” for the purpose of
- 11 determining who is entitled to receive notice of, and participate in, a proceeding
- 12 relating to the estate of a deceased person. (NRS 132.185) **Sections 9 and 11** of this
- 13 bill amend this definition to include all persons whose interest in an estate or trust
- 14 will be materially affected by a decision of a fiduciary or a decision of the court and



15 that a person's status as an interested person is determined according to the  
16 particular purposes of, and the matter involved in, each proceeding.

17 Existing law provides that if a decedent executed a will before his or her  
18 marriage, the will is revoked as to the surviving spouse of the decedent unless the  
19 spouse is provided for in the will or is mentioned in the will in such a way that  
20 indicates an intent not to make a provision for the spouse. (NRS 133.110)  
21 **Section 12** of this bill revises this provision so that such a will is not revoked if the  
22 will refers to a future spouse by name.

23 **Section 13** of this bill provides that if a declaratory judgment establishing the  
24 validity of a will is entered during the lifetime of the person executing the will,  
25 the validity of the will cannot be challenged after the death of the person executing  
26 the will. **Section 13** does not prohibit an action to establish that the will was  
27 revoked or that the decedent executed a valid later will.

28 Existing law establishes the qualifications for a person to serve as executor or  
29 administrator of a decedent's estate. (NRS 138.020, 139.010) **Sections 14 and 16**  
30 of this bill authorize a court to disqualify a person from acting as the executor or  
31 administrator of a decedent's estate upon proof of any compelling reason.

32 Existing law establishes the authority of administrators with the will annexed  
33 and the order of appointment for such administrators. (NRS 138.090) **Section 15** of  
34 this bill provides certain discretionary powers to administrators with the will  
35 annexed. **Section 15** also provides that a person who is expressly excluded as a  
36 beneficiary or as a fiduciary in a will is ineligible to serve as an administrator with  
37 the will annexed and that the court has discretion to disregard the order of priority  
38 for the appointment of an administrator under existing law to favor the appointment  
39 of certain beneficiaries of the will as administrators with the will annexed.

40 **Section 17** of this bill provides a technical correction to NRS 143.380  
41 concerning the sale of property held in an estate after the personal representative is  
42 granted full authority under the Independent Administration of Estates Act.

43 Existing law requires an appraisal of certain property of the estate of a deceased  
44 person and an inventory of all estate property. (NRS 144.010, 144.020, 144.040)  
45 **Sections 18 and 19** of this bill authorize the waiver of such an appraisal or  
46 inventory in certain circumstances.

47 Existing law provides that if a person dies leaving an estate the gross value of  
48 which, after deducting encumbrances, is \$100,000 or less, the estate must not be  
49 administered and must be assigned and set apart, after directing such payments as  
50 the court deems just, for the support of the surviving spouse or any minor children  
51 of the decedent. (NRS 146.070) **Section 20** of this bill authorizes the court to  
52 reduce the amount assigned and set apart for the surviving spouse or any minor  
53 children of the decedent by the amount of certain nonprobate transfers to those  
54 persons.

55 **Sections 25 and 63** of this bill enact provisions governing personal jurisdiction  
56 over certain persons in proceedings related to the estate of a deceased person and  
57 the administration of a trust and governing the law to be applied in certain  
58 proceedings related to trusts.

59 Existing law creates a presumption that certain transfers at death are void due to  
60 fraud, undue influence or coercion. (NRS 155.097, 155.0975) **Sections 33 and 34**  
61 of this bill create the same presumption for certain transfers that occur during the  
62 lifetime of the transferor and further define the applicability of when the  
63 presumption of undue influence arises. Existing law authorizes the court to impose  
64 certain sanctions on a person whom the court finds to be a vexatious litigant in a  
65 proceeding related to the administration of the estate of a deceased person or a trust.  
66 (NRS 155.165) **Section 35** of this bill includes a trustee or a personal representative  
67 as a person who may be a vexatious litigant.

68 Existing law enumerates the powers of a trustee. (Chapter 163 of NRS)  
69 **Sections 40 and 41** of this bill add to the powers of a trustee the power to combine

70 or divide trusts and the power to change the name of a trust in certain  
71 circumstances. **Section 46.5** of this bill authorizes certain trustees to terminate  
72 certain trusts that have a value less than \$100,000 or are uneconomical to  
73 administer if the trustee concludes that the value of the property held by the trust is  
74 insufficient to justify the cost of administering the trust. Existing law governs the  
75 administration of directed trusts, which are trusts under which someone other than  
76 the trustee has the authority to direct the trustee to take certain actions. (NRS  
77 163.553-163.556) **Sections 42, 43, 55 and 56** of this bill amend provisions  
78 governing directed trusts. **Section 55** provides that a trustee of a directed trust is not  
79 liable individually or as a fiduciary for a loss resulting from the trustee's  
80 compliance with certain directions or failure to take any proposed action that  
81 required an approval which was not given or was contingent upon a condition that  
82 was not satisfied. **Section 44** of this bill provides for the creation and administering  
83 of public benefit trusts, which are trusts without identifiable beneficiaries that are  
84 not charitable trusts and are established to further one or more specifically declared  
85 religious, scientific, literary, educational, community development, personal  
86 improvement or philanthropic purpose that is not illegal or against public policy.  
87 Existing law provides that a trust may be created by a declaration by the owner of  
88 property that he or she holds the property as trustee. (NRS 163.002, 163.004,  
89 163.006) **Section 48** of this bill provides that regardless of the formal title to the  
90 property, in the absence of a contrary declaration by the owner or a transfer of the  
91 property to a third party: (1) property declared to be trust property and all  
92 the income and reinvestment thereof remains trust property; and (2) any additions  
93 or contributions to accounts or certain other property declared to be trust property  
94 are also trust property. **Section 49** of this bill clarifies the powers a settlor has in  
95 creating terms of a trust and establishes a default position that a trust is irrevocable  
96 unless and to the extent a settlor specifically reserves the right to amend such trust.

97 **Section 45** of this bill provides for the appointment of a successor trustee where  
98 a trust contains no provision for such appointment. **Section 46** of this bill  
99 authorizes a fiduciary to classify gains from the sale or exchange of trust assets as  
100 income for tax purposes. **Section 53** of this bill provides that a beneficiary holding  
101 a discretionary interest in a trust has no enforceable right to a distribution. **Section**  
102 **50** of this bill provides for the creation of charitable and public benefit trusts.  
103 **Sections 55 and 56** of this bill further extend the provisions establishing the  
104 situations in which a directed fiduciary is not liable for actions taken on behalf of  
105 the trust. Existing law permits a trustee with discretion or authority to distribute  
106 trust income or principal to decant such income or principal to a second trust. (NRS  
107 163.556) **Section 59** of this bill provides choice of law provisions applicable to the  
108 construction and administration of trusts. **Section 60** of this bill allows a settlor to  
109 include language in the trust requiring that disputes arising thereunder are subject to  
110 arbitration and provides a method for such arbitration. Under existing law, in order  
111 for a court to assume jurisdiction over a case involving a trust, a petition to confirm  
112 a trustee must be filed. (NRS 164.010) **Sections 61 and 62** of this bill provide for  
113 the creation and enforcement of nonjudicial settlement agreements between all  
114 indispensable parties to a trust. **Section 63** of this bill provides for a petition  
115 requesting the court to assume jurisdiction without confirming the trustee.

116 **Section 64** of this bill provides a court with exclusive jurisdiction to determine  
117 whether property not formally titled in the name of the trust constitutes trust  
118 property and where a person contests the validity of the trust in a declaratory  
119 judgment action. **Section 64** further defines the circumstances and situations in  
120 which a trustee may decant a trust to a second trust in light of federal taxation laws.  
121 **Section 66** of this bill authorizes a trustee presenting a certification of trust to  
122 include a declaration of a trust's domicile and governing law. Under the Uniform  
123 Prudent Investor Act, as adopted by this State, a trustee is authorized to take certain  
124 action without court approval if all interested persons consent or acquiesce in such

125 action. (NRS 164.725) **Section 67** of this bill authorizes a trustee, trust protector or  
126 trust advisor to use that same procedure for any aspect of trust administration.  
127 Existing law provides that a trustee who invests and manages trust property owes a  
128 duty to the beneficiaries to comply with the prudent investor rule set forth in  
129 existing law, but that a trustee is not liable to a beneficiary to the extent the trustee  
130 acted in reasonable reliance on the terms of the trust. (NRS 164.740) **Section 68** of  
131 this bill provides that such a trustee is not liable to a beneficiary if the trustee  
132 determined in good faith not to diversify the investments of the trust in accordance  
133 with existing law.

134 Existing law governs the duty of a trustee to inform and account to a trust's  
135 beneficiaries. (Chapter 165 of NRS) **Sections 70-85** of this bill revise chapter 165  
136 of NRS to restructure the trust accounting rules applicable to testamentary and  
137 nontestamentary trusts. Nevada's current law provides different requirements for  
138 accountings applicable to testamentary trusts and nontestamentary trusts; these  
139 revisions establish one set of accounting rules for both types of trusts.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN  
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 **Section 1.** NRS 40.515 is hereby amended to read as follows:

2 40.515 **1.** If any person has died, or shall hereafter die, who  
3 at the time of the person's death was the owner of a life estate which  
4 terminates by reason of the person's death, any person interested in  
5 the property, or in the title thereto, in which such life estate was  
6 held, may file in the district court of the county in which the  
7 property is situated, the person's verified petition, setting forth such  
8 facts, and thereupon and after such notice by publication or  
9 otherwise, as the court or judge may order, the court or judge shall  
10 hear such petition and the evidence offered in support thereof, and if  
11 upon such hearing it shall appear that such life estate of such  
12 deceased person absolutely terminated by reason of the person's  
13 death, the court or judge shall make an order to that effect, and  
14 thereupon a certified copy of such order may be recorded in the  
15 office of the county recorder.

16 **2.** *As an alternative method of terminating the interest of any*  
17 *person who has died, or will hereafter die, and who at the time of*  
18 *the person's death was the owner of a life estate which terminates*  
19 *by reason of the person's death, any person who has knowledge of*  
20 *the facts may record in the office of the county recorder in the*  
21 *county where the property is situated an affidavit meeting the*  
22 *requirements of NRS 111.365, accompanied by a certified copy of*  
23 *the death certificate of the deceased person.*

24 **Sec. 2.** NRS 111.365 is hereby amended to read as follows:

25 111.365 **1.** In the case of real property owned by two or more  
26 persons as joint tenants or as community property with right of  
27 survivorship, it is presumed that all title or interest in and to that real  
28 property of each of one or more deceased joint tenants or the



1 deceased spouse has terminated, and vested solely in the surviving  
2 joint tenant or spouse or vested jointly in the surviving joint tenants,  
3 if there has been recorded in the office of the recorder of the county  
4 or counties in which the real property is ~~situate~~ *situated* an  
5 affidavit, subscribed and sworn to by a person who has knowledge  
6 of the facts required in this subsection, which *is accompanied by a*  
7 *certified copy of the death certificate of each deceased joint tenant*  
8 *or deceased spouse and* sets forth the following:

9 (a) The family relationship, if any, of the affiant to each  
10 deceased joint tenant or the deceased spouse;

11 (b) A description of the instrument or conveyance by which the  
12 joint tenancy or right of survivorship was created;

13 (c) A description of the property subject to the joint tenancy or  
14 right of survivorship; and

15 (d) The date and place of death of each deceased joint tenant or  
16 the deceased spouse.

17 2. *In the case of real property owned by a person as a life*  
18 *tenant, with the ownership of the real property passing to the*  
19 *owner of the remainder interest upon the death of the life tenant,*  
20 *it is presumed that all title or interest in and to that real property*  
21 *of the life tenant has terminated, and vested solely in the owner of*  
22 *the remainder interest, if there has been recorded in the office of*  
23 *the recorder of the county or counties in which the real property is*  
24 *situated, an affidavit, subscribed and sworn to by a person who*  
25 *has knowledge of the facts required in this subsection, which is*  
26 *accompanied by a certified copy of the death certificate of the*  
27 *deceased life tenant and which sets forth the following:*

28 (a) *The relationship of the affiant to each deceased life tenant;*

29 (b) *A description of the instrument or conveyance by which the*  
30 *life estate was created;*

31 (c) *A description of the property subject to the life estate; and*

32 (d) *The date and place of death of each deceased life tenant.*

33 3. Each month, a county recorder shall send all the information  
34 contained in each affidavit received by the county recorder pursuant  
35 to subsection 1 *or 2* during the immediately preceding month to the  
36 Department of Health and Human Services in any format and by any  
37 medium approved by the Department.

38 **Sec. 3.** NRS 111.781 is hereby amended to read as follows:

39 111.781 1. Except as otherwise provided by the express  
40 terms of a governing instrument, a court order or a contract relating  
41 to the division of the marital estate made between the divorced  
42 persons before or after the marriage, divorce or annulment, the  
43 divorce or annulment of a marriage:

44 (a) Revokes any revocable:



1 (1) Disposition or appointment of property made by a  
2 divorced person to his or her former spouse in a governing  
3 instrument and any disposition or appointment created by law or in a  
4 governing instrument to a relative of the divorced person's former  
5 spouse;

6 (2) Provision in a governing instrument conferring a general  
7 or nongeneral power of appointment on the divorced person's  
8 former spouse or on a relative of the divorced person's former  
9 spouse; and

10 (3) Nomination in a governing instrument that nominates a  
11 divorced person's former spouse or a relative of the divorced  
12 person's former spouse to serve in any fiduciary or representative  
13 capacity, including a personal representative capacity, including a  
14 personal representative, executor, trustee, conservator, agent or  
15 guardian; and

16 (b) Severs the interest of the former spouses in property held by  
17 them at the time of the divorce or annulment as joint tenants with  
18 the right of survivorship or as community property with a right of  
19 survivorship and transforms the interests of the former spouses into  
20 equal tenancies in common.

21 2. A severance under paragraph (b) of subsection 1 does not  
22 affect any third-party interest in property acquired for value and in  
23 good faith reliance on an apparent title by survivorship in the  
24 survivor of the former spouses unless a writing declaring the  
25 severance has been noted, registered, filed or recorded in records  
26 appropriate to the kind and location of the property which records  
27 are relied upon, in the ordinary course of transactions involving such  
28 property, as evidence of ownership.

29 3. The provisions of a governing instrument are given effect as  
30 if the former spouse and relatives of the former spouse disclaimed  
31 all provisions revoked by this section or, in the case of a revoked  
32 nomination in a fiduciary or representative capacity, as if the former  
33 spouse and relatives of the former spouse died immediately before  
34 the divorce or annulment.

35 4. Any provisions revoked solely by this section are revived by  
36 the divorced person's remarriage to the former spouse or by a  
37 nullification of the divorce or annulment.

38 5. Unless a court in an action commenced pursuant to chapter  
39 125 of NRS specifically orders otherwise, a restraining order  
40 entered pursuant to NRS 125.050 does not preclude a party to such  
41 an action from making or changing beneficiary designations that  
42 specify who will receive the party's assets upon the party's death.

43 6. A payor or other third party is not liable for having made a  
44 payment or transferred an item of property or any other benefit to a  
45 beneficiary designated in a governing instrument affected by the



1 provisions of this section or for having taken any other action in  
2 good faith reliance on the validity of the governing instrument  
3 before the payor or other third party received written or actual notice  
4 of any event affecting a beneficiary designation. A payor or other  
5 third party is liable for a payment made or other action taken after  
6 the payor or other third party received written or actual notice of a  
7 claimed forfeiture or revocation under this section.

8 7. Written notice of the divorce, annulment or remarriage or  
9 written notice of a complaint or petition for divorce or annulment  
10 must be mailed to the payor's or other third party's main office or  
11 home by registered or certified mail, return receipt requested, or  
12 served upon the payor or other third party in the same manner as a  
13 summons in a civil action. Upon receipt of written notice of the  
14 divorce, annulment or remarriage, a payor or other third party may  
15 pay any amount owed or transfer or deposit any item of property  
16 held by it to or with the court having jurisdiction of the probate  
17 proceedings relating to the decedent's estate or, if no proceedings  
18 have been commenced, to or with the court having jurisdiction of  
19 probate proceedings relating to decedents' estates located in the  
20 county of the decedent's residence. The court shall hold the funds or  
21 item of property and, upon its determination under this section, shall  
22 order disbursement or transfer in accordance with the determination.  
23 Payments, transfers or deposits made to or with the court discharge  
24 the payor or other third party from all claims for the value of  
25 amounts paid to or items of property transferred to or deposited with  
26 the court.

27 8. A person who purchases property from a former spouse,  
28 relative of a former spouse or any other person for value and  
29 without notice, or who receives from a former spouse, relative of a  
30 former spouse or any other person a payment or other item of  
31 property in partial or full satisfaction of a legally enforceable  
32 obligation, is neither obligated under this section to return the  
33 payment, item of property or benefit nor is liable under this section  
34 for the amount of the payment or the value of the item of property or  
35 benefit. A former spouse, relative of a former spouse or other person  
36 who, not for value, received a payment, item of property or any  
37 other benefit to which that person is not entitled under this section is  
38 obligated to return the payment, item of property or benefit or is  
39 personally liable for the amount of the payment or the value of the  
40 item of property or benefit to the person who is entitled to it under  
41 this section.

42 9. If this section or any part of this section is preempted by  
43 federal law with respect to a payment, an item of property or any  
44 other benefit covered by this section, a former spouse, relative of the  
45 former spouse or any other person who, not for value, received a



1 payment, item of property or any other benefit to which that person  
2 is not entitled under this section is obligated to return that payment,  
3 item of property or benefit or is personally liable for the amount of  
4 the payment or the value of the item of property or benefit to the  
5 person who would have been entitled to it were this section or part  
6 of this section not preempted.

7 **10. *This section applies only to nonprobate transfers which***  
8 ***become effective because of the death of a person on or after***  
9 ***October 1, 2011, regardless of when the divorce or annulment***  
10 ***occurred.***

11 **11.** As used in this section:

12 (a) "Disposition or appointment of property" includes a transfer  
13 of an item of property or any other benefit to a beneficiary  
14 designated in a governing instrument.

15 (b) "Divorce or annulment" means any divorce or annulment or  
16 any dissolution or declaration of invalidity of a marriage. A decree  
17 of separation that does not terminate the status of husband and wife  
18 is not a divorce for purposes of this section.

19 (c) "Divorced person" includes a person whose marriage has  
20 been annulled.

21 (d) "Governing instrument" means a governing instrument  
22 executed by a divorced person before the divorce or annulment of  
23 the person's marriage to the person's former spouse.

24 (e) "Relative of the divorced person's former spouse" means a  
25 person who is related to the divorced person's former spouse by  
26 blood, adoption or affinity and who, after the divorce or annulment,  
27 is not related to the divorced person by blood, adoption or affinity.

28 (f) "Revocable," with respect to a disposition, appointment,  
29 provision or nomination, means one under which the divorced  
30 person, at the time of the divorce or annulment, was alone  
31 empowered, by law or under the governing instrument, to cancel the  
32 designation in favor of the person's former spouse or former  
33 spouse's relative, whether or not the divorced person was then  
34 empowered to designate himself or herself in place of his or her  
35 former spouse or in place of his or her former spouse's relative and  
36 whether or not the divorced person then had the capacity to exercise  
37 the power.

38 **Sec. 4.** Chapter 132 of NRS is hereby amended by adding  
39 thereto the provisions set forth as sections 5 to 9, inclusive, of this  
40 act.

41 **Sec. 5. *"Domestic partners" has the meaning ascribed to it in***  
42 ***NRS 122A.030.***

43 **Sec. 6. *"Foreign jurisdiction" means any jurisdiction other***  
44 ***than this State.***



1       **Sec. 7. "Spouse" includes a domestic partner as set forth in**  
2 **NRS 122A.200.**

3       **Sec. 8. "Testamentary trust" means a trust created by the**  
4 **terms of the will of a person.**

5       **Sec. 9. 1. For the purposes of this title, a person is an**  
6 **interested person with respect to:**

7       **(a) A judicial proceeding, a notice of a proposed action or a**  
8 **nonjudicial settlement, if the person has or claims to have an**  
9 **enforceable right or interest that may be materially affected by the**  
10 **outcome of that proceeding, proposed action or nonjudicial**  
11 **settlement. While living, a settlor or a testator shall be deemed to**  
12 **have an enforceable right with respect to any trust or will that he**  
13 **or she created. For the purposes of this paragraph, a person may**  
14 **not claim to have a right or interest under an estate or trust after**  
15 **the entry of an order of the court declaring the right or interest**  
16 **invalid.**

17       **(b) An estate of a decedent, if the person:**

18       **(1) Is an heir, devisee, child, spouse, creditor, settlor or**  
19 **beneficiary;**

20       **(2) Has a property right in or claim against the estate of a**  
21 **decedent, including, without limitation, the Director of the**  
22 **Department of Health and Human Services in any case in which**  
23 **money is owed to the Department of Health and Human Services**  
24 **as a result of the payment of benefits for Medicaid;**

25       **(3) Has priority for appointment as a personal**  
26 **representative; or**

27       **(4) Is any other fiduciary representing an interested person.**

28       **(c) A trust, if the person:**

29       **(1) Is a living settlor or, if a court has appointed a guardian**  
30 **of the estate of the settlor, the guardian of the estate appointed by**  
31 **the court;**

32       **(2) Is the trustee, including, without limitation, each acting**  
33 **cotrustee;**

34       **(3) Holds the presently exercisable right to remove or**  
35 **replace the trustee or a cotrustee;**

36       **(4) Asserts the right to serve as the trustee or as a cotrustee;**

37       **(5) Is a current beneficiary or a remainder beneficiary of**  
38 **that trust;**

39       **(6) Holds a presently exercisable power of appointment that**  
40 **permits the holder to designate or change the designation of a**  
41 **current beneficiary or a remainder beneficiary of that trust;**

42       **(7) Holds a presently exercisable power that permits the**  
43 **holder to designate, remove or otherwise change the designation**  
44 **of a person who, pursuant to this paragraph, would be an**  
45 **interested person;**



1           (8) *Is a creditor of the settlor who has a claim which has*  
2 *been accepted by the trustee or who has asserted the trustee's*  
3 *liability therefor in a probate proceeding or in a civil action under*  
4 *subsection 8 or 9 of NRS 111.779; or*

5           (9) *Is a creditor of the trust who has given the trustee*  
6 *written notice of its claim.*

7           (d) *A revocable trust that is the subject of a petition under NRS*  
8 *164.015 relating to the validity of the trust or any trust-related*  
9 *document, if the person, after the death of the settlor, under the*  
10 *terms of any version of the trust documents in dispute, would be:*

11           (1) *A current beneficiary or a remainder beneficiary of that*  
12 *trust; or*

13           (2) *A trustee or a successor trustee, including, without*  
14 *limitation, a cotrustee.*

15           (e) *A will that, while the testator is still living, is the subject of*  
16 *a petition under subsection 2 of NRS 30.040, if the person, after*  
17 *the death of the testator, would be:*

9 (b) The reviewer's duty is to review the account and to prepare a  
10 written report, which must be filed with the court clerk under seal or  
11 submitted to the court for in camera review, informing the court if  
12 there is anything that would indicate that the trust, as it affects the  
13 beneficiary's interest, has not been or may not have been properly  
14 administered or accounted for in accordance with applicable law,  
15 the trust instrument and generally accepted accounting principles  
16 applicable to trusts. At the same time a copy of the reviewer's report  
17 is provided to the court, a copy of each reviewer's report must be  
18 delivered to the trustee or to the trustee's attorney of record.

19 6. The trustee may submit to the court and to each reviewer an  
20 objection to the report of a reviewer within 10 days after the trustee  
21 received the reviewer's report. The trustee shall submit the  
22 objections to the court and to each reviewer in the same manner as  
23 the trustee provided the account. The court may consider each  
24 reviewer's report and the objections of the trustee with or without a  
25 hearing. If the court, after considering the report of any reviewer and  
26 any objection submitted by the trustee, finds that the trust, as it  
27 affects the beneficiary's interest, has not been or may not have been  
28 properly administered or accounted for in accordance with  
29 applicable law, the trust instrument and generally accepted  
30 accounting principles applicable to trusts, in addition to any other  
31 relief granted by the court pursuant to NRS 153.031 or 165.143, the  
32 court shall enter an order granting the relief necessary to protect the  
33 beneficiary's interests or to allow the beneficiary to enforce his or  
34 her rights under the trust.

35 7. An order granting relief described in subsection 6 may  
36 include one or more of the following:

37 (a) A directive to the trustee to provide the beneficiary an  
38 account which complies with the provisions of ~~subsection 3 or 4 of~~  
39 NRS 165.135, together with such additional information as the  
40 beneficiary may require to properly enforce his or her rights under  
41 the trust;

42 (b) A directive to the trustee to provide further ~~annual~~ accounts  
43 required under this section without further court order;

44 (c) A directive to the trustee to provide the court and each  
45 reviewer a more complete account or such additional information as



1 the court deems necessary to determine if the trust is being properly  
2 administered in compliance with the trust instrument and applicable  
3 law;

4 (d) A directive to the trustee to take action to remedy or mitigate  
5 the effects of any improper administration of the trust;

6 (e) A declaration relieving each reviewer from any further  
7 obligation of confidentiality; and

8 (f) Any such additional relief as the court deems proper to  
9 ensure the trustee's compliance with the trust instrument and  
10 applicable law and to allow enforcement of the beneficiary's rights.

11 8. If the beneficiary is granted any relief by the court on the  
12 basis that the trust was not properly administered or accounted for,  
13 the provisions of subsection 3 of NRS 153.031 ~~and subsection 4 of~~  
14 ~~NRS 165.139~~ apply with regard to the reimbursement of costs  
15 incurred by the beneficiary.

16 **Sec. 84.** NRS 165.147 is hereby amended to read as follows:

17 165.147 1. Upon ~~request~~ *demand* by a beneficiary  
18 *pursuant to NRS 165.141* who is entitled to receive an account  
19 pursuant to the terms of NRS ~~165.122~~ *165.030* to 165.149,  
20 inclusive, *and sections 71 to 77, inclusive, of this act*, a trustee shall  
21 provide a copy of the trust instrument to that beneficiary except as  
22 expressly provided otherwise in the trust instrument.

23 2. Notwithstanding the provisions of subsection 1 or any  
24 provision to the contrary in the trust instrument, the court may direct  
25 the trustee to provide a beneficiary who is entitled to receive an  
26 account pursuant to the terms of NRS ~~165.122~~ *165.030* to 165.149,  
27 inclusive, *and sections 71 to 77, inclusive, of this act* a copy of the  
28 trust instrument, or such portions as the court deems to be pertinent  
29 to the determination of the adequacy of the trustee's account and to  
30 the enforcement of the beneficiary's rights under the trust.

31 3. Except as otherwise provided in NRS 165.145 or by order of  
32 the court for good cause shown, the trustee must not be compelled to  
33 provide a copy of the trust instrument to a person who is not a  
34 beneficiary of the trust or a person who is not entitled to an account  
35 of the trust pursuant to the provisions of NRS ~~165.122~~ *165.030* to  
36 165.149, inclusive ~~1~~, *and sections 71 to 77, inclusive, of this act.*
