(At the request of the Governor)

- 1 A BILL for an Act to provide an appropriation for defraying the expenses of the public service
- 2 commission; to provide for a railroad safety pilot program; to provide for a railroad training
- 3 program; to amend and reenact sections 49-01-05 and 57-43.2-19 of the North Dakota Century
- 4 Code, relating to the salary of public service commissioners and the special fuels excise taxes
- 5 distribution of funds; to provide a statement of legislative intent; to authorize a transfer; to
- 6 provide an effective date; to provide for retroactive application; and to declare an emergency.

7 BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

SECTION 1. APPROPRIATION. The funds provided in this section, or so much of the funds as may be necessary, are appropriated out of any moneys in the general fund in the state treasury, not otherwise appropriated, and from special funds derived from federal funds and other income, to the public service commission for the purpose of defraying the expenses of that agency, for the biennium beginning July 1, 2015, and ending June 30, 2017, as follows:

21	LEGISLATIVE INTENT. The railroad safety program line item in section 1 of this Act includes				
22	\$523,345 from the rail safety fund, of which \$253,345 relates to salaries and wages, \$70,000				
23	relates to operating expenses, and \$200	,000 relates to a ra	ailroad safety pilot pro	ogram

29	Railroad training program.				
30	All railroads shall make training avail	able to all fire depart	artments having juris	diction along	
31	routes traversed by unit oil trains. Training	g must be made a	vailable by June 30,	2016, with	

- 1 refresher training made available at least every three years thereafter. Training must address
- 2 the general hazards of oil and hazardous substances, techniques to assess hazards to the
- 3 <u>environment and to the safety of responders and the public, factors an incident commander</u>
- 4 <u>must consider in determining whether to attempt to suppress a fire or to evacuate the public and</u>
- 5 emergency responders from the area, and other strategies for initial response by local
- 6 <u>emergency responders. Training must include suggested protocol or practices for local</u>
- 7 responders to safely accomplish these tasks.
- 8 **SECTION 5. AMENDMENT.** Section 49-01-05 of the North Dakota Century Code is amended and reenacted as follows:
- 10 **49-01-05. Salary of commissioners.**
- 11 The annual salary of a commissioner is ninety-nine thousand four hundred thirty-five dollars
- 12 through June 30, 2014, and one hundred two thousand four hundred eighteen one hundred five
- 13 thousand four hundred ninety-one dollars through June 30, 2016, and one hundred eight
- 14 thousand six hundred fifty-six dollars thereafter. All fees received or charged by any
- 15 commissioner for any act or service rendered in any official capacity must be accounted for and
- paid over by the commissioner monthly to the state treasurer and must be credited to the
- 17 general fund of the state.
- 18 SECTION 6. TRANSFER AND REPAYMENT BEGINNING FARMER REVOLVING LOAN
- 19 **FUND.** The Bank of North Dakota shall transfer from the beginning farmer revolving loan fund to
- 20 the public service commission the sum of \$900,000, or so much of the sum as may be
- 21 necessary, included in the estimated income line item in section 1 of this Act to pay for costs
- 22 associated with a rail rate complaint case. Transfers must be made during the biennium
- beginning July 1, 2015, and ending June 30, 2017, upon order of the commission. If any
- 24 amounts are spent pursuant to this section, the public service commission shall reimburse the
- 25 beginning farmer revolving loan fund using amounts available from damages or proceeds
- received, net of legal fees, from a successful outcome of a rail complaint case.
- 27 **SECTION 7. AMENDMENT.** Section 57-43.2-19 of the North Dakota Century Code is
- 28 amended and reenacted as follows:

1	57-43.2-19. (Effective through June 30, 2015) Transfer, deposit, and distribution of
2	funds.
3	All taxes, license fees, penalties, and interest collected under this chapter must be
4	transferred to the state treasurer who shall deposit moneys in a highway tax distribution fund,
5	except all special fuels excise taxes collected on sales of diesel fuel to a railroad under section
6	57-43.2-03 of up to two hundred fifty thousand dollars per year must be transferred to the state
7	treasurer who shall deposit the moneys in the highway-rail grade crossing safety projects fund.
8	The highway tax distribution fund must be distributed in the manner as prescribed by section
9	54-27-19.
0	(Effective after June 30 July 1, 2015, through June 30, 2019) Transfer, deposit, and
11	distribution of funds. All taxes, license fees, penalties, and interest collected under this
2	chapter must be transferred to the state treasurer who shall deposit moneys in a highway tax
3	distribution fund, except all special fuels excise taxes collected on sales of diesel fuel to a
4	railroad under section 57-43.2-03 of up to two hundred seventy-five thousand dollars per year
5	must be transferred to the state treasurer who shall deposit the moneys in the rail safety fund.
6	The highway tax distribution fund must be distributed in the manner as prescribed by section
7	54-27-19.
8	(Effective after June 30, 2019) Transfer, deposit, and distribution of funds. All taxes,
9	license fees, penalties, and interest collected under this chapter must be transferred to the state
20	treasurer who shall deposit moneys in the highway tax distribution fund. The highway tax
21	distribution fund must be distributed in the manner as prescribed by section 54-27-19.
22	SECTION 8. EFFECTIVE DATE. Section 7 of this Act is effective for special fuels excise
23	taxes collected after June 30, 2015.
24	SECTION 9. RETROACTIVE APPLICATION. The specialized legal services line item in
25	section 1 of this Act is retroactive in application.
26	SECTION 10. EMERGENCY. The specialized legal services line item in section 1 of this Act
27	is declared to be an emergency measure.
