11                   A Concurrent Resolution recognizing April 3, 2023, as  
12                   National Rifle Association of America and Oklahoma  
13                   Rifle Association Day; and directing distribution.

16                   WHEREAS, the National Rifle Association of America (NRA) was  
17 originally founded in 1871 for the purpose of serving as America's  
18 national organization dedicated to the patriotic endeavor of  
19 training civilians in the use of military arms so as to enable  
20 patriotic citizens to be fully prepared to come to the defense of  
21 their country in times of war and national crisis; and

22                   WHEREAS, the National Rifle Association of America is America's  
23 longest standing civil rights organization. Together, with more  
24

1 than five million members, the NRA are pro-defenders of history's  
2 patriots and are diligent protectors of the Second Amendment; and

3 WHEREAS, the Oklahoma Rifle Association (ORA), with eight  
4 hundred members and growing, is the official NRA Oklahoma-affiliate  
5 for the State of Oklahoma; and

6 WHEREAS, the National Rifle Association of America and the  
7 Oklahoma Rifle Association, representing the firearms and shooting  
8 community in Oklahoma, promotes and provides for the safe enjoyment  
9 of firearms through competitions, matches, training, and other  
10 organized activities within the state; and

11 WHEREAS, the National Rifle Association of America and the  
12 Oklahoma Rifle Association collaborates with and supports firearm-  
13 related clubs, organizations, and manufacturers to benefit the  
14 state; and

15 WHEREAS, in recognition of its significant contributions to the  
16 state, the Oklahoma State Legislature dedicates April 3, 2023, as  
17 National Rifle Association of America and Oklahoma Rifle Association  
18 Day.

19 NOW, THEREFORE, BE IT RESOLVED BY THE HOUSE OF REPRESENTATIVES  
20 OF THE 1ST SESSION OF THE 59TH OKLAHOMA LEGISLATURE, THE SENATE  
21 CONCURRING THEREIN:

22 THAT the Oklahoma State Legislature recognizes April 3, 2023, as  
23 National Rifle Association of America and Oklahoma Rifle Association  
24 Day.
