



1 The license shall be valid in this state for a period of five (5) or  
2 ten (10) years, unless subsequently surrendered, suspended, or  
3 revoked as provided by law. The person shall have no authority to  
4 continue to carry a concealed or unconcealed handgun in this state  
5 pursuant to the Oklahoma Self-Defense Act when a license is expired  
6 or when a license has been voluntarily surrendered or suspended or  
7 revoked for any reason.

8 B. A license may be renewed any time within ninety (90) days  
9 prior to the expiration date as provided in this subsection. The  
10 ~~Bureau~~ Oklahoma State Bureau of Investigation may notify each  
11 eligible licensee at the email address on file at least ninety (90)  
12 days prior to the expiration of the license. However, any applicant  
13 shall have ~~three (3) years~~ thirty (30) days from the expiration of  
14 the license to comply with the renewal requirements of this section.  
15 Renewal applications shall be denied by the Bureau if a current  
16 license is subject to being or currently is suspended or revoked ~~or~~  
17 ~~if the license has previously been suspended or revoked by the~~  
18 Bureau.

19 1. To renew a handgun license, the licensee ~~must first obtain~~  
20 may either complete a written renewal form from provided by the  
21 ~~Oklahoma State Bureau of Investigation~~ Bureau or a digital renewal  
22 form provided by the Bureau online.

23 2. ~~The~~ If the applicant ~~must complete~~ completes the digital  
24 renewal form, ~~attach~~ online, the applicant must submit a passport-

1 sized photograph with the application. If the applicant completes a  
2 written renewal application, the applicant must submit two current  
3 passport-sized photographs of the applicant, ~~and submit a~~ with the  
4 application.

5 3. A renewal fee in the amount of Eighty-five Dollars (\$85.00)  
6 must be submitted to the Bureau with an application. The renewal  
7 fee may be paid with a nationally recognized credit card as provided  
8 in subparagraph b of paragraph 4 of subsection A of Section 1290.12  
9 of this title, by electronic funds transfer, or by a cashier's check  
10 or money order made payable to the Oklahoma State Bureau of  
11 Investigation.

12 ~~3.~~ 4. Upon receipt of the renewal application, photographs, and  
13 fee, the Bureau will conduct a background check and investigation  
14 pursuant to Section 1290.12 of this title, excluding the  
15 requirements of a state fingerprint search and Federal Bureau of  
16 Investigation fingerprint search.

17 C. ~~Beginning November 1, 2007, any~~ Any person making submitting  
18 an application for a handgun license or any licensee seeking to  
19 renew a handgun license shall have the option to request that the  
20 license be valid for a period of ten (10) years. The fee for any  
21 handgun license issued for a period of ten (10) years shall be  
22 double the amount of the fee provided for in paragraph 4 of  
23 subsection A of Section 1290.12 of this title. The renewal fee for  
24 a handgun license issued for a period of ten (10) years shall be

1 double the amount of the fee provided for in paragraph ~~2~~ 3 of  
2 subsection B of this section.

3 SECTION 2. This act shall become effective November 1, 2024.
