SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure. The statement includes a measure digest written in compliance with applicable readability standards.

Digest: The Act makes changes to laws to make it easier to get treatment for substance use problems. The Act changes drug laws. The Act takes effect when the Governor signs it. (Flesch Readability Score: 87.1).

[Digest: The Act requires the OHA to study the problems in this state caused by drug use and to send a report on its findings to the legislature. The section is repealed on January 2, 2026. (Flesch Readability Score: 63.3).]

[Requires the Oregon Health Authority to study Oregon's addiction crisis. Directs the authority to submit findings to the interim committees of the Legislative Assembly related to health not later than September 15, 2025.]

[Sunsets January 2, 2026.]

Prohibits insurers from requiring prior authorization or other utilization review for coverage of substance use disorder medications. Specifies exceptions.

Requires coordinated care organizations to provide to members medications for treatment of opioid use disorder and any co-occurring substance use disorder or mental health condition.

Prohibits coordinated care organizations and public payers of health insurance from requiring prior authorization for medication-assisted treatment.

Allows pharmacists to prescribe and dispense early refills of medication for opioid use disorder under specified conditions. Allows pharmacists to have on-site prescription drug lockers without obtaining a license or registration from the State Board of Pharmacy.

Requires coordinated care organizations to have adequate networks of addiction treatment providers.

Directs the Alcohol and Drug Policy Commission to conduct a study related to access to opioid use disorder treatment and interventions. Requires commission to report recommendations to Legislative Assembly to address barriers to accessing opioid use disorder treatment and interventions.

Establishes a certified community behavioral health clinic program in the Oregon Health Authority and specifies the requirements for the program.

Establishes the Joint Task Force on Regional Behavioral Health Accountability to make recommendations to the Legislative Assembly to improve the governance of behavioral health systems and strengthen evidence-based and equitable funding decisions and accountability of behavioral health systems. Sunsets January 2, 2026.

Establishes the Task Force on Improving the Safety of Behavioral Health Workers to make recommendations to the Legislative Assembly to address the safety concerns that are prevalent in the behavioral health industry. Sunsets January 2, 2026.

Establishes the United We Heal Medicaid Payment Program in the authority to provide supplemental medical assistance payments to behavioral health providers to enable the providers to access enhanced apprenticeship and training programs and opportunities by participating in a labor-management training trust.

Modifies the definition of "delivery" for purposes of the Uniform Controlled Substance Act. Increases presumptive sentences when unlawful delivery of a controlled substance occurs in specified locations.

Increases penalties for unlawful possession of a controlled substance on September 1, 2024. Designates crime as a drug enforcement misdemeanor and specifies sentence. Creates a new form of conditional discharge for drug enforcement misdemeanors and establishes processes for sealing records related to the crime.

Establishes the Oregon Behavioral Health Deflection Program consisting of grants awarded to fund deflection programs.

Directs the Oregon Criminal Justice Commission to track data including arrests and prosecutions for possession and delivery crimes and data concerning deflection program

outcomes.

Increases the number of hours a person can be held in a facility when admitted to the facility due to intoxication or being under the influence of controlled substances. Authorizes members of a mobile crisis intervention team to take a person to a sobering facility or appropriate facility. Modifies immunity from civil and criminal liability for certain persons involved in the provision of treatment.

Establishes the Oregon Jail-Based Medications for Opioid Use Disorder Grant Program. Declares an emergency, effective on passage.

A BILL FOR AN ACT

Be It Enacted by the People of the State of Oregon:

BEHAVIORAL HEALTH

(Payment for Substance Use Disorder Treatment)

SECTION 1. Section 2 of this 2024 Act is added to and made a part of ORS chapter 743A.

SECTION 2. (1) As used in this section:

- (a) "Group health insurance" has the meaning given that term in ORS 731.098.
- (b) "Health benefit plan" has the meaning given that term in ORS 743B.005.
- (c) "Substance use disorder" has the meaning given that term in the fifth edition of the Diagnostic and Statistical Manual of Mental Disorders published by the American Psychiatric Association.

(d) "Utilization review" has the meaning given that term in ORS 743B.001.

(2) Notwithstanding any provision of ORS 743A.168, an issuer of group health insurance or an individual health benefit plan, other than a health plan that is subject to 42 U.S.C. 18011:

(a) May not impose a requirement for prior authorization or any other form of utilization review for the reimbursement of a covered medication approved by the United States Food and Drug Administration that is prescribed for the purpose of treating a substance use disorder, including but not limited to opioid addiction and opioid withdrawal.

(b) Shall reimburse the cost of refills of medications described in paragraph (a) of this subsection if dispensed by a licensed health care professional who is legally authorized to dispense such medications, including early refills described in section 7 of this section.

(3) Subsection (2) of this section applies to any form of buprenorphine, including but not limited to sublingual, tablet or injectable forms.

(4) This section does not prohibit prior authorization or other utilization review for opioids or opiates prescribed for a purpose other than medication-assisted treatment or the treatment of opiate abuse or addiction.

(5) This section does not prohibit utilization review for the purpose of:

- (a) Auditing claims for improper payments, fraud or abuse; or
 - (b) Reasonable periodic redeterminations about the need for continuing care.
- (6) Coverage under this section may be subject to the same terms and conditions that

1 **apply to other benefits under the plan except for utilization review as provided in subsection**
2 **(2) of this section.**

3 **(7) This section is exempt from ORS 743A.001.**

4 **SECTION 3.** ORS 743A.168 is amended to read:

5 743A.168. (1) As used in this section:

6 (a) "Behavioral health assessment" means an evaluation by a provider, in person or using tele-
7 medicine, to determine a patient's need for behavioral health treatment.

8 (b) "Behavioral health condition" has the meaning prescribed by rule by the Department of
9 Consumer and Business Services.

10 (c) "Behavioral health crisis" means a disruption in an insured's mental or emotional stability
11 or functioning resulting in an urgent need for immediate outpatient treatment in an emergency de-
12 partment or admission to a hospital to prevent a serious deterioration in the insured's mental or
13 physical health.

14 (d) "Facility" means a corporate or governmental entity or other provider of services for the
15 treatment of behavioral health conditions.

16 (e) "Generally accepted standards of care" means:

17 (A) Standards of care and clinical practice guidelines that:

18 (i) Are generally recognized by health care providers practicing in relevant clinical specialties;
19 and

20 (ii) Are based on valid, evidence-based sources; and

21 (B) Products and services that:

22 (i) Address the specific needs of a patient for the purpose of screening for, preventing, diagnos-
23 ing, managing or treating an illness, injury or condition or symptoms of an illness, injury or condi-
24 tion;

25 (ii) Are clinically appropriate in terms of type, frequency, extent, site and duration; and

26 (iii) Are not primarily for the economic benefit of an insurer or payer or for the convenience
27 of a patient, treating physician or other health care provider.

28 (f) "Group health insurer" means an insurer, a health maintenance organization or a health care
29 service contractor.

30 (g) "Median maximum allowable reimbursement rate" means the median of all maximum allow-
31 able reimbursement rates, minus incentive payments, paid for each billing code for each provider
32 type during a calendar year.

33 (h) "Prior authorization" has the meaning given that term in ORS 743B.001.

34 (i) "Program" means a particular type or level of service that is organizationally distinct within
35 a facility.

36 (j) "Provider" means:

37 (A) A behavioral health professional or medical professional licensed or certified in this state
38 who has met the credentialing requirement of a group health insurer or an issuer of an individual
39 health benefit plan that is not a grandfathered health plan as defined in ORS 743B.005 and is oth-
40 erwise eligible to receive reimbursement for coverage under the policy;

41 (B) A health care facility as defined in ORS 433.060;

42 (C) A residential facility as defined in ORS 430.010;

43 (D) A day or partial hospitalization program;

44 (E) An outpatient service as defined in ORS 430.010; or

45 (F) A provider organization certified by the Oregon Health Authority under subsection (9) of this

1 section.

2 (k) "Relevant clinical specialties" includes but is not limited to:

3 (A) Psychiatry;

4 (B) Psychology;

5 (C) Clinical sociology;

6 (D) Addiction medicine and counseling; and

7 (E) Behavioral health treatment.

8 (L) "Standards of care and clinical practice guidelines" includes but is not limited to:

9 (A) Patient placement criteria;

10 (B) Recommendations of agencies of the federal government; and

11 (C) Drug labeling approved by the United States Food and Drug Administration.

12 (m) "Utilization review" has the meaning given that term in ORS 743B.001.

13 (n) "Valid, evidence-based sources" includes but is not limited to:

14 (A) Peer-reviewed scientific studies and medical literature;

15 (B) Recommendations of nonprofit health care provider professional associations; and

16 (C) Specialty societies.

17 (2) A group health insurance policy or an individual health benefit plan that is not a grandfa-
18 thered health plan providing coverage for hospital or medical expenses, other than limited benefit
19 coverage, shall provide coverage for expenses arising from the diagnosis of behavioral health con-
20 ditions and medically necessary behavioral health treatment at the same level as, and subject to
21 limitations no more restrictive than, those imposed on coverage or reimbursement of expenses aris-
22 ing from treatment for other medical conditions. The following apply to coverage for behavioral
23 health treatment:

24 (a) The coverage may be made subject to provisions of the policy that apply to other benefits
25 under the policy, including but not limited to provisions relating to copayments, deductibles and
26 coinsurance. Copayments, deductibles and coinsurance for treatment in health care facilities or
27 residential facilities may not be greater than those under the policy for expenses of hospitalization
28 in the treatment of other medical conditions. Copayments, deductibles and coinsurance for outpa-
29 tient treatment may not be greater than those under the policy for expenses of outpatient treatment
30 of other medical conditions.

31 (b) The coverage of behavioral health treatment may not be made subject to treatment limita-
32 tions, limits on total payments for treatment, limits on duration of treatment or financial require-
33 ments unless similar limitations or requirements are imposed on coverage of other medical
34 conditions. The coverage of eligible expenses of behavioral health treatment may be limited to
35 treatment that is medically necessary as determined in accordance with this section and no more
36 stringently under the policy than for other medical conditions.

37 (c) The coverage of behavioral health treatment must include:

38 (A) A behavioral health assessment;

39 (B) No less than the level of services determined to be medically necessary in a behavioral
40 health assessment of the specific needs of a patient or in a patient's care plan:

41 (i) To effectively treat the patient's underlying behavioral health condition rather than the mere
42 amelioration of current symptoms such as suicidal ideation or psychosis; and

43 (ii) For care following a behavioral health crisis, to transition the patient to a lower level of
44 care;

45 (C) Treatment of co-occurring behavioral health conditions or medical conditions in a coordi-

1 nated manner;

2 (D) Treatment at the least intensive and least restrictive level of care that is safe and most ef-
3 fective and meets the needs of the insured's condition;

4 (E) A lower level or less intensive care only if it is comparably as safe and effective as treat-
5 ment at a higher level of service or intensity;

6 (F) Treatment to maintain functioning or prevent deterioration;

7 (G) Treatment for an appropriate duration based on the insured's particular needs;

8 (H) Treatment appropriate to the unique needs of children and adolescents;

9 (I) Treatment appropriate to the unique needs of older adults; and

10 (J) Coordinated care and case management as defined by the Department of Consumer and
11 Business Services by rule.

12 (d) The coverage of behavioral health treatment may not limit coverage for treatment of perva-
13 sive or chronic behavioral health conditions to short-term or acute behavioral health treatment at
14 any level of care or placement.

15 (e) A group health insurer or an issuer of an individual health benefit plan other than a grand-
16 fathered health plan shall have a network of providers of behavioral health treatment sufficient to
17 meet the standards described in ORS 743B.505. If there is no in-network provider qualified to timely
18 deliver, as defined by rule, medically necessary behavioral treatment to an insured in a geographic
19 area, the group health insurer or issuer of an individual health benefit plan shall provide coverage
20 of out-of-network medically necessary behavioral health treatment without any additional out-of-
21 pocket costs if provided by an available out-of-network provider that enters into an agreement with
22 the insurer to be reimbursed at in-network rates.

23 (f) A provider is eligible for reimbursement under this section if:

24 (A) The provider is approved or certified by the Oregon Health Authority;

25 (B) The provider is accredited for the particular level of care for which reimbursement is being
26 requested by the Joint Commission or the Commission on Accreditation of Rehabilitation Facilities;

27 (C) The patient is staying overnight at the facility and is involved in a structured program at
28 least eight hours per day, five days per week; or

29 (D) The provider is providing a covered benefit under the policy.

30 (g) A group health insurer or an issuer of an individual health benefit plan other than a grand-
31 fathered health plan must use the same methodology to set reimbursement rates paid to behavioral
32 health treatment providers that the group health insurer or issuer of an individual health benefit
33 plan uses to set reimbursement rates for medical and surgical treatment providers.

34 (h) A group health insurer or an issuer of an individual health benefit plan other than a
35 grandfathered health plan must update the methodology and rates for reimbursing behavioral health
36 treatment providers in a manner equivalent to the manner in which the group health insurer or
37 issuer of an individual health benefit plan updates the methodology and rates for reimbursing med-
38 ical and surgical treatment providers, unless otherwise required by federal law.

39 (i) A group health insurer or an issuer of an individual health benefit plan other than a grand-
40 fathered health plan that reimburses out-of-network providers for medical or surgical services must
41 reimburse out-of-network behavioral health treatment providers on the same terms and at a rate that
42 is in parity with the rate paid to medical or surgical treatment providers.

43 (j) Outpatient coverage of behavioral health treatment shall include follow-up in-home service
44 or outpatient services if clinically indicated under criteria and guidelines described in subsection (5)
45 of this section. The policy may limit coverage for in-home service to persons who are homebound

1 under the care of a physician only if clinically indicated under criteria and guidelines described in
2 subsection (5) of this section.

3 (k)(A) Subject to **section 2 of this 2024 Act and to** the patient or client confidentiality pro-
4 visions of ORS 40.235 relating to physicians, ORS 40.240 relating to nurse practitioners, ORS 40.230
5 relating to psychologists, ORS 40.250 and 675.580 relating to licensed clinical social workers and
6 ORS 40.262 relating to licensed professional counselors and licensed marriage and family therapists,
7 a group health insurer or issuer of an individual health benefit plan may provide for review for level
8 of treatment of admissions and continued stays for treatment in health facilities, residential facili-
9 ties, day or partial hospitalization programs and outpatient services by either staff of a group health
10 insurer or issuer of an individual health benefit plan or personnel under contract to the group health
11 insurer or issuer of an individual health benefit plan that is not a grandfathered health plan, or by
12 a utilization review contractor, who shall have the authority to certify for or deny level of payment.

13 (B) Review shall be made according to criteria made available to providers in advance upon
14 request.

15 (C) Review shall be performed by or under the direction of a physician licensed under ORS
16 677.100 to 677.228, a psychologist licensed by the Oregon Board of Psychology, a clinical social
17 worker licensed by the State Board of Licensed Social Workers or a professional counselor or mar-
18 riage and family therapist licensed by the Oregon Board of Licensed Professional Counselors and
19 Therapists, in accordance with standards of the National Committee for Quality Assurance or
20 Medicare review standards of the Centers for Medicare and Medicaid Services.

21 (D) Review may involve prior [*approval*] **authorization**, concurrent review of the continuation
22 of treatment, post-treatment review or any combination of these. However, if prior [*approval*] **au-**
23 **thorization** is required, provision shall be made to allow for payment of urgent or emergency ad-
24 missions, subject to subsequent review. If prior [*approval*] **authorization** is not required, group
25 health insurers and issuers of individual health benefit plans that are not grandfathered health plans
26 shall permit providers, policyholders or persons acting on their behalf to make advance inquiries
27 regarding the appropriateness of a particular admission to a treatment program. Group health
28 insurers and issuers of individual health benefit plans that are not grandfathered health plans shall
29 provide a timely response to such inquiries. Noncontracting providers must cooperate with these
30 procedures to the same extent as contracting providers to be eligible for reimbursement.

31 (L) Health maintenance organizations may limit the receipt of covered services by enrollees to
32 services provided by or upon referral by providers contracting with the health maintenance organ-
33 ization. Health maintenance organizations and health care service contractors may create substan-
34 tive plan benefit and reimbursement differentials at the same level as, and subject to limitations no
35 more restrictive than, those imposed on coverage or reimbursement of expenses arising out of other
36 medical conditions and apply them to contracting and noncontracting providers.

37 (3) **Except as provided in section 2 of this 2024 Act**, this section does not prohibit a group
38 health insurer or issuer of an individual health benefit plan that is not a grandfathered health plan
39 from managing the provision of benefits through common methods, including but not limited to se-
40 lectively contracted panels, health plan benefit differential designs, preadmission screening, prior
41 authorization of services, utilization review or other mechanisms designed to limit eligible expenses
42 to those described in subsection (2)(b) of this section provided such methods comply with the re-
43 quirements of this section.

44 (4) The Legislative Assembly finds that health care cost containment is necessary and intends
45 to encourage health insurance plans designed to achieve cost containment by ensuring that re-

1 imbursement is limited to appropriate utilization under criteria incorporated into the insurance, ei-
2 ther directly or by reference, in accordance with this section.

3 (5)(a) Any medical necessity, utilization or other clinical review conducted for the diagnosis,
4 prevention or treatment of behavioral health conditions or relating to service intensity, level of care
5 placement, continued stay or discharge must be based solely on the following:

6 (A) The current generally accepted standards of care.

7 (B) For level of care placement decisions, the most recent version of the levels of care placement
8 criteria developed by the nonprofit professional association for the relevant clinical specialty.

9 (C) For medical necessity, utilization or other clinical review conducted for the diagnosis, pre-
10 vention or treatment of behavioral health conditions that does not involve level of care placement
11 decisions, other criteria and guidelines may be utilized if such criteria and guidelines are based on
12 the current generally accepted standards of care including valid, evidence-based sources and current
13 treatment criteria or practice guidelines developed by the nonprofit professional association for the
14 relevant clinical specialty. Such other criteria and guidelines must be made publicly available and
15 made available to insureds upon request to the extent permitted by copyright laws.

16 (b) This subsection does not prevent a group health insurer or an issuer of an individual health
17 benefit plan other than a grandfathered health plan from using criteria that:

18 (A) Are outside the scope of criteria and guidelines described in paragraph (a)(B) of this sub-
19 section, if the guidelines were developed in accordance with the current generally accepted stan-
20 dards of care; or

21 (B) Are based on advancements in technology of types of care that are not addressed in the most
22 recent versions of sources specified in paragraph (a)(B) of this subsection, if the guidelines were
23 developed in accordance with current generally accepted standards of care.

24 (c) For all level of care placement decisions, an insurer shall authorize placement at the level
25 of care consistent with the insured's score or assessment using the relevant level of care placement
26 criteria and guidelines as specified in paragraph (a)(B) of this subsection. If the level of care indi-
27 cated by the criteria and guidelines is not available, the insurer shall authorize the next higher level
28 of care. If there is disagreement about the appropriate level of care, the insurer shall provide to the
29 provider of the service the full details of the insurer's scoring or assessment using the relevant level
30 of care placement criteria and guidelines specified in paragraph (a)(B) of this subsection.

31 (6) To ensure the proper use of any criteria and guidelines described in subsection (5) of this
32 section, a group health insurer or an issuer of an individual health benefit plan shall provide, at no
33 cost:

34 (a) A formal education program, presented by nonprofit clinical specialty associations or other
35 entities authorized by the department, to educate the insurer's or the issuer's staff and any individ-
36 uals described in subsection (2)(k) of this section who conduct reviews.

37 (b) To stakeholders, including participating providers and insureds, the criteria and guidelines
38 described in subsection (5) of this section and any education or training materials or resources re-
39 garding the criteria and guidelines.

40 (7) This section does not prevent a group health insurer or issuer of an individual health benefit
41 plan that is not a grandfathered health plan from contracting with providers of health care services
42 to furnish services to policyholders or certificate holders according to ORS 743B.460 or 750.005,
43 subject to the following conditions:

44 (a) A group health insurer or issuer of an individual health benefit plan that is not a grandfa-
45 thered health plan is not required to contract with all providers that are eligible for reimbursement

1 under this section.

2 (b) An insurer or health care service contractor shall, subject to subsection (2) of this section,
3 pay benefits toward the covered charges of noncontracting providers of services for behavioral
4 health treatment. The insured shall, subject to subsection (2) of this section, have the right to use
5 the services of a noncontracting provider of behavioral health treatment, whether or not the be-
6 havioral health treatment is provided by contracting or noncontracting providers.

7 (8)(a) This section does not require coverage for:

8 (A) Educational or correctional services or sheltered living provided by a school or halfway
9 house;

10 (B) A long-term residential mental health program that lasts longer than 45 days unless clin-
11 ically indicated under criteria and guidelines described in subsection (5) of this section;

12 (C) Psychoanalysis or psychotherapy received as part of an educational or training program,
13 regardless of diagnosis or symptoms that may be present;

14 (D) A court-ordered sex offender treatment program; or

15 (E) Support groups.

16 (b) Notwithstanding paragraph (a)(A) of this subsection, an insured may receive covered outpa-
17 tient services under the terms of the insured's policy while the insured is living temporarily in a
18 sheltered living situation.

19 (9) The Oregon Health Authority shall establish a process for the certification of an organiza-
20 tion described in subsection (1)(j)(F) of this section that:

21 (a) Is not otherwise subject to licensing or certification by the authority; and

22 (b) Does not contract with the authority, a subcontractor of the authority or a community
23 mental health program.

24 (10) The Oregon Health Authority shall adopt by rule standards for the certification provided
25 under subsection (9) of this section to ensure that a certified provider organization offers a distinct
26 and specialized program for the treatment of mental or nervous conditions.

27 (11) The Oregon Health Authority may adopt by rule an application fee or a certification fee,
28 or both, to be imposed on any provider organization that applies for certification under subsection
29 (9) of this section. Any fees collected shall be paid into the Oregon Health Authority Fund estab-
30 lished in ORS 413.101 and shall be used only for carrying out the provisions of subsection (9) of this
31 section.

32 (12) The intent of the Legislative Assembly in adopting this section is to reserve benefits for
33 different types of care to encourage cost effective care and to ensure continuing access to levels
34 of care most appropriate for the insured's condition and progress in accordance with this section.
35 This section does not prohibit an insurer from requiring a provider organization certified by the
36 Oregon Health Authority under subsection (9) of this section to meet the insurer's credentialing
37 requirements as a condition of entering into a contract.

38 (13) The Director of the Department of Consumer and Business Services and the Oregon Health
39 Authority, after notice and hearing, may adopt reasonable rules not inconsistent with this section
40 that are considered necessary for the proper administration of this section. The director shall adopt
41 rules making it a violation of this section for a group health insurer or issuer of an individual health
42 benefit plan other than a grandfathered health plan to require providers to bill using a specific
43 billing code or to restrict the reimbursement paid for particular billing codes other than on the basis
44 of medical necessity.

45 (14) This section does not:

1 (a) Prohibit an insured from receiving behavioral health treatment from an out-of-network pro-
2 vider or prevent an out-of-network behavioral health provider from billing the insured for any un-
3 reimbursed cost of treatment.

4 (b) Prohibit the use of value-based payment methods, including global budgets or capitated,
5 bundled, risk-based or other value-based payment methods.

6 (c) Require that any value-based payment method reimburse behavioral health services based
7 on an equivalent fee-for-service rate.

8 **SECTION 4.** ORS 414.766 is amended to read:

9 414.766. (1) Notwithstanding ORS 414.065 and 414.690, a coordinated care organization must
10 provide behavioral health services to its members that include but are not limited to all of the fol-
11 lowing:

12 (a) For a member who is experiencing a behavioral health crisis:

13 (A) A behavioral health assessment; and

14 (B) Services that are medically necessary to transition the member to a lower level of care;

15 (b) At least the minimum level of services that are medically necessary to treat a member's
16 underlying behavioral health condition rather than a mere amelioration of current symptoms, such
17 as suicidal ideation or psychosis, as determined in a behavioral health assessment of the member
18 or specified in the member's care plan;

19 (c) Treatment of co-occurring behavioral health disorders or medical conditions in a coordinated
20 manner;

21 (d) Treatment at the least intensive and least restrictive level of care that is safe and effective
22 and meets the needs of the individual's condition;

23 (e) For all level of care placement decisions, placement at the level of care consistent with a
24 member's score or assessment using the relevant level of care placement criteria and guidelines;

25 (f) If the level of placement described in paragraph (e) of this subsection is not available,
26 placement at the next higher level of care;

27 (g) Treatment to maintain functioning or prevent deterioration;

28 (h) Treatment for an appropriate duration based on the individual's particular needs;

29 (i) Treatment appropriate to the unique needs of children and adolescents;

30 (j) Treatment appropriate to the unique needs of older adults;

31 (k) Treatment that is culturally and linguistically appropriate;

32 (L) Treatment that is appropriate to the unique needs of gay, lesbian, bisexual and transgender
33 individuals and individuals of any other minority gender identity or sexual orientation;

34 (m) Coordinated care and case management as defined by the Department of Consumer and
35 Business Services by rule; *[and]*

36 (n) Mental health wellness appointments as prescribed by the Oregon Health Authority by
37 rule; **and**

38 **(o) Medications and refills of medications prescribed for the treatment of opioid use dis-**
39 **order and any co-occurring substance use disorder or mental health condition, including**
40 **early refills as described in section 7 of this 2024 Act.**

41 (2) If there is a disagreement about the level of care required by subsection (1)(e) or (f) of this
42 section, a coordinated care organization shall provide to the behavioral health treatment provider
43 full details of the coordinated care organization's scoring or assessment, to the extent permitted by
44 the federal Health Insurance Portability and Accountability Act privacy regulations, 45 C.F.R. parts
45 160 and 164, ORS 192.553 to 192.581 or other state or federal laws limiting the disclosure of health

1 information.

2 (3) The Oregon Health Authority shall adopt by rule a list of behavioral health services that
3 may not be subject to prior authorization.

4 **SECTION 5.** ORS 431A.463 is amended to read:

5 431A.463. (1) As used in this section, “medication-assisted treatment” means any
6 medication, and the dispensing or administering of the medication, that is approved by the
7 United States Food and Drug Administration on or before January 1, 2024, for the treatment
8 of substance use disorders, and that is used for that purpose, including opioid and opiate
9 addiction.

10 [(1)] (2) The Oregon Health Authority shall prohibit coordinated care organizations and public
11 payers of health insurance[, when reimbursing the cost of medication-assisted treatment for treating
12 substance use disorders, including opioid and opiate addiction,] from requiring prior authorization
13 [of payment during the first 30 days of medication-assisted treatment] for the reimbursement of the
14 costs of medication-assisted treatment.

15 (3) Notwithstanding subsection (2) of this section, a coordinated care organization may
16 require prior authorization of a brand name drug for medication-assisted treatment if a ge-
17 neric equivalent is available to substitute for a prescribed brand name drug. As used in this
18 subsection, a different formulation of the medication is not a generic equivalent.

19 [(2)] (4) The authority may adopt rules to carry out this section.

20
21 **(Pharmacist Prescribing and Dispensing of**
22 **Opioid Use Disorder Medication Refills)**
23

24 **SECTION 6.** Sections 7 and 8 of this 2024 Act are added to and made a part of ORS
25 chapter 689.

26 **SECTION 7.** (1) As used in this section:

27 (a) “Early refill” means:

28 (A) Up to three refills of a current prescription for a medication that a patient has lost
29 or that has been stolen or destroyed; or

30 (B) One refill in a 12 month period of a medication for which the previous prescription
31 expired in the prior 12 month period.

32 (b) “Refill” means a supply of a medication consistent with the amount specified in the
33 most recent prescription for the medication.

34 (2) A pharmacist may prescribe and dispense to a patient, to the extent permitted by
35 federal law, an early refill of a medication for the treatment of opioid use disorder in ac-
36 cordance with subsection (3) of the section.

37 (3) A pharmacist who prescribes and dispenses early refills under this section shall:

38 (a) Complete a patient assessment to determine whether the prescription is appropriate;

39 (b) Document the patient visit and include notations regarding evidence of the patient’s
40 previous prescription from the patient’s licensed health care provider, information relating
41 to the patient’s treatment and other relevant information; and

42 (c) Notify the patient’s primary care provider, and the licensed health care provider who
43 made the previous prescription, of the pharmacist’s dispensing of early refills, to the extent
44 permitted by state and federal law.

45 (4) Notations in a record documenting evidence of a patient’s previous prescription under

1 subsection (3)(b) of this section constitute verification of a valid prescription.

2 (5) The State Board of Pharmacy shall adopt rules to carry out this section, including
3 but not limited to rules to allow a:

4 (a) Pharmacist to apply for and obtain a registration number from the Drug Enforcement
5 Administration of the United States Department of Justice as a mid-level practitioner; and

6 (b) Pharmacy to store on the premises medications for the treatment of opioid use dis-
7 order.

8 (6) In adopting rules to carry out this section, the board shall consult with the Public
9 Health and Pharmacy Advisory Formulary Committee described in ORS 689.649.

10 **SECTION 8.** (1) As used in this section, “prescription drug locker” means a mechanical
11 device that serves as an extension of a retail drug outlet’s will call or point of sale area in
12 which completed patient-specific prescription drugs, devices and related supplies and
13 nonprescription drugs, devices and related supplies are stored for pickup.

14 (2) A prescription drug locker located within this state and at the same physical address
15 as the retail drug outlet with which the prescription drug locker is associated:

16 (a) Is considered part of the retail drug outlet and is not required to obtain a license or
17 registration from the State Board of Pharmacy; and

18 (b) Is not required to obtain a registration from the Drug Enforcement Administration
19 of the United States Department of Justice.

20 (3) A prescription drug locker located within this state but at a physical address other
21 than the physical address of the retail drug outlet with which the prescription drug locker
22 is associated is considered a remote dispensing site pharmacy and must obtain a registration
23 from the Drug Enforcement Administration in order to dispense controlled substances.

24 (4) The board may adopt rules to carry out this section.

25 **SECTION 9.** ORS 689.005 is amended to read:

26 689.005. As used in this chapter:

27 (1) “Administer” means the direct application of a drug or device whether by injection,
28 inhalation, ingestion, or any other means, to the body of a patient or research subject by:

29 (a) A practitioner or the practitioner’s authorized agent; or

30 (b) The patient or research subject at the direction of the practitioner.

31 (2) “Approved continuing pharmacy education program” means those seminars, classes,
32 meetings, workshops and other educational programs on the subject of pharmacy approved by the
33 State Board of Pharmacy.

34 (3) “Clinical pharmacy agreement” means an agreement between a pharmacist or pharmacy and
35 a health care organization or a physician as defined in ORS 677.010 or a naturopathic physician as
36 defined in ORS 685.010 that permits the pharmacist to engage in the practice of clinical pharmacy
37 for the benefit of the patients of the health care organization, physician or naturopathic physician.

38 (4) “Continuing pharmacy education” means:

39 (a) Professional, pharmaceutical post-graduate education in the general areas of socio-economic
40 and legal aspects of health care;

41 (b) The properties and actions of drugs and dosage forms; and

42 (c) The etiology, characteristics and therapeutics of the disease state.

43 (5) “Continuing pharmacy education unit” means the unit of measurement of credits for ap-
44 proved continuing education courses and programs.

45 (6) “Deliver” or “delivery” means the actual, constructive or attempted transfer of a drug or

1 device other than by administration from one person to another, whether or not for a consideration.

2 (7) "Device" means an instrument, apparatus, implement, machine, contrivance, implant, in vitro
3 reagent or other similar or related article, including any component part or accessory, which is re-
4 quired under federal or state law to be prescribed by a practitioner and dispensed by a pharmacist.

5 (8) "Dispense" or "dispensing" means the preparation and delivery of a prescription drug pur-
6 suant to a lawful order of a practitioner in a suitable container appropriately labeled for subsequent
7 administration to or use by a patient or other individual entitled to receive the prescription drug.

8 (9) "Distribute" means the delivery of a drug other than by administering or dispensing.

9 (10) "Drug" means:

10 (a) Articles recognized as drugs in the official United States Pharmacopoeia, official National
11 Formulary, official Homeopathic Pharmacopoeia, other drug compendium or any supplement to any
12 of them;

13 (b) Articles intended for use in the diagnosis, cure, mitigation, treatment or prevention of dis-
14 ease in a human or other animal;

15 (c) Articles, other than food, intended to affect the structure or any function of the body of hu-
16 mans or other animals; and

17 (d) Articles intended for use as a component of any articles specified in paragraph (a), (b) or (c)
18 of this subsection.

19 (11) "Drug order" means a written order, in a hospital or other inpatient care facility, for an
20 ultimate user of any drug or device issued and signed by a practitioner, or an order transmitted by
21 other means of communication from a practitioner, that is immediately reduced to writing by a
22 pharmacist, licensed nurse or other practitioner.

23 (12) "Drug outlet" means a pharmacy, nursing home, shelter home, convalescent home, extended
24 care facility, drug abuse treatment center, penal institution, hospital, family planning clinic, student
25 health center, retail store, wholesaler, manufacturer, mail-order vendor or other establishment with
26 facilities located within or out of this state that is engaged in dispensing, delivery or distribution
27 of drugs within this state.

28 (13) "Drug room" means a secure and lockable location within an inpatient care facility that
29 does not have a licensed pharmacy.

30 (14) "Electronically transmitted" or "electronic transmission" means a communication sent or
31 received through technological apparatuses, including computer terminals or other equipment or
32 mechanisms linked by telephone or microwave relays, or similar apparatus having electrical, digital,
33 magnetic, wireless, optical, electromagnetic or similar capabilities.

34 (15) "Injectable hormonal contraceptive" means a drug composed of a hormone or a combination
35 of hormones that is approved by the United States Food and Drug Administration to prevent preg-
36 nancy and that a health care practitioner administers to the patient by injection.

37 (16) "Institutional drug outlet" means hospitals and inpatient care facilities where medications
38 are dispensed to another health care professional for administration to patients served by the hos-
39 pitals or facilities.

40 (17) "Intern" means a person who is enrolled in or has completed a course of study at a school
41 or college of pharmacy approved by the board and who is licensed with the board as an intern.

42 (18) "Internship" means a professional experiential program approved by the board under the
43 supervision of a licensed pharmacist registered with the board as a preceptor.

44 (19) "Labeling" means the process of preparing and affixing of a label to any drug container
45 exclusive, however, of the labeling by a manufacturer, packer or distributor of a nonprescription

1 drug or commercially packaged legend drug or device.

2 (20) "Manufacture" means the production, preparation, propagation, compounding, conversion
3 or processing of a device or a drug, either directly or indirectly by extraction from substances of
4 natural origin or independently by means of chemical synthesis or by a combination of extraction
5 and chemical synthesis and includes any packaging or repackaging of the substances or labeling or
6 relabeling of its container, except that this term does not include the preparation or compounding
7 of a drug by an individual for their own use or the preparation, compounding, packaging or labeling
8 of a drug:

9 (a) By a practitioner as an incident to administering or dispensing of a drug in the course of
10 professional practice; or

11 (b) By a practitioner or by the practitioner's authorization under supervision of the practitioner
12 for the purpose of or as an incident to research, teaching or chemical analysis and not for sale.

13 (21) "Manufacturer" means a person engaged in the manufacture of drugs.

14 (22) "Nonprescription drug outlet" means a business or other establishment that is open to the
15 general public for the sale or nonprofit distribution of nonprescription drugs and is registered under
16 ORS 689.305.

17 (23) "Nonprescription drugs" means drugs that may be sold without a prescription and that are
18 prepackaged for use by the consumer and labeled in accordance with the requirements of the stat-
19 utes and regulations of this state and the federal government.

20 (24) "Person" means an individual, corporation, partnership, association or other legal entity.

21 (25) "Pharmacist" means an individual licensed by this state to engage in the practice of phar-
22 macy or to engage in the practice of clinical pharmacy.

23 (26) "Pharmacy" means a place that meets the requirements of rules of the board, is licensed
24 and approved by the board where the practice of pharmacy may lawfully occur and includes
25 apothecaries, drug stores, dispensaries, hospital outpatient pharmacies, pharmacy departments and
26 prescription laboratories but does not include a place used by a manufacturer or wholesaler.

27 (27) "Pharmacy technician" means a person licensed by the board who assists in the practice
28 of pharmacy pursuant to rules of the board.

29 (28) "Practice of clinical pharmacy" means:

30 (a) The health science discipline in which, in conjunction with the patient's other practitioners,
31 a pharmacist provides patient care to optimize medication therapy and to promote disease pre-
32 vention and the patient's health and wellness;

33 (b) The provision of patient care services, including but not limited to post-diagnostic disease
34 state management services; and

35 (c) The practice of pharmacy by a pharmacist pursuant to a clinical pharmacy agreement.

36 (29) "Practice of pharmacy" means:

37 (a) The interpretation and evaluation of prescription orders;

38 (b) The compounding, dispensing and labeling of drugs and devices, except labeling by a man-
39 ufacturer, packer or distributor of nonprescription drugs and commercially packaged legend drugs
40 and devices;

41 (c) The prescribing and administering of vaccines and immunizations and the providing of pa-
42 tient care services pursuant to ORS 689.645;

43 (d) The administering of drugs and devices to the extent permitted under ORS 689.655;

44 (e) The participation in drug selection and drug utilization reviews;

45 (f) The proper and safe storage of drugs and devices and the maintenance of proper records re-

1 guarding the safe storage of drugs and devices;

2 (g) The responsibility for advising, where necessary or where regulated, of therapeutic values,
3 content, hazards and use of drugs and devices;

4 (h) The monitoring of therapeutic response or adverse effect to drug therapy;

5 (i) The optimizing of drug therapy through the practice of clinical pharmacy;

6 (j) Patient care services, including medication therapy management and comprehensive
7 medication review;

8 (k) The offering or performing of those acts, services, operations or transactions necessary in
9 the conduct, operation, management and control of pharmacy;

10 (L) The prescribing and administering of injectable hormonal contraceptives and the prescribing
11 and dispensing of self-administered hormonal contraceptives pursuant to ORS 689.689;

12 (m) The prescribing and dispensing of emergency refills of insulin and associated insulin-related
13 devices and supplies pursuant to ORS 689.696;

14 (n) The prescribing, dispensing and administering of preexposure prophylactic antiretroviral
15 therapies and post-exposure prophylactic antiretroviral therapies, pursuant to ORS 689.704 and rules
16 adopted by the board under ORS 689.645 and 689.704; [and]

17 (o) The delegation of tasks to other health care providers who are appropriately trained and
18 authorized to perform the delegated tasks; **and**

19 **(p) The prescribing and dispensing of early refills of medication for the treatment of**
20 **opioid use disorder pursuant to section 7 of this 2024 Act.**

21 (30) "Practitioner" means a person licensed and operating within the scope of such license to
22 prescribe, dispense, conduct research with respect to or administer drugs in the course of profes-
23 sional practice or research:

24 (a) In this state; or

25 (b) In another state or territory of the United States if the person does not reside in Oregon and
26 is registered under the federal Controlled Substances Act.

27 (31) "Preceptor" means a pharmacist or a person licensed by the board to supervise the
28 internship training of a licensed intern.

29 (32) "Prescription drug" or "legend drug" means a drug that is:

30 (a) Required by federal law, prior to being dispensed or delivered, to be labeled with either of
31 the following statements:

32 (A) "Caution: Federal law prohibits dispensing without prescription"; or

33 (B) "Caution: Federal law restricts this drug to use by or on the order of a licensed
34 veterinarian"; or

35 (b) Required by any applicable federal or state law or regulation to be dispensed on prescription
36 only or is restricted to use by practitioners only.

37 (33) "Prescription" or "prescription drug order" means a written, oral or electronically trans-
38 mitted direction, given by a practitioner authorized to prescribe drugs, for the preparation and use
39 of a drug. When the context requires, "prescription" also means the drug prepared under such
40 written, oral or electronically transmitted direction.

41 (34) "Retail drug outlet" means a place used for the conduct of the retail sale, administering or
42 dispensing or compounding of drugs or chemicals or for the administering or dispensing of pre-
43 scriptions and licensed by the board as a place where the practice of pharmacy may lawfully occur.

44 (35) "Self-administered hormonal contraceptive" means a drug composed of a hormone or a
45 combination of hormones that is approved by the United States Food and Drug Administration to

1 prevent pregnancy and that the patient to whom the drug is prescribed may administer to oneself.
2 “Self-administered hormonal contraceptive” includes, but is not limited to, hormonal contraceptive
3 patches and hormonal contraceptive pills.

4 (36) “Third-party logistics provider” means an entity that:

5 (a) Provides or coordinates warehousing of, or other logistics services for, a product in inter-
6 state commerce on behalf of a manufacturer, wholesale distributor or dispenser of the product; and

7 (b) Does not take ownership of, or have responsibility to direct the sale or disposition of, the
8 product.

9 (37) “Unit dose” means a sealed single-unit container so designed that the contents are admin-
10 istered to the patient as a single dose, direct from the container. Each unit dose container must bear
11 a separate label, be labeled with the name and strength of the medication, the name of the man-
12 ufacturer or distributor, an identifying lot number and, if applicable, the expiration date of the
13 medication.

14 (38) “Wholesale distributor drug outlet” means a person, other than a manufacturer,
15 manufacturer’s colicensed partner, third-party logistics provider or repackager, as defined in 21
16 U.S.C. 360eee(16), that is engaged in wholesale distribution, as defined in 21 U.S.C. 353(e)(4).

17
18 **(Access to Addiction Treatment**
19 **by Members of Coordinated Care Organizations)**

20
21 **SECTION 10.** ORS 414.609 is amended to read:

22 414.609. (1) A coordinated care organization that contracts with the Oregon Health Authority
23 must maintain a network of providers, **including but not limited to addiction treatment provid-**
24 **ers**, sufficient in numbers and areas of practice and geographically distributed in a manner to en-
25 sure that the health services provided under the contract are reasonably accessible to members.

26 (2) A member may transfer from one organization to another organization no more than once
27 during each enrollment period.

28
29 **(Alcohol and Drug Policy Commission Study)**

30
31 **SECTION 11.** (1) **The Alcohol and Drug Policy Commission created under ORS 430.221**
32 **shall conduct a study of barriers to and best practices for:**

33 (a) **Youth accessing opioid use disorder treatment; and**

34 (b) **Increasing access to opioid use disorder medications, including:**

35 (A) **Opioid use disorder medication treatment interventions and the prescribing of opioid**
36 **use disorder medication in emergency departments; and**

37 (B) **Increasing the number of providers of opioid use disorder treatment statewide.**

38 (2) **In studying the barriers to and best practices for youth accessing opioid use disorder**
39 **treatment under subsection (1)(a) of this section, the commission shall collaborate with**
40 **participating state agencies, as defined in ORS 430.221, and the System of Care Advisory**
41 **Council established in ORS 418.978.**

42 (3) **No later than September 30, 2024, the commission shall provide to the interim com-**
43 **mittees of the Legislative Assembly related to health a report on the status of the study and**
44 **any preliminary recommendations that the commission has developed.**

45 (4) **No later than September 15, 2025, the commission shall report to the interim com-**

1 mittees of the Legislative Assembly related to behavioral health, in the manner provided in
2 ORS 192.245:

3 (a) A strategic plan to improve the access of youth to opioid use disorder treatment;

4 (b) A strategic plan that includes evidence-based and evidence-informed strategies for
5 increasing the number of opioid use disorder treatment providers statewide and expanding
6 the capacity of the opioid use disorder treatment system in this state;

7 (c) Recommendations for reducing the barriers to accessing opioid use disorder treat-
8 ment, including barriers to the provision of opioid use disorder treatment interventions in
9 emergency departments; and

10 (d) Needed changes to address obstacles encountered by behavioral health providers when
11 seeking health insurance reimbursement for opioid use disorder medications, including but
12 not limited to:

13 (A) Requiring providers to use specialty pharmacies instead of purchasing medications
14 directly from vendors and billing the insurers;

15 (B) Limiting the coverage of opioid use disorder treatment to specific forms of
16 medications, such as sublingual or injectable forms;

17 (C) Imposing limits on the amount of an opioid use disorder medication that may be
18 dispensed during a single visit; and

19 (D) Obstacles identified from data regarding insurance claim denials, including retroac-
20 tive denials, of reimbursement for opioid use disorder medications.

21 **SECTION 12.** Section 11 of this 2024 Act is repealed on January 2, 2026.

22
23 (Certified Community Behavioral Health Clinic Program)

24
25 **SECTION 13.** Section 14 of this 2024 Act is added to and made a part of ORS chapter 413.

26 **SECTION 14.** (1) The certified community behavioral health clinic program is established
27 in the Oregon Health Authority for the purpose of certifying community behavioral health
28 clinics that meet criteria adopted by the authority by rule to receive prospective fixed cost-
29 based rates, as provided in subsection (4) of this section, for services provided to medical
30 assistance enrollees.

31 (2) The authority shall appoint an advisory committee, as described in ORS 183.333, to
32 advise the authority in the adoption of rules to carry out this section. The Director of the
33 Oregon Health Authority shall appoint to the advisory committee 15 individuals who repre-
34 sent a diverse constituency and are knowledgeable about certified community behavioral
35 health clinic delivery systems, patient-centered primary care home delivery systems, inte-
36 grated health care or health care quality. At least five members of the advisory committee
37 must be current or former consumers of the type of behavioral health services that are
38 typically provided by certified community behavioral health clinics or family members, rep-
39 resentatives or advocates for such consumers. Rules adopted by the authority:

40 (a) Must be consistent with the criteria adopted by the United States Department of
41 Health and Human Services for certified community behavioral health clinics; and

42 (b) Shall ensure that certified community behavioral health clinics provide, either di-
43 rectly or by referral through formal relationships with other providers, all of the services
44 required by the criteria adopted by the United States Department of Health and Human
45 Services for certified community behavioral health clinics.

1 **(3) If the authority adopts requirements for certified community behavioral health clinics**
2 **that are in addition to the criteria described in subsection (2)(a) of this section, the authority**
3 **shall:**

4 **(a) Provide funding to the clinics sufficient to reimburse the costs of the additional re-**
5 **quirements; or**

6 **(b) Have a process for granting allowable variances to one or more of the requirements.**

7 **(4)(a) A certified community behavioral health clinic shall complete the federally required**
8 **cost report for the authority to review and approve the clinic's prospective fixed cost-based**
9 **rate for a patient encounter.**

10 **(b) The authority shall regularly adjust the prospective fixed cost-based rate at intervals**
11 **consistent with federal guidance. A certified community behavioral health clinic may request**
12 **a rate adjustment if a clinic changes the clinic's scope of services.**

13 **(c) The authority shall adopt and provide to certified community behavioral health clinics**
14 **guidance on the development of fixed rates and billing. The fixed rate must include but is**
15 **not limited to:**

16 **(A) An estimate of the projected cost of anticipated expansions of the certified commu-**
17 **nity behavioral health clinic program or the populations served by the program; and**

18 **(B) The cost of the technology and data systems needed by each clinic to track and**
19 **measure outcomes and other data that the authority requires to be tracked or measured.**

20 **(d) The authority shall review federal guidance on rate setting for clinics that are dually**
21 **certified as federally qualified health centers, as defined in 42 U.S.C. 1396d(1)(2), and as cer-**
22 **tified community behavioral health clinics and provide recommendations to such dually cer-**
23 **tified clinics about how the clinics can best bill for services.**

24 **(5) In any geographic region of this state that is served by both a certified community**
25 **behavioral health clinic and a community mental health program:**

26 **(a) Before the authority may approve the certification of a certified community behav-**
27 **ioral health clinic, the certified community behavioral health clinic and the community**
28 **mental health program shall enter into a written agreement concerning collaboration be-**
29 **tween the clinic and the program in the coordination of services that are provided by both**
30 **the clinic and the program.**

31 **(b) The authority shall develop a plan to ensure:**

32 **(A) Coordination of services between the clinic and the program to minimize service re-**
33 **dundancies; and**

34 **(B) Financial efficiencies to maximize financial benefits.**

35 **(6) This section does not require a clinic that is eligible for certification under this sec-**
36 **tion to apply for certification. Participation in the certified community behavioral health**
37 **clinic program is voluntary.**

7 (Joint Task Force on Regional Behavioral Health Accountability)

9 **SECTION 16.** (1) The Joint Task Force on Regional Behavioral Health Accountability is
10 established to make recommendations to the Legislative Assembly to improve the
11 governance of behavioral health systems and strengthen evidence-based and equitable fund-
12 ing decisions and accountability of behavioral health systems.

23 (B) One member representing the Alcohol and Drug Policy Commission;

24 (C) One member representing the Department of Human Services;

25 (D) One member representing coordinated care organizations;

26 (E) One member representing providers of psychiatric care in clinical settings;

27 (F) One member representing Oregon counties;

28 (G) One member representing Oregon cities;

29 (H) One member who provides county mental health services or who represents county
30 mental health providers;

31 (I) One member from a large labor organization representing behavioral health workers;

32 (J) One member who is a behavioral health provider or who represents private and
33 nonprofit behavioral health providers;

34 (K) One member who provides nonprofit substance use disorder treatment or who re-
35 presents nonprofit substance use disorder treatment providers;

36 (L) One member from a large labor organization representing nurses;

37 (M) One member who is a licensed doctor or who represents licensed doctors with expe-
38 rience in behavioral health or substance use disorder treatment programs, care delivery or
39 funding;

40 (N) One member from a business coalition representing the hospital industry;

41 (O) One member from a business coalition representing the insurance industry;

42 (P) One member from a business coalition representing pharmacists;

43 (Q) One member representing a consumer of behavioral health services;

44 (R) One member with extensive experience in Oregon Indian tribes and a deep under-
45 standing of Oregon's rural and urban tribal populations, appointed after consultation with

1 the Commission on Indian Services;

2 (S) One member who is an emergency response transportation provider;

3 (T) One member representing long term care facilities; and

4 (U) One member with experience in regional behavioral health system governance.

5 (3) The task force, in collaboration with any other task forces that are charged with
6 scopes of work that overlap or intersect with the charges of the Joint Task Force on Re-
7 gional Behavioral Health Accountability, shall develop recommendations to:

8 (a) Improve collaboration and accountability across federal, state and local behavioral
9 health and substance use disorder treatment programs and funding;

10 (b) Ensure equitable outcomes in publicly supported treatment settings across Oregon
11 communities;

12 (c) Provide greater cost efficiencies in the continuum of care of Oregon's behavioral
13 health system; and

14 (d) Establish broad access to methadone and other opioid use disorder medications
15 through mobile devices, telehealth and pharmacy-based services to measurably increase the
16 engagement statewide of individuals with opioid use disorder in opioid use disorder treat-
17 ment.

18 (4) Recommendations developed under subsection (3) of this section should include:

19 (a) Any statutory changes needed to ensure that federal, state and local funds are being
20 spent to maximize outcomes and resource efficiency;

21 (b) Policy changes recommended based on a comparative analysis of policies in other
22 states that spend less on treatment but demonstrate better behavioral health and substance
23 use disorder treatment outcomes, including better outcomes for groups that are dispropor-
24 tionately impacted by health inequities; and

25 (c) Any governance changes that would facilitate greater alignment of spending decisions
26 between federal, state and local behavioral health and substance use disorder treatment
27 programs.

28 (5) A majority of the voting members of the task force constitutes a quorum for the
29 transaction of business.

30 (6) Official action by the task force requires the approval of a majority of the voting
31 members of the task force.

32 (7) The task force shall elect one of its members to serve as chairperson.

33 (8) If there is a vacancy for any cause, the appointing authority shall make an appoint-
34 ment to become immediately effective.

35 (9) The task force shall meet at times and places specified by the call of the chairperson
36 or of a majority of the voting members of the task force.

37 (10) The task force may adopt rules necessary for the operation of the task force.

38 (11)(a) The task force shall provide draft recommendations developed under subsections
39 (3) and (4) of this section to the interim committees of the Legislative Assembly related to
40 health no later than September 15, 2025.

41 (b) The task force shall submit a final report of the task force's recommendations, in the

44 (12) The Legislative Policy and Research Director shall provide staff support to the task

5 (c) Reviewing data related to the challenges faced by individuals receiving substance use

7 (d) Reviewing the responsibilities of county and state agencies and the accountability of
8 county and state agencies for providing behavioral health and substance use disorder treat-
9 ment.

10 (13) Members of the Legislative Assembly appointed to the task force are nonvoting
11 members of the task force and may act in an advisory capacity only.

12 (14) Members of the task force who are not members of the Legislative Assembly are not
13 entitled to compensation or reimbursement for expenses and serve as volunteers on the task
14 force.

15 (15) All agencies of state government, as defined in ORS 174.111, are directed to assist
16 the task force in the performance of the duties of the task force and, to the extent permitted
17 by laws relating to confidentiality, to furnish information and advice the members of the task
18 force consider necessary to perform their duties.

43 **(Delivery Definition Based on State v. Boyd)**

45 **SECTION 24.** ORS 475.005 is amended to read:

1 475.005. As used in ORS 475.005 to 475.285 and 475.752 to 475.980, unless the context requires
2 otherwise:

3 (1) "Abuse" means the repetitive excessive use of a drug short of dependence, without legal or
4 medical supervision, which may have a detrimental effect on the individual or society.

5 (2) "Administer" means the direct application of a controlled substance, whether by injection,
6 inhalation, ingestion or any other means, to the body of a patient or research subject by:

7 (a) A practitioner or an authorized agent thereof; or

8 (b) The patient or research subject at the direction of the practitioner.

9 (3) "Administration" means the Drug Enforcement Administration of the United States Depart-
10 ment of Justice, or its successor agency.

11 (4) "Agent" means an authorized person who acts on behalf of or at the direction of a man-
12 ufacturer, distributor or dispenser. It does not include a common or contract carrier, public
13 warehouseman or employee of the carrier or warehouseman.

14 (5) "Board" means the State Board of Pharmacy.

15 (6) "Controlled substance":

16 (a) Means a drug or its immediate precursor classified in Schedules I through V under the fed-
17 eral Controlled Substances Act, 21 U.S.C. 811 to 812, as modified under ORS 475.035. The use of the
18 term "precursor" in this paragraph does not control and is not controlled by the use of the term
19 "precursor" in ORS 475.752 to 475.980.

20 (b) Does not include:

21 (A) The plant Cannabis family Cannabaceae;

22 (B) Any part of the plant Cannabis family Cannabaceae, whether growing or not;

23 (C) Resin extracted from any part of the plant Cannabis family Cannabaceae;

24 (D) The seeds of the plant Cannabis family Cannabaceae;

25 (E) Any compound, manufacture, salt, derivative, mixture or preparation of a plant, part of a
26 plant, resin or seed described in this paragraph; or

27 (F) Psilocybin or psilocin, but only if and to the extent that a person manufactures, delivers, or
28 possesses psilocybin, psilocin, or psilocybin products in accordance with the provisions of ORS
29 475A.210 to 475A.722 and rules adopted under ORS 475A.210 to 475A.722.

30 (7) "Counterfeit substance" means a controlled substance or its container or labeling, which,
31 without authorization, bears the trademark, trade name, or other identifying mark, imprint, number
32 or device, or any likeness thereof, of a manufacturer, distributor or dispenser other than the person
33 who in fact manufactured, delivered or dispensed the substance.

34 (8) "Deliver" or "delivery" means the actual, constructive or attempted transfer **of, or pos-**
35 **session with the intent to transfer**, other than by administering or dispensing, from one person
36 to another, [of] a controlled substance, whether or not there is an agency relationship.

37 (9) "Device" means instruments, apparatus or contrivances, including their components, parts
38 or accessories, intended:

39 (a) For use in the diagnosis, cure, mitigation, treatment or prevention of disease in humans or
40 animals; or

41 (b) To affect the structure of any function of the body of humans or animals.

42 (10) "Dispense" means to deliver a controlled substance to an ultimate user or research subject
43 by or pursuant to the lawful order of a practitioner, and includes the prescribing, administering,
44 packaging, labeling or compounding necessary to prepare the substance for that delivery.

45 (11) "Dispenser" means a practitioner who dispenses.

1 (12) "Distributor" means a person who delivers.

2 (13) "Drug" means:

3 (a) Substances recognized as drugs in the official United States Pharmacopoeia, official
4 Homeopathic Pharmacopoeia of the United States or official National Formulary, or any supplement
5 to any of them;

6 (b) Substances intended for use in the diagnosis, cure, mitigation, treatment or prevention of
7 disease in humans or animals;

8 (c) Substances (other than food) intended to affect the structure or any function of the body of
9 humans or animals; and

10 (d) Substances intended for use as a component of any article specified in paragraph (a), (b) or
11 (c) of this subsection; however, the term does not include devices or their components, parts or ac-
12 cessories.

13 (14) "Electronically transmitted" or "electronic transmission" means a communication sent or
14 received through technological apparatuses, including computer terminals or other equipment or
15 mechanisms linked by telephone or microwave relays, or any similar apparatus having electrical,
16 digital, magnetic, wireless, optical, electromagnetic or similar capabilities.

17 (15) "Manufacture" means the production, preparation, propagation, compounding, conversion
18 or processing of a controlled substance, either directly or indirectly by extraction from substances
19 of natural origin, or independently by means of chemical synthesis, or by a combination of extraction
20 and chemical synthesis, and includes any packaging or repackaging of the substance or labeling or
21 relabeling of its container, except that this term does not include the preparation or compounding
22 of a controlled substance:

23 (a) By a practitioner as an incident to administering or dispensing of a controlled substance in
24 the course of professional practice; or

25 (b) By a practitioner, or by an authorized agent under the practitioner's supervision, for the
26 purpose of, or as an incident to, research, teaching or chemical analysis and not for sale.

27 (16) "Person" includes a government subdivision or agency, business trust, estate, trust or any
28 other legal entity.

29 (17) "Practitioner" means physician, dentist, veterinarian, scientific investigator, licensed nurse
30 practitioner, physician assistant or other person licensed, registered or otherwise permitted by law
31 to dispense, conduct research with respect to or to administer a controlled substance in the course
32 of professional practice or research in this state but does not include a pharmacist or a pharmacy.

33 (18) "Prescription" means a written, oral or electronically transmitted direction, given by a

43 (21) "Ultimate user" means a person who lawfully possesses a controlled substance for the use
44 of the person or for the use of a member of the household of the person or for administering to an
45 animal owned by the person or by a member of the household of the person.

2 (a) An amount of a controlled substance that is sufficient to physically weigh independent of its
3 packaging and that does not fall below the uncertainty of the measuring scale; or

5 by a Department of State Police forensic laboratory, due to the circumstances of the controlled

**POSSESSION OF CONTROLLED SUBSTANCES
(Drug Enforcement Misdemeanor Provisions)**

SECTION 34. Section 35 of this 2024 Act is added to and made a part of ORS 475.752 to 475.980.

SECTION 35. (1) Unlawful possession of a controlled substance constituting a drug enforcement misdemeanor under ORS 475.752 (3)(a), (b), (c) or (d), 475.814 (2)(a), 475.824 (2)(a), 475.834 (2)(a), 475.854 (2)(a), 475.874 (2)(a), 475.884 (2)(a) or 475.894 (2)(a) is punishable as described in this section.

(2)(a) When imposing a sentence for the crime described in this section:

(A) The court may decide to not suspend the imposition or execution of any part of the sentence, and impose a term of incarceration in accordance with ORS 137.010 (7) of up to 180 days, only upon the request of the defendant.

(B) If the defendant has not requested to be sentenced under subparagraph (A) of this paragraph, or if the court has decided not to sentence the defendant under subparagraph (A) of this paragraph, the court shall suspend the imposition of any sentence of incarceration and, notwithstanding ORS 137.010 (4), impose a sentence of supervised probation of a definite period of up to 18 months.

(b) When imposing a sentence of probation under this section, the court may not order as a condition of probation that the defendant serve a sentence of incarceration or confinement in the county jail.

5 **SECTION 51.** Section 52 of this 2024 Act is added to and made a part of ORS 475.752 to
6 475.980.

7 **SECTION 52.** (1)(a) When a person is charged with unlawful possession of a controlled
8 substance under ORS 475.752 (3)(a), (b), (c) or (d), 475.814 (2)(a), 475.824 (2)(a), 475.834 (2)(a),
9 475.854 (2)(a), 475.874 (2)(a), 475.884 (2)(a) or 475.894 (2)(a) constituting a drug enforcement
10 misdemeanor as described in section 35 of this 2024 Act, the person is eligible to enter, and
11 subject to paragraphs (b) and (c) of this subsection may request to enter, into a probation
12 agreement as described in this section.

13 (b) The district attorney may object to the defendant’s entry into a probation agreement
14 under this section. After hearing the reasons for the objection, the court may deny the
15 person’s entry if the probation agreement would not serve the needs of the person or the
16 protection and welfare of the community.

3 (iv) Whether average times to access services to which clients are referred, such as housing or
4 medically assisted treatment, have decreased over time since December 3, 2020.

5 (v) Demographic data on clients served by Behavioral Health Resource Networks, including
6 self-reported demographic data on race, ethnicity, gender and age.

7 (i) Each recipient of a grant or funding.

8 (j) Other areas identified by the division for ascertaining best practices for overdose prevention.

9 (6) The division shall conduct periodic performance audits and financial reviews pursuant to the
10 division's annual audit plan and taking into consideration the risks of the program.

DATA TRACKING

SECTION 75. 12 **SECTION 76.** (1) As used in this section, “deflection program” means a collaborative
13 program between law enforcement agencies and behavioral health entities that assists indi-
14 viduals who may have substance use disorder, another behavioral health disorder or co-
15 occurring disorders, to create community-based pathways to treatment, recovery support
16 services, housing, case management or other services.

17 (2) The Oregon Behavioral Health Deflection Program is established within the Improving
18 People’s Access to Community-based Treatment, Supports and Services Grant Review Com-
19 mittee established under ORS 430.234. The program consists of grants awarded by the com-
20 mittee to counties and federally recognized tribal governments to fund deflection programs.

21 (3)(a) The purpose of the program described in this section is to:

22 (A) Address the need for more deflection programs to assist individuals whose behavioral
23 health conditions, including substance use disorder, lead to interactions with law enforce-
24 ment, incarceration, conviction and other engagement with the criminal justice system.

25 (B) Track and report data concerning deflection program outcomes in order to determine
26 the best practices for deflection programs within this state.

27 (b) ORS 430.230 to 430.236 do not apply to the program described in this section.

28 (4)(a) The committee shall develop a grant application process for awarding grants under
29 this section.

30 (b) An application for a grant under this section may be submitted by a county or the
31 designee of a county, or by a tribal government or designee of a tribal government. Only one

44 another [treatment] facility or a sobering facility or denied referral or admission. If the person is

5 grant recipients support with technical assistance and best practices.

6 **SECTION 83.** (1) The Oregon Criminal Justice Commission shall award grants to cities
7 and counties in Oregon that operate a local correctional facility and to federally recognized
8 tribes in Oregon that operate a tribal correctional facility.

9 (2) Applicants may submit an individual application or a joint application in partnership
10 with other local correctional facilities or tribal correctional facilities.

11 (3) At least 10 percent of total moneys awarded to grant recipients must be awarded to
12 local correctional facilities in rural areas, as defined by the commission by rule, or tribal
13 correctional facilities. If any amount of the 10 percent is not awarded during an initial ap-
14 plication cycle, the remaining amount may be awarded to any otherwise eligible local
15 correctional facility or tribal correctional facility under a supplemental application cycle.

16 (4) The commission may enter a contract with a third party to provide statewide tech-
17 nical assistance to grant recipients.

18 (5) The commission shall consider geographic equity when awarding grant funds.

19 **SECTION 84.** Moneys awarded to grant recipients under section 83 of this 2024 Act may
20 be used to:

21 (1) Provide medication, telemedicine or any other reasonable treatment to persons in
22 custody with an opioid use disorder.

23 (2) Develop or operate mobile or nonmobile opioid treatment units.

24 (3) Administer screenings for opioid use disorder or risk of acute withdrawal.

25 (4) Facilitate transition planning services for persons in custody who seek or receive
26 opioid use disorder treatment.

27 (5) Undertake any other actions reasonably calculated to mitigate operational or struc-
28 tural barriers to providing opioid use disorder treatment in local correctional facilities or
29 tribal correctional facilities, including but not limited to mitigating any lack of secure stor-
30 age for medication.

31 **SECTION 85.** The Oregon Criminal Justice Commission shall adopt rules necessary to
32 administer sections 81 to 86 of this 2024 Act. The rules, at minimum, must:

33 (1) Establish a methodology for reviewing and approving grant applications and awarding
34 grants.

35 (2) Require applicants to submit a statement acknowledging that any grant funds re-
36 ceived must be expended in accordance with the allowable uses described in section 84 of this
37 2024 Act.

38 (3) Require applicants to submit a letter of commitment from each administrator of a
39 local correctional facility or tribal correctional facility who is associated with the application,
40 committing to participate in good faith in the grant program.

41 (4) Define "rural" for purposes of section 83 (3) of this 2024 Act.

42 **SECTION 86.** (1) The Oregon Criminal Justice Commission shall convene an advisory
43 committee to evaluate applications and make recommendations to the commission for the
44 awarding of grants under section 83 of this 2024 Act.

45 (2) The chairperson of the commission shall exercise discretion to appoint members to

1 serve on the advisory committee.

2 **SECTION 87.** (1) The Oregon Jail-Based Medications for Opioid Use Disorder Fund is es-
3 tablished in the State Treasury, separate and distinct from the General Fund. Interest
4 earned by the Oregon Jail-Based Medications for Opioid Use Disorder Fund shall be credited
5 to the fund. The fund consists of moneys appropriated or otherwise transferred to the fund
6 by the Legislative Assembly.

7 (2) Moneys in the fund are continuously appropriated to the Oregon Criminal Justice
8 Commission for the purposes of carrying out sections 81 to 86 of this 2024 Act.

9 **SECTION 88.** No later than December 1, 2024, the Oregon Criminal Justice Commission
10 shall submit a report, in the manner provided in ORS 192.245, to the interim committees of
11 the Legislative Assembly related to the judiciary and health care. The report must include:

12 (1) The name of each recipient of a grant under section 83 of this 2024 Act and the
13 amount of moneys each grant recipient has received to date.

14 (2) Opportunities, if any, for local correctional facilities or tribal correctional facilities
15 to obtain medications for opioid use disorder from state agencies.

16 (3) Any other information relevant to the provision of opioid use disorder treatment to
17 persons in custody in local correctional facilities or tribal correctional facilities.

18 **SECTION 89.** Section 88 of this 2024 Act is repealed on January 2, 2025.

22 **SECTION 90.** The unit captions used in this 2024 Act are provided only for the conven-
23 ience of the reader and do not become part of the statutory law of this state or express any
24 legislative intent in the enactment of this 2024 Act.

26 **EMERGENCY CLAUSE**

28 **SECTION 91.** This 2024 Act being necessary for the immediate preservation of the public
29 peace, health and safety, an emergency is declared to exist, and this 2024 Act takes effect
30 on its passage.
