AN ACT

1 Amending Titles 18 (Crimes and Offenses) and 44 (Law and
2 Justice) of the Pennsylvania Consolidated Statutes, in
3 firearms and other dangerous articles, further providing for
4 licenses and for licensing of dealers; and providing for
5 sheriffs and deputy sheriffs.

6 The General Assembly of the Commonwealth of Pennsylvania
7 hereby enacts as follows:

8 Section 1. Sections 6109(h) and 6113(b) of Title 18 of the
9 Pennsylvania Consolidated Statutes are amended to read:

10 § 6109. Licenses.

11 * * *

12 (h) [Fee] Fees.--

13 [(1) In addition to fees described in paragraphs (2)(ii)
14 and (3), the fee for a license to carry a firearm is \$19.

15 This includes all of the following:

16 (i) A renewal notice processing fee of \$1.50.

17 (ii) An administrative fee of \$5 under section 14(2)

18 of the act of July 6, 1984 (P.L.614, No.127), known as

1 the Sheriff Fee Act.

2 (2) (Expired).

3 (3) An additional fee of \$1 shall be paid by the
4 applicant for a license to carry a firearm and shall be
5 remitted by the sheriff to the Firearms License Validation
6 System Account, which is hereby established as a special
7 restricted receipt account within the General Fund of the
8 State Treasury. The account shall be used for purposes under
9 subsection (1). Moneys credited to the account and any
10 investment income accrued are hereby appropriated on a
11 continuing basis to the Pennsylvania State Police.]

12 (4) No fee other than that provided by [this subsection
13 or the Sheriff Fee Act] 44 Pa.C.S. § 7324 (relating to
14 licenses) may be assessed by the sheriff for the performance
15 of any background check made pursuant to this act.

16 (5) The [fee is] fees specified under 44 Pa.C.S. §
17 7324(1), (2) and (3) are payable to the sheriff to whom the
18 application is submitted and [is] are payable at the time of
19 application for the license.

20 (6) Except for the administrative fee of \$5 under
21 [section 14(2) of the Sheriff Fee Act] 44 Pa.C.S. § 7324(a)
22 (3), all other fees shall be refunded if the application is
23 denied but shall not be refunded if a license is issued and
24 subsequently revoked.

25 (7) A person who sells or attempts to sell a license to
26 carry a firearm for a fee in excess of the amounts fixed
27 under [this subsection] 44 Pa.C.S. § 7324 commits a summary
28 offense.

30 § 6113. Licensing of dealers.

2 (b) Fee.--The fee for issuing said license shall be [\$30] as
3 specified under 44 Pa.C.S. § 7324(a)(1) (relating to licenses),
4 which fee shall be paid into the county treasury.

12 § 7312. Counties included.

13 In counties of the second class, second class A and third
 14 through eighth class and home rule counties except a county of
 15 the first class, the fees, including commissions and mileage, to
 16 be received by the sheriff from persons or counties requiring
 17 services of the sheriff shall be as set forth in this
 18 subchapter.

19 § 7313. Civil and criminal actions.

20 (a) General rule.--Fees for the services of the sheriff
 21 involved with civil actions, criminal proceedings or public
 22 matters required by any court, statute or regulation, including,
 23 but not limited to, writs, complaints, orders, equity matters,
 24 subpoenas, interrogatories and official notices, are as follows:

- 25 (1) Receiving, docketing and making

2 (a) General rule.--For executing court-issued writs or
3 orders requiring the levy, seizure or sale of lands and
4 tenements, the following fees apply and, unless otherwise stated
5 in this section, shall be paid by the plaintiff, petitioner or
6 other moving party:

1 (b) Additional fees.--Except under subsection (a)(8), the
2 sheriff shall receive as an official fee a commission, based
3 upon the total amount bid for the property, whether paid to the
4 sheriff or credited to the purchaser, of 2% of the first
5 \$250,000 and of 0.5% of the remaining amount.

6 (c) Fees chargeable to sheriff.--The purchaser shall pay to
7 the sheriff fees of the prothonotary and fees of the recorder
8 chargeable by the prothonotary or the recorder to the sheriff
9 relating to consummation of real estate executions, including,
10 but not limited to, the recording of the deed.

11 § 7315. Executing writs, orders and decrees.

12 For executing a writ of inquiry, partition, condemnation,
13 appraisement or inquisition or a similar writ, order or decree
14 issued by a court, district justice or commissioner under a
15 statute, the party procuring execution shall pay the following
16 fees:

3 (a) General rule.--For executing execution writs, fraudulent
4 debtors attachment, retorno habendo, replevin or order issued by
5 a court requiring the levy, seizure or sale of personal
6 property, unless otherwise provided in this section, the party
7 procuring execution shall pay the following fees:

8 (1) Receiving, docketing and making return..... \$15.00

9 (2) Serving or posting a copy or notice..... 15.00

10 (3) Each levy on personal property..... 30.00

11 (4) Seizing personal property levied upon..... 25.00

12 (5) Making return of nulla bona (unable to find
13 goods to levy upon)..... 15.00

14 (6) Advertising personal property for public
15 sale by handbills..... 20.00

16 (7) Each adjourned sale..... 30.00

17 (8) Service upon a garnishee..... 15.00

18 (9) Receiving a claim of exemption or immunity

2 taken into legal custody, including, but not limited
3 to, obtaining a watchman, together with the cost of
4 compensation for the watchman by the party benefited
5 by the watchman or person requiring service..... 50.00

6 (14) Securing insurance; arranging goods for
7 sale; furnishing heat, light, power, storage, rent,
8 transportation and supplies; feeding livestock; and
9 meeting similar expenses incurred in caring for and
10 keeping the goods and chattels levied upon or
11 attached when necessary or advantageous or requested
12 by any party interested to incur any such expense,
13 the actual costs of the expense to be paid by the
14 plaintiff, petitioner or party requiring the expense
15 to be incurred, providing any surplus of advances for
16 the expense to be refunded.

17 (b) Additional fees.--The sheriff shall receive as an
18 official fee a commission, based upon the total amount bid for
19 the property, whether paid to the sheriff or credited to the
20 purchaser, of 2% of the first \$100,000 and of 0.5% of the
21 remaining amount.

22 § 7317. Settlement or staying of writs.

23 For the settlement or staying by the plaintiff of a writ
24 relating to property, execution not being concluded, the sheriff
25 shall receive the same fees for receiving, docketing and
26 returning, levying, advertising and performing other functions
27 enumerated in this subchapter, including commission as would be
28 chargeable if the sale had been made upon the writ, on the
29 amount paid to settle or stay the writ, whether the sum is paid
30 to the sheriff or to the plaintiff or a compromise is made

1 between plaintiff and defendant for the future payment to
2 satisfy the writ.

3 § 7318. Property claims.

4 For processing of property claims filed under statute or
5 rules of civil procedure, the claimant shall pay the following
6 fees:

27 § 7320. Writs of ejectment or possession.

28 For executing writs of ejectment or possession, \$50.00
29 dower or similar writs requiring the delivery of
30 possession of real property or ejecting or

1 dispossessing a person of personal property, the
2 claimant shall pay.....
3 § 7321. Warrants and attachments.

4 For executing a process, warrant, attachment, decree,
5 sentence or order of the court, issued in court on a person or
6 taking the defendant's body into custody, the party procuring
7 the process, writ, order or decree or, if the Commonwealth is
8 interested, the county, shall pay the following fees:

16 § 7322. Sheriff in charge of prison.

17 If the sheriff is in charge of a jail, prison or place of
18 detention, the sheriff shall receive allowances for the custody,
19 care and maintenance of prisoners and inmates as may be fixed by
20 the courts or official boards of the respective counties having
21 supervision of the institutions, or as the courts or boards may
22 approve, upon submitted bills to be paid by the county in
23 addition to compensation for services fixed by statute, by a
24 court or by official board authorized to fix the compensation.

25 § 7323. Attending court.

26 For attending court, when required to do so by law or by a
27 judge or district attorney, or bringing into or removing
28 prisoners for arraignment, trial or sentence or witnesses held
29 in custody, an hourly rate equivalent to the prevailing wage
30 scale of the performing sheriff's office shall be paid by the

1 county for each deputy or special deputy actually present.

2 § 7324. Licenses.

3 (a) Fees.--For issuing and recording of a license, the
4 licensee shall pay, in addition to a fee payable to the county
5 or Commonwealth, the following fees:

6 (1) Issuing a license to sell firearms directly
7 to a consumer..... \$27.00

8 (2) Issuing or reissuing a license to carry a
9 firearm on or about one's person..... 5.00

10 (3) Issuing a license to carry a firearm. This
11 fee includes a renewal processing fee of \$1.50 and an
12 administrative fee of \$5..... 22.00

13 (b) Additional fee.--An additional fee of \$3 shall be paid
14 by the applicant for a license to carry a firearm and shall be
15 remitted by the sheriff to the Firearms License Validation
16 System Account, which is established as a special restricted
17 receipt account within the General Fund. Money remitted to the
18 Firearms License Validation System Account and any investment
19 income accrued are appropriated on a continuing basis to the
20 Pennsylvania State Police.

21 (C) EXEMPTION.--A PERSON WHO IS THE HOLDER OF A UNITED
22 STATES UNIFORMED SERVICES IDENTIFICATION CARD SPECIFYING THAT
23 THE PERSON IS RETIRED SHALL BE EXEMPT FROM ANY FEE TO RENEW A
24 LICENSE TO CARRY A FIREARM.

25 § 7325. Conservator of the peace.

26 (a) Sheriff.--For the services performed in the capacity as
27 a conservator of the peace or police officer in suppressing
28 riots, mobs or insurrections, and when discharging any duty
29 requiring the summoning of a posse, comitatus or special deputy
30 sheriffs, the sheriff shall receive per diem compensation at the

1 rate of \$50 in a county for eight hours' service, together with
2 the mileage and necessary expenses, including subsistence for
3 the sheriff and those employees supervised by the sheriff, all
4 to be paid by the county.

5 (b) Deputies.--For each special deputy appointed by the
6 sheriff in the case of an emergency, to assist in executing
7 civil or criminal process or court order or preserving the
8 peace, the sheriff shall receive from the county, for
9 compensation of the deputy, an hourly rate equal to the
10 prevailing wage scale of the sheriff's office, together with the
11 expenses incurred for transportation and subsistence of the
12 deputy.

13 § 7326. Mileage.

14 For mileage in serving and executing writs, official notices,
15 rules, decrees, orders or processes, or copies thereof, or
16 performing the duties or services specified in this subchapter
17 or authorized by law, the sheriff shall receive and may tax as
18 official costs the mileage fee as established by section 1 of
19 the act of July 20, 1979 (P.L.156, No.51), referred to as the
20 Uniform Mileage Fee Law, for each mile necessary to be traveled
21 by the sheriff, deputies or employees. The mileage fee shall be
22 received on each separate writ, rule, order, decree, process or
23 notice served or service performed. The sheriff shall not
24 receive more than one mileage fee where the plaintiff and the
25 defendant and two or more contemporaneous writs are the same, or
26 when two or more persons or prisoners are being conducted at one
27 time to or from a place of detention or correction. The sheriff
28 shall receive the mileage fee for transporting the prisoners and
29 the deputies guarding them and meals and lodging during the
30 journey and the return of the deputies.

1 § 7327. Appraisals.

2 For appraisal in a proceeding, the sheriff or an interested
3 party may petition the court having jurisdiction over the matter
4 for an order fixing the sum to be paid to the sheriff for
5 services, for compensation of services of expert appraisers, or
6 for other property costs of making the appraisal, which sum
7 shall be a legal cost of proceedings. The court in its order
8 shall determine who shall pay for the costs unless otherwise
9 provided by law.

10 § 7328. Other matters.

11 For the executing of a matter directed to the sheriff or
12 required by law or rule of court, the performance of which is
13 not mentioned in this subchapter, the sheriff shall receive the
14 same official fees, commissions and legal costs, including
15 mileage, as for similar services specifically provided for by
16 law.

17 § 7329. Counties of the second class.

18 ~~(a) Establishment and modification of fees.—In counties of~~ <--
19 ~~the second class on or after the effective date of this section,~~
20 ~~the sheriff may establish, increase, decrease, modify or~~
21 ~~eliminate fees and charges used exclusively to offset existing~~
22 ~~costs with the approval of the president judge of the court of~~
23 ~~common pleas.~~

24 ~~(b) Additional fee for computerizing sheriff's office. An~~ <--
25 ~~additional fee of \$5 may be charged and collected by the sheriff~~
26 ~~of a county of the second class for the initiation of any action~~
27 ~~or legal proceeding. The additional fee shall be deposited into~~
28 ~~a special sheriff computer fund established in each county of~~
29 ~~the second class. Money in the special fund shall be used solely~~

2 § 7330. ADDITIONAL FEE FOR COMPUTERIZING SHERIFF'S OFFICE. <--

3 AN ADDITIONAL FEE OF \$5 MAY BE CHARGED AND COLLECTED BY THE
4 SHERIFF OF A COUNTY FOR THE INITIATION OF ANY ACTION OR LEGAL
5 PROCEEDING. THE ADDITIONAL FEE SHALL BE DEPOSITED INTO A SPECIAL
6 SHERIFF COMPUTER FUND ESTABLISHED IN EACH COUNTY. MONEY IN THE
7 SPECIAL FUND SHALL BE USED SOLELY FOR THE PURPOSE OF
8 COMPUTERIZING THE OFFICE OF THE SHERIFF.

9 § 7331. COSTS TO BE ADDITIONAL.

10 In addition to fees provided for in this subchapter, the
11 sheriff shall be paid costs, charges and expenses incident to
12 the performance of an act required by court, order, statute,
13 rule or regulation, including, but not limited to, printing
14 costs, publication costs, services of experts, watchmen, postage
15 and mileage, which shall be costs to be paid by the plaintiff,
16 petitioner or person requiring them to be incurred.

17 ~~§ 7331~~ 7332. Surcharge. <--

18 There shall be assessed a surcharge on each fee collected by
19 the sheriff of every county upon acceptance for each service
20 required for any complaint, summons, writ or other legal paper
21 required to be served or posted by the sheriff of \$20, which
22 which shall be collected by the sheriff of every county.

23 Section 3. Repeals are as follows:

24 (1) The General Assembly declares that the repeals under
25 paragraphs (2) and (3) are necessary to effectuate the
26 addition of 44 Pa.C.S. Ch. 73 Subch. B.

27 (2) The act of July 6, 1984 (P.L.614, No.127), known as
28 the Sheriff Fee Act, is repealed.

29 (3) Section 8(b) of the act of February 9, 1984 (P.L.3,
30 No.2), known as the Sheriff and Deputy Sheriff Education and

1 Training Act, is repealed.

2 Section 4. The addition of 44 Pa.C.S. Ch. 73 Subch. B is a
3 continuation of the act of July 6, 1984 (P.L.614, No.127), known
4 as the Sheriff Fee Act. Except as otherwise provided in 44
5 Pa.C.S. Ch. 73 Subch. B, all activities initiated under the
6 Sheriff Fee Act shall continue and remain in full force and
7 effect and may be completed under 44 Pa.C.S. Ch. 73 Subch. B.
8 Orders, regulations, rules and decisions which were made under
9 the Sheriff Fee Act and which are in effect on the effective
10 date of 44 Pa.C.S. Ch. 73 Subch. B shall remain in full force
