AN ACT

- 1 Providing for equal treatment for transgender pupils.
- 2 The General Assembly of the Commonwealth of Pennsylvania
- 3 hereby enacts as follows:
- 4 Section 1. Short title.
- 5 This act shall be known and may be cited as the Transgender
- 6 Pupil Educational Rights Act.
- 7 Section 2. Uniforms.
- 8 A school district may offer different uniforms for male and
- 9 female pupils, but may not require a pupil to wear a specific
- 10 uniform based on the pupil's sex.
- 11 Section 3. Courses.
- 12 A school district may not:
- 13 (1) Prohibit a pupil from enrolling in any class or
- course on the basis of the sex of the pupil.
- 15 (2) Require a pupil of one sex to enroll in a particular
- 16 class or course, unless the same class or course is also
- 17 required of a pupil of the opposite sex.

- 1 Section 4. School programs and activities.
- 2 The following shall apply:
- 3 (1) Participation in a particular activity or sport, if
- 4 required of pupils of one sex, shall be available to pupils
- 5 of each sex.
- 6 (2) A pupil shall be permitted to participate in sex-
- 7 segregated school programs and activities, including athletic
- 8 teams, consistent with the pupil's gender identity, except
- 9 where the participation of the pupil would ban the team from
- 10 national competitions.
- 11 Section 5. Guidance.
- 12 (a) General rule. -- A school counselor, teacher, instructor,
- 13 administrator or aide may not, on the basis of the sex of a
- 14 pupil, do any of the following:
- 15 (1) Offer vocational or school program guidance to a
- 16 pupil of one sex that is different from that offered to a
- 17 pupil of the opposite sex.
- 18 (2) In counseling a pupil, differentiate career,
- 19 vocational or higher education opportunities on the basis of
- the sex of the pupil.
- 21 (b) Career planning. -- Any school personnel acting in a
- 22 career counseling or course selection capacity to a pupil shall
- 23 affirmatively explore with the pupil the possibility of careers,
- 24 or courses leading to careers, that are nontraditional for the
- 25 pupil's sex.
- 26 Section 6. Documentation.
- 27 A pupil who identifies as a transgender individual may use
- 28 any facility, including bathrooms and locker rooms, consistent
- 29 with the pupil's gender identity upon providing any of the
- 30 following documentation to the school district:

- 1 (1) A signed statement from a licensed physician,
- 2 psychiatrist or psychologist, who has seen the pupil as a
- 3 patient for at least six months, which recognizes the pupil
- 4 as identifying as transgender.
- 5 (2) A signed, sworn statement from the pupil stating
- 6 that the pupil identifies as transgender and will
- 7 consistently live as the gender opposite from the pupil's sex
- 8 for the pupil's school career.
- 9 Section 7. Effective date.
- 10 This act shall take effect in 60 days.
