AN ACT

1 Amending the act of December 4, 1996 (P.L.911, No.147), entitled
 2 "An act providing for registration requirements for
 3 telemarketers and for powers and duties of the Office of
 4 Attorney General," further providing for unlawful acts and
 5 penalties and for unwanted telephone solicitation calls
 6 prohibited.

7 The General Assembly of the Commonwealth of Pennsylvania
 8 hereby enacts as follows:

9 Section 1. Section 5(a) of the act of December 4, 1996
 10 (P.L.911, No.147), known as the Telemarketer Registration Act,
 11 is amended by adding a paragraph to read:

12 Section 5. Unlawful acts and penalties.

13 (a) Acts enumerated.--The following acts are prohibited:

14 * * *

15 (10) Conducting telemarketing on a legal holiday.

2 Section 2. Section 5.2(c) of the act, amended September 12,
3 2003 (P.L.105, No.22), is amended to read:

4 Section 5.2. Unwanted telephone solicitation calls prohibited.

5 * * *

6 (c) Duration.--A listing on a do-not-call list shall be
7 maintained [for a minimum of five years from the date of the
8 enrollment or] until the telephone number is no longer valid for
9 the residential or wireless telephone subscriber[, whichever
10 occurs first] or until the subscriber requests to have the
11 telephone number removed from the list.

13 Section 3. This act shall take effect in 60 days.
