A CONCURRENT RESOLUTION

1 Establishing a commission to study the Commonwealth's fragmented
2 system of local governance and identify methods to promote
3 more regional collaboration in the delivery of municipal
4 services and the execution of local government.

5 RESOLVED (the House of Representatives concurring), That the
6 General Assembly, in response to the recommendations of the 2007
7 Brookings Institution Report, Committing to Prosperity: Moving
8 Forward on the Agenda to Renew Pennsylvania, and the
9 recommendations of the 2007 Pennsylvania Economy League Report,
10 Structuring Healthy Communities, direct the Majority Leader of
11 the Senate and the Majority Leader of the House of
12 Representatives to appoint a commission to study the
13 Commonwealth's system of local governance and identify methods
14 to promote more regional collaboration in the delivery of
15 municipal services and the execution of local government; and be
16 it further

17 RESOLVED, That the membership of the commission be:

18 (1) The Deputy Secretary for Community Affairs and

1 Development, Pennsylvania Department of Community and
2 Economic Development, who shall serve as chairperson.

3 (2) The chairperson and minority chairperson of the
4 Local Government Committee of the Senate or their designees.

5 (3) The chairperson and minority chairperson of the
6 Local Government Committee of the House of Representatives or
7 their designees.

8 (4) One member of the Senate appointed by the Majority
9 Leader of the Senate.

10 (5) One member of the Senate appointed by the Minority
11 Leader of the Senate.

12 (6) One member of the House of Representatives appointed
13 by the Majority Leader of the House of Representatives.

14 (7) One member of the House of Representatives appointed
15 by the Minority Leader of the House of Representatives.

16 (8) Members appointed as follows:

17 (i) A representative of the Pennsylvania Economy
18 League, appointed from a list submitted by the league to
19 the Speaker of the House of Representatives.

20 (ii) A representative of the Council of State
21 Governments, appointed from a list submitted by the
22 council to the Speaker of the House of Representatives.

23 (iii) A representative of the County Commissioners
24 Association of Pennsylvania, appointed from a list
25 submitted by the association to the Speaker of the House
26 of Representatives.

27 (iv) Two representatives of 10,000 Friends of
28 Pennsylvania, one representing the organization at large
29 and one representing the organization's subsidiary
30 campaign to Renew Pennsylvania, both appointed from a

1 list submitted by the organization to the Speaker of the
2 House of Representatives.

3 (v) A representative of the Pennsylvania State
4 Association of Township Supervisors, appointed from a
5 list submitted by the association to the President pro
6 tempore of the Senate.

7 (vi) A representative of the Pennsylvania State
8 Association of Boroughs, appointed from a list submitted
9 by the association to the President pro tempore of the
10 Senate.

11 (vii) A representative of the Pennsylvania League of
12 Cities and Municipalities, appointed from a list
13 submitted by the league to the President pro tempore of
14 the Senate.

15 (viii) A representative of the Pennsylvania
16 Municipal Authorities Association, appointed from a list
17 submitted by the association to the President pro tempore
18 of the Senate.

19 (ix) The Executive Director of the State Planning
20 Board, or his designee.

21 (x) The Executive Director of the Local Government
22 Commission or his designee;

23 and be it further

24 RESOLVED, That the commission be staffed by the Local
25 Government Commission; and be it further

26 RESOLVED, That the commission be charged with the following:

27 (1) Conduct a study of the current system of local
28 governance in Pennsylvania.

29 (2) Conduct a study of the current State financial and
30 technical assistance programs available to municipalities.

1 (3) Provide recommended measures that would ensure or
2 improve the fiscal stability of municipalities.

3 (4) Provide recommended changes that would make regional
4 cooperation more attractive to municipalities.

5 (5) Provide recommended changes that would remove or
6 reduce barriers to regional cooperation;

7 and be it further

8 RESOLVED, That the commission report to the General Assembly
9 the results of its study and its recommendations and file the
10 report with the Secretary of the Senate and the Chief Clerk of
11 the House of Representatives within six months of the adoption
12 of this concurrent resolution.
