## AN ACT

6	The General Assembly of the Commonwealth of Pennsylvania
7	hereby enacts as follows:
8	Section 1. Lieutenant Commander John J. Peterman Memorial
9	Highway.
10	(a) FindingsThe General Assembly finds and declares as
11	follows:
12	(1) Lieutenant Commander John J. Peterman was born in
13	Nordmont, Sullivan County, on January 19, 1923, and in 1941,
14	graduated from Sullivan Highlands School, Sonestown. He
15	enlisted in the United States Navy 11 days after graduation.
16	(2) Lieutenant Commander Peterman spent the early years

- of his service in the Navy assigned to submarines. Lieutenant
- 2 Commander Peterman was initially assigned to the USS Flying
- Fish (SS229). While abroad, Lieutenant Commander Peterman
- 4 made nine war patrols, having a part in the Battle of Midway,
- 5 patrolling the Truk Lagoon off the Caroline Islands and
- 6 patrolling in the Sea of Japan.
- 7 (3) After serving aboard submarines for 11 years,
- 8 Lieutenant Commander Peterman served as a torpedo instructor.
- 9 In 1955, Lieutenant Commander Peterman became a commissioned
- 10 officer, serving at ammunition depots in New Jersey and
- 11 California. He also spent time on the USS Henrico (APA45) as
- a gunnery officer and then on the USS Sperry (AS12) as a
- weapons repair officer. He served the last five years of his
- Navy career as an underwater weapons officer in Newport,
- Rhode Island. Upon retiring in 1972 as a lieutenant
- 16 commander, he returned home to his native Sullivan County,
- where he served a term as county sheriff, and as a Laporte
- 18 Township Supervisor.
- 19 (4) Lieutenant Commander Peterman was active in his
- community where, as a member of the Williamsport Base of the
- 21 United States Submarine Veterans, Inc., he participated in
- visits to the Janet Weis Children's Hospital, visiting with
- 23 pediatric patients while making them "honorary submariners."
- 24 Lieutenant Commander Peterman would wear his uniform for
- 25 these visits, often giving the children a living history
- 26 lesson. Lieutenant Commander Peterman was also an active
- 27 member of the Sonestown American Legion Post #601.
- 28 (b) Designation. -- The section of State Route 220 from State
- 29 Route 405 in Hughesville Borough, Lycoming County, to State
- 30 Route 42 in Laporte Township, Sullivan County, is hereby

- 1 designated as the Lieutenant Commander John J. Peterman Memorial
- 2 Highway.
- 3 (c) Signs. -- The Department of Transportation shall erect and
- 4 maintain appropriate signs displaying the name of the highway to

- 6 SECTION 2. THOMAS A. PATERNOSTRO MEMORIAL HIGHWAY.
- 7 (A) FINDINGS.--THE GENERAL ASSEMBLY FINDS AS FOLLOWS:
- 8 (1) THOMAS A. PATERNOSTRO WAS BORN IN WILLIAMSPORT ON
- 9 AUGUST 9, 1939. HE WAS MARRIED TO MARTHALIE RYAN PATERNOSTRO
- 10 FOR OVER 48 YEARS. HE WAS A 1957 GRADUATE OF THE FORMER ST.
- 11 MARY'S HIGH SCHOOL IN WILLIAMSPORT. HE WAS A 1964 GRADUATE OF
- 12 LYCOMING COLLEGE WHERE HE RECEIVED A BACHELOR OF ARTS DEGREE
- 13 IN POLITICAL SCIENCE. IN 1975, HE RECEIVED HIS MASTERS OF
- 14 PUBLIC ADMINISTRATION FROM ST. LAWRENCE UNIVERSITY IN CANTON,
- 15 NEW YORK.
- 16 (2) MR. PATERNOSTRO WAS A LIFELONG EDUCATOR. HE WAS BOTH
- 17 AN ELEMENTARY AND SECONDARY SCHOOL TEACHER BEFORE SERVING AS
- AN ELEMENTARY PRINCIPAL IN PRATTSBURGH, NEW YORK. HE THEN
- 19 SERVED AS SUPERINTENDENT OF SCHOOLS IN THE CLIFTON-FINE
- 20 SCHOOL DISTRICT IN STAR LAKE, NEW YORK AND THE ONEONTA CITY
- 21 SCHOOL DISTRICT IN ONEONTA, NEW YORK. IN 1981, HE BECAME
- 22 SUPERINTENDENT OF SCHOOLS AT THE EAST LYCOMING SCHOOL
- 23 DISTRICT IN HUGHESVILLE, WHERE HE SERVED ADMIRABLY FOR 11
- 24 YEARS.
- 25 (3) FOLLOWING HIS RETIREMENT FROM PUBLIC SCHOOLS IN
- 26 1992, MR. PATERNOSTRO WENT TO WORK FOR THE INDUSTRIAL
- 27 MODERNIZATION CENTER IN MONTOURSVILLE. THERE HE WAS A DRIVING
- FORCE BEHIND THE PENNSYLVANIA SCHOOL-TO-WORK INITIATIVE, A
- 29 PROJECT THAT ULTIMATELY BECAME A NATIONAL MODEL FOR YOUTH
- 30 APPRENTICESHIP. HE TESTIFIED ABOUT THIS INITIATIVE IN FRONT

- 1 OF A UNITED STATES SENATE COMMITTEE. HIS TESTIMONY AND THE
- 2 INITIATIVE WERE LATER FEATURED ON THE ABC NEWS AMERICAN
- 3 AGENDA AND IN SMITHSONIAN MAGAZINE.
- 4 (4) CONTINUING HIS DEDICATED SERVICE TO PUBLIC EDUCATION
- 5 AND CHILDREN, MR. PATERNOSTRO SERVED AS THE DIRECTOR OF THE
- 6 CHILDREN'S ADVOCACY INITIATIVE FOR LYCOMING COUNTY IN THE
- 7 EARLY 2000S. IN 2004, HE RECEIVED THE CHILD ADVOCATE AWARD
- 8 FOR LEADERSHIP ON CHILDREN'S ISSUES.
- 9 (5) MR. PATERNOSTRO SPENT TIME SUPERVISING STUDENT
- 10 TEACHERS AT BLOOMSBURG UNIVERSITY. HE ALSO SPENT THREE YEARS
- 11 AS A CONSULTANT FOR THE AMERICAN BOARD FOR THE CERTIFICATION
- 12 OF TEACHER EXCELLENCE IN WASHINGTON, DC.
- 13 (6) FROM 2005 TO 2011, FOLLOWING AN APPOINTMENT BY THE
- 14 PENNSYLVANIA SECRETARY OF EDUCATION, MR. PATERNOSTRO SERVED
- AS ONE OF THE COMMONWEALTH'S FIRST DISTINGUISHED EDUCATORS,
- 16 INDIVIDUALS SERVING TO HELP STRUGGLING DISTRICTS THROUGHOUT
- 17 THE STATE IMPROVE STUDENT ACHIEVEMENT.
- 18 (7) MR. PATERNOSTRO WAS AN ACTIVE MEMBER OF HIS
- 19 COMMUNITY. HE WAS A CHARTER BOARD MEMBER OF THE NORTHCENTRAL
- 20 PENNSYLVANIA CONSERVANCY, PAST PRESIDENT OF THE LYCOMING
- 21 AUDUBON SOCIETY, CHAIRMAN OF THE CAPITAL CAMPAIGN OF THE
- 22 HUGHESVILLE LIBRARY BUILDING COMMITTEE, PAST PRESIDENT OF THE
- 23 HUGHESVILLE ROTARY, PAST CHAIRMAN OF THE LITERACY BOARD AT
- 24 THE JAMES V. BROWN LIBRARY, FORMER MEMBER OF THE LYCOMING
- 25 COUNTY HISTORICAL SOCIETY MUSEUM BOARD, FORMER MEMBER OF THE
- 26 WILLIAMSPORT/LYCOMING CHAMBER OF COMMERCE EDUCATION COMMITTEE
- 27 AND A LEADERSHIP LYCOMING VOLUNTEER.
- 28 (8) MR. PATERNOSTRO ALSO SERVED ON THE STATE LEGISLATIVE
- 29 JOINT COMMISSION TASK FORCE ON CHILDREN, LYCOMING COUNTY'S
- 30 CHILD DEATH REVIEW TEAM, LYCOMING COUNTY'S SCHOOL SAFETY

- 1 COMMITTEE ON HOMELAND SECURITY, AND MOST RECENTLY, AS A
- 2 MEMBER OF THE LYCOMING COUNTY HEROIN DRUG TASK FORCE. HE WAS
- 3 ALSO A PROUD FORMER MEMBER OF THE PICTURE ROCKS VOLUNTEER
- 4 FIRE DEPARTMENT FIRE POLICE.
- 5 (9) UNTIL HIS PASSING, MR. PATERNOSTRO WAS A REGULAR
- 6 CONTRIBUTOR TO WEBB WEEKLY, WHERE HE WROTE A FEATURE COLUMN
- 7 ON NATURE.
- 8 (10) MR. PATERNOSTRO SERVED HIS COUNTRY IN THE U.S. NAVY
- 9 FROM 1957 THROUGH 1965, INCLUDING TIME SPENT IN THE NAVAL
- 10 RESERVE. HE ATTENDED NAVAL COMMUNICATIONS SCHOOL AS WELL AS
- 11 OFFICER CANDIDATE SCHOOL IN NEWPORT, RHODE ISLAND. HE
- 12 RECEIVED A SPECIAL COMMENDATION FROM THE CHIEF OF NAVAL
- 13 OPERATIONS FOR HIS FAR EAST SERVICE FOLLOWING HIS TIME SPENT
- 14 IN JAPAN.
- 15 (B) DESIGNATION.--THE SECTION OF STATE ROUTE 220 IN LYCOMING
- 16 COUNTY FROM STATE ROUTE 2081 IN WOLF TOWNSHIP TO STATE ROUTE 42
- 17 IN HUGHESVILLE BOROUGH IS HEREBY DESIGNATED THE THOMAS A.
- 18 PATERNOSTRO MEMORIAL HIGHWAY.
- 19 (C) SIGNS.--THE DEPARTMENT OF TRANSPORTATION SHALL ERECT AND
- 20 MAINTAIN APPROPRIATE SIGNS DISPLAYING THE NAME OF THE HIGHWAY TO

- 21 TRAFFIC IN BOTH DIRECTIONS ON THE HIGHWAY.
- 22 Section 2 3. Effective date.
