AN ACT

1 Amending Title 18 (Crimes and Offenses) of the Pennsylvania
2 Consolidated Statutes, in firearms and other dangerous
3 articles, further providing for definitions, for licenses,
4 for sale or transfer of firearms, for Pennsylvania State
5 Police, for firearm sales surcharge, for the Firearm Records
6 Check Fund, for licensing of dealers, for administrative
7 regulations and for the Firearms Background Check Advisory
8 Committee.

9 The General Assembly of the Commonwealth of Pennsylvania
10 hereby enacts as follows:

11 Section 1. Section 6102 of Title 18 of the Pennsylvania
12 Consolidated Statutes is amended by adding a definition to read:

13 § 6102. Definitions.

14 Subject to additional definitions contained in subsequent
15 provisions of this subchapter which are applicable to specific
16 provisions of this subchapter, the following words and phrases,
17 when used in this subchapter shall have, unless the context
18 clearly indicates otherwise, the meanings given to them in this

1 section:

2 * * *

3 "NICS." The National Instant Criminal Background Check
4 System maintained by the Federal Bureau of Investigation in
5 accordance with the Brady Handgun Violence Prevention Act
6 (Public Law 103-159, 107 Stat. 1536).

7 * * *

8 Section 2. Sections 6109(d)(5) and 6111(a), (b), (f), (g)(3)
9 and (j) of Title 18 are amended to read:

10 § 6109. Licenses.

11 * * *

12 (d) Sheriff to conduct investigation.--The sheriff to whom
13 the application is made shall:

14 * * *

15 (5) [conduct a criminal background, juvenile delinquency
16 and mental health check following the procedures set forth in
17 section 6111 (relating to sale or transfer of firearms),
18 receive a unique approval number for that inquiry and record
19 the date and number on the application] contact the NICS and
20 comply with the requirements of 18 U.S.C. § 922(t) (relating
21 to unlawful acts).

22 * * *

23 § 6111. Sale or transfer of firearms.

24 [(a) Time and manner of delivery.--

25 (1) Except as provided in paragraph (2), no seller shall
26 deliver a firearm to the purchaser or transferee thereof
27 until 48 hours shall have elapsed from the time of the
28 application for the purchase thereof, and, when delivered,
29 the firearm shall be securely wrapped and shall be unloaded.

30 (2) Thirty days after publication in the Pennsylvania

1 Bulletin that the Instantaneous Criminal History Records
2 Check System has been established in accordance with the
3 Brady Handgun Violence Prevention Act (Public Law 103-159, 18
4 U.S.C. § 921 et seq.), no seller shall deliver a firearm to
5 the purchaser thereof until the provisions of this section
6 have been satisfied, and, when delivered, the firearm shall
7 be securely wrapped and shall be unloaded.]

8 (b) Duty of seller.--No licensed importer, licensed
9 manufacturer or licensed dealer shall sell or deliver any
10 firearm to another person, other than a licensed importer,
11 licensed manufacturer, licensed dealer or licensed collector,
12 [until the conditions of subsection (a) have been satisfied and]
13 until he has:

14 [(1) For purposes of a firearm as defined in section
15 6102 (relating to definitions), obtained a completed
16 application/record of sale from the potential buyer or
17 transferee to be filled out in triplicate, the original copy
18 to be sent to the Pennsylvania State Police, postmarked via
19 first class mail, within 14 days of the sale, one copy to be
20 retained by the licensed importer, licensed manufacturer or
21 licensed dealer for a period of 20 years and one copy to be
22 provided to the purchaser or transferee. The form of this
23 application/record of sale shall be no more than one page in
24 length and shall be promulgated by the Pennsylvania State
25 Police and provided by the licensed importer, licensed
26 manufacturer or licensed dealer. The application/record of
27 sale shall include the name, address, birthdate, gender,
28 race, physical description and Social Security number of the
29 purchaser or transferee, the date of the application and the
30 caliber, length of barrel, make, model and manufacturer's

1 number of the firearm to be purchased or transferred. The
2 application/record of sale shall also contain the following
3 question:

4 Are you the actual buyer of the firearm(s), as defined
5 under 18 Pa.C.S. § 6102 (relating to definitions), listed
6 on this application/record of sale? Warning: You are not
7 the actual buyer if you are acquiring the firearm(s) on
8 behalf of another person, unless you are legitimately
9 acquiring the firearm as a gift for any of the following
10 individuals who are legally eligible to own a firearm:

- 11 (1) spouse;
- 12 (2) parent;
- 13 (3) child;
- 14 (4) grandparent; or
- 15 (5) grandchild.

16 (1.1) On the date of publication in the Pennsylvania
17 Bulletin of a notice by the Pennsylvania State Police that
18 the instantaneous records check has been implemented, all of
19 the following shall apply:

20 (i) In the event of an electronic failure under
21 section 6111.1(b)(2) (relating to Pennsylvania State
22 Police) for purposes of a firearm which exceeds the
23 barrel and related lengths set forth in section 6102,
24 obtained a completed application/record of sale from the
25 potential buyer or transferee to be filled out in
26 triplicate, the original copy to be sent to the
27 Pennsylvania State Police, postmarked via first class
28 mail, within 14 days of sale, one copy to be retained by
29 the licensed importer, licensed manufacturer or licensed
30 dealer for a period of 20 years and one copy to be

1 provided to the purchaser or transferee.

2 (ii) The form of the application/record of sale
3 shall be no more than one page in length and shall be
4 promulgated by the Pennsylvania State Police and provided
5 by the licensed importer, licensed manufacturer or
6 licensed dealer.

7 (iii) For purposes of conducting the criminal
8 history, juvenile delinquency and mental health records
9 background check which shall be completed within ten days
10 of receipt of the information from the dealer, the
11 application/record of sale shall include the name,
12 address, birthdate, gender, race, physical description
13 and Social Security number of the purchaser or transferee
14 and the date of application.

15 (iv) No information regarding the type of firearm
16 need be included other than an indication that the
17 firearm exceeds the barrel lengths set forth in section
18 6102.

19 (v) Unless it has been discovered pursuant to a
20 criminal history, juvenile delinquency and mental health
21 records background check that the potential purchaser or
22 transferee is prohibited from possessing a firearm
23 pursuant to section 6105 (relating to persons not to
24 possess, use, manufacture, control, sell or transfer
25 firearms), no information on the application/record of
26 sale provided pursuant to this subsection shall be
27 retained as precluded by section 6111.4 (relating to
28 registration of firearms) by the Pennsylvania State
29 Police either through retention of the application/record
30 of sale or by entering the information onto a computer,

1 and, further, an application/record of sale received by
2 the Pennsylvania State Police pursuant to this subsection
3 shall be destroyed within 72 hours of the completion of
4 the criminal history, juvenile delinquency and mental
5 health records background check.

6 (1.2) Fees collected under paragraph (3) and section
7 6111.2 (relating to firearm sales surcharge) shall be
8 transmitted to the Pennsylvania State Police within 14 days
9 of collection.]

10 (1) (Reserved).

11 (1.1) (Reserved).

12 (1.2) (Reserved).

13 (1.3) In addition to the criminal penalty under section
14 6119 (relating to violation penalty), any person who
15 knowingly and intentionally [maintains or fails to destroy
16 any information submitted to the Pennsylvania State Police
17 for purposes of a background check pursuant to paragraphs
18 (1.1) and (1.4) or] violates section 6111.4 shall be subject
19 to a civil penalty of \$250 per violation. [, entry or failure
20 to destroy.

21 (1.4) Following implementation of the instantaneous
22 records check by the Pennsylvania State Police on or before
23 December 1, 1998, no application/record of sale shall be
24 completed for the purchase or transfer of a firearm which
25 exceeds the barrel lengths set forth in section 6102. A
26 statement shall be submitted by the dealer to the
27 Pennsylvania State Police, postmarked via first class mail,
28 within 14 days of the sale, containing the number of firearms
29 sold which exceed the barrel and related lengths set forth in
30 section 6102, the amount of surcharge and other fees remitted

1 and a list of the unique approval numbers given pursuant to
2 paragraph (4), together with a statement that the background
3 checks have been performed on the firearms contained in the
4 statement. The form of the statement relating to performance
5 of background checks shall be promulgated by the Pennsylvania
6 State Police.]

7 (1.5) Contacted the NICS and complied with the
8 requirements of 18 U.S.C. § 922(t) (relating to unlawful
9 acts).

10 (2) Inspected photoidentification of the potential
11 purchaser or transferee, including, but not limited to, a
12 driver's license, official Pennsylvania photoidentification
13 card or official government photoidentification card. In the
14 case of a potential buyer or transferee who is a member of a
15 recognized religious sect or community whose tenets forbid or
16 discourage the taking of photographs of members of that sect
17 or community, a seller shall accept a valid-without-photo
18 driver's license or a combination of documents, as prescribed
19 by the Pennsylvania State Police, containing the applicant's
20 name, address, date of birth and the signature of the
21 applicant.

22 [(3) Requested by means of a telephone call that the
23 Pennsylvania State Police conduct a criminal history,
24 juvenile delinquency history and a mental health record
25 check. The purchaser and the licensed dealer shall provide
26 such information as is necessary to accurately identify the
27 purchaser. The requester shall be charged a fee equivalent to
28 the cost of providing the service but not to exceed \$2 per
29 buyer or transferee.

30 (4) Received a unique approval number for that inquiry

1 from the Pennsylvania State Police and recorded the date and
2 the number on the application/record of sale form.

3 (5) Issued a receipt containing the information from
4 paragraph (4), including the unique approval number of the
5 purchaser. This receipt shall be prima facie evidence of the
6 purchaser's or transferee's compliance with the provisions of
7 this section.

8 (6) Unless it has been discovered pursuant to a criminal
9 history, juvenile delinquency and mental health records
10 background check that the potential purchaser or transferee
11 is prohibited from possessing a firearm pursuant to section
12 6105, no information received via telephone following the
13 implementation of the instantaneous background check system
14 from a purchaser or transferee who has received a unique
15 approval number shall be retained by the Pennsylvania State
16 Police.

17 (7) For purposes of the enforcement of 18 U.S.C. §
18 922(d)(9), (g)(1) and (s)(1) (relating to unlawful acts), in
19 the event the criminal history or juvenile delinquency
20 background check indicates a conviction for a misdemeanor
21 that the Pennsylvania State Police cannot determine is or is
22 not related to an act of domestic violence, the Pennsylvania
23 State Police shall issue a temporary delay of the approval of
24 the purchase or transfer. During the temporary delay, the
25 Pennsylvania State Police shall conduct a review or
26 investigation of the conviction with courts, local police
27 departments, district attorneys and other law enforcement or
28 related institutions as necessary to determine whether or not
29 the misdemeanor conviction involved an act of domestic
30 violence. The Pennsylvania State Police shall conduct the

1 review or investigation as expeditiously as possible. No
2 firearm may be transferred by the dealer to the purchaser who
3 is the subject of the investigation during the temporary
4 delay. The Pennsylvania State Police shall notify the dealer
5 of the termination of the temporary delay and either deny the
6 sale or provide the unique approval number under paragraph
7 (4).]

8 * * *

9 (f) Application of section.--

10 (1) For the purposes of this section only, except as
11 provided by paragraph (2), "firearm" shall mean any weapon
12 which is designed to or may readily be converted to expel any
13 projectile by the action of an explosive or the frame or
14 receiver of any such weapon.

15 (2) The provisions contained in [subsections (a) and]
16 subsection (c) shall only apply to pistols or revolvers with
17 a barrel length of less than 15 inches, any shotgun with a
18 barrel length of less than 18 inches, any rifle with a barrel
19 length of less than 16 inches or any firearm with an overall
20 length of less than 26 inches.

21 (3) The provisions contained in subsection [(a)] (b)
22 (1.5) shall not apply to any law enforcement officer whose
23 current identification as a law enforcement officer shall be
24 construed as a valid license to carry a firearm or any person
25 who possesses a valid license to carry a firearm under
26 section 6109 (relating to licenses).

27 [(4) (i) The provisions of subsection (a) shall not
28 apply to any person who presents to the seller or
29 transferor a written statement issued by the official
30 described in subparagraph (iii) during the ten-day period

1 ending on the date of the most recent proposal of such
2 transfer or sale by the transferee or purchaser stating
3 that the transferee or purchaser requires access to a
4 firearm because of a threat to the life of the transferee
5 or purchaser or any member of the household of that
6 transferee or purchaser.

7 (ii) The issuing official shall notify the
8 applicant's local police authority that such a statement
9 has been issued. In counties of the first class the chief
10 of police shall notify the police station or substation
11 closest to the applicant's residence.

12 (iii) The statement issued under subparagraph (ii)
13 shall be issued by the district attorney, or his
14 designee, of the county of residence if the transferee or
15 purchaser resides in a municipality where there is no
16 chief of police. Otherwise, the statement shall be issued
17 by the chief of police in the municipality in which the
18 purchaser or transferee resides.]

19 (g) Penalties.--

20 * * *

21 (3) Any person, licensed dealer, licensed manufacturer
22 or licensed importer who knowingly and intentionally requests
23 a [criminal history, juvenile delinquency or mental health
24 record check or other confidential information from the
25 Pennsylvania State Police under this chapter] NICS check for
26 any purpose other than compliance with this chapter or
27 knowingly and intentionally disseminates any [criminal
28 history, juvenile delinquency or mental health record]
29 information obtained from a NICS check or other confidential
30 information to any person other than the subject of the

1 information commits a felony of the third degree.

2 * * *

3 (j) Exemption.--

4 (1) The provisions of [subsections (a) and] subsection

5 (b) shall not apply to:

6 (i) sales between Federal firearms licensees; or

7 (ii) the purchase of firearms by a chief law
8 enforcement officer or his designee, for the official use
9 of law enforcement officers.

10 (2) For the purposes of this subsection, the term "chief
11 law enforcement officer" shall include the Commissioner of
12 the Pennsylvania State Police, the chief or head of a police
13 department, a county sheriff or any equivalent law
14 enforcement official.

15 Section 3. Section 6111.1(b)(1), (2) and (3), (c), (e), (i),
16 (j.1), (j.2) and (j.3) of Title 18 are amended and the section
17 is amended by adding a subsection to read:

18 § 6111.1. Pennsylvania State Police.

19 * * *

20 (b) Duty of Pennsylvania State Police.--

21 [(1) Upon receipt of a request for a criminal history,
22 juvenile delinquency history and mental health record check
23 of the potential purchaser or transferee, the Pennsylvania
24 State Police shall immediately during the licensee's call or
25 by return call forthwith:

26 (i) review the Pennsylvania State Police criminal
27 history and fingerprint records to determine if the
28 potential purchaser or transferee is prohibited from
29 receipt or possession of a firearm under Federal or State
30 law;

1 (ii) review the juvenile delinquency and mental
2 health records of the Pennsylvania State Police to
3 determine whether the potential purchaser or transferee
4 is prohibited from receipt or possession of a firearm
5 under Federal or State law; and

6 (iii) inform the licensee making the inquiry either:

7 (A) that the potential purchase or transfer is
8 prohibited; or

9 (B) provide the licensee with a unique approval
10 number.

11 (2) In the event of electronic failure, scheduled
12 computer downtime or similar event beyond the control of the
13 Pennsylvania State Police, the Pennsylvania State Police
14 shall immediately notify the requesting licensee of the
15 reason for and estimated length of the delay. If the failure
16 or event lasts for a period exceeding 48 hours, the dealer
17 shall not be subject to any penalty for completing a
18 transaction absent the completion of an instantaneous records
19 check for the remainder of the failure or similar event, but
20 the dealer shall obtain a completed application/record of
21 sale following the provisions of section 6111(b)(1) and (1.1)
22 (relating to sale or transfer of firearms) as if an
23 instantaneous records check has not been established for any
24 sale or transfer of a firearm for the purpose of a subsequent
25 background check.

26 (3) The Pennsylvania State Police shall fully comply,
27 execute and enforce the directives of this section as
28 follows:

29 (i) The instantaneous background check for firearms
30 as defined in section 6102 (relating to definitions)

1 shall begin on July 1, 1998.

2 (ii) The instantaneous background check for firearms
3 that exceed the barrel lengths set forth in section 6102
4 shall begin on the later of:

5 (A) the date of publication of the notice under
6 section 6111(a)(2); or

7 (B) December 31, 1998.]

8 * * *

9 [(c) Establish a telephone number.--The Pennsylvania State
10 Police shall establish a telephone number which shall be
11 operational seven days a week between the hours of 8 a.m. and 10
12 p.m. local time for purposes of responding to inquiries as
13 described in this section from licensed manufacturers, licensed
14 importers and licensed dealers. The Pennsylvania State Police
15 shall employ and train such personnel as are necessary to
16 administer expeditiously the provisions of this section.]

17 * * *

18 (e) Challenge to records.--

19 (1) Any person who is denied the right to receive, sell,
20 transfer, possess, carry, manufacture or purchase a firearm
21 as a result of the [procedures established by this section]
22 information recorded in a registry of the Pennsylvania State
23 Police may challenge the accuracy of that person's criminal
24 history, juvenile delinquency history or mental health record
25 [pursuant to a denial by the instantaneous records check] by
26 submitting a challenge to the Pennsylvania State Police
27 within 30 days from the date of the denial.

28 (2) The Pennsylvania State Police shall conduct a review
29 of the accuracy of the information forming the basis for the
30 denial and shall have the burden of proving the accuracy of

1 the record. Within 20 days after receiving a challenge, the
2 Pennsylvania State Police shall notify the challenger of the
3 basis for the denial, including, but not limited to, the
4 jurisdiction and docket number of any relevant court decision
5 and provide the challenger an opportunity to provide
6 additional information for the purposes of the review. The
7 Pennsylvania State Police shall communicate its final
8 decision to the challenger within 60 days of the receipt of
9 the challenge. The decision of the Pennsylvania State Police
10 shall include all information which formed a basis for the
11 decision.

12 (3) If the challenge is ruled invalid, the person shall
13 have the right to appeal the decision to the Attorney General
14 within 30 days of the decision. The Attorney General shall
15 conduct a hearing de novo in accordance with the
16 Administrative Agency Law. The burden of proof shall be upon
17 the Commonwealth.

18 (4) The decision of the Attorney General may be appealed
19 to the Commonwealth Court by an aggrieved party.

20 (5) Pursuant to the memorandum of understanding under
21 subsection (j.4), the Pennsylvania State Police shall report
22 to the National Instant Criminal Background Check System
23 Index, Denied Persons Files, the name, date of birth and
24 physical description of any person who successfully
25 challenges the accuracy of that person's criminal history,
26 juvenile delinquency history or mental health record under
27 this subsection.

28 * * *

29 [(i) Reports.--The Pennsylvania State Police shall annually
30 compile and report to the General Assembly, on or before

1 December 31, the following information for the previous year:

2 (1) number of firearm sales, including the types of
3 firearms;

4 (2) number of applications for sale of firearms denied,
5 number of challenges of the denials and number of final
6 reversals of initial denials;

7 (3) summary of the Pennsylvania State Police's
8 activities, including the average time taken to complete a
9 criminal history, juvenile delinquency history or mental
10 health record check; and

11 (4) uniform crime reporting statistics compiled by the
12 Pennsylvania State Police based on the National Incident-
13 based Reporting System.]

14 * * *

15 [(j.1) Delinquency and mental health records.--The
16 provisions of this section which relate to juvenile delinquency
17 and mental health records checks shall be applicable when the
18 data has been made available to the Pennsylvania State Police
19 but not later than October 11, 1999.

20 (j.2) Records check.--The provisions of this section which
21 relate to the instantaneous records check conducted by telephone
22 shall be applicable 30 days following notice by the Pennsylvania
23 State Police pursuant to section 6111(a)(2).]

24 (j.3) Immunity.--[The Pennsylvania State Police and its
25 employees shall be immune from actions for damages for the use
26 of a firearm by a purchaser or for the unlawful transfer of a
27 firearm by a dealer unless the act of the Pennsylvania State
28 Police or its employees constitutes a crime, actual fraud,
29 actual malice or willful misconduct.] Unless the act of the
30 Pennsylvania State Police or its employees constitutes a crime,

1 actual fraud, actual malice or willful misconduct, the
2 Pennsylvania State Police and its employees shall be immune from
3 actions for damages for:

4 (1) the use of a firearm by a purchaser or lawful owner;

5 or

6 (2) the unlawful transfer of a firearm by a dealer.

7 (j.4) Report to NICS.--The Pennsylvania State Police shall,
8 in accordance with Federal and State law regarding
9 confidentiality, enter into a memorandum of understanding with
10 the Federal Bureau of Investigation for the purpose of
11 implementing the NICS in this Commonwealth. The Pennsylvania
12 State Police shall report to the National Instant Criminal
13 Background Check System Index, Denied Persons Files, the name,
14 date of birth and physical description of any person who:

15 (1) under section 6105, may not possess, use, control,
16 sell, transfer or manufacture a firearm in this Commonwealth;

17 or

18 (2) was previously reported under paragraph (1) or any
19 predecessor statute or agreement and may currently possess,
20 use, control, sell, transfer or manufacture a firearm in this
21 Commonwealth.

22 * * *

23 Section 4. Sections 6111.2 and 6111.3 of Title 18 are
24 repealed:

25 [§ 6111.2. Firearm sales surcharge.

26 (a) Surcharge imposed.--There is hereby imposed on each sale
27 of a firearm subject to tax under Article II of the act of March
28 4, 1971 (P.L.6, No.2), known as the Tax Reform Code of 1971, an
29 additional surcharge of \$3. This shall be referred to as the
30 Firearm Sale Surcharge. All moneys received from this surcharge

1 shall be deposited in the Firearm Instant Records Check Fund.

2 (b) Increases or decreases.--Five years from the effective
3 date of this subsection, and every five years thereafter, the
4 Pennsylvania State Police shall provide such information as
5 necessary to the Legislative Budget and Finance Committee for
6 the purpose of reviewing the need to increase or decrease the
7 instant check fee. The committee shall issue a report of its
8 findings and recommendations to the General Assembly for a
9 statutory change in the fee.

10 (c) Revenue sources.--Funds received under the provisions of
11 this section and section 6111(b)(3) (relating to sale or
12 transfer of firearms), as estimated and certified by the
13 Secretary of Revenue, shall be deposited within five days of the
14 end of each quarter into the fund.

15 (d) Definition.--As used in this section only, the term
16 "firearm" shall mean any weapon which is designed to or may
17 readily be converted to expel any projectile by the action of an
18 explosion or the frame or receiver of any such weapon.

19 § 6111.3. Firearm Records Check Fund.

20 (a) Establishment.--The Firearm Records Check Fund is hereby
21 established as a restricted account in the State Treasury,
22 separate and apart from all other public money or funds of the
23 Commonwealth, to be appropriated annually by the General
24 Assembly, for use in carrying out the provisions of section 6111
25 (relating to firearm ownership). The moneys in the fund on June
26 1, 1998, are hereby appropriated to the Pennsylvania State
27 Police.

28 (b) Source.--The source of the fund shall be moneys
29 collected and transferred under section 6111.2 (relating to
30 firearm sales surcharge) and moneys collected and transferred

1 under section 6111(b)(3).]

2 Section 4.1. Sections 6113(a) and 6124 of Title 18 are
3 amended to read:

4 § 6113. Licensing of dealers.

5 (a) General rule.--The chief or head of any police force or
6 police department of a city, and, elsewhere, the sheriff of the
7 county, shall grant to reputable applicants licenses, in form
8 prescribed by the Pennsylvania State Police, effective for three
9 years from date of issue, permitting the licensee to sell
10 firearms direct to the consumer, subject to the following
11 conditions in addition to those specified in section 6111
12 (relating to sale or transfer of firearms), for breach of any of
13 which the license shall be forfeited and the licensee subject to
14 punishment as provided in this subchapter:

15 (1) The business shall be carried on only upon the
16 premises designated in the license or at a lawful gun show or
17 meet.

18 (2) The license, or a copy thereof, certified by the
19 issuing authority, shall be displayed on the premises where
20 it can easily be read.

21 (3) No firearm shall be sold in violation of any
22 provision of this subchapter.

23 (4) No firearm shall be sold under any circumstances
24 unless the purchaser is personally known to the seller or
25 shall present clear evidence of the purchaser's identity.

26 (5) [A true record in triplicate shall be made of every
27 firearm sold, in a book kept for the purpose, the form of
28 which may be prescribed by the Pennsylvania State Police, and
29 shall be personally signed by the purchaser and by the person
30 effecting the sale, each in the presence of the other, and

1 shall contain the information required by section 6111. The
2 record shall be maintained by the licensee for a period of 20
3 years.] (Reserved).

4 (6) No firearm as defined in section 6102 (relating to
5 definitions) shall be displayed in any part of any premises
6 where it can readily be seen from the outside. In the event
7 that the Commissioner of the Pennsylvania State Police shall
8 find a clear and present danger to public safety within this
9 Commonwealth or any area thereof, firearms shall be stored
10 and safeguarded pursuant to regulations to be established by
11 the Pennsylvania State Police by the licensee during the
12 hours when the licensee is closed for business.

13 (7) The dealer shall possess all applicable current
14 revenue licenses.

16 § 6124. Administrative regulations.

17 The commissioner may establish form specifications and
18 regulations, consistent with section 6109(c) (relating to
19 licenses), with respect to uniform forms control, including the

21 (1) License to carry firearms.

24 [(4) Application for purchase of a firearm.

27 [§ 6126. Firearms Background Check Advisory Committee.

28 (a) Establishment.--There is hereby established the Firearms
29 Background Check Advisory Committee which shall consist of six
30 members as follows:

- 1 (1) The Governor or a designee.
- 2 (2) The Attorney General or a designee.
- 3 (3) The Majority Leader of the Senate or a designee.
- 4 (4) The Minority Leader of the Senate or a designee.
- 5 (5) The Majority Leader of the House of Representatives
- 6 or a designee.
- 7 (6) The Minority Leader of the House of Representatives
- 8 or a designee.

9 (b) Duties.--To facilitate compliance with this chapter and
10 the intent thereof, the Firearms Background Check Advisory
11 Committee shall, as follows:

12 (1) Review the operations and procedures of the
13 Pennsylvania State Police relating to the implementation and
14 administration of the criminal history, juvenile delinquency
15 and mental health records background checks.

16 (2) Advise the Pennsylvania State Police relating to the
17 development and maintenance of the instantaneous records
18 check system.

19 (3) Provide annual reports to the Governor and the
20 General Assembly on the advisory committee's findings and
21 recommendations, including discussions concerning conformance
22 with the preamble of the act of June 13, 1995 (1st Sp.Sess.,
23 P.L.1024, No.17), entitled, "An act amending Titles 18
24 (Crimes and Offenses) and 42 (Judiciary and Judicial
25 Procedure) of the Pennsylvania Consolidated Statutes, further
26 providing for the possession of firearms; establishing a
27 selected Statewide juvenile offender registry; and making an
28 appropriation."

29 (c) Terms.--Members or their designees shall serve a term of
30 office concurrent with the term of office for which the member

1 was elected. Any vacancy shall be filled by the appointing
2 authority.

3 (d) Chairperson.--The Governor shall appoint the chairperson
4 of the advisory committee.

5 (e) Expiration.--This section shall expire November 30,
6 2002.]

7 Section 5. This act shall take effect June 1, 2013, or
