RELATING TO CRIMINAL OFFENSES - WEAPONS

It is enacted by the General Assembly as follows:

1 SECTION 1. Section 11-47-9 of the General Laws in Chapter 11-47 entitled "Weapons" is
2 hereby amended to read as follows:

3 **11-47-9. Persons exempt from restrictions.**

4 (a) The provisions of § 11-47-8 shall not apply to sheriffs; deputy sheriffs; the
5 superintendent and members of the state police; members of the Rhode Island airport police
6 department; members of the Rhode Island state marshals; Rhode Island state fire marshal; chief
7 deputy state fire marshals; deputy state fire marshals assigned to the bomb squad, and those
8 assigned to the investigation unit; Providence fire department arson investigators, provided that the
9 investigator receiving the permit is a graduate of a police-training academy; correctional officers,
10 within the department of corrections; members of the city or town police force; capitol police
11 investigators of the department of attorney general appointed pursuant to § 42-9-8.1; the witness
12 protection coordinator for the witness protection review board as set forth in chapter 30 of title 12
13 and subject to the minimum qualifications of § 42-9-8.1; automobile theft investigators of the
14 Rhode Island state police pursuant to § 31-50-1; railroad police while traveling to and from official
15 assignments or while on assignments; conservation officers; or other duly appointed law
16 enforcement officers; nor to members of the Army, Navy, Air Force, and Marine Corps of the
17 United States, the National Guard, or organized reserves, when on duty; nor to members of
18 organizations by law authorized to purchase or receive firearms from the United States or this state,
19 provided these members are at, or going to or from, their places of assembly or target practice; nor

1 to officers or employees of the United States authorized by law to carry a concealed firearm; nor to
2 any civilian guard or criminal investigator carrying sidearms or a concealed firearm in the
3 performance of his or her official duties under the authority of the commanding officer of the
4 military establishment in the state of Rhode Island where he or she is employed by the United
5 States; nor to any civilian guard carrying sidearms or a concealed firearm in the performance of his
6 or her official duties under the authority of the adjutant general where he or she is employed
7 guarding a national guard facility, provided, that the commanding officer of the military
8 establishment shall have on file with the attorney general of this state a list of the names and
9 addresses of all civilian guards and criminal investigators so authorized; nor to duly authorized
10 military organizations when on duty; nor to members when at, or going to or from, their customary
11 places of assembly; nor to any individual employed in the capacity of warden, associate warden,
12 major, captain, lieutenant, sergeant, correctional officer or investigator at any project owned or
13 operated by a municipal detention facility corporation, including the Donald W. Wyatt Detention
14 Facility; nor to the regular and/or ordinary transportation of pistols or revolvers as merchandise;
15 nor to any person while transporting a pistol, or revolvers, unloaded from the place of purchase to
16 their residence; or place of business, from their residence to their place of business or from their
17 place of business to their residence, or to a federal firearms licensee for the purpose of sale, to or
18 from a bona fide gunsmith, or firearms repair facility, to any police station or other location
19 designated as a site of a bona fide "gun buy-back" program, but only if said pistol or revolver is
20 unloaded and any ammunition for said pistol or revolver is not readily or directly accessible from
21 the passenger compartment of such vehicle while transporting same and further provided, that in
22 the case of a vehicle without a compartment separate from the passenger compartment, the firearm
23 or the ammunition shall be stored in a locked container.

24 (b) Persons exempted by the provisions of this section from the provisions of § 11-47-8
25 shall have the right to carry concealed firearms everywhere within this state; provided, that this
26 shall not be construed as giving the right to carry concealed firearms to a person transporting
27 firearms as merchandise or as household or business goods.

28 (c) Except as provided in subsection (d) of this section, the attorney general shall have the
29 authority to enter into an agreement or to otherwise formally approve the reciprocal recognition of
30 concealed handgun permits issued in the state of Massachusetts and/or the state of Connecticut on
31 the same terms and conditions as Rhode Island concealed handgun permits are recognized and
32 honored in the state of Massachusetts and/or Connecticut.

33 (d) Any agreement or formal approval by the attorney general pursuant to the provisions
34 of subsection (c) of this section shall include, but not be limited to, the following conditions:

1 (1) The Massachusetts or Connecticut permit or license holder must be a nonresident of
2 Rhode Island who is twenty-one (21) years of age or older;

3 (2) Massachusetts and/or Connecticut shall provide upon request by state or local law
4 enforcement or authorities for instantaneous verification of the validity of all handgun permits or
5 licenses issued within their state. The verification to be accessible twenty-four (24) hours per day;

6 (3) The Massachusetts or Connecticut permit or license holder must have in their
7 immediate possession the concealed handgun or weapon permit or license along with a photo
8 identification issued by a state or government agency, and present for verification the permit or
9 license and identification upon demand by a law enforcement officer; and

10 (4) The Massachusetts or Connecticut permit or license holder shall be subject to the same
11 laws and restrictions with respect to carrying a concealed weapon or firearm as a resident of Rhode
12 Island who is so licensed.

13 (e) The provisions of § 11-47-8 shall not apply to nonresident law enforcement personnel
14 in possession of an official government-issued law enforcement identification card issued to an
15 active duty law enforcement officer from any other state or county. These individuals shall have
16 the right to carry a concealed firearm everywhere within the state.

17 SECTION 2. This act shall take effect upon passage.

EXPLANATION
BY THE LEGISLATIVE COUNCIL
OF
A N A C T
RELATING TO CRIMINAL OFFENSES - WEAPONS

1 This act would authorize the attorney general to enter into a reciprocal agreement with
2 Massachusetts and/or Connecticut to honor each other's issued concealed handgun permits. This
3 act would also exempt active law enforcement officers from other states from the prohibition to
4 carry concealed handguns without a permit.

5 This act would take effect upon passage.
