RELATING TO CRIMINAL OFFENSES - WEAPONS

It is enacted by the General Assembly as follows:

1 SECTION 1. Sections 11-47-35 and 11-47-35.2 of the General Laws in Chapter 11-47
2 entitled "Weapons" are hereby amended to read as follows:

3 **11-47-35. Sale of concealable weapons -- Safety courses and tests -- Review board --**
4 **Issuance of permits to certain government officers.**

5 (a)(1) No person shall deliver a pistol or revolver to a purchaser until seven (7) days shall
6 have elapsed from twelve o'clock (12:00) noon of the day following the day of application for the
7 purchase, and when delivered, the pistol or revolver shall be unloaded and securely wrapped, with
8 the bill of sale to be enclosed within the wrapper with the pistol or revolver. Any citizen of the
9 United States and/or lawful resident of this state who is twenty-one (21) years of age or older, and
10 any nonresident member of the armed forces of the United States who is stationed in this state
11 and who is twenty-one (21) years of age or older, may upon application purchase or acquire a
12 pistol or revolver. At the time of applying for the purchase of a concealable firearm, the purchaser
13 shall: (i) complete and sign in triplicate and deliver to the person selling the pistol or revolver the
14 application form described in this section, and in no case shall it contain the serial number of the
15 pistol or revolver; and (ii) shall present to the person selling the pistol or revolver a
16 pistol/revolver safety certificate issued by the department of environmental management. The
17 certificate shall be retained in the possession of the buyer. The pistol/revolver safety certificate
18 shall certify that the purchaser has completed a basic pistol/revolver safety course as shall be
19 administered by the department of environmental management.

8 (2) The person selling the pistol or revolver shall on the date of application sign and
9 forward by registered mail, ~~or~~ by delivery in person, or by electronic mail if approved by the
10 applicable police department, the original and duplicate copies of the application to the
11 superintendent of the Rhode Island state police or the chief of police in the city or town in which
12 the ~~person~~ purchaser has his or her residence ~~or place of business~~. The superintendent of the
13 Rhode Island state police or the chief of police in the city or town in which the ~~person~~ purchaser
14 has his or her residence ~~or place of business~~ shall mark or stamp the original copy of the
15 application form with the date and the time of receipt and return it by the most expeditious means
16 to the person who is selling the pistol or revolver. The triplicate copy duly signed by the person
17 who is selling the pistol or revolver shall within seven (7) days be sent by him or her by
18 registered mail, by delivery in person, or by electronic mail to the attorney general. The person
19 who is selling the pistol or revolver shall retain the original copy duly received by the police
20 authority to whom sent or delivered for a period of six (6) years with other records of the sale. It
21 shall be the duty of the police authority to whom the duplicate copy of the application form is sent
22 or delivered to make a background check of the applicant to ascertain whether he or she falls
23 under the provisions of § 11-47-5, 11-47-6, 11-47-7, or 11-47-23. If, after the lapse of seven (7)
24 days from twelve o'clock (12:00) noon of the day following application, no disqualifying
25 information has been received from the investigating police authority by the person who is selling
26 the pistol or revolver, he or she will deliver the firearm applied for to the ~~applicant~~ purchaser.
27 Upon the finding of no disqualifying information under the provisions of the above cited sections
28 of this chapter, and in no case later than thirty (30) days after the date of application, the duplicate
29 and triplicate copies of the application will be destroyed. Retention of the duplicate and triplicate
30 copies in violation of this section or any unauthorized use of the information contained in the
31 copies by a person or agency shall be punishable by a fine of not more than one thousand dollars
32 (\$1,000). The provisions of this section shall not apply to bona fide sales at wholesale to duly
33 licensed retail dealers, nor to purchases by retail dealers duly licensed under the provisions of §
34 11-47-39.

1 (b)(1) The department of environmental management shall establish the basic
2 pistol/revolver safety course required by this section. The safety course shall consist of not less
3 than two (2) hours of instruction in the safe use and handling of pistols and revolvers and the
4 course shall be available to buyers continually throughout the year at convenient times and places
5 but at least monthly at locations throughout the state, or more frequently as required. Proficiency
6 in the use of pistols or revolvers shall not be prerequisite to the issuance of the safety certificate.
7 No person shall be required to complete the course more than once; provided, that any person
8 completing the course who is unable to produce the safety certificate issued by the department of
9 environmental management shall be required to take the course again unless the person provides
10 evidence to the department that he or she has successfully completed the course.

11 (2) The administration of the basic pistol/revolver safety course required by this section
12 shall not exceed the cost of thirty-five thousand dollars (\$35,000) in any fiscal year.

13 (c) Proof of passage of the department of environmental management's basic hunter
14 safety course will be equivalent to the pistol/revolver safety certificate mandated by this section.

15 (d) Any person who has reason to believe that he or she does not need the required
16 handgun safety course may apply by any written means to the department of environmental
17 management to take an objective test on the subject of matter of the handgun safety course. The
18 test shall be prepared, as well as an instruction manual upon which the test shall be based, by the
19 department. The manual shall be made available by any means to the applicant who may, within
20 the time limits for application, take the objective test at the department or at any location where
21 the handgun safety course is being given. Any person receiving a passing grade on the test shall
22 be issued a pistol/revolver safety certificate by the department.

24 (f) The following persons shall be issued basic pistol/revolver permits by the department
25 of environmental management: sheriffs, deputy sheriffs, the superintendent and members of the
26 state police, prison or jail wardens or their deputies, members of the city or town police force,
27 members of the park police, conservation officers, members of the airport police and officers of
28 the United States government authorized by law to carry a concealed firearm and, at the
29 discretion of the department of environmental management, any person who can satisfactorily
30 establish that he or she formerly held one of these offices or were so authorized.

31 (g) Any person who is serving in the Army, Navy, Air Force, Marine Corps or Coast
32 Guard on active duty shall not be required to obtain a basic pistol/revolver safety certificate or
33 basic pistol/revolver permit under this section so long as he or she remains on active duty.

34 (h) Any person who is serving in the active reserve components of the Army, Navy, Air

1 Force, Marine Corps or Coast Guard, or any person in an active duty paid status in the Rhode
2 Island National Guard, shall not be required to obtain a basic pistol/revolver safety certificate
3 under this section so long as he or she remains in active status.

4 **11-47-35.2. Sale of rifles/shotguns.**

5 (a) No person shall deliver a rifle or shotgun to a purchaser until seven (7) days shall
6 have elapsed from twelve o'clock (12:00) noon of the day following the day of application for the
7 purchase, and when delivered, the rifle or shotgun shall be unloaded and securely wrapped, with
8 the bill of sale for it to be enclosed within the wrapper with the rifle or shotgun. Any citizen of
9 the United States and/or lawful resident of this state who is eighteen (18) years of age or older,
10 and any non-resident member of the armed forces of the United States who is stationed in this
11 state and who is eighteen (18) years of age or older, may, upon application, purchase or acquire a
12 rifle or shotgun. At the time of applying for the purchase of a shotgun or rifle the purchaser shall
13 complete and sign in triplicate and deliver to the seller the application form described in this
14 section, and in no case shall it contain the serial number of the rifle or shotgun.

21 (b) The person who is selling the rifle or shotgun shall, on the date of application, sign
22 and forward by registered mail, ~~or~~ by delivery in person, or by electronic mail if approved by the
23 applicable police department, the original and duplicate copies of the application to the
24 superintendent of the Rhode Island state police or the chief of police in the city or town in which
25 the ~~seller~~ purchaser has his or her residence ~~or place of business~~. The superintendent of the Rhode
26 Island state police or the chief of police in the city or town in which the ~~person~~ purchaser has his
27 or her residence ~~or place of business~~ shall mark or stamp the original copy of the application form
28 with the date and time of receipt and return it by the most expeditious means to the seller. The
29 triplicate copy duly signed by the seller shall within seven (7) days be sent by him or her by
30 registered mail, by delivery in person, or by electronic mail, to the attorney general. The person
31 who is selling the rifle or shotgun shall retain the original copy duly received by the police
32 authority to whom sent or delivered for a period of six (6) years with other records of the sale. It
33 shall be the duty of the police authority to whom the duplicate copy of the application form is sent
34 or delivered to make a background check of the applicant to ascertain whether he or she falls

1 under the provisions of § 11-47-5, 11-47-6, 11-47-7, or 11-47-23. If, after the lapse of seven (7)
2 days from twelve o'clock (12:00) noon of the day following application, no disqualifying
3 information has been received from the investigating police authority by the person who is selling
4 the rifle or shotgun, he or she will deliver the firearm applied for to the ~~applicant~~ purchaser. Upon
5 the finding of no disqualifying information under the provisions of the above cited sections of this
6 chapter, and in no case later than thirty (30) days after the date of application, the duplicate and
7 triplicate copies of the application will be destroyed. Retention of the duplicate and triplicate
8 copies in violation of this chapter or any unauthorized use of the information contained in them
9 by a person or agency shall be punishable by a fine of not more than one thousand dollars
10 (\$1,000). The provisions of this section shall not apply to bona fide sales at wholesale to duly
11 licensed retail dealers, nor to purchases by retail dealers duly licensed under the provisions of §
12 11-47-39.

13 (c) The provisions of this section shall not apply to full-time members of the state police,
14 full-time members of city or town police departments, persons licensed under §§ 11-47-9 and 11-
15 47-11, or to sales of air rifles or " BB guns" or to sales of antique firearms as defined in § 11-47-
16 2.

17 SECTION 2. This act shall take effect upon passage.

EXPLANATION
BY THE LEGISLATIVE COUNCIL
OF
A N A C T
RELATING TO CRIMINAL OFFENSES - WEAPONS

1 This act would provide that applications to purchase certain firearms be sent by the seller
2 of the firearm to the police department of the city or town in which the purchaser of the firearms
3 has his or her residence and would provide for the use of electronic mail in the forwarding of the
4 application.

5 This act would take effect upon passage.
