- FOR AN ACT ENTITLED, An Act to revise certain provisions regarding the definition of a resident for the purposes of hunting, fishing, and trapping licenses.
- 3 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF SOUTH DAKOTA:
- 4 Section 1. That § 41-1-1.1 be amended to read as follows:
- 5 41-1-1.1. For the purposes of this title, the following are deemed to be residents of this state:
- 6 (1) Any person who previously had a domicile in this state who is absent due to business
- of the United States or of this state, or is serving in the armed forces of the United
- 8 States or the spouse of an active duty military person;
- 9 (2) Any person who previously had a domicile in this state who is absent due to the
- person's regular attendance at a post-high school institution as a full-time student <u>or</u>
- due to the person's regular attendance in a medical or dental residency program;
- 12 (3) Any person in the active military of the United States or that person's spouse who is
- continuously stationed in this state;
- 14 (4) Any person who is a patient in any war veterans' hospital within this state;

1	(5)	Any person who is an employee of the veterans' administration or any veterans'
2		hospital in this state;
3	(6)	Any person residing on restricted military reservations in this state;
4	(7)	Any person attending regularly a post-high school institution in this state as a full-
5		time student for thirty days or more immediately preceding the application;
6	(8)	Any foreign exchange student over sixteen years of age attending a public or private
7		high school who has resided in the state for thirty days or more preceding the
8		application;
9	(9)	Any foreign exchange student who is between the ages of twelve years and sixteen
10		years who has completed the Department of Game, Fish and Parks' course of
11		instruction in the safe handling of firearms and has been issued a certificate of
12		competency upon completion of instruction and who has resided in the state for thirty
13		days or more preceding application for a license;
14	(10)	Any person who is a minor dependent of a resident of this state; and
15	(11)	For the purpose of acquiring resident small game and fishing licenses, any person
16		who does not reside in South Dakota but who is a member of the South Dakota
17		National Guard or of any other unit of a reserve component of the armed forces of the
18		United States that is located in South Dakota.
