WHEREAS, in his free time, Chief Feathers enjoyed outdoor activities such as hunting, fishing, and playing golf, but he was a dedicated family man whose first priority was his children; and

WHEREAS, he is survived by his daughter, Chelsea Feathers, and his son, Blaine Feathers; and

WHEREAS, Chief Feathers was a devout member of First Baptist Church Somerville, where he served as a Sunday School teacher and deacon; and

WHEREAS, Chief Feather leaves behind an indelible legacy of integrity and probity in public life, compassion and loyalty in private life, and diligence and dedication in all his chosen endeavors; and

WHEREAS, the citizens of Somerville, and indeed the entire state, have felt the deep pain produced by this loss of one of our best and brightest law enforcement officers; and
