WHEREAS, Gaylon Turnage was an exemplary public servant and consummate professional who worked assiduously to improve the quality of life for his fellow citizens in numerous capacities; and

WHEREAS, he served with acumen in positions of business and political leadership in Crockett County and West Tennessee, and he leaves behind a significant legacy as a prominent leader in his community; and

WHEREAS, Gaylon Turnage, born in Maury City on January 15, 1935, was the son of Cecil Garland Turnage and Faye Evelyn Gibbons Turnage; and

WHEREAS, Mr. Turnage was a devoted member of the Maury City, Bells, and Alamo Lions Clubs, the Bells Jaycees, and the Crockett County Chamber of Commerce. He was also an avid Rotarian and served as the Alamo Rotary Club president in 1983, during which time he initiated charter changes to open membership to the entire county; and

WHEREAS, with a passion for politics, Gaylon Turnage was elected county commissioner in 2002 and continued serving in that position until the time of his death. He also

led Governor Ray Blanton's and President Jimmy Carter's bids for office on the Crockett County front in earlier years; and

WHEREAS, Mr. Turnage was an active and devout member of Bells United Methodist Church, where he served and worshipped faithfully for many years. In his later years, Alamo First United Methodist was his home church; and

WHEREAS, Mr. Turnage was also deeply devoted to his family, and always endeavored to remain true to family values of the highest order; and

WHEREAS, he enjoyed the loving companionship of his wife, Debra Haynes Turnage, and was the proud parent of Barry Turnage, Ronnie "Pete" Turnage, Randy Turnage, Chris Turnage, Gaylynn Turnage Lynch, Charles Turnage, and stepdaughter Dawn East Ing; and

WHEREAS, the progeny of Gaylon Turnage includes seven grandchildren, Casey Ward, Tristan Turnage Krenek, Nicholas Turnage, Avery Turnage, Connor Lynch, Brandon Lynch, and Allie Ing; and four great-grandchildren, Brinley Krenek, Kipton Krenek, Jamison Turnage, and Steely Ward; and
