WHEREAS, Rev. McCadney was a veteran of the United States Army and served in the Korean War; he was awarded the Bronze Star for his military service in the infantry; and

WHEREAS, W. L. McCadney was deeply devoted to his family, and he always endeavored to remain true to family values of the highest order; and

WHEREAS, Rev. McCadney enjoyed the loving companionship of his wife, Ida Mae Pitts McCadney, and was the proud birth and adoptive father of Howard, Willie, Ray, Albert, Bobby, Phyllis, Dotty, Lisa, Karen, Danny, Claudia Starks, and Ena Qualls; and

WHEREAS, Rev. and Mrs. McCadney also played a large role in the upbringing of many of their grandchildren and great-grandchildren, and the sum total of their progeny now numbers greater than seventy; and
