WHEREAS, in addition to being a concerned and dedicated physician, Dr. Huff was also an involved member of his community, helping to establish the OMEDCO Clinic, Mountain People's Health Council, and Scott County Rescue Squad, and serving as chairman of the Plateau Electric Co-op board of directors; and

WHEREAS, he was a member of Knoxville Scottish Rite Bodies, Kerbela Shriners, and was a member of the Oneida Masonic Lodge for fifty years; and

WHEREAS, an active and devout member of First Baptist Church of Oneida, which he served faithfully for many years, Dr. Huff was also deeply devoted to his family, and he always endeavored to remain true to family values of the highest order; and

WHEREAS, he enjoyed the loving companionship of his wife of thirty-five years, Cathy Powell Huff, and was the proud parent of Adam, Benjamin, Sara, Maxwell, Warren, Avery, Alison, and Nathan, and was a loving grandparent to Rachel, Nolan, Matthew, and Liam; and

WHEREAS, he will be sadly mourned yet fondly remembered by his sister, Susan Rosemary Huff; brother, Caswell Huff; and several other family members, friends, and colleagues; and

WHEREAS, Dr. Huff leaves behind an indelible legacy of integrity and probity in public life, compassion and loyalty in private life, and diligence and dedication in all his chosen endeavors; and
