## A BILL

To amend the Homeland Security Act of 2002 to require the Under Secretary for Management of the Department of Homeland Security to achieve security of sensitive assets among the components of the Department of Homeland Security, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Securing Department  
5 of Homeland Security Firearms Act of 2017” or the “Se-  
6 curing DHS Firearms Act of 2017”.

1 **SEC. 2. DEFINITIONS.**

2 In this Act:

3 (1) DEPARTMENT.—The term “Department”  
4 means the Department of Homeland Security.

5 (2) UNDER SECRETARY FOR MANAGEMENT.—  
6 The term “Under Secretary for Management”  
7 means the Under Secretary for Management of the  
8 Department of Homeland Security.

9 **SEC. 3. INCLUSION OF SECURING FIREARMS AND OTHER**  
10 **SENSITIVE ASSETS IN RESPONSIBILITIES OF**  
11 **UNDER SECRETARY FOR MANAGEMENT.**

12 Paragraph (6) of section 701(a) of the Homeland Se-  
13 curity Act of 2002 (6 U.S.C. 341(a)) is amended by in-  
14 serting “(including firearms and other sensitive assets)”  
15 after “equipment”.

16 **SEC. 4. MANAGEMENT DIRECTIVE.**

17 (a) SAFEGUARDING FIREARMS AND SENSITIVE AS-  
18 SETS DIRECTIVE.—

19 (1) IN GENERAL.—Not later than 120 days  
20 after the date of the enactment of this Act, the  
21 Under Secretary for Management shall disseminate  
22 a Department-wide directive for achieving adequate  
23 security over firearms and other sensitive assets  
24 across the Department.

1           (2) CONTENTS.—The directive required under  
2 subsection (a) shall, at a minimum, include the fol-  
3 lowing:

4           (A) Descriptions of what equipment, in ad-  
5 dition to firearms, is classified as a sensitive  
6 asset for the purpose of carrying out this Act.

7           (B) Requirements for securing Depart-  
8 ment-issued firearms and other sensitive assets.

9           (C) A classification system for all cat-  
10 egories of Department-issued badges and cor-  
11 responding requirements for safeguarding such  
12 assets.

13           (D) Reporting requirements for lost fire-  
14 arms and other sensitive assets, including  
15 timelines for such reporting, to supervisors,  
16 local law enforcement, the Federal Bureau of  
17 Investigation’s National Crime Information  
18 Center, and Department headquarters.

19           (E) Recordkeeping requirements for lost  
20 firearms and other sensitive assets in inventory  
21 systems, including a timeline for recording such  
22 losses.

23           (3) REVIEW AND UPDATE OF DIRECTIVE.—Not  
24 later than one year after the issuance of the direc-  
25 tive required under subsection (a) the Under Sec-

1       retary for Management shall review and update, as  
2       necessary, such directive, including adding a require-  
3       ment relating to recording in the inventory systems  
4       maintained by each component of the Department  
5       the acceptance or transfer of a firearm or other sen-  
6       sitive asset by such component.

7       (b) PERSONAL PROPERTY ASSET MANAGEMENT  
8 PROGRAM MANUAL.—Together with the issuance of the  
9 directive pursuant to subsection (a), the Under Secretary  
10 for Management shall disseminate a revised version of the  
11 Personal Property Asset Management Program Manual  
12 that includes the following:

13           (1) Procedures to safeguard sensitive assets  
14       during on- and off-duty time, and utilization of safe-  
15       ty locking devices and policies on the use of such as-  
16       sets, as applicable.

17           (2) Initial, recurrent, and remedial training on  
18       safeguarding such assets.

19           (3) Examples, with detail, of how to record lost  
20       sensitive assets across components of the Depart-  
21       ment, and an enforcement mechanism to ensure su-  
22       pervisors maintain such records.

23           (4) A requirement that the file maintained on  
24       a lost firearm or other sensitive asset contains both  
25       the corresponding police report and the Department

1 report detailing the circumstances surrounding such  
2 loss, including information on adherence to safe-  
3 guarding procedures.

4 **SEC. 5. COMPONENT RESPONSIBILITIES.**

5 Department component heads shall—

6 (1) comply with Federal law, Federal regula-  
7 tions, executive branch guidance, and Department  
8 policy, including directives required by this Act, re-  
9 lating to the management and oversight of securing  
10 firearms and other sensitive assets;

11 (2) review the need for non-law enforcement  
12 badges;

13 (3) require component personnel to safeguard  
14 firearms and other sensitive assets in accordance  
15 with the directive issued by the Under Secretary for  
16 Management under section 4;

17 (4) require that component personnel adhere to  
18 the procedures and timelines for properly reporting  
19 to supervisors lost firearms and other sensitive as-  
20 sets;

21 (5) require that lost firearms and other sen-  
22 sitive assets are reported to local law enforcement,  
23 the Federal Bureau of Investigation's National  
24 Crime Information Center, and Department head-

1       quarters in the timeframe established in such direc-  
2       tive; and

3               (6) require that lost firearms and other sen-  
4       sitive assets are recorded in inventory systems in the  
5       timeframe established by such directive.

6       **SEC. 6. INSPECTOR GENERAL REVIEW.**

7       The Inspector General of the Department of Home-  
8       land Security shall, on an ongoing basis, review implemen-  
9       tation of this Act and, not later than 180 days after  
10      issuance of the directive under section 4, submit to the  
11      Committee on Homeland Security of the House of Rep-  
12      resentatives and the Committee on Homeland Security  
13      and Governmental Affairs of the Senate a review of the  
14      progress and effectiveness of such directive, including an  
15      assessment of the adequacy of such directive, as well as  
16      the level of compliance among the components of the De-  
17      partment to achieve adequate security of sensitive assets  
18      across Department components.
