# A BILL

To preserve knowledge and promote education about jazz in the United States and abroad.

1       *Be it enacted by the Senate and House of Representa-  
2       tives of the United States of America in Congress assembled,*

3       **SECTION 1. SHORT TITLE.**

4       This Act may be cited as the “National Jazz Preser-  
5       vation, Education, and Promulgation Act of 2015”.

6       **SEC. 2. NATIONAL JAZZ PRESERVATION PROGRAM.**

7       (a) ESTABLISHMENT.—There is established a Na-  
8       tional Jazz Preservation Program, to be carried out by

1 the Secretary of the Smithsonian Institution through the  
2 Director of the National Museum of American History  
3 and in collaboration with other Smithsonian museums, to  
4 preserve knowledge and promote education about jazz.

5 (b) PROGRAM COMPONENTS.—Under the National  
6 Jazz Preservation Program, the Secretary of the Smithso-  
7 nian Institution shall—

8 (1) record audio and video interviews with lead-  
9 ing jazz artists;

10 (2) acquire and preserve jazz artifacts, and in-  
11 terpret the artifacts through activities such as exhi-  
12 bitions and performances by the Smithsonian Jazz  
13 Masterworks Orchestra;

14 (3) continue to recognize Jazz Appreciation  
15 Month;

16 (4) establish, with governmental agencies, uni-  
17 versities, museums, and community-based organiza-  
18 tions with jazz archival collections, collaborative  
19 agreements for the sharing of jazz artifacts; and

20 (5) encourage, consult with, and engage in ca-  
21 pacity building with community-based and regional  
22 organizations with the potential to establish jazz ar-  
23 chival collections.

24 (c) AUTHORIZATION OF APPROPRIATIONS.—There is  
25 authorized to be appropriated to carry out this section

1 \$2,000,000 for each of fiscal years 2016 through 2018,  
2 to remain available until expended.

3 **SEC. 3. JAZZ EDUCATION IN ELEMENTARY AND SEC-**  
4 **ONDARY SCHOOLS.**

5 Section 5411(b) of the Elementary and Secondary  
6 Education Act of 1965 (20 U.S.C. 7243(b)) is amended—

7 (1) by redesignating paragraph (9) as para-  
8 graph (10); and

9 (2) by inserting after paragraph (8) the fol-  
10 lowing new paragraph:

11 “(9) Programs to promote jazz education,  
12 which may include—

13 “(A) a Jazz Artists in the Schools program  
14 to provide support for State arts agencies to  
15 bring jazz artists to elementary and secondary  
16 schools in collaboration with local educational  
17 agencies;

18 “(B) a program for—

19 “(i) the development by jazz artists  
20 and educators of lesson plans and other  
21 educational materials about jazz;

22 “(ii) the distribution of such edu-  
23 cational materials by organizations that  
24 may include the National Endowment for  
25 the Arts, educational institutions, State

1                   and local arts and cultural organizations,  
2                   or non-profit organizations; and  
3                         “(iii) teacher training on jazz edu-  
4                   cation by jazz artists and educators; and  
5                         “(C) an Ambassadors of Jazz program to  
6                   send jazz musicians, and jazz orchestras from  
7                   secondary schools, abroad to perform for di-  
8                   verse audiences on missions of goodwill, edu-  
9                   cation, and cultural exchange, in collaboration  
10                  with the Secretary of State.”.

11 **SEC. 4. NATIONAL JAZZ APPRECIATION PROGRAM.**

12                 (a) ESTABLISHMENT.—There is established a Na-  
13 tional Jazz Appreciation Program, to be carried out by  
14 the Secretary of the Smithsonian Institution through the  
15 Director of the National Museum of American History  
16 and in collaboration with other Smithsonian museums and  
17 affiliates, the National Endowment for the Arts, and the  
18 National Endowment for the Humanities, to further the  
19 appreciation of jazz music throughout the Nation.

20                 (b) PROGRAM COMPONENTS.—Under the National  
21 Jazz Appreciation Program, the Secretary of the Smithso-  
22 nian Institution shall establish a series of jazz perform-  
23 ances at Smithsonian affiliates throughout the Nation that  
24 provides broad geographic access to jazz and supports  
25 public appreciation for the diversity of jazz music.

1       (c) AUTHORIZATION OF APPROPRIATIONS.—There is  
2 authorized to be appropriated to carry out this section  
3 \$1,000,000 for each of fiscal years 2016 through 2018,  
4 to remain available until expended.
