## A BILL

To amend chapter 11 of title 31, United States Code, to require the Director of the Office of Management and Budget to annually submit to Congress a report on all disaster-related assistance provided by the Federal Government.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Disclosing Aid Spent  
5 to Ensure Relief Act” or the “DISASTER Act”.

6 **SEC. 2. FINDINGS.**

7 Congress finds the following:

1           (1) At a time of constrained budgets, it is fis-  
2 cally prudent to understand the amount and the  
3 scope of the Federal Government's involvement in  
4 providing disaster-related assistance to communities  
5 in need.

6           (2) The Federal Government does not provide  
7 a single, publicly available estimate of the amount it  
8 is spending on disaster-related assistance.

9           (3) Because recovery is a long-term process,  
10 providing disaster-related assistance requires signifi-  
11 cant Federal resources to support a multi-agency,  
12 multi-year restoration of infrastructure and com-  
13 merce in affected communities.

14           (4) Understanding the expenditures of indi-  
15 vidual Federal agencies for disaster-related assist-  
16 ance will help better inform the congressional appro-  
17 priations process, as well as presidential budget re-  
18 quests.

19           (5) Knowledge about disaster-related expenses  
20 will illustrate opportunities for reducing these ex-  
21 penses through efforts to reduce vulnerabilities to  
22 future natural disasters.

23 **SEC. 3. PURPOSE.**

24           The purpose of this Act is to require the Director  
25 of the Office of Management and Budget to annually sub-

1 mit to Congress a report on all disaster-related assistance  
2 provided by the Federal Government.

3 **SEC. 4. REPORTING OF DISASTER-RELATED ASSISTANCE.**

4 (a) IN GENERAL.—Chapter 11 of title 31, United  
5 States Code, is amended by adding at the end the fol-  
6 lowing new section:

7 **“§ 1126. Reporting of disaster-related assistance**

8 “(a) IN GENERAL.—On the same day that the Presi-  
9 dent makes the annual budget submission to the Congress  
10 under section 1105(a) for a fiscal year, the Director of  
11 the Office of Management and Budget shall submit to  
12 Congress a report on Federal disaster-related assistance  
13 for the fiscal year ending in the calendar year immediately  
14 preceding the calendar year in which the annual budget  
15 submission is made. Disaster-related assistance encom-  
16 passes Federal obligations related to disaster response, re-  
17 covery, and mitigation efforts, as well as administrative  
18 costs associated with these activities, including spending  
19 by the following agencies and programs:

20 “(1) Department of Agriculture:

21 “(A) Agriculture Research Service.

22 “(B) Farm Service Agency.

23 “(C) Food and Nutrition Service.

24 “(D) Natural Resource Conservation Serv-

25 ice.

1           “(E) Forest Service.

2           “(F) Rural Housing Service.

4           “(2) Department of Commerce:

7 ice.

21          “(b) CONTENT.—The report shall detail the fol-  
22          lowing:

23                 “(1) Overall amount of disaster-related assist-  
24                 ance obligations during the fiscal year.

1           “(2) Disaster-related assistance obligations by  
2 agency and account.

3           “(3) Disaster for which the spending was obli-  
4 gated.

5           “(4) Obligations by disaster.

6           “(5) Disaster-related assistance by disaster  
7 type.

8           “(6) Response and recovery spending.

9           “(7) Mitigation spending.

10           “(8) Spending in the form of loans.

11           “(9) Spending in the form of grants.

12           “(c) AVAILABILITY OF REPORT.—The report shall be  
13 made publicly available on the website of the Office of  
14 Management and Budget and should be searchable, sort-  
15 able and downloadable.”.

16           (b) CONFORMING AMENDMENT.—The table of chap-  
17 ters for chapter 11 of title 31, United States Code, is  
18 amended by adding at the end the following new item:

“1126. Reporting of disaster-related assistance.”.

19 **SEC. 5. EFFECTIVE DATE.**

20           The reporting requirement under the amendment  
21 made by section 3(a) shall take effect with the budget sub-  
22 mission of the President under section 1105(a) of title 31,  
23 United States Code, for fiscal year 2018.
