Mr. McGOVERN, from the Committee on Rules, reported the following resolution; which was referred to the House Calendar and ordered to be printed

## RESOLUTION

Providing for consideration of the bill (H.R. 2377) to authorize the issuance of extreme risk protection orders; providing for consideration of the bill (H.R. 7910) to amend title 18, United States Code, to provide for an increased age limit on the purchase of certain firearms, prevent gun trafficking, modernize the prohibition on untraceable firearms, encourage the safe storage of firearms, and for other purposes; and for other purposes.

1        *Resolved*, That upon adoption of this resolution it  
2 shall be in order to consider in the House the bill (H.R.  
3 2377) to authorize the issuance of extreme risk protection  
4 orders. All points of order against consideration of the bill  
5 are waived. In lieu of the amendment in the nature of a  
6 substitute recommended by the Committee on the Judiciary  
7 ary now printed in the bill, an amendment in the nature  
8 of a substitute consisting of the text of Rules Committee  
9 Print 117-46, modified by the amendment printed in the  
10 report of the Committee on Rules accompanying this reso-  
11 lution, shall be considered as adopted. The bill, as amend-  
12 ed, shall be considered as read. All points of order against  
13 provisions in the bill, as amended, are waived. The pre-  
14 vious question shall be considered as ordered on the bill,  
15 as amended, and on any further amendment thereto, to  
16 final passage without intervening motion except: (1) one  
17 hour of debate equally divided and controlled by the chair  
18 and ranking minority member of the Committee on the  
19 Judiciary or their respective designees; and (2) one motion  
20 to recommit.

21        SEC. 2. Upon adoption of this resolution it shall be  
22 in order to consider in the House the bill (H.R. 7910)  
23 to amend title 18, United States Code, to provide for an  
24 increased age limit on the purchase of certain firearms,  
25 prevent gun trafficking, modernize the prohibition on

1 untraceable firearms, encourage the safe storage of fire-  
2 arms, and for other purposes. All points of order against  
3 consideration of the bill are waived. In lieu of the amend-  
4 ment in the nature of a substitute recommended by the  
5 Committee on the Judiciary now printed in the bill, an  
6 amendment in the nature of a substitute consisting of the  
7 text of Rules Committee Print 117-48 shall be considered  
8 as adopted. The bill, as amended, shall be considered as  
9 read. All points of order against provisions in the bill, as  
10 amended, are waived. The previous question shall be con-  
11 sidered as ordered on the bill, as amended, and on any  
12 further amendment thereto, to final passage without inter-  
13 vening motion except: (1) two hours of debate equally di-  
14 vided and controlled by the chair and ranking minority  
15 member of the Committee on the Judiciary or their respec-  
16 tive designees; (2) proceedings under section 3 of this res-  
17 olution; and (3) one motion to recommit.

18 SEC. 3. The proceedings referred to in section 2 of  
19 this resolution are as follows:

20 (a) after debate pursuant to section 2 of this resolu-  
21 tion, the Chair shall put the question on retaining each  
22 title of the bill, as amended, in the order specified by the  
23 Chair;

24 (b) the yeas and nays shall be considered as ordered  
25 on each of the questions under subsection (a); and

1       (c) after disposition of the questions under subsection  
2 (a), the Chair shall put the question on engrossment and  
3 third reading of the text comprising those portions of the  
4 bill retained pursuant to subsection (a).

5       SEC. 4. In the engrossment of H.R. 7910, the Clerk  
6 shall conform title and section numbers and make related  
7 corrections to cross-references in the event a portion of  
8 the bill is not retained pursuant to section 3 of this resolu-  
9 tion.

10      SEC. 5. House Resolution 1151 is hereby adopted.

11      SEC. 6. House Resolution 1152 is hereby adopted.

12      SEC. 7. House Resolution 188, agreed to March 8,  
13 2021 (as most recently amended by House Resolution  
14 1097, agreed to May 10, 2022), is amended by striking  
15 “June 10, 2022” each place it appears and inserting (in  
16 each instance) “June 17, 2022”.
