RESOLUTION

Providing for consideration of the bill (H.R. 842) to amend the National Labor Relations Act, the Labor Management Relations Act, 1947, and the Labor-Management Reporting and Disclosure Act of 1959, and for other purposes; providing for consideration of the bill (H.R. 8) to require a background check for every firearm sale; providing for consideration of the bill (H.R. 1446) to

amend chapter 44 of title 18, United States Code, to strengthen the background check procedures to be followed before a Federal firearms licensee may transfer a firearm to a person who is not such a licensee; and for other purposes.

1 *Resolved*, That upon adoption of this resolution it
2 shall be in order to consider in the House the bill (H.R.
3 842) to amend the National Labor Relations Act, the
4 Labor Management Relations Act, 1947, and the Labor-
5 Management Reporting and Disclosure Act of 1959, and
6 for other purposes. All points of order against consider-
7 ation of the bill are waived. The amendment printed in
8 part A of the report of the Committee on Rules accom-
9 panying this resolution shall be considered as adopted.
10 The bill, as amended, shall be considered as read. All
11 points of order against provisions in the bill, as amended,
12 are waived. The previous question shall be considered as
13 ordered on the bill, as amended, and on any further
14 amendment thereto, to final passage without intervening
15 motion except: (1) one hour of debate equally divided and
16 controlled by the chair and ranking minority member of
17 the Committee on Education and Labor or their respective
18 designees; (2) the further amendments described in sec-
19 tion 2 of this resolution; (3) the amendments en bloc de-
20 scribed in section 3 of this resolution; and (4) one motion
21 to recommit.

1 SEC. 2. After debate pursuant to the first section of
2 this resolution, each further amendment printed in part
3 B of the report of the Committee on Rules not earlier con-
4 sidered as part of amendments en bloc pursuant to section
5 3 of this resolution shall be considered only in the order
6 printed in the report, may be offered only by a Member
7 designated in the report, shall be considered as read, shall
8 be debatable for the time specified in the report equally
9 divided and controlled by the proponent and an opponent,
10 may be withdrawn by the proponent at any time before
11 the question is put thereon, shall not be subject to amend-
12 ment, and shall not be subject to a demand for division
13 of the question.

14 SEC. 3. It shall be in order at any time after debate
15 pursuant to the first section of this resolution for the chair
16 of the Committee on Education and Labor or his designee
17 to offer amendments en bloc consisting of further amend-
18 ments printed in part B of the report of the Committee
19 on Rules accompanying this resolution not earlier disposed
20 of. Amendments en bloc offered pursuant to this section
21 shall be considered as read, shall be debatable for 20 min-
22 utes equally divided and controlled by the chair and rank-
23 ing minority member of the Committee on Education and
24 Labor or their respective designees, shall not be subject

1 to amendment, and shall not be subject to a demand for
2 division of the question.

3 SEC. 4. Upon adoption of this resolution it shall be
4 in order to consider in the House the bill (H.R. 8) to re-
5 quire a background check for every firearm sale. All points
6 of order against consideration of the bill are waived. The
7 bill shall be considered as read. All points of order against
8 provisions in the bill are waived. The previous question
9 shall be considered as ordered on the bill and on any
10 amendment thereto to final passage without intervening
11 motion except: (1) one hour of debate equally divided and
12 controlled by the chair and ranking minority member of
13 the Committee on the Judiciary or their respective des-
14 ignees; (2) the further amendments described in section
15 5 of this resolution; (3) the amendments en bloc described
16 in section 6 of this resolution; and (4) one motion to re-
17 commit.

18 SEC. 5. After debate pursuant to section 4 of this
19 resolution, each further amendment printed in part C of
20 the report of the Committee on Rules not earlier consid-
21 ered as part of amendments en bloc pursuant to section
22 6 of this resolution shall be considered only in the order
23 printed in the report, may be offered only by a Member
24 designated in the report, shall be considered as read, shall
25 be debatable for the time specified in the report equally

1 divided and controlled by the proponent and an opponent,
2 may be withdrawn by the proponent at any time before
3 the question is put thereon, shall not be subject to amend-
4 ment, and shall not be subject to a demand for division
5 of the question.

6 SEC. 6. It shall be in order at any time after debate
7 pursuant to section 4 of this resolution for the chair of
8 the Committee on the Judiciary or his designee to offer
9 amendments en bloc consisting of further amendments
10 printed in part C of the report of the Committee on Rules
11 accompanying this resolution not earlier disposed of.
12 Amendments en bloc offered pursuant to this section shall
13 be considered as read, shall be debatable for 20 minutes
14 equally divided and controlled by the chair and ranking
15 minority member of the Committee on the Judiciary or
16 their respective designees, shall not be subject to amend-
17 ment, and shall not be subject to a demand for division
18 of the question.

19 SEC. 7. Upon adoption of this resolution it shall be
20 in order to consider in the House the bill (H.R. 1446)
21 to amend chapter 44 of title 18, United States Code, to
22 strengthen the background check procedures to be fol-
23 lowed before a Federal firearms licensee may transfer a
24 firearm to a person who is not such a licensee. All points
25 of order against consideration of the bill are waived. The

1 bill shall be considered as read. All points of order against
2 provisions in the bill are waived. The previous question
3 shall be considered as ordered on the bill and on any
4 amendment thereto to final passage without intervening
5 motion except: (1) one hour of debate equally divided and
6 controlled by the chair and ranking minority member of
7 the Committee on the Judiciary or their respective des-
8 ignees; (2) the further amendments described in section
9 8 of this resolution; (3) the amendments en bloc described
10 in section 9 of this resolution; and (4) one motion to re-
11 commit.

12 SEC. 8. After debate pursuant to section 7 of this
13 resolution, each further amendment printed in part D of
14 the report of the Committee on Rules not earlier consid-
15 ered as part of amendments en bloc pursuant to section
16 9 of this resolution shall be considered only in the order
17 printed in the report, may be offered only by a Member
18 designated in the report, shall be considered as read, shall
19 be debatable for the time specified in the report equally
20 divided and controlled by the proponent and an opponent,
21 may be withdrawn by the proponent at any time before
22 the question is put thereon, shall not be subject to amend-
23 ment, and shall not be subject to a demand for division
24 of the question.

1 SEC. 9. It shall be in order at any time after debate
2 pursuant to section 7 of this resolution for the chair of
3 the Committee on the Judiciary or his designee to offer
4 amendments en bloc consisting of further amendments
5 printed in part D of the report of the Committee on Rules
6 accompanying this resolution not earlier disposed of.
7 Amendments en bloc offered pursuant to this section shall
8 be considered as read, shall be debatable for 20 minutes
9 equally divided and controlled by the chair and ranking
10 minority member of the Committee on the Judiciary or
11 their respective designees, shall not be subject to amend-
12 ment, and shall not be subject to a demand for division
13 of the question.

14 SEC. 10. All points of order against the further
15 amendments printed in parts B, C, and D of the report
16 of the Committee on Rules accompanying this resolution
17 or amendments en bloc described in sections 3, 6, and 9
18 of this resolution are waived.

19 SEC. 11. On any legislative day during the period
20 from March 13, 2021, through April 22, 2021—

21 (a) the Journal of the proceedings of the previous day
22 shall be considered as approved; and

23 (b) the Chair may at any time declare the House ad-
24 journed to meet at a date and time, within the limits of

1 clause 4, section 5, article I of the Constitution, to be an-
2 nounced by the Chair in declaring the adjournment.

3 SEC. 12. The Speaker may appoint Members to per-
4 form the duties of the Chair for the duration of the period
5 addressed by section 11 of this resolution as though under
6 clause 8(a) of rule I.

7 SEC. 13. Each day during the period addressed by
8 section 11 of this resolution shall not constitute a calendar
9 day for purposes of section 7 of the War Powers Resolu-
10 tion (50 U.S.C. 1546).

11 SEC. 14. Each day during the period addressed by
12 section 11 of this resolution shall not constitute a legisla-
13 tive day for purposes of clause 7 of rule XIII.

14 SEC. 15. Each day during the period addressed by
15 section 11 of this resolution shall not constitute a calendar
16 or legislative day for purposes of clause 7(c)(1) of rule
17 XXII.

18 SEC. 16. It shall be in order at any time through the
19 calendar day of April 22, 2021, for the Speaker to enter-
20 tain motions that the House suspend the rules as though
21 under clause 1 of rule XV. The Speaker or her designee
22 shall consult with the Minority Leader or his designee on
23 the designation of any matter for consideration pursuant
24 to this section.

1 SEC. 17. The requirement of clause 6(a) of rule XIII
2 for a two-thirds vote to consider a report from the Com-
3 mittee on Rules on the same day it is presented to the
4 House is waived with respect to any resolution reported
5 through the legislative day of April 22, 2021.

6 SEC. 18. Section 4(d) of House Resolution 8, One
7 Hundred Seventeenth Congress, is amended by—

8 (a) in paragraph (3), striking “and”;
9 (b) in paragraph (4), striking the period and insert-
10 ing “; and”; and
11 (c) adding at the end the following:

12 “(5) the Select Committee shall be composed of 16
13 Members, Delegates, or the Resident Commissioner ap-
14 pointed by the Speaker, of whom 7 shall be appointed on
15 the recommendation of the Minority Leader.”.
