Mr. PANETTA introduced the following bill; which was referred to the Committee on the Judiciary

A BILL

To require the search and retention of certain records with respect to conducting criminal background checks, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “National Instant
5 Criminal Background Check System (NICS) Data Integ-
6 rity Act of 2023”.

7 **SEC. 2. SEARCH OF NATIONAL DATA EXCHANGE.**

8 (a) RETENTION OF BACKGROUND CHECK
9 RECORDS.—Section 103 of the Brady Handgun Violence
10 Prevention Act (34 U.S.C. 40901) is amended—

1 (1) by redesignating subsections (h) through (k)
2 as subsections (i) through (l), respectively;

3 (2) in subsection (g), in the last sentence, by
4 striking “subsection (k)” and inserting “subsection
5 (l)”; and

6 (3) by inserting after subsection (g) the fol-
7 lowing:

8 “(h) RECORD RETENTION.—

9 “(1) DEADLINE FOR RETENTION.—Notwith-
10 standing any other provision of law, the system shall
11 retain records related to a transfer or potential
12 transfer of a firearm to a person who is the subject
13 of a call to the system pursuant to subsection (s) or
14 (t) of section 922 of title 18, United States Code,
15 for as long as necessary to determine whether re-
16 ceipt of a firearm by the person would violate sub-
17 section (g) or (n) of such section or State law.

18 “(2) NOTICE OF RETENTION.—If the system
19 has not determined whether receipt of a firearm by
20 a person would violate subsection (g) or (n) of sec-
21 tion 922 of title 18, United States Code, or State
22 law within 30 days after a call to the system with
23 respect to the person, the system shall notify the
24 person in writing (or by electronic mail if the person
25 has consented to the use of electronic mail) that—

1 “(A) the system may retain records relating
2 to the person and the transfer of a firearm
3 until the system determines that receipt of such
4 firearm by the person does not violate subsection
5 (g) or (n) of section 922 of title 18,
6 United States Code, or State law; and

7 “(B) the person may submit to the Attorney
8 General information to correct, clarify, or
9 supplement records (with respect to the person)
10 retained by the system in accordance with this
11 section and any regulation established by the
12 Attorney General.”.

13 (b) SEARCH OF NATIONAL DATA EXCHANGE.—Section
14 103(e)(1) of the Brady Handgun Violence Prevention
15 Act (34 U.S.C. 40901(e)(1)) is amended by adding at the
16 end the following:

17 “(L) SEARCH OF NATIONAL DATA EX-
18 CHANGE DATABASE.—When determining whether
19 receipt of a firearm by a person would violate
20 subsection (g) or (n) of section 922 of title 18,
21 United States Code, the system established
22 under this section shall search databases contain-
23 ing relevant information, including—

24 “(i) the National Data Exchange;

1 “(ii) the Interstate Identification
2 Index System (as defined in article I of the
3 National Crime Prevention and Privacy
4 Compact, set forth in section 217 of the
5 Crime Identification Technology Act of
6 1998 (34 U.S.C. 40316));

7 “(iii) the National Crime Information
8 Center databases;

9 “(iv) the database created for use by
10 the National Instant Criminal Background
11 Check System and that contains descriptive
12 information on persons determined to
13 be disqualified from possessing a firearm
14 based upon State or Federal law (commonly
15 known as the ‘NICS Index’); and

16 “(v) any other database determined
17 by the Attorney General to be relevant to
18 conducting a background search.”.
