Res. 44) providing for congressional disapproval under chapter 8 of title 5, United States Code, of the rule submitted by the Bureau of Alcohol, Tobacco, Firearms, and Explosives relating to “Factoring Criteria for Firearms with Attached ‘stabilizing braces’”; providing for consideration of the bill (H.R. 277) to amend chapter 8 of title 5, United States Code, to provide that major rules of the executive branch shall have no force or effect unless a joint resolution of approval is enacted into law; providing for consideration of the bill (H.R. 288) to amend title 5, United States Code, to clarify the nature of judicial review of agency interpretations of statutory and regulatory provisions; providing for consideration of the bill (H.R. 1615) to prohibit the use of Federal funds to ban gas stoves; and providing for consideration of the bill (H.R. 1640) to prohibit the Secretary of Energy from finalizing, implementing, or enforcing the proposed rule titled “Energy Conservation Program: Energy Conservation Standards for Consumer Conventional Cooking Products”, and for other purposes.

RESOLUTION

Providing for consideration of the joint resolution (H.J. Res. 44) providing for congressional disapproval under chapter 8 of title 5, United States Code, of the rule submitted

by the Bureau of Alcohol, Tobacco, Firearms, and Explosives relating to “Factoring Criteria for Firearms with Attached ‘stabilizing braces’”; providing for consideration of the bill (H.R. 277) to amend chapter 8 of title 5, United States Code, to provide that major rules of the executive branch shall have no force or effect unless a joint resolution of approval is enacted into law; providing for consideration of the bill (H.R. 288) to amend title 5, United States Code, to clarify the nature of judicial review of agency interpretations of statutory and regulatory provisions; providing for consideration of the bill (H.R. 1615) to prohibit the use of Federal funds to ban gas stoves; and providing for consideration of the bill (H.R. 1640) to prohibit the Secretary of Energy from finalizing, implementing, or enforcing the proposed rule titled “Energy Conservation Program: Energy Conservation Standards for Consumer Conventional Cooking Products”, and for other purposes.

1 *Resolved*, That upon adoption of this resolution it
2 shall be in order to consider in the House the joint resolu-
3 tion (H.J. Res. 44) providing for congressional dis-
4 approval under chapter 8 of title 5, United States Code,
5 of the rule submitted by the Bureau of Alcohol, Tobacco,
6 Firearms, and Explosives relating to “Factoring Criteria
7 for Firearms with Attached ‘Stabilizing Braces’”. All
8 points of order against consideration of the joint resolu-
9 tion are waived. The joint resolution shall be considered
10 as read. All points of order against provisions in the joint
11 resolution are waived. The previous question shall be con-

1 sidered as ordered on the joint resolution and on any
2 amendment thereto to final passage without intervening
3 motion except: (1) one hour of debate equally divided and
4 controlled by the chair and ranking minority member of
5 the Committee on the Judiciary or their respective des-
6 ignees; and (2) one motion to recommit.

7 SEC. 2. At any time after adoption of this resolution
8 the Speaker may, pursuant to clause 2(b) of rule XVIII,
9 declare the House resolved into the Committee of the
10 Whole House on the state of the Union for consideration
11 of the bill (H.R. 277) to amend chapter 8 of title 5, United
12 States Code, to provide that major rules of the executive
13 branch shall have no force or effect unless a joint resolu-
14 tion of approval is enacted into law. The first reading of
15 the bill shall be dispensed with. All points of order against
16 consideration of the bill are waived. General debate shall
17 be confined to the bill and shall not exceed one hour equal-
18 ly divided and controlled by the chair and ranking minor-
19 ity member of the Committee on the Judiciary or their
20 respective designees. After general debate the bill shall be
21 considered for amendment under the five-minute rule. In
22 lieu of the amendment in the nature of a substitute rec-
23 ommended by the Committee on the Judiciary now printed
24 in the bill, an amendment in the nature of a substitute
25 consisting of the text of Rules Committee Print 118-6

1 shall be considered as adopted in the House and in the
2 Committee of the Whole. The bill, as amended, shall be
3 considered as the original bill for the purpose of further
4 amendment under the five-minute rule and shall be consid-
5 ered as read. All points of order against provisions in the
6 bill, as amended, are waived. No further amendment to
7 the bill, as amended, shall be in order except those printed
8 in part A of the report of the Committee on Rules accom-
9 panying this resolution. Each such further amendment
10 may be offered only in the order printed in the report,
11 may be offered only by a Member designated in the report,
12 shall be considered as read, shall be debatable for the time
13 specified in the report equally divided and controlled by
14 the proponent and an opponent, shall not be subject to
15 amendment, and shall not be subject to a demand for divi-
16 sion of the question in the House or in the Committee
17 of the Whole. All points of order against such further
18 amendments are waived. At the conclusion of consider-
19 ation of the bill for amendment the Committee shall rise
20 and report the bill, as amended, to the House with such
21 further amendments as may have been adopted. The pre-
22 vious question shall be considered as ordered on the bill,
23 as amended, and on any further amendment thereto to
24 final passage without intervening motion except one mo-
25 tion to recommit.

1 SEC. 3. Upon adoption of this resolution it shall be
2 in order to consider in the House the bill (H.R. 288) to
3 amend title 5, United States Code, to clarify the nature
4 of judicial review of agency interpretations of statutory
5 and regulatory provisions. All points of order against con-
6 sideration of the bill are waived. In lieu of the amendment
7 in the nature of a substitute recommended by the Com-
8 mittee on the Judiciary now printed in the bill, an amend-
9 ment in the nature of a substitute consisting of the text
10 of Rules Committee Print 118-7 shall be considered as
11 adopted. The bill, as amended, shall be considered as read.
12 All points of order against provisions in the bill, as amend-
13 ed, are waived. The previous question shall be considered
14 as ordered on the bill, as amended, and on any further
15 amendment thereto, to final passage without intervening
16 motion except: (1) one hour of debate equally divided and
17 controlled by the chair and ranking minority member of
18 the Committee on the Judiciary or their respective des-
19 ignees; (2) the further amendment printed in part B of
20 the report of the Committee on Rules accompanying this
21 resolution, if offered by the Member designated in the re-
22 port, which shall be in order without intervention of any
23 point of order, shall be considered as read, shall be sepa-
24 rately debatable for the time specified in the report equally
25 divided and controlled by the proponent and an opponent,

1 and shall not be subject to a demand for a division of the
2 question; and (3) one motion to recommit.

3 SEC. 4. At any time after adoption of this resolution
4 the Speaker may, pursuant to clause 2(b) of rule XVIII,
5 declare the House resolved into the Committee of the
6 Whole House on the state of the Union for consideration
7 of the bill (H.R. 1615) to prohibit the use of Federal funds
8 to ban gas stoves. The first reading of the bill shall be
9 dispensed with. All points of order against consideration
10 of the bill are waived. General debate shall be confined
11 to the bill and shall not exceed one hour equally divided
12 and controlled by the chair and ranking minority member
13 of the Committee on Energy and Commerce or their re-
14 spective designees. After general debate the bill shall be
15 considered for amendment under the five-minute rule. The
16 bill shall be considered as read. All points of order against
17 provisions in the bill are waived. No amendment to the
18 bill shall be in order except those printed in part C of
19 the report of the Committee on Rules accompanying this
20 resolution. Each such amendment may be offered only in
21 the order printed in the report, may be offered only by
22 a Member designated in the report, shall be considered
23 as read, shall be debatable for the time specified in the
24 report equally divided and controlled by the proponent and
25 an opponent, shall not be subject to amendment, and shall

1 not be subject to a demand for division of the question
2 in the House or in the Committee of the Whole. All points
3 of order against such amendments are waived. At the con-
4 clusion of consideration of the bill for amendment the
5 Committee shall rise and report the bill to the House with
6 such amendments as may have been adopted. The previous
7 question shall be considered as ordered on the bill and
8 amendments thereto to final passage without intervening
9 motion except one motion to recommit.

10 SEC. 5. At any time after adoption of this resolution
11 the Speaker may, pursuant to clause 2(b) of rule XVIII,
12 declare the House resolved into the Committee of the
13 Whole House on the state of the Union for consideration
14 of the bill (H.R. 1640) to prohibit the Secretary of Energy
15 from finalizing, implementing, or enforcing the proposed
16 rule titled “Energy Conservation Program: Energy Con-
17 servation Standards for Consumer Conventional Cooking
18 Products”, and for other purposes. The first reading of
19 the bill shall be dispensed with. All points of order against
20 consideration of the bill are waived. General debate shall
21 be confined to the bill and shall not exceed one hour equal-
22 ly divided and controlled by the chair and ranking minor-
23 ity member of the Committee on Energy and Commerce
24 or their respective designees. After general debate the bill
25 shall be considered for amendment under the five-minute

1 rule. The bill shall be considered as read. All points of
2 order against provisions in the bill are waived. No amend-
3 ment to the bill shall be in order except those printed in
4 part D of the report of the Committee on Rules accom-
5 panying this resolution. Each such amendment may be of-
6 fered only in the order printed in the report, may be of-
7 fered only by a Member designated in the report, shall
8 be considered as read, shall be debatable for the time spec-
9 ified in the report equally divided and controlled by the
10 proponent and an opponent, shall not be subject to amend-
11 ment, and shall not be subject to a demand for division
12 of the question in the House or in the Committee of the
13 Whole. All points of order against such amendments are
14 waived. At the conclusion of consideration of the bill for
15 amendment the Committee shall rise and report the bill
16 to the House with such amendments as may have been
17 adopted. The previous question shall be considered as or-
18 dered on the bill and amendments thereto to final passage
19 without intervening motion except one motion to recom-
20 mit.

21 SEC. 6. The ordering of the yeas and nays on the
22 question of reconsideration of the vote on adoption of
23 House Resolution 463 is vacated to the end that the mo-
24 tion to reconsider be laid on the table.
