## A BILL

To authorize and request the President to award the Medal

of Honor to Bennie G. Adkins and Donald P. Sloat of the United States Army for acts of valor during the Vietnam Conflict and to authorize the award of the Medal of Honor to certain other veterans who were previously recommended for award of the Medal of Honor.

1       *Be it enacted by the Senate and House of Representa-*  
2   *tives of the United States of America in Congress assembled,*

3   **SECTION 1. AUTHORIZATION AND REQUEST FOR AWARD**  
4                   **OF MEDAL OF HONOR TO BENNIE G. ADKINS**  
5                   **FOR ACTS OF VALOR DURING THE VIETNAM**  
6                   **CONFLICT.**

7       (a) AUTHORIZATION.—Notwithstanding the time lim-  
8 itations specified in section 3744 of title 10, United States  
9 Code, or any other time limitation with respect to the  
10 awarding of certain medals to persons who served in the  
11 Armed Forces, the President is authorized and requested  
12 to award the Medal of Honor under section 3741 of such  
13 title to Bennie G. Adkins of the United States Army for  
14 the acts of valor during the Vietnam Conflict described  
15 in subsection (b).

16       (b) ACTS OF VALOR DESCRIBED.—The acts of valor  
17 referred to in subsection (a) are the actions of then Ser-  
18 geant First Class Bennie G. Adkins of the United States  
19 Army serving with Special Forces Detachment A-102  
20 from March 9 to 12, 1966, during the Vietnam Conflict

1 for which he was originally awarded the Distinguished  
2 Service Cross.

3 **SEC. 2. AUTHORIZATION AND REQUEST FOR AWARD OF**  
4 **MEDAL OF HONOR TO DONALD P. SLOAT FOR**  
5 **ACTS OF VALOR DURING THE VIETNAM CON-**  
6 **FLICT.**

7 (a) AUTHORIZATION.—Notwithstanding the time lim-  
8 itations specified in section 3744 of title 10, United States  
9 Code, or any other time limitation with respect to the  
10 awarding of certain medals to persons who served in the  
11 Armed Forces, the President is authorized and requested  
12 to award the Medal of Honor under section 3741 of such  
13 title to Donald P. Sloat of the United States Army for  
14 the acts of valor during the Vietnam Conflict described  
15 in subsection (b).

16 (b) ACTS OF VALOR DESCRIBED.—The acts of valor  
17 referred to in subsection (a) are the actions of then Spe-  
18 cialist Four Donald P. Sloat of the United States Army  
19 serving with 3rd Platoon, Delta Company, 2nd Battalion,  
20 1st Infantry, 196th Light Infantry Brigade, Americal Di-  
21 vision on January 17, 1970, during the Vietnam Conflict.

1       **SEC. 3. AUTHORIZATION FOR AWARD OF MEDAL OF HONOR**

2                   **TO FORMER MEMBERS OF THE ARMED**

3                   **FORCES PREVIOUSLY RECOMMENDED FOR**

4                   **AWARD OF THE MEDAL OF HONOR.**

5       Section 552(e) of the National Defense Authorization  
6   Act for Fiscal Year 2002 (Public Law 107-107; 10 U.S.C.  
7   3741 note) is amended—

8                   (1) by inserting “(1)” after “HONOR.—”; and  
9                   (2) by adding at the end the following new  
10          paragraph:

11          “(2) In addition to the authority provided by para-  
12   graph (1), a Medal of Honor may be awarded to a veteran  
13   of the Armed Forces who, although not a Jewish-Amer-  
14   ican war veteran or Hispanic-American war veteran de-  
15   scribed in subsection (b), was identified during the review  
16   of service records conducted under subsection (a) and re-  
17   garding whom the Secretary of Defense submitted, before  
18   January 1, 2014, a recommendation to the President that  
19   the President award the Medal of Honor to that veteran.”.
