8                    **LONG TITLE**

9                    **General Description:**

10                    This bill modifies the Public Safety Code regarding the collection of DNA from  
11 offenders.

12                    **Highlighted Provisions:**

13                    This bill:

14                    ▶ adds specified felony offenses to the list of felonies for which the state collects  
15 DNA from an offender at the time of booking.

24                    *Be it enacted by the Legislature of the state of Utah:*

25                    Section 1. Section **53-10-403** is amended to read:

26                    **53-10-403. DNA specimen analysis -- Application to offenders, including minors.**

27                    (1) Sections 53-10-404, 53-10-404.5, 53-10-405, and 53-10-406 apply to any person  
28 who:

29                    (a) has pled guilty to or has been convicted of any of the offenses under Subsection

30 (2)(a) or (b) on or after July 1, 2002;

31 (b) has pled guilty to or has been convicted by any other state or by the United States  
32 government of an offense which if committed in this state would be punishable as one or more  
33 of the offenses listed in Subsection (2)(a) or (b) on or after July 1, 2003;

34 (c) has been booked on or after January 1, 2011, for any offense under Subsection  
35 (2)(c); or

36 (d) is a minor under Subsection (3).

37 (2) Offenses referred to in Subsection (1) are:

38 (a) any felony or class A misdemeanor under the Utah Code;

39 (b) any offense under Subsection (2)(a):

40 (i) for which the court enters a judgment for conviction to a lower degree of offense  
41 under Section 76-3-402; or

42 (ii) regarding which the court allows the defendant to enter a plea in abeyance as  
43 defined in Section 77-2a-1; or

44 (c) (i) any violent felony[-] as defined in Section 53-10-403.5;

45 (ii) sale or use of body parts, Section 26-28-116;

46 (iii) failure to stop at an accident that resulted in death, Section 41-6a-401.5;

- 82           (3) A minor under Subsection (1) is a minor 14 years of age or older whom a Utah
- 83 court has adjudicated to be within the jurisdiction of the juvenile court due to the commission
- 84 of any offense described in Subsection (2), and who is:
- 85           (a) within the jurisdiction of the juvenile court on or after July 1, 2002 for an offense

86 under Subsection (2); or

87 (b) in the legal custody of the Division of Juvenile Justice Services on or after July 1,

88 2002 for an offense under Subsection (2).
