9 **General Description:**

10 This bill modifies provisions related to governance of the Utah College of Applied

175 (1) There is created the Utah College of Applied Technology Board of Trustees[;].

176 (2) Except as provided in Subsections (3) and (4), the board of trustees is composed of
 177 the following members:

178 (a) one member of the State Board of Education appointed by the chair of the State
 179 Board of Education, to serve as a nonvoting member;

180 (b) one member of the State Board of Regents appointed by the chair of the State

181 Board of Regents, to serve as a nonvoting member;

182 (c) one member representing business and industry employers from the campus board
183 of directors of each applied technology college campus appointed by a majority vote of the
184 business and industry employer members of the campus board;

185 (d) one member representing business and industry employers from the Snow College
186 Economic Development and Workforce Preparation Advisory Committee appointed by a
