Whereas, suicide is a public health issue that affects individuals and families of all ages, socio-economic strata, ethnicities, and cultures, and

Whereas, in Vermont, the Agency of Transportation recorded 44 highway fatalities in 2014, while the Vermont Suicide Prevention Center (VSPC) reported that in recent years there were 80 suicides annually, and

Whereas, according to data derived from the Centers for Disease Control and Prevention, for 2013, suicide was the 10th-ranking cause of death in the United States, but second for persons 15–24 years of age, and

Whereas, in Vermont, data derived from federal statistical sources indicate that in the years 2009–2013, for persons 24 years of age and younger, suicide was the second leading cause of death, and

Whereas, the Vermont Suicide Prevention Center starts with the premise that suicide is preventable, and the Vermont Suicide Prevention Coalition (the coalition) is the center's advisory group, and

Whereas, this important coalition consists of representatives from public health, education, state agencies, advocacy groups, youth leadership, mental health services, and survivors of suicide attempts, and

Whereas, the coalition's mission is to create communities of hope throughout Vermont, in which schools, mental health agencies, and individuals are given the knowledge and resources to respond effectively to suicidal behavior, and

Whereas, "Umatter" is the coalition's underlying theme, and its work is premised on multiple levels of suicide prevention, ranging from family to friends to community and, finally, to society at large, and

Whereas, Umatter suicide prevention training also entails short-term crisis scenarios that include urging individuals under stress to call local or national hotlines, to contact a local mental health agency, or to proceed immediately to an emergency room, and

Whereas, today, February 13, 2015, representatives of the Vermont Suicide Prevention Center and the Vermont Suicide Prevention Coalition are visiting the State House to inform legislators about suicide prevention programs, now therefore be it

## Resolved by the Senate and House of Representatives:

That the General Assembly recognizes the vital and lifesaving work of the Vermont Suicide Prevention Center and the Vermont Suicide Prevention Coalition, and be it further

<u>Resolved</u>: That the Secretary of State be directed to send a copy of this resolution to the Vermont Suicide Prevention Center.
