## 2023 SENATE BILL 205

April 3, 2023 - Introduced by Senators JAMES, BALLWEG, CABRAL-GUEVARA, CARPENTER, SPREITZER and TAYLOR, cosponsored by Representatives SORTWELL, S. JOHNSON, DOYLE, ANDRACA, ARMSTRONG, DITTRICH, EDMING and SHANKLAND. Referred to Committee on Mental Health, Substance Abuse Prevention, Children and Families.

1 **AN ACT** *to create* 20.435 (5) (eh) and 51.73 of the statutes; **relating to:** grants  
2 to prevent suicide by firearm and making an appropriation.

***Analysis by the Legislative Reference Bureau***

This bill requires the Department of Health Services to award grants to organizations or coalitions of organizations, including cities, villages, towns, counties, and federally recognized American Indian tribes or bands, for 1) training staff at a firearm retailer or firearm range on how to recognize a person that may be considering suicide; 2) providing suicide prevention materials for distribution at a firearm retailer or firearm range; or 3) providing voluntary, temporary firearm storage for the lawful owner of a firearm. A grant recipient must contribute matching funds or in-kind services having a value equal to at least 20 percent of the grant amount.

3 **SECTION 1.** 20.005 (3) (schedule) of the statutes: at the appropriate place, insert

5 **SECTION 2.** 20.435 (5) (eh) of the statutes is created to read:

6 20.435 (5) (eh) *Grants to prevent suicide by firearm.* Biennially, the amounts  
7 in the schedule for grants related to preventing suicide by firearm under s. 51.73.

8 **SECTION 3.** 51.73 of the statutes is created to read:

9 **51.73 Grants to prevent suicide by firearm. (1)** From the appropriation  
10 under s. 20.435 (5) (eh), the department shall award grants to organizations or  
11 coalitions of organizations, which may include a city, village, town, county, or  
12 federally recognized American Indian tribe or band in this state, for any of the  
13 following purposes:

14 (a) To train staff at a firearm retailer or firearm range on how to recognize a  
15 person that may be considering suicide.

16 (b) To provide suicide prevention materials for distribution at a firearm retailer  
17 or firearm range.

18 (c) To provide voluntary, temporary firearm storage for the lawful owner of a  
19 firearm.

20 **(2)** The department may not award a grant under sub. (1) unless the recipient  
21 contributes matching funds or in-kind services having a value equal to at least 20  
22 percent of the grant.

**SENATE BILL 205****SECTION 3**

1           **(3)** The department may not award a grant to a recipient under sub. (1) for an  
2 amount that exceeds \$5,000. The department may not award a grant under sub. (1)  
3 having a duration of more than one year and may not automatically renew a grant  
4 awarded under sub. (1). This subsection shall not be construed to prevent an  
5 organization or coalition of organizations from reapplying for a grant in consecutive  
6 years. In awarding grants under sub. (1), the department shall give preference to  
7 organizations or coalitions of organizations that have not previously received a grant  
8 under this section.

9           **SECTION 4. Effective date.**

10           (1) This act takes effect on the day after publication, or on the 2nd day after  
11 publication of the 2023 biennial budget act, whichever is later.
